Ariza, 27, of Denver City was driving his 2007 Chevrolet Silverado pickup truck east on Interstate 20 near mile marker 353, about three miles east of Ranger, when he traveled out of the traffic lanes into the center median. Ariza attempted to steer back into the traffic lanes, causing the vehicle to go out of control and overturn.

While Ariza was treated for non-incapacitating injuries and released, his passenger, Guadalupe Ortega Ariza, 40, of Denver City was pronounced dead at the scene of the accident by Justice of the Peace Jesse Speers.

According to the report, Guadalupe Ariza was wearing his safety belt at the time of the accident.

According to another report issued by the TxDPS, at 8:34 p.m. Thursday, Zoila Aguirre Valles, 61, of Midland was at a stop sign facing north on County Road 1110 at the intersection with FM 307 in Midland County. The report states that Valles failed to yield the right of way at the stop sign, causing a 2019 Nissan Sentra driven by Sylvia Pulido Clavel, 43, of Midland to strike his 2018 Ford F-150.

While neither Valles nor

his passenger, 83-year-old Isabel Valles of Midland, were injured in the wreck, Clavel was pronounced dead at the scene by Midland Fire and Emergency Medi-

Clavel was not. Weather conditions were reportedly clear and dry.

DPS Trooper Sean Hazel of Midland investigated the accident.

The family will receive friends from 4 p.m. to 6 p.m. Tuesday, Nov. 29, at the funeral home.



## Hawaii's Mauna Loa erupts, officials warn people to prepare

HONOLULU (AP) — The world's largest active volcano was erupting Monday and wasn't immediately threatening communities on Hawaii's Big Island, but officials warned residents to be ready for worse.

Many current residents weren't living there when Mauna Loa last erupted 38 years ago. The U.S. Geological Survey warned the roughly 200,000 people on the Big Island that an eruption "can be very dynamic, and the location and advance of lava flows can change rapidly."

The eruption began late Sunday night following a series of fairly large earthquakes, said Ken Hon, the scientist-in-charge at the Hawaiian Volcano Observatory.

There's been a surge of development on the Big Island in recent decades — its population has more than doubled, from 92,000 in 1980.

Most of the people on the island live in the city of Kailua-Kona to the west of the volcano, which has about 23,000 people, and Hilo to the east, with about 45,000. Officials were most worried about several subdivisions about 30 miles to the south of the volcano, which are home to about 5,000 people.

A time-lapse video of the eruption from overnight showed lava lighting up one area, moving across it like waves on the ocean.

The U.S. Geological Survey said that the eruption had migrated to a rift zone - a place where the mountain rock is cracked and relatively weak

emerge.

An eruption from the zone could send lava toward the county seat of Hilo or other towns in East Hawaii but it could take the lava weeks or months to reach populated areas.

"We don't want to try and second-guess the volcano," Hon said. "We have to let it actually show us what it's going to do and then we inform people of what is happening ASAP."

Hawaii County Civil Defense announced that it had opened shelters because it had reports of people evacuating from along the coast on their own initiative.

The average Mauna Loa eruption is not typically prolonged, lasting a couple of weeks, Hon said.

"Typically, Mauna Loa eruptions start off with the heaviest volume first," Hon said. "After a few days, it starts to calm down a little bit."

The USGS warned residents at risk from Mauna Loa lava flows to review their eruption preparations. Scientists had been on alert because of a recent spike in earthquakes at the summit of the volcano, which last erupted in 1984.

Portions of the Big Island were under an ashfall advisory issued by the National Weather Service in Honolulu, which said up to a quarter-inch (0.6 centimeters) of ash could accumulate in some areas.

Mauna Loa is one of five volcanoes that together make up the Big Island of Hawaii, which is the southernmost island in the Hawaiian archipelago.

Kilauea, which erupted in a residential neighborhood and destroyed 700 homes in 2018. Some of its slopes are much steeper than Kilauea's, so lava can flow much faster when it erupts.

During a 1950 eruption, the mountain's lava traveled 15 miles (24 kilometers) to the ocean in fewer than three hours.

Tourism is Hawaii's economic engine but Roth predicted few problems for those on vacation during the eruption.

"It will be spectacular where it is, but the chances of it really interrupting the visitor industry very, very slim," he said.

For some, the eruption might cut down on some travel time, even if there is more volcanic smog caused by higher sulfurdioxide emissions.

"But the good thing is you don't have to drive from Kona over to Hawaii Volcanoes National Park to see an eruption anymore," Roth said. "You can just look out your window at night and you'll be able to see Mauna Loa erupting."

Julia Neal, owner of Pahala Plantation Cottages, said the eruption brings some relief after many preparedness meetings, and much wondering about what the volcano will do.

"It's exciting," she said. "It's kind of a relief that it's happening and we're not waiting for it to happen."

A few future guests from the U.S. mainland called Neal "asking me to make a prediction, which I can't," she said. "So I said, just stand by."

## Water boil order issued for more than 2 million in Houston

HOUSTON (AP) — More than 2 million people in the Houston area were under a boil order notice Monday after a power outage at a purification plant caused water pressure to drop, and the mayor of the nation's fourth-largest city ordered a full review of the system.

The notice tells customers to boil water before it's used for cooking, bathing or drinking. Multiple Houston area public and private schools, as well as some local colleges, were closed Monday as a result of the notice, while others made adjustments to provide affected campuses with bottled water and sanitizer.

The notice was issued Sunday, hours after two transformers failed, causing power outages at the water plant, Houston Mayor Sylvester Turner said at a press conference Monday. There was no indication the water system had been contaminated.

Water quality testing was underway, Turner said. He said he expects the notice to be lifted by early Tuesday at the latest, once the state's environmental agency gives an all-clear after analyzing test results.

According to Turner, the city issued a notice, which affects all of Houston and multiple adjacent areas, in an "abundance of caution" after the two transformers— a main one and its backup— "uniquely and coincidentally" failed. The problem affected the plant's ability to treat water and pump water into the transmission system, resulting in low water pressure.

The power system at the water plant undergoes regular maintenance, Turner said, but he did not give a timeline for how often.

The mayor said he has ordered a diagnostic review of the system to understand how this was possible and how it can be prevented. He said because the issue was within the plant's system, backup power generators would not have made a difference.

LUBBOCK, Texas (AP) — Trey Wolff made a 35yard field goal in overtime after a tying kick in the final seconds of regulation, and Texas Tech erased an 18-point deficit in a 51-48 win over Oklahoma on Saturday night.

Dillon Gabriel threw for 449 yards and six touchdowns, but the OU quarterback was sidelined briefly in OT after a hard hit from safety Reggie Pearson Jr. on a catch on a throwback play.

The Sooners appeared out of sync on offense and had to settle for a 34-yard field goal try from Zach Schmit after Gabriel was sacked. The kick was wide right.

After Wolff's winner, Texas Tech fans stormed the field just as they did after an OT victory over Texas in September.

The Red Raiders ended a 10-game losing streak against OU and beat the Sooners and Longhorns in the same season for the first time in coach Joey Mc-Guire's first season.

Texas Tech (7-5, 5-4 Big 12) secured a winning conference record for the first time since 2009.

The Sooners (6-6, 3-6) couldn't hold a 24-6 secondquarter lead, giving up 24 consecutive points from late in the second quarter to early in the third on the way to six lead changes in the second half and overtime.

Oklahoma finished the regular season without a winning record for the first time since 1998 in a disappointing debut for coach Brent Venables.

"I thought they did a great job of executing, finding the plays within a couple of those drives where they executed at the most critical moments," Venables said. "And we didn't."

Texas Tech's Tyler Shough threw for a careerhigh 436 yards with two scores, but he was intercepted by C.J. Coldon to set up Schmit's tiebreaking 43-yard field goal with four minutes remaining.

Shough put the Red Raiders in position for the tie in the final seconds. Wolff's first kick was blocked by Josh Ellison, but Venables had called a timeout. Wolff made the 43-yarder on the second try. "One day, people might not need to ice him, because when you ice him, he's perfect," McGuire said. "What a huge kick. He's done it all year for us."

Oklahoma's Marvin Mims Jr. had a career-high 162 yards receiving and two touchdowns, and Brayden Willis also had two TD grabs. Eric Gray rushed for 161 yards.

Jerand Bradley also finished with a career best in receiving yards with 173 for Texas Tech, and he had a 44-yard tiebreaking TD catch in the fourth quarter.

Texas Tech's SaRodorick Thompson had two rushing TDs.

#### FIT TO BE TIED

There were three tying scores in the fourth quarter, starting with Gabriel's 5-yard pass to Willis for 38-38. After Bradley's 44-yarder, Jalil Farooq had a 1-yard catch for 45-45. Then there was the exchange of field goals.

The Red Raiders had to convert a fourth-and-7 to keep their drive to the tying field goal alive. Shough completed a 14-yard pass to Loic Fouonji.

Gabriel was 28 of 40 and Shough 31 of 50, with each throwing an interception.

"We knew it was going to be a dogfight," Shough said. "We started slow, not how we wanted to start, but I'm proud of how we fought."

## Achane runs for 215 yards, Texas A&M stuns No. 6 LSU 38-23

COLLEGE STATION, Texas (AP) — Riding a five-game winning streak and assured of playing in next week's Southeastern Conference title game, No. 6 LSU just had to take care of underperforming Texas A&M to keep its College Football Playoff hopes alive. team overlooked the Aggies.

"We just needed more juice, more fire and we just seemed to lack that today and that's on me," Kelly said.

The Aggies, who opened the season ranked No. 6 but won't qualify for a bowl game for the first time since 2008, had a strong finish to their disappointing season. They won consecutive games for the first time since Sep tember after snapping a six-game skid with a victory over UMass last week. "There's not a secret to this," Texas A&M coach Jimbo Fisher said. "Just go do your job. There's no magical formula." Achane ran for 119 yards and a score before halftime to help A&M to a 17-10 lead. "Their best players played to their level today," Kelly said. "We didn't match it. Our best players needed to make great plays and we fell short in that area." LSU opened the second half with a nine-play, 71-yard drive, capped by a 19-yard run by John Emery Jr. to tie it at 17-17. But Edgerrin Cooper hit Jayden Daniels and forced him to fumble on LSU's next drive. Richardson scooped it up and dashed 37 yards for his second touchdown this season to put A&M on top 24-17 with about seven minutes left in the third quarter. "I think there was some momentum swing there," Kelly said. "I don't know if we ever really recovered from it." The Aggies extended the lead to 31-17 on the first play of the fourth quarter when Moose Muhammad reeled in a 21-yard TD catch with one hand. A 10-yard run by Achane, who returned after missing two games with a foot injury, made it 38-17 with about eight minutes to go. A rowdy crowd of more than

93,000 fans packed Kyle Field and some began to rush the field with about 17 seconds left, causing a delay. It was a stark difference from last week, when most of the crowd emptied out after halftime on a wet and cold day.

Those fans and several thousand more poured onto the field when time expired.

Daniels threw for 189 yards and ran for 84 more and Emery had three touchdowns for the Tigers, who lost their first game since they fell 40-13 at home to Tennessee on Oct. 8. Emery cut the lead to 38-23 with a 3-yard run with about 6 1/2 minutes to go, but the 2-point conversion failed. Daniels nearly connected with Jaray Jenkins in the end zone on fourth down on LSU's next possession, but Tyreek Chappell knocked the ball out of Jenkins' hands. The Aggies then ran out the clock.

Instead, Devon Achane had a career-best 215 yards rushing with two touchdowns, and Texas A&M stunned LSU 38-23, all but certainly knocking the Tigers out of contention for the CFP.

"They have done some incredible things and I don't want this loss to at all take away from what they've accomplished this year," LSU coach Brian Kelly said. "This was not a step back. This was a bump in the road and they're going to learn from it."

Conner Weigman threw two TD passes for the Aggies (5-7, 2-6 SEC) and Demani Richardson returned a fumble for a score. The game was tied at 17-all in the third quarter before A&M scored 21 straight points.

"It shows the type of team we can be," Achane said. "Just showing that it wasn't the season we wanted but came out to beat a top-(10) team."

LSU (9-3, 6-2, No. 5 CFP) had already won the SEC West and secured chance to play for the conference title against unbeaten No. 1 Georgia, and a win there could have put the Tigers in the playoff. But with three losses, even beating the Bulldogs likely won't be enough.

"We just weren't our best today," Kelly said. "I'd like to give you a reason why weren't our best but we just weren't and we needed to be better."

Kelly said he didn't think his




