ers Court met Monday in the third floor county court room. The meeting was called to order by Howard County Judge Kathryn Wiseman at 3:31 p.m.

The public was invited to address the court, but no one from the public was in attendance and therefore no comment was made.

"Nobody wants to talk to us ya'll," said Judge Wiseman before moving on to the agenda items. However, that proved to be brief as well. "Phillip Reed call me and said their was no action and no change," said Wiseman and relayed Reeds request to table the presentation and acceptance of County Officials Monthly Reports.

The motion was carried as there were no comments.

At 3:34 p.m. the commissioners adjourned to executive session to discuss three items that included: Vacation time for an employee was rolled over due to extenuating circumstances. Motion was approved.

Commissioner Jimmie Long presented discussion to remove the contract

with Rose of Sharon because of bonding issues. Any bond over \$100,000 requires a bond so the suggestion was going back out for bids for shutters on court house. "We are going out for bids on plantation shutters on both buildings and ask it not require a bond," Wiseman said. Motion was carried.

One of the highlights of the meeting was item three concerning the Howard County Volunteer Fire Department receiving funding from ARPA funds.

The third item was presented by Commissioner Craig Bailey.

"We in the past few years have developed what I think is the finest group of people in Howard county and that's the Volunteer Fire Department," Baily be-gan and continued. "One of the things that has happened is that some years ago we established a group of people.... who have done an exceptional job. They would go out and fight fires all night and have to come back in and work on the equipment to be able to go out again because we were running on a wing and a prayer most days. I like to remind everyone that these people

do this out of the kindness of their heart and don't get paid a penny for what they do," Bailev concluded.

During closed session it was the courts decision that a part of the ARPA money that was received from the federal government should be presented in appreciation for the efforts of the board of directors, Bailey explained.

Deputy dressed as Grinch gives onions to speeding drivers

MARATHON, Fla. (AP) - Several motorists who were speeding through an elementary school zone on the Florida Keys Overseas Highway received an odorous onion as a reminder to slow down from a county sheriff's deputy dressed as the Grinch.

Col. Lou Caputo, a 37-year veteran of the Monroe County Sheriff's Office who conjured up the concept more than 20 years ago, was back on the streets Tuesday.

Drivers who travel about 5 mph or less above the school zone's speed limit can choose between traffic citations and an onion presented by the Grinch. Those speeding beyond that likely receive a costly ticket.

"It's about education, awareness that our school zones are still operating even though it's the holiday season," Caputo said. "We want people to slow down."

Caputo said he portravs the fictional character created by children's author Dr. Seuss to give motorists a "gift" but also to call attention in a nice way to the need to obey speed limits in school zones.

"It catches them off guard," Caputo said.

"But when I give them a clear choice of a citation or the onion. they will take the onion. And I've had them eat the onion right in front of me."

Green scores 26, Rockets beat slumping Suns in Silas' return

HOUSTON (AP) — Jalen Green had 26 points and Kevin Porter Jr. added 18 as the Houston Rockets never trailed in a 111-97 win over the slumping Phoenix Suns on Tuesday night.

The Rockets led by as many as 23 and held a comfortable lead for most of the night in the return of coach Stephen Silas, who was back after missing the previous game following the death of his father, longtime NBA player and coach Paul Silas.

"It was definitely great to be back," Silas said. "I love these

Paul said he isn't worried about things snowballing for the Suns.

"Not really," he said. "As long as the locker room stays positive and understands that it's a long season. We went on ... an 18game winning streak (last season) and lost in the second round. You know what I mean? In this league you can't get too high or too low."

The Rockets scored the game's first seven points and led 54-35 after a first half where the Suns made just 11 of 50 shots, including 4 of 24 3-pointers. "Mikal was 4 for 24," coach Monty Williams said. "That's going to be a tough recipe when you don't have Book and all the other guys that are out."


Chris Paul had 16 points on 5-of-17 shooting, including 2 of 10 on 3s.

Silas was emotional when speaking about his father before the game. He said he's been moved by the outpouring of support he's received since Paul Silas' death Sunday at 79.



A perfect dish for a

New Year's Day brunch

The late-night revelry of New Year's Eve has made New Year's Day brunch a go-to tradition for millions of people. Staying up until the calendar officially turns from one year to the next at the stroke of midnight can make it harder to get out of bed on the morning of January 1, so there may be no better day to plan a brunch than the first day of the calendar year. Many restaurants offer brunch specials

on New Year's Day, but people need not leave home to ensure their first meal of the new year is delicious. This recipe for "Pan-Fried Eggs and Mixed Mushroom Sauté on Toasted Sourdough Slices" from "Sunday Brunch" (Chronicle Books) by Betty Rosbottom can be just the dish to begin a new year.

Pan-Fried Eggs and Mixed Mushroom Sauté on Toasted Sourdough Slices Serves 4

Mushroom Sauté

11/4 ounces mixed dried mushrooms cups boiling water 11/2 tablespoons olive oil 3 8 ounces sliced brown mushrooms 2 teaspoons minced garlic 1 teaspoon dried crushed rosemary (see tip) Kosher salt Freshly ground black pepper

Toast and Eggs

- 1/2-inch thick sourdough slices Olive oil

1. For the Mushroom Sauté: Place the dried mushrooms in a medium bowl and cover with the boiling water. Let stand until softened, 20 minutes. Strain in a sieve lined with a double thickness of paper towels and reserve the soaking liquid. Coarsely chop the mushrooms. 2. Heat the olive oil in a medium, heavy frying pan set over medium heat. When hot, add the brown mushrooms and sauté, stirring often, for 6 minutes. Add the reserved mushrooms, garlic, rosemary, and 1/2 teaspoon salt; stir for 1 minute. Add the mushroom liquid and cook, stirring, until it has evaporated, 4 to 7 minutes. Season with salt and several grinds of pepper. Remove the frying pan from the heat and cover with foil to keep warm. (The mushrooms can be prepared 1 day ahead; cool, cover and refrigerate. Reheat, stirring, over medium heat.)

3. For the toast and eggs: Brush both sides



of the bread slices generously with olive oil. Set a 10- to 11-inch nonstick frying pan over medium-high heat, and, when hot, add the bread and cook until lightly browned, about 2 minutes per side. Remove the toast and cover loosely with foil. When pan is cool enough to handle, wipe it out with clean paper towels. 4. Add the butter to the frying pan and set it over medium heat. When the butter starts to foam, break an egg into a saucer, being careful to remove any shell fragments., and gently slide it into the frying pan. Repeat with the remaining eggs. Immediately reduce the heat to low and cook, basting the eggs with some of the butter in the pan frequently, until the whites are firm and the yolks are still soft and runny, 3 minutes.

5. While the eggs are cooking, arrange a toasted bread slice on each of four plates. Mound the mushrooms evenly over the toast.

6. Remove each egg with a spatula and arrange on top of the mushrooms. Season with salt and pepper and, if desired, garnish each serving with a rosemary sprig. Serve immediately.

Tip: If you can't find dried crushed rosemary, crush regular dried rosemary in an electic spice mill, or place it in a self-sealing plastic bag and roll over it with a rolling pin.

At times, determining the most promising line of play can be extremely complicated, with any number of variables needing to be considered and assessed. In many cases, though, the solution is rather easy to find.

reached a very reasonable six-heart contract, and West led the king of clubs.

Making the slam appeared to depend on a successful spade finesse as the only way to avoid a club loser. At the first table, South briefly considered the alternative of cashing the ace of spades and ruffing two spades in his hand in the hope that the king would fall, but he correctly dismissed this as nowhere near as good a possibility as the straightforward finesse.

Accordingly, after taking the club ace, he drew trump and led a spade to the queen. East won with the king and returned a club, and that was that — down one.

At the other table, South spotted a superior line of play — one that would give him an extra chance
