Plane Crash Claims Life



Bobby Joe Dunn, Jr. of Texhoma was killed when the spray plane he was flying, crashed Sunday Morning May 29, 1988.

Sunday morning, May 29th at approximately 10 a.m., an airplane crash claimed the life of Bobby Joe Dunn, Jr. age 30 of Texhoma, Oklahoma.

9171 Piper PA 25 aircraft, spraying near Farm-to-market Road 2349 about 24 miles

northeast of Stratford, when the accident occured.

DPS reported the engine may have possibly stalled causing the aircraft to lose altitude. The plane struck nose first with the front end and chemical tank being sheared off in the crash. The

chemical tank, carring parathion was ruptured, but the spill was contained.

The plane was registered to Custom Air Corporation of Texhoma.

There were no witnesses to the crash and the FAA will conduct an investigation, DPS reported.

Three Gymnasts Compete At World

The World Age Group Games were held Lubbock, Tex. May 17-22. participants from Stratford were among the over 800 competitors from 11 different countries. The competition was stiff, the competitors, wonderful. There were some probable future Olympians in the group. Australia, France, Canada, Sweden, Great Britain, Switzerland, West Germany, Japan, New Zealand and the United States

were represented by the best of their gymnasts. Also participating was South Africa, but due to problems with political sanction, were not able to compete. Clint Vincent competed in Boys Age level 11-12, (level 5), and places 2nd in Double Mini Trampoline, 5th in Synchronized Trampoline, 8

th in Trampoline and 13th in Tumbling. Jenny Carter competed in Girls age level 13-14, (Level 4B), and placed 11th in Synchronized Trampoline, 13th in Double Mini Trampoline, 21st in Trampoline and 57th in Tumbling. Heather Carter had the misfortune of hurting her ankle during Tuesday's warmups and could not compete. This was also a National Event for all of the U.S. participants. Clint

placed 2nd in Double Mini Trampoline, 3rd in Trampoline 5th in Synchonized Trampoline, and 12th in Tumbling. Jenny placed 4th in Synchronized trampoline, 7th in Trampoline, 9th in Double Mini tramp and 55 th in tumbling.

Everyone preparing for a world meet must attain a certain level. All competitions are divided into age groups, ability levels, and male or female divisions. There are area meets, then qualifying meets such as area, state, regional, national finally World. World meets are held every two vears, the last one was in France, the next in Germany By 1992, power tumbling and trampoline should be an Olympic Competition. John Beck, a student at all american will be doing an exhibition in Seoul at the Summer Olympics '88.

As a gymnast advances, his ability level goes higher. The top level is five and the level that all gymnasts at World compete at. A 4 B tumbler with a qualifying score may participate at World but will usually have a lower difficulty ability than a 5 tumbler, and well not score

Dear Editor,



as high. A full or 1 rotation (4B level) will not count as much as a double or triple (5level). Sometimes, however, better form can count as much as a harder trick and so it is possible to receive a higher score.

Due to the total use of European equipment at this meet, several gymnasts were hurt. Many had never used the equipment before. Six were taken to the hospital during the first practice session and 5-6 each day of the meet, plus those taped and bandaged at the area.



FINDING WHAT WAS LOST

Luke 15

Luke 15 is usually treated as three parables: [1] The Lost Sheep, [2] The Lost Coin and [3] The Lost Son. If you look carefully however, Luke 15:3 says, "he spake this parable unto them," and then follows with all three as one parable. Each part of this parable is a grand illustration of God's plan to find the lost and restore its value.

The first part is of the Shepherd's seeking the lost sheep. This represents God the Son-the good Shepherd- who came to "seek and save that which was lost". It shows that the initiative for salvation lies with God. he seeks through the preaching of His Word, the witness of His people and the drawing of His Spirit. It is the seeking to restore usefulness of God's created being for a lost sheep is of no use. It can not provide either offspring or wool to its owner.

The second part is the woman seeking the lost coins and she lights a candle to see the dark places. This represents the Holy Spirit shining the searchlight of God's grace into our lives to find us. The Spirit draws lost people to Christ. It is the seeking to restore lost value to God's created beings, for coins that are lost have no value until they are found.

The third part is the Father's seeking his lost son for his father kept watch and saw him a great way off. This represents God the Father's desire for his sons by creation, lost by their rebellion, to come home. It is the seeking to restore lost relationship to the Father who made us for himself.

Forget here and now, this a matter of here and then. If you were a farmer in the 1970's, you're entitled to a refund for some of your fuel expenses. But you have to act before June 30, reports Jim Allison, county agent with the Texas Agricultural Extension Service, The Texas A & M University

System. The refund is a result of a settlement reached by the Dept. of Energy with oil companies that allegedly overcharged for crude oil during a period regulated by price ceilings

Consequently, farmers can get back about \$80 or more for every 100,000 gallons of fuel used between

By Jim Allison August 19, 1973 and January 27, 1981. That equates to a little over \$14 for every 100 acres of cropland in production during the sevenand-a-half year period, according to economist with the Extension Service.

This refund should not be confused with the income tax credit for Federal excise taxes on fuel.

The Dept. of Energy will base refunds on actual gallons purchased, estimated gallons used or a USDA estimate of 23.8 gallons per acre of cropland per year. An explanation of filing procedures for the refund and a simple two-page filing form can be obtained from Jim Allison at the Sherman County Extension Office.


