Safe Fourth Of July Calls For **Caution With Fireworks**

Every year, the same story unfolds. A child setting off fireworks at the family's Fourth of July picnic is brought to the local hospital's emergency room for medical treatment. Numerous cases of hand or facial burns, eye injuries and even hearing loss will occur throughout Texas this summer as a result of unsupervised and careless handling of fireworks.

The most common case of injury is due to unsupervised children playing with fireworks. Dr. Rich Cole, emergency room physician

at Scott and White in Temple, points out that fireworks can cause burns to the fingers and hands, ignite clothing, and cause possible loss of fingertips. These cases usually occur because the handler has not released the firework before it exploded or the firework has misfired.

children should not play with fireworks. "These are not toys,'' he says. ''Even children with sparklers should be supervised. Toddlers will grab at the lit sparkler, which is hot

enough to burn someone." Eye injury is another area of medical concern when it comes to firework safety. According to the American Academy of Ophthalmolgists, close to 4,000 people will suffer eye injuries, with 1,000 resulting in permanent vision loss, due to faulty







STATEMENT OF INTENT **TO CHANGE RATES**

tragic feeling when we have to remove eyes from children or adults and know the injury was preventable. Wearing protective goggles or glasses will prevent most eye injuries," Dr. Cunningham says.

Children and people who have been drinking alcoholic beverages should never be allowed to handle or ignite explosive fireworks. Alcohol has been proven to slow down response time.

Nationwide, more than half the states have adopted a model law which limits the use of fireworks to licensed displays or relatively safe fireworks to licensed displays or relatively safe fireworks such as sparklers. A three-state study indicated that there were ten times more fireworks injuries where no model law was in effect.

"The best thing to do," Dr. Cole adds, "is watch a professional fireworks display from a distance."

If individuals plan to include fireworks in their festive Fourth celebration, they are urged to take the following precautions:

*Always wear safety goggles or glasses when setting off fireworks.

*Only adults should handle or ignite explosive fireworks. *Adults should be present to supervise children during the use of the relatively safe fireworks such as sparklers.

Editors Note: The following article was taken out of the Amarillo Globe News Sunday paper written about **Bob Burgess and written by** Kay Ledbetter, farm and ranch Editor at Amarillo Globe News.

Many farmers hang on to the tradition of their grandparents, but few can actually say they farm like their granddaddy did, what with all of today's modern machinery.

Wade Burgess 19, however can say he knows firsthand the hours and sweat his grandfather puts into bringing in harvest, because for the last 11 years he's helped Bob Burgess cut wheat.

And the 85-year-old Sherman County farmer brings

the harvest in with 1958 and 1959 John Deere Combines and 1948 and 1958 Chevrolet grain trucks. The Burgess duo started

harvesting their wheat patch five miles north of Etter last Sunday and finished on Wednesday.

Farming since 1941, Burgess said he use to cut as much as 1,000 acres of wheat yearly with this machinery. Now, he's cutting only 200 acres, but he's still going and so is the machinery.

Working with 30 year old machinery can bring a few headaches, such as finding parts and making twice as many rounds because the headers are only 14 feet and 18 feet long, compared to the 24 feet to 30 feet-long headers used today.

But with the mechanical help of his grandson, Burgess said, he's able to keep them running and last year he finished harvest before his neighbor who was running four big new machines.

"I figure these machines will last as long as I will," he said. "They're getting old, but not getting as old as I am.'

The green paint is faded, the hot harvest sun is deflected by only a small shade, air conditioning is provided by Mother Nature, the auger is tied on and hangs out to the side continually, "and you know you're going to eat dirt going one way''-but they're all paid for.

"I can't see how they can pay for newer vehicles," Burgess said. "After these

new government programs came along, I'm especially proud of them because I don't owe anybody anything for them.'

The combines cost approximately \$8,000 brand new, compared to the \$80,000 to \$100,000 machines today & Burgess said he didn't think he paid more than \$4,000 for the trucks-but it's been so long ago, he can't remember

Burgess said farming is a mess today and nothing compares to the days he bought the equipment.

"You didn't have to go to the ASCS (Agricultural Stabilization and Conservation Service) office to see what you could do," he said. "Also, back then, wheat was higher than it is now and it cost you half as much to produce it. "


