The Texas Education Agency sent a team to visit the Stratford ISD during the month of May, 1988. This team, headed by Dr. Steve Cavendar, was to evaluate the effectiveness of our school system and to report back to the School Board their findings. This type of visit is required every five years by the Texas Education Agency to keep our school fully accredited by the state.

This committee looked at many different facets of the school including 1. Planning by the District 2. Effective school leadership by the adminstration 3. School Board member training. 4. Curriculum offerings. 5. Instruction 6. Instructional resources 7. Student services 8. Teacher qualifications 9. Governance by the Board 10. Community conditions and support and 11. Physical facilities.

#### NOTICE OF **PUBLIC HEARING ON APPLICATION FOR** WASTE DISPOSAL PERMIT AMENDMENT


City of Stratford, P.O. Box 188, Stratford, Texas 79084 has applied to the Texas Water Commission for an amendment to Permit No. 10293-02 to authorize an increase in the volume of treated domestic wastewater effluent authorized for disposal by irrigation at its East Wastewater Treatment Facilities. The disposal volume is to be increased from 21,000 gallons per day average to 200,000 gallons per day average. Effluent storage calculations and design information indicate that existing treatment facilities are capable of treatment and disposal of the increased volume. Approximately 640 acres of farm land are available for irrigation of crops that are not for human consumption. Application rates for the irrigated land are not to exceed 4.2 acre-feet/acre/ year. No discharge of pollutants into surface water in the State is authorized by this permit.

The plant site is approximately 1/2 mile southeast of U.S. Highway 54 and 21/2 miles northeast of the intersection of U.S. Highways 54 and 287 in the City of Stratford, Sherman County, Texas. The plant site and irrigated land are in the drainage area of Coldwater Creek in the Canadian River Basin.

The Executive director of the Texas Water Commission has prepared a draft permit based on the application submitted by the applicant and other information presently available.

A Hearings Examiner of the Texas Water Commission will conduct a public hearing at 10:00 a.m. -Tuesday, September 20, 1988; Stratford City Hall -City Council Meeting Room; 520 North Third-Stratford Texas to receive evidence on the conditions, if any, under which the permit may be issued, and determine whether State Certification in accordance with Section 401 of the Federal Clean Water Act may be issued. This hearing will be held under the authority of Sections 26.020, 26.021 and 26.028 of the Texas Water Code, as amended, and the Rules of the Texas Water Commission.

The record of this proceeding will include evidence and testimony taken at the public hearing. The hearing may be continued from time to time and place to place, if necessary, to develop all relevant evidence bearing on the subject of the hearing. The Texas Water Commission reserves the right to schedule or reschedule hearings as it deems necessary. 
