The history of Sacred Heart Church, or rather of the Catholic congregation in Rockport, begins long ago, shortly after the War for Texan Independence, when, in 1838, two Vincentian Fathers from Missouri, Fathers Timon and Lleberia, visited Texas to investigate the future of the church in this wilderness.

# **Texas Fisheries Produce 13 Million Pounds More Than For Last Year**

Texas commercial fisheries production for the fiscal year of 1953-54 is up 12,697,750 pounds over the 1952-53 period. A large proportion of this gain is attributable to shrimp and menhaden catches, although these, in part, were offset by drops in the poundage of trout, flounder, and drum.

The altar was arranged, and the hosts made by Mrs. Hynes and her smoothing irons, a method apparently learned when Mrs. Hynes, as a young woman, had attended the Ursuline Convent in New Orleans, where she was schooled in all cares of the Church and Sanctuary.

Mass was celebrated in the Hynes' home for a number of years by the different priests that would come, nearly always from Refugio. and there also were performed some baptisms, communions, and marriages. However, because there was no parish house, records of these events were carried back by the fathers to the various towns from whence they came. Some, concerning early members of the congregation in this area, have been found in San Patricio, Laredo, Refugio, Corpus Christi, and even San Antonio, and there are records of baptisms that took place here or at Lamar, signed by at least seven different priests who ministered to the spiritual needs of the community.

Later, although a room was always maintained in the Hynes home for the missionary fathers, church services were held, and
