One Burglar Gets Two Years, **Others Released**

Out of the seven youths and young men mixed up in the recent burglaries in Aransas County, one of them, Tony Sanchez, alias Antonio Garcia, was sentenced from two to five years in the penitentiary, and the balance of them were turned loose, some under suspended sentences.

Alfonso Zavala and Augustin Rodriguez, both of whom were indicted along with Sanchez in three cases of burglary, were given suspended sentences of two to five years each.

The grand jury failed to find bills against Joe Torres of Rockport and Joe Ortiz, of Gregory, both of whom had been charged

in Justice of the Peace Court with burglary in the night time. Two 14-year-old juveniles were also given suspended sentences and released in the custody of their families.

"We built twenty-four 110-foot subchasers for the Navy," Rice said, "and nine 65-foot T-boats

"Since then we have built 10 or 12 big shrimpers, including a couple for the Crawford Packing Co. at Palacios, in addition to our regular repair work."

Among the shipyard's regular customers was the Matagorda Air Force Base at Port O'Connor, which depended on Rice to keep boats, barges and ferries used there in tip-top shape. The Coast Guard also had its cutters hauled out there whenever they needed repairs or an overhaul, as Rice's was practically the only ways that would handle boats larger than shrimpers, from Galveston to Port Isabel, and it employed a work force of between 25 and 30 men the year round.
