Marineland, New **Boat Firm to** Open Here Aug. 1

Marineland, Inc., a new firm composed of Corpus Christi businessman Homer V. Faber, and retiring Aransas County School Superintendent Pat H. Greene, has leased the building now occupied by Chester Johnson Motors in Rockport, and, after extensive remodeling, will open a boat sales and service, handling everything for the outboard enthusiast.

Main items that Marineland intends to merchandise are wood, aluminum, and glass outboard boats, motors, as well as motors, trailers, and accessories.

"We do not contemplate handthat kind," Faber said, "for we feel that the area is adequately in this area. provided along those lines, but we will handle water skis, life preservers, boat hardware, spare parts for some types of motors and that building here will increase



Descendant of **Founder Here**
