

The scooters come in two sizes-10 and 12 feet-and even the smaller one will plane with four men aboard, although such a load is not recommended and is far too many for safety or fishing.

With one occupant and a 12 to 18 horse power outboard, the scooter will make 20 to 22 miles an hour, and in reasonably smooth water the sensation is more akin to bi-

Superintendent J. D. Gray reported to the board that in addition to the remodeling of the old high school building, other work now in progress or that would get underway almost immediately included repainting of the fence around the football field, and repair and repainting of trim on the new high school and gymnasium. In addition, he said, library tables would be completely refinished; doors at Fulton Elementary would be renovated; the interior of the band hall would receive necessary repairs and repainting; and buses would be touched up where needed. Because of the fact that gymnasium dressing rooms were becoming very crowded, he recommended acquisition of more racks and baskets, as although only 27 seniors would leave this year, approximately 100 new students would be received from the elementary schools in the system. Total scholastics enumerated in January, 1959, amounted to 1,-324, Gray said, of which 33 were negroes. This is an increase of 57% in negro scholastics, he pointed out, compared to an overall increase of 9.7%. Present enrollment from the radar base amounts to 18 students he said, and gave a breakdown of the various student bodies as follows: Fulton Elementary, 4 Negroes, 30 Latins, and 94 Anglos; Rockport Elementary, 11 Negroes, 179 Latins, and 321 Anglos; Junior High School, 5 Negroes, 42 Latins, and 122 Anglos; Senior High School, 3 Negroes; 19 Latins, and 178 Anglos. The combined enrollments total 1008 at this time, the superintendent said. He also reported that one position on the teaching staff, that of English-Spanish teacher in the high school, was still vacant, as so far no one had been found to replace Mrs. Martha Ballou, who resigned this year.
