## Area Crash Kills Two Youngsters

Two small children were killed and their mother and brother were seriously injured Friday when their car went out of control and overturned on U. S. Highway 87 about a mile and one-half north of Abernathy.

Darcy Ann Hollister, 6, was pronounced dead at the scene about noon. Her brother, 5-year-old Robert, was dead on arrival at Methodist Hospital in Lubbock.

The children's mother, Mrs. Lynn Carter Hollister, 25, was listed in fair condition late Friday at Methodist Hospital while another member of the family, 2-year-old Gavin, was termed critical in the hospital's intensive care unit suffering from multiple injuries. Hospital officials said Mrs. Hollister suffered a broken arm and head lacerations.

The family was believed to be en route to their Amarillo home when the crash occurred.

Highway Patrolmen David Boswell and George Webb of Plainview said Mrs. Hollister's car apparently ran off the divided roadway and swerved back onto the pavement before overturning three times. The car came to rest on its top, they said.

Mrs. Hollister, a clerk for Mason & Hanger-Silas Mason Co. in Amarillo, was transferred to the Lubbock hospital after undergoing emergency treatment at Hi-Plains Hospital in Hale Center.

Services for Darcy Ann Hollister, 6, and her brother, Robert, 5, were held Monday in Amarillo. Burial was in Llano Cemetery at Amarillo.

The two children died Friday of injuries suffered in a traffic accident on U. S. 87 north of Abernathy.

Their mother, Mrs. Lynn Carter Hollister, 25, and their 2-year-old brother, Gavin, also were injured in the accident. Mrs. Hollister is listed in fair condition and Gavin is listed in serious condition at a late hour Saturday in Lubbock's Methodist Hospital.

The family was en route to their Amarillo home when the crash occurred.

Other survivors include the father, Thomas D. Hollister of Oklahoma City; and the grandparents, Mr. and Mrs. O. A. Carter of Amarillo and Mrs. Lillian Hale of Plainview.

### County Accepts Low Bids On Two Vehicles

In a short meeting Friday, Hale County Commissioners accepted low bids on two cars for use by the county.

The group accepted a bid of \$2,270.44 from Hale County Motor Co. on the autos. Only one other bid was submitted.

Following the bid opening, County Judge C. L. Abernethy told the group that a vacancy existed on the Hale County Hospital Authority board and would need to be filled.

The vacancy was created by the resignation of Dr. Jeff Davis from the board last week. Commissioners decided to postpone selection of a new board member until a later date.

Other discussion at the meeting centered around the county retirement system, which goes into effect on Jan. 1.

Abernethy also told the group that until terms of a grant given to the Plainview - Hale County Health Unit for migrant care, local sponsors of the unit needed to employ another nurse for the unit, in order to meet matching fund requirements.

Local cost of the health unit comes from both the City of Plainview and Hale County, while the state provides other funds and the federal government contributes to the migrant program operated by the unit.

### SEMINARS ARE IN JANUARY

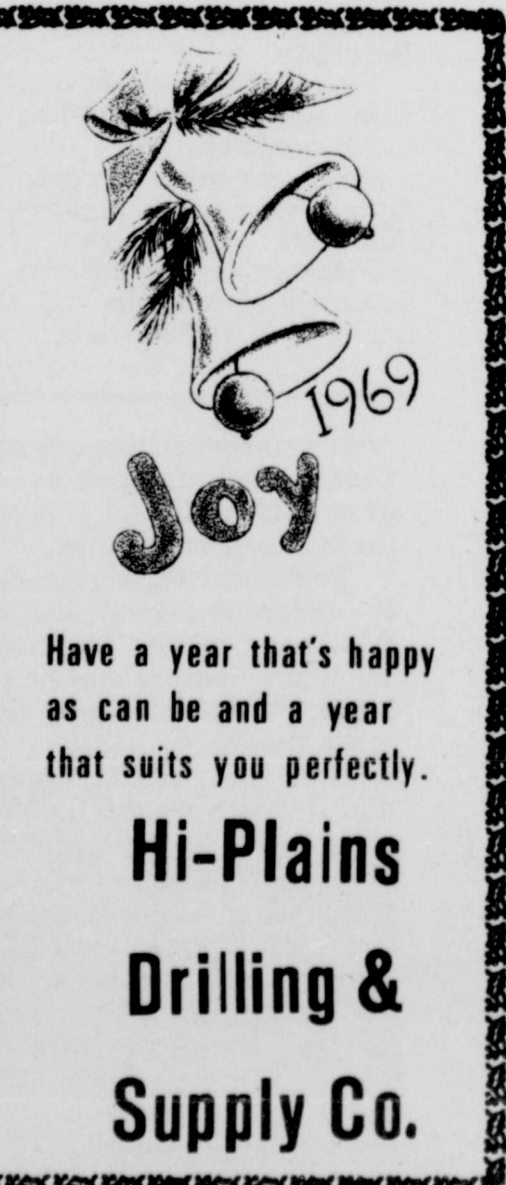

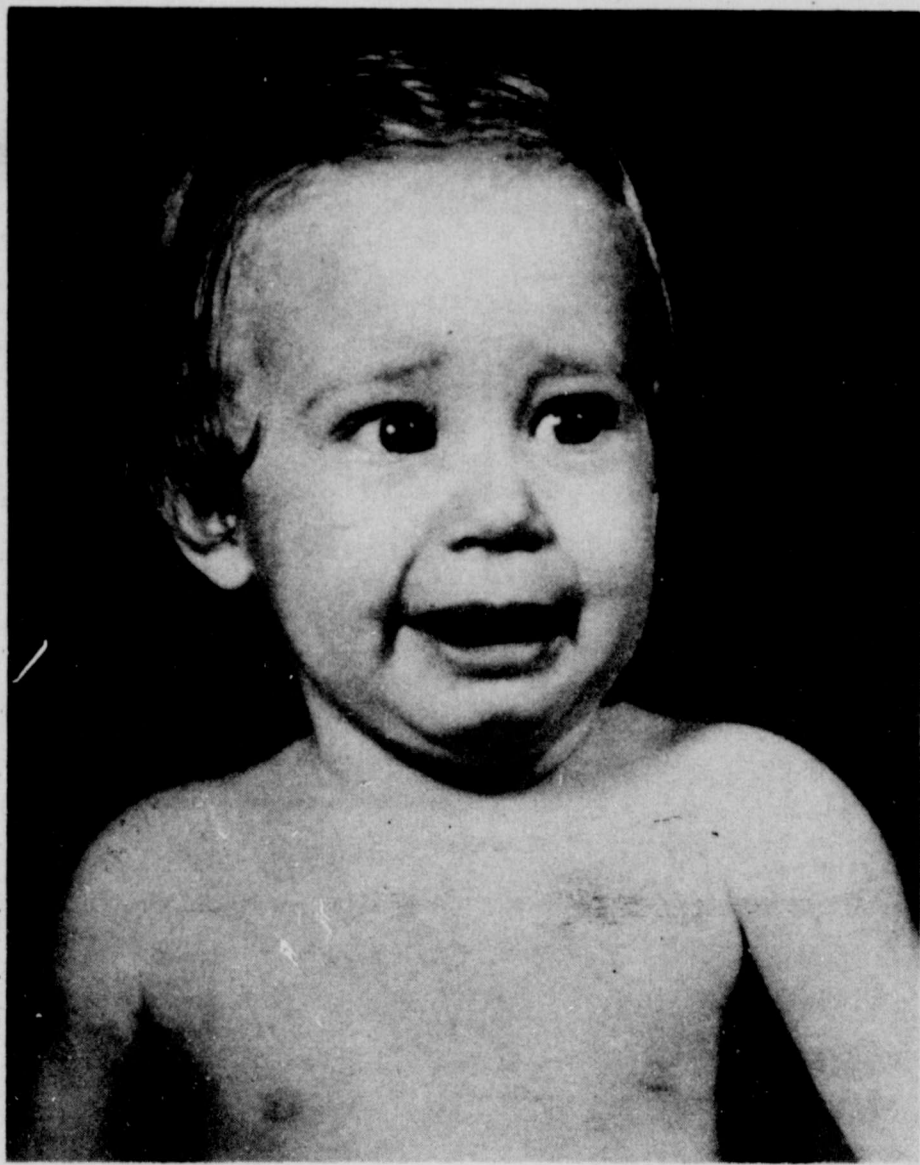

## Business Deduction Pamphlet Available

If you plan a list of business deduction for travel and entertainment expenses be sure to have the records to substantiate these expenses, Ellis Campbell Jr., District Director of Internal Revenue for Northern Texas, said today. Estimates of these expenses are not legally acceptable for tax purposes.

Campbell said in many instances, a taxpayer should keep a diary or timely record as well as receipts and invoices to back up a travel or entertainment expense.

To substantiate entertainment expenses you must establish the amount of each separate expenditure except for miscellaneous items like cabs, phone calls, tips and meals while traveling away from home, which can be added together for each day. In addition, the date of the expenditure must be confirmed, the name of the person entertained indicated and the type and location of the entertainment described.

Campbell said the taxpayer's records should also show the reason for the entertainment or the business benefit expected, the nature of the business discussion and the names, titles and business relationship of the persons enter-

tained.

The detailed rules on how to deduct travel and entertainment expenses are given in IRS Publication 463. For a free copy, send a post card to Supply, Internal Revenue Service, P. O. Box 1738, Dallas, Texas 75221

During 1967 Internal Revenue audited the tax returns of 3.1 million taxpayers. 52.4% or 1.6 million were found to owe an additional \$3,313,800,000. However, 40.2%, or 1.3 million, had no change in their returns. (These people had obviously kept good records and followed the tax instructions.) About 200,000 or 7.6% of those audited had the happy experience of receiving refunds amounting to \$190,600,000. (Of course these taxpayers had overpaid their tax to start with and would never have known of the \$190 million if they had not had the good fortune to get a tax audit.) Correcting tax returns is a necessary part of the Internal Revenue Service's business to assure that each of us pays his fair share. However, if 7.6% of us pay more than we owe, the Internal Revenue Service may not find time to audit our returns and send the money back. It just might be a good idea to read the instructions a little more carefully this year.

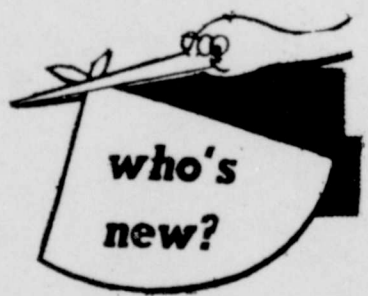
