Doug Wheat, School Board president, explained that the selection process has been carefully made to meet the requirements of the Winters School system.

Two more places are open for the City council, the District 1 seat, currently held by Jim Lincycomb and District 3 seat, currently held by Rene Woffenden. ## **Beware of SCAMS**

Recently, I was contacted about an ongoing scam. The victim had responded to an advertisement in a magazine directing him to put his contact numbers at various locations around the city and "if his number were picked" he would win a prize. The scammers then told

Nathan Johnson him he won a large cash prize and all he needed to do to have

the cash deposited into his account was to pay a small transportation fee.

Unfortunately, law enforcement and adult protective services see a lot of these types of incidents. The old Latin saying, "Caveat emptor" for "Let the buyer beware" seems more appropriate than ever.

The word "scam" means "a fraudulent or deceptive act or operation." There are many "tried and true" methods that unscrupulous people use to take advantage of others, and the internet has created a whole new realm of opportunities to scam uninformed victims. No one wants to be scammed or to have someone they love taken advantage of. Here are some tips to help avoid being a victim of those unethical and criminal people who want to take advantage

1. Internet issues: Pay attention to e-mail addresses. Major companies generally have their own website and associated e-mails for their staff contacts. If the e-mail is xyzbigcompanyname@yahoo.com or xyzbigcompanyname@gmail.com, for example, it's likely a scam.

2. Don't open email from unknown sources. Scam artists try a shotgun approach by sending out a barrage of emails hoping for one or two takers. If you are selling a product online, be wary of offers that exceed

the actual value of your product. Also, the buyer should be able to pay in the method that you request such as PayPal or a valid major credit card. Use a reputable auction or

3. If you are buying something online, search for products from reputable sites. Use a credit card that you specifically use for online transactions only. This will make it easier to cancel the card if there's a problem and to track any unauthorized transactions. Check with your card concerning what protection you have with regards to online purchases. As the buyer, be careful what you purchase online.

4. Do a little research before you do business with any company. Ask for references, check out the company with the Better Business Bureau, and Google search the company or

5. When contacting companies to verify a check, do not trust the phone numbers or addresses listed in the job offer or document. Independently verify a phone listing for the company and contact that number for verification.

6. Be very careful in responding to phone solicitations from business or charitable organizations. There are many local charities in need of your help, and you can always check up on how they are spending the money. Local businesses have a reputation to uphold and their advertisements can be verified.

7. Never give out personal information over the phone or internet to someone who initiated the contact even if they say it is for security of an already existing account or document. Get their information, obtain a callback number from an independent source, then verify the issue with the appropriate provider.

8. Consider paying with a credit card rather than a debit card or wire transfer. Most credit card companies will help recover your money if you

9. Document everything you can, whether it is a phone recording, email, text, or letter. You will need paperwork to prove your case if you end up making a fraud report about the incident.

10. Report suspicious incidents to the police and other fraud watch organizations such as Fraud.org. They may not always be able to get your money back, but they are able to track trends and warn other consumers.

11. Be suspicious of a check, money order or bank transfer you did not earn, especially if it comes with a request to return (or forward) part of the funds to someone else. Scammers often create sophisticated counterfeit checks resembling those from financial institutions and large companies. Just because you can deposit the check and withdraw money doesn't mean the check or money order is good. It can take weeks, even months, for counterfeits to be discovered; however, you can still be held responsible and it can cause major problems for you finan-

12. Be careful to maintain (and shred) copies of credit and debit card receipts or checks. These documents have identifying and account information that should be kept in the right hands.

13. Finally, use your gut instinct. If it sounds too good to be true, then it probably is. There is no "free lunch". Everything costs "someone" "somewhere" "something"! Don't be scammed.

## Flood safety awareness week

March 14-18, 2011

SAN ANGELO - NOAA's National Weather Service (NWS) has designated March 14-18, 2011, as the annual Flood Safety Awareness Week. It floods someplace in the United States or its territories nearly every day of the year. In the past 30 years, floods have killed an average of 95 people a year and have caused an average of \$7.5 billion dollars in damages annually. The goals of Flood Safety Awareness Week are to heighten public awareness of the risks associated with floods and flash floods, inform the public about NWS forecast and warning services and flood safety information, and empower citizens to take actions necessary to protect their lives and property.

Floods can occur any time of the year and at any time of the day. Currently, many areas across Texas are dry and are experiencing drought conditions. However, even in times of drought, rapid rises in normally dry draws, creeks and rivers is possible due to excessive rainfall over short periods of time. Spring and early summer seasons are favorable times for thunderstorm development that can produce significant amounts of rainfall and cause localized

**Advanced Hydrologic Prediction Service** 

The Advanced Hydrologic Prediction Service (AHPS) is the NWS frontline solution for providing improved river and flood forecasting and water information across America. AHPS provides a suite of graphical and

numeric products over the Internet to assist the public, community leaders and emergency managers in making better life and cost saving decisions about evacuations and movement of property before flooding occurs. The broad reach of AHPS extends the range of forecasts from short-term (up to 6 hours) to long-term (out to weeks and months). AHPS provides the public with more detailed and accurate answers to the following questions: How high will the river rise? When will the river reach its peak? Where will the flooding occur? How long will the flood last? How long will the drought continue? and How certain is the forecast? Your gateway to web resources provided through AHPS begins here: http://water.weather.gov

**Turn Around Don't Drown** Most flood-related deaths occur in motor vehicles when people attempt to drive through flooded roadways. Don't underestimate the power of flowing water across a road. NWS has developed the flood safety slogan: Turn Around Don't Drown and hopes you will remember these words when you're faced with a flooded roadway and have an important decision to make. Be especially cautious when driving at night when it is harder to recognize flood dangers.

Yellow warning signs which include the phrase "Turn Around, Don't Drown" are compliant with the Federal Highway Administration Regulations and can be deployed on roadways where flooding occurs.

Floods, Droughts, and Other Related Phenomena.

Many parts of the nation will experience floods or flash floods this year. In other areas, drought will prevail. Hydrologic extremes have always plagued our vast nation. Tropical cyclone inland flooding, snowmelt flooding, ice jams and debris flows are just some of the flood-related phenomena which pose a threat to Americans.

Flood Insurance

Flood losses typically are not covered in homeowner insurance policies; however, flood insurance is available in communities taking part in the Federal Emergency Management Agency's (FEMA) National Flood Insurance Program. FEMA's FloodSmart campaign promotes the idea that all Americans should know their flood risk and choose the appropriate flood insurance. **Flood Safety** 

NWS, along with government and private sector partners, educates communities across the United States about flood risks and how to respond to flood threat. Knowing what to do before, during and after a flood can save lives and reduce injuries and property damage.

Flash Flood/Flood Safety

- Avoid areas subject to sudden

- Do not attempt to drive through a flooded road. The depth of water is not always obvious. The road bed may be washed out under the water, and vou could be stranded or trapped.

Do not drive around a barricade. Barricades are there for your protection. TURN AROUND

DON'T DROWN!

- Be especially cautious at night when it is harder to recognize flood dangers.


Underpasses can fill rapidly with water, while adjacent roadways remain clear. Driving into a flooded underpass can quickly put you in 5-6 feet of water.

If the vehicle stalls, leave it immediately and move to higher ground. Rapidly rising water may engulf the vehicle and its occupants sweeping them away. - Do not camp or park your

vehicle along streams and washes, particularly during threatening conditions.

Children should NEVER play around high water, storm drains, viaducts, or arroyos. It is very easy to be swept away by fast-

Never try to walk, swim, drive, or play in flood water. You may not be able to see how fast the flood water is moving or see holes or submerged debris.

copy of Getting Past No by William Ury. The book is a quick read and a helpful resource for negotiating through confrontation to cooperation. These five tips have helped me

through conversations at work, at home, and even at the grocery store. Don't React: Can you think of times when you

just reacted to what someone said versus listening to them? According to Ury, there are three natural reactions to conflict; striking back, giving in or breaking off. Think of a business situation where a customer or a vendor pushed you to the point of reacting. By reacting, you lose your ability to be objective and make it hard to be constructive. The best way to work through that natural tendency is to recognize your reaction. Understand what causes you to react and try not to let others push your "hot buttons."

Don't Argue: This tip may not be easy for some. In a stressful situation, it

**Business Tips** is easy to argue or

become defensive. You fall into the trap of wanting to make the other person understand your side of the issues. However, it is actually easier to work through a conflict if you make the effort to see the other person's side of things. By actively listening to the other person's issues and asking questions, you can actually defuse a conflict. It may help when you are working with an employee and performance issues. By better understanding someone, the better you can work with them.

Don't Reject: In negotiations, it is easy to dismiss the other person's position. As a good negotiator, it is important to shift from the person's asserted positions to their actual interests in the negotiation. Rather than trying to change a person's position on a topic, you can work on negotiating an outcome that serves both of your interests. For example, you may not

change a vender's payment policy, but you may be able to negotiate with them on their interests such as how quickly do they need to be paid, how much you need to pay them and when.

Don't Push: There may be many reasons why a negotiating process breaks down. Two very common reasons are the fear of losing face and trying to push too much too fast. Keep in mind that in negotiations there can be fear of giving too much away or agreeing to something that isn't reasonable. Take the responsibility as a negotiator to recognize why the other person or business isn't willing to work with you. You may be pushing the other person into a decision they are not ready to

Don't Escalate: Ury uses the term, "Don't escalate, educate." If you are in a negotiation process and the other party is resistant to negotiate, you may be tempted to exert more power to get your way. At this point, you have two choices: to either force the person into a decision or attempt to educate the person so you both can

win. Using threatening words during a negotiation will cause the other party to become defensive. Try using respectful words to show the person that not coming to an agreement will cause more harm and not allow them to advance their interests. This approach can keep the conversation going versus shutting down. These simple tips can be useful for various business or personal situations. If you have an upset customer or employee, try this approach. You may be surprised at the results. In an economy where it is costly to find new customers and employees, you may find by using these negotiating techniques, you will keep a relationship that is valuable for everyone.


