Forgotten gun puts Darby in jail

BALLINGER- Texas Representative Drew Darby is trying to leave behind an incident occurring in Austin, Texas, after being was arrested and booked into Travis County Jail for carrying a handgun in the secured area of the Austin-Bergstrom International Airport.

According to a statement by Darby he forgot to remove his gun from a carry-on bag before going through security for a morning flight on Thursday, November 14, 2013 when he was on his way to a water conference in California.

Federal and state laws prohibit a concealed handgun license carrier from taking a firearm into the secured area of an airport.

"First, I want to compliment security personnel and law enforcement. All procedures by airport security were followed with professionalism and courtesy, as were procedures by Travis County officials," said Darby in the statement.

"Our airport security laws are good laws with the important purpose of protecting the public. I regret my carelessness in preparing for the flight. I accept full responsibility for my failure to fully examine my luggage when

packing," he added.
Darby said that he didn't seek or receive special treatment. "I will cooperate with everyone involved in this process to have it resolved in full compliance with all laws and regulations."

Darby is a licensed gun owner, and was carrying a small handgun that was found by Transportation Security Administration personnel in his carry-on luggage.

According to Gus Clemens, a spokesman for Darby, law enforcement officers had to follow procedures arresting Darby and booking him into Travis County Jail.

"Airport security found the gun, it is a federal offense and they seize the weapon, however in Texas, if you carry a gun (in an airport) it becomes a state criminal matter, and the law requires that the person is arrested and put in jail."

According to Clemens guns on passengers are frequently found in airports in the United States. Almost 900 cases have been reported in this year only. Thirty of those cases have been reported at Austin-Bergstrom International Airport.

Darby represents District 72 in the Texas Legislature which includes the counties of Runnels, Coke, Concho, Glasscock, Howard, Irion, Reagan, Sterling and Tom Green.

Ironically, this year Darby co-authored H.B. No. 553 advocating for gun rights and relating to firearms and the preservation of the Second Amendment to the United States Constitution.



Her first complaint was that individual/family membership was not given recognition on the form other than what it cost to join.

The first sentence on the membership form is "Your Winters Area Chamber of Commerce serves as the 'welcome mat' for your community, providing a wide assortment of important information to new businesses as well as households." The end of the first paragraph states " to make Winters a better place to live." Both sentences points to family and individuals. There has been discussion lately to have two separate forms; one generalized that we have used up to this point and one focused more on family/individual membership. When the new group took over at the beginning of the year the only thing we changed on the original form was pricing plans. I don't know how long this particular form has been circulated. Her second complaint in her own words is "...When

have we ever had to APPLY for membership?"
All people are welcomed and encouraged to join. The form (or application) is nothing more than an object that people fill out to join. As far as I know, all members have had to complete this form in the past. It's not new to this particular group.

Her third complaint is that the Chamber does not value its members.

We value each member whether they are individuals, non-profit, locally owned, or large corporations. We have made it a point to buy gift certificates from local businesses to hand out as prizes at Chamber Events (which benefits the businesses and the individuals). I have built a website http://www.winterschamber.us to help promote local events and to give recognition to people who have done good things for this community. COLLEGE STATION- The Texas A&M University System and Texas A&M AgriLife are on a mission to address the state's dwindling wild quail populations, and a recent \$2 million state-funded initiative reflects the importance of quail to the state of Texas.

The biennial exceptional item slated for fiscal years 2014-2015 was funded by

the state legislature and became effective Sept. 1. The initiative will support integrated approaches by the Texas A&M AgriLife Extension Service, collaborating with Texas A&M AgriLife Research, to marshal the resources of the A&M System to address quail decline.

John Sharp, Chancellor for Texas A&M University said, "Based on our AgriLife Extension studies, every time a pickup

and dog-trailer pull into a West Texas community, they're worth about \$8,500 to the state's economy, with about 60 percent of those dollars going to local coffers."

According to a recent study by the U.S. Fish and Wildlife Service, quail are ranked third behind deer and dove as the state's most popular game species in an industry that exceeds \$1.5 billion annually. AgriLife Extension studies show about 65 percent of Texas hunters come from urban areas. So dwindling bird numbers not only threaten rural economies, but also reduce hunting opportunities for many urban residents.

"Reversing quail decline in Texas is built around both education and research focused on landscape improvements to increase quail populations and investigations."

Veteran's Corner

Although the government shutdown is temporarily over and the debt ceiling deadline has been extended until February 7, 2014, sequestration cuts for the Department of Defense (mandated by the Budget Control Act of 2011) will continue to be implemented for 10 years unless alternative savings are found or Congress repeals the law. The agreement to end the government shutdown does not provide any additional flexibility for Defense regarding the \$52 billion in cuts slated for the second round of sequestration that will occur January 15, 2014. These scheduled cuts are creating pressure to offset sequestration reductions, including those related to personnel - smaller active duty/

Reserve pay increases, increasing TRICARE fees for retirees under age 65, reducing stateside housing allowances (BAH) and reducing future Cost of Living Adjustment increases for retirees. Q: What exactly is acid rain?

A: Acid rain is rain that contains pollutants, says Brent McRoberts of Texas A&M University. "The term has been around a long time, having been coined by an English scientist in 1872," he reports. "Even then, scientists believed acid rain could lead to a natural destruction of many of Earth's resources, which many still believe today. Much of the acid rain today comes from products of burning coal or other fuels and from industrial sources. If there is a significant concentration of these products, chemical reactions with water molecules will lead to acid rain.

THE ORGANIZATION OF RUNNELS COUNTY

Railroad becomes the dream of every small town

WINTERS- By 1885, prosperity had returned, spirits were revived and immigration had resumed. Runnels County had a population of 4,000 and an assessed valuation of \$1,995,126. The population of the county seat was 400. The Commissioners' Court had voted to increase the county officials' wages and businessmen displayed smiles again. The Editor of The Runnels Record, January 10, 1885 resumed his long list of descriptions to entice more people to Runnels. Although the law was passed to stop hogs from running wild, the hogs and the population generally ignored it. A deficiency in Runnels despite "the superior culture" was the abun-dance of crude language being spoken. The paper noted this should not be allowed. Temperance societies of all sorts flourished. A few of the less refined wanted to know if there might be some special provision by which total abstinence could be suspended "til after the holidays." (Runnels Rumorings, 1885.) Intelligence and culture did not mean the same thing in Runnels City as they did in the East. (Taylor County News, 1885.) They believed "the young man who knows how to lay ff corn rows is worth cow-pen full of nice, cid-gloved, fancy coated ellows who may know ow to dance and caper a fashionable waltz". nowledge of how to

set a plow correctly was worth a "thousand-fold" more than knowing how to pose in a parlor or adjust the shade of a cravat to the complexion of the wearer." Such niceties had little place in the lives of Runnels people.

Runnels people. When J.W. Winters wrote his glowing description of Runnels City in 1883, 'railroad had already become the magic word. Aside from a few stage coach robberies, railroad had become the topic of discussion on all sides. The railroad had become the dream of every small town becoming established in the new county. (A survey had been made in 1853 through the area that would become Runnels County in 1880, but it failed to produce a railroad. Fort Concho and the Texas Frontier, Haley). At this time, 1885, in the history of the county, interest had reached a peak bordering on hysteria.

Content, the second largest town in the county was flourishing. Their bond election for the school passed, and there were people moving into that area. Although the Indian threat had nearly ceased and the Rangers had left Ranger Peak, Nancy Parker continued to work with those who became ill in the area all around. She continued to live in the log cabin the Rangers helped to build. She had mended their clothes and assisted when they became ill. She made the dress for Cynthia Parker when the Rangers brought her back after she was captured by the Indians. She would walk miles and miles over the rugged land to find the plants she needed and then prepare her teas in a large cast iron pot over an open fire. From her Mother, Nancy had learned to identify the medicinal plants and applied her knowledge with those growing all around in the area. She used the leaves of some and roots of others for the brews. The pokeweed leaves when boiled served as a green vegetable much like spinach and it was called poke salet." The liquid from the leaves soothed skin irritations and rashes. The tea made from the redroot weed aided in stopping diarrhea, as did inner bark from the live oak tree. The coarse outer bark was removed giving access to the tender inner bark used for making tea. The hoar hound weed, steeped, sugar added, boiled and strained made syrup to ease coughing, and when boiled long enough, it became candy. The potent tea made from the balmoney, a slender green plant, given in half cup doses usually caused the patient to remain in bed for a couple of days or so because of weak-

Nancy knew these weeds and used them effectively with her patients. One of Nancy's patients was an 8-year-old boy with a severe throat infection that the doctor had failed to cure. The parents called for her to come when the doctor said he could do no more. She came with her poultices and teas. She stayed with

the boy, treating him for long hours, until his high fever broke, and she knew healing had taken place. She went as far as Brownwood, Texas to help when she was called. The Runnels County Commissioner's Court met in a Special Term March 9, A. D. 1885, at the Courthouse in Runnels. The officers present were the Judge C.H. Willingham, Commissioners: Job Davies, H.C. Wylie, Marvin Bright, Deputy Sheriff, H. C. Jordan and W.L. Towner, County Clerk. The court's first order was to have a meeting with the County Surveyor of Coleman set for April 8, A. D. 1885. The purpose was to meet in the NE area of Runnels County and the NW corner of Coleman County to establish the East line of Runnels County. This was pursuant of a notice from the Commissioner's Court of Coleman, County Texas, February 14, A. D., 1885. The request was to place a prominent stone on each mile and mark it R.C. The court requested a

and a plat of the line. Twenty-nine citizens of Runnels School District No. 1, petitioned for holding an election for the purpose of taxing themselves for building a school house and supplementing the State School Fund apportioned to that district. The court's response was to approve and set the election to be held on the second Saturday in April, the 11th day at the Courthouse in the Town of Runnels between the hours of 10 a.m. and 4

p.m. The tax would be for "20 cents on one-hundred dollars' worth of property." The order went out to post a notice for three weeks prior to the election.

The court also examined the petition from the Jail Contractors to receive the Jail in Runnels. The Commissioners' Court refused to receive the jail in the condition it was in at that time for the reasons listed: 1. The nails holding a plate in the ceiling of the cell room were not clenched as specified in the Contract. 2. The cap requires one more coat of paint. 3. The trap in town is not completed. 4. The tin on the wall was not soldered. 5. Two panels of glass were required in town. 6. Fixing pump in cistern and obtaining required length of pipe. 7. Roofing portico with tin. 8. A cap of rock on cistern was needed. 9. Wood work requires another coat of paint. 10. Sweeping and cleaning out the inside of jail. 11. Gathering up and carrying away all loose rock and debris on inside of jail. 12. Grating to windows wanted on second story in town. The court then released funds totaling \$715 for the purpose of meeting the interest accruing on the jail bonds. They paid each officer

Farm Bill update to be held Dec. 5 in Abilene

ABILENE- The Texas A&M AgriLife Extension Service will hold a Farm Bill Update from 9 a.m.-noon Dec. 5 at the AgriLife Extension office in Taylor County, 1982 Lytle Way.

The update, which is free and open to the public, is being held in conjunction with the regular monthly meeting of the Taylor County Marketing Club, said Robert Pritz, AgriLife Extension agent in Taylor County.

"Dr. Joe Outlaw, co-director for the Agriculture and Food Policy Center and an AgriLife Extension economist at College Station, will discuss what is taking shape as a result of the House-Senate conference committee meetings," Pritz said.

"While they haven't reached a full agreement yet, there is more agreement than disagreement at this point," Outlaw said.

Other speakers are Dr. Mark Welch, AgriLife Extension state grain marketing specialist at College Station and William Thompson, AgriLife Extension economist at San Angelo. Welch will be discussing the differences in crop insurance coverage between yield protection and revenue protections policies, and how both policy types use the futures market to determine coverage levels.




