'I am proud of these kids, we had a great year, now it's time to look back at the season and evaluate how we played. We played with a good group, I am re-ally proud of these kids," said Winters Head Football Coach Stan Caffey.

Jimmy John Ripley passed for 7 of 21 for 124 yards and had three interceptions. Luke Kraatz led the team with two receptions for 39 yards, followed by Daryl Hagle 2 for 35, and Chris Diaz 1 for 35. 

## **Trans-Pecos Big Buck tourney set for Nov 28-Dec15**

VAN HORN - The Texas A&M AgriLife Extension Service office in Culberson County and the town of Van Horn will again conduct their popular Trans-Pecos Big Buck Tournament from Nov. 28-Dec.15, said an AgriLife Extension contest official.

Lainie Koch, AgriLife Extension agent in Culberson County, said the Van Horn Convention Center will serve as tournament headquarters and will be open from 9 a.m.-5 p.m. during the week of the contest except Dec. 15, the final day of the activities when the hours will be shortened to 9 a.m.-noon.The convention center is located at 1801 W. Broadway in Van Horn.

'We have nine categories that include other species besides mule deer," Koch said. "They will include two mule deer buck categories for animals taken north and south of U.S. Interstate-10, both Boone and Crockett contests; a youth category, for hunters 16 years old and under; and categories for the greatest antler spread, most points

and heaviest dressed weight. There will also be an Aou-dad sheep category and categories for heaviest dressed weight javelina and heaviest dressed weight feral hog."

**Registration is \$45 for adults and \$25 for youth, plus an additional \$15 for the feral hog and javelina** competitions. Koch said a group rate -pay for four mule deer entries and get the fifth one free is again being offered this year.

"Contestants must remember to be sure they enter before hunting, because the actual time of harvest must be after the recorded official entry time and date," Koch said.

"All trophy animals entered must be taken in accordance with the rules and regulations of the Texas Parks and Wildlife Department," Koch said. "Mule deer must be taken only from West Texas, west of the Pecos River.

**COLEMAN-** Anticipating an active prescribed fire season, the Texas A&M AgriLife Extension Service in Coleman County will conduct the Coleman County Prescribed Burn Workshop on Dec. 18 at the Bill Franklin Center/ Goree Expo Center in Coleman.

Michael Palmer, AgriLife Extension agent in Coleman County, said registration will start at 8:30 a.m. with the program running from 9 a.m.-1:30 p.m.

"We've had some timely rains throughout the region and have grown some grass that will make prime fuel in many spots for what could prove to be a very successful winter prescribed burning season," Palmer said. "With proper planning and execution, prescribed fire is undoubtedly the most cost effective-brush control management tool available.

"Our goal with this workshop is to update our producers on proper burning procedures while allowing them to become acquainted with some of the agency resources available to them should they decide to use this range-management tool.'




