


Homemaking **Teachers At** Conference

Red River Ambulance In Fifth Year

The Board of Directors and staff of Red River Ambulance Service, Inc. are concerned that the residents of the Bogata area feel that the ambulance service has forgotten them by no longer having an ambulance in Bogata. Red River Ambulance Service, Inc. began its fifth year of operation on December 1, 1983 as the ambulance service in Red River County, and we cannot emphasize enough that we are providing service to all the residents of Red River County, and the Bogata area is certainly as much a part of this county as any other area.

One very important factor to remember is that Red River Ambulance Service, Inc. was established as a non-profit corporation and is governed by a 15 member Board of Directors which includes representatives from all over the county. The directors are O'Brian, president, Clarksville: Travis Hale, vicepresident, Bogata; Bill Bryson, secretary, Clarksville; Morris Foster, Bogata; J.C. The day to day operations are directed by Manager Allan Helberg who has been charged by the Board of Directors to see that the ambulances are equipped and staffed 24 hours per day, seven days a week, so that if any county resident is in need of an ambulance, one will respond to their aid. In the last few months the most modern equipment has been placed on all three ambulances so that better patient care can be

provided. The staff of Red River Ambulance Service, Inc. is continually upgrading their training and certification. The Texas Department of Health certifies all ambulances and recognizes four certification levels of training and skills, the Emergency Care Attendant (ECA) and three levels of Emergency Medical Technician (EMT); EMT-Basic, EMT-SS (Specially Skilled) and EMT-P (Paramedic). ECA means an individual who has completed a minimum of 40 hours of classroom training approved by the Texas

promotes comfort and avoids aggravation of an injury or illness. EMT-Basic means an individual who has received a minimum of 100 classroom hours, 20 hours of observation and on the job training in hospitals, three emergency ambulance runs and who is certified by department as minimally proficient to perform emergency pre-hospital care that is necessary for basic life support and that includes the control of hemorrhaging and cardiopulmonary resuscitation (CPR). EMT-SS means an individual who has successfully completed the EMT-Basic requirements and an additional minimum of 60 classroom hours, 50 hours of observation and on the job training in hospitals, 50 hours of advanced life support ambulances and who is certified by the department as minimally proficient in performing skills required to provide emergency pre-hospital care by initiating, under medical supervision or standing orders, intravenous therapy and endotracheal or esophogeal intubation or both. EMT-P means an individual who has successfully completed the EMT-Basic requirements and an additional minimum of 160 classroom hours, 140 hours of observation and on the job training in hospitals, 100 hours on a mobile intensive care ambulance and who is certified by the department as minimally proficient to provide emergency prehospital care by providing advanced life support that includes initiation, under medical supervision or standing orders, of intraveneous therapy, endoctracheal esophogeal intubation or both, electrical cardiac defibrillation or

cardioversion and drug therapy. All attendants that respond on the Red River Ambulance Service units are at the EMT level. Currently the full time staff includes four certified as EMT's at Basic Level and one certified as EMT Specially Skilled. Within two months as a result of additional training and certification, the full time staff will consist of two EMT Paramedics, one EMT Paramedic, LVN, one EMT Specially Skilled and one EMT-Basic. In addition to the full time staff, Red River Ambulance Service, Inc. maintains an excellent reserve staff to respond when needed and relieve the full time staff periodically. The reserve staff includes one EMT-Paramedic, RN, one EMT-Specially Skilled, and three EMT, RN's, one EMT, LVN and four EMT's at the

Basic level. An amendment to the Emergency hospital and emergency medical responsibilities, especially since the Department of Health and who is

certified by the department to services was passed by the 63rd provide emergency pre-hospital care legislature in 1983 and amends the providing initial aid that Vernon's Texas Civil Statutes to affect certification requirements as follows:

1) from January 1, 1984 through December 31, 1984, every basic life support ambulance must be staffed with at least two attendants, one of whom shall be trained at the ECA level and

2) on or after January 1, 1985, with

at least two ECA attendants. Red River Ambulance Service, Inc. already far exceeds the minimum requirements for January 1, 1985 and will continue to increase the levels of training and certification of all personnel associated

with the service. Red River Ambulance Service, Inc. is dispatched by the Clarksville Police Department. The dispatchers are trained to receive the calls and have an ambulance responding to the aid of county residents within minutes. The number to call in an emergency is 1-214-427-2911. For those residents on the Clarksville 427 exchange, the number is 911. We continue to maintain an emergency number in the Bogata area. That number is 632-5115. Mary Lassiter receives the call and then requests the ambulance by calling the Clarksville Police Department at 1-214-427-2911.

All of the ambulances of Red River Ambulance Service, Inc. are located in Clarksville with the office in the City Hall at 800 West Main. It is a fact that our response time will not be within five minutes to all areas of the county. However, we will respond in the quickest time possible, and when we arrive the patient will be cared for by the most well trained staff available, in our county, in emergency patient care. We want all the residents of Red River County to know that Red River Ambulance Service, Inc. cares about you and when you need us, please
