A few weeks ago, as I was making my rounds a lady waved and stopped me at Detroit. She requested that I run again the story of my night in the hospital the week that we purchased these newspapers. Then, shortly after, I received my third request for the "hospital" column that I wrote after major surgery. Apparently, hospitals are on some folks' minds right now. But, I decided that I would run the columns over. Here is the first one, dated December 9, 1982.

For all of you who have been in the hospital, this one is for you. I haven't spent much time in hospitals, just the length of time it takes to have tonsils out, but a messed up knee brought me to the hospital for some repair surgery.

I had no more than checked in than some fresh-faced youngsters came to do an EKG. This means lying on the bed without a stitch on from the waist up while they fan the door, leaving it open most of the time. I commented on how humiliating this was and they replied "Oh, don't be embarrassed, we do this ALL the time".

Somehow, I think they missed my point. I don't care HOW often THEY do it, just so it isn't done to me.

Then the lab technician came to take blood. Brandishing a needle that looked about a foot long she sweetly said "now will be a little STICK". That seems an absolutely stupid thing to say. After all, when someone is going to take a blood sample with a needle I think I can figure out that it will stick!

Finally after assorted other necessary but not necessarily pleasant things were finished, I settled in to catch up on some much needed sleep. I had missed a lot getting out our very first edition of the papers.

But, there were so many different noises going on that it was nearly midnight before I grew sleepy. It had just turned out the light when an energetic lady bounced in. She let me have one last drink of water and then told me no more liquids or food from that time on. Of course, my tongue immediately stuck to the roof of my mouth! I read a little longer and was going to try sleep again when a horrendous growling filled the hall. The cleaning staff was cleaning the carpet at 12:30 in the morning!

After a long, long while the growling ceased and I tried to drift off. Had just about made when there was a loud snap and the entire forward section of the bed collapsed, rolling me into a little ball at the head of the bed! Maintenance was duly notified that my bed was broken.

About an hour later maintenance finally appeared, then disappeared to find a part. The nurses invited me to sit with them for a while, as long as I didn't interfere with their work. Sweeter, nicer people couldn't be found, but I wasn't getting any sleep.

About 4:30 or 5:00 the bed was finally fixed, but by then I was so wide awake that I looked like an owl. The nurses said they wouldn't come in at all and disturb me, just to get some sleep. But, at six, the lab flew in the door, not having checked with the nurse's station, yelling once more there "There'll be a little stick!" refrain.

By then I was becoming convinced there was some sort of conspiracy against me! I was so wide-eyed I was practically hanging from the ceiling.

Everyone remained kind and patient with me, though. And, I needn't have worried about all that missed sleep. Because when they took me downstairs to surgery they made quite sure that I slept...boy! did I sleep.

American Cancer Society Driver Is Underway In Bogata

The American Cancer Society is the nationwide community based voluntary health organization dedicated to controlling cancer through research, education, and service.

Over 45,000 cancer patients of all ages were reached this year with service and rehabilitation programs provided through local volunteers in every Texas community. These included transportation, home equipment, support groups, information and guidance for cancer patients and their families. Cancer prevention and the importance of early detection are the focus of education efforts in schools and businesses, community organizations, and health care facilities.

Thanks to the invaluable assistance of over 2 million volunteers, 200,000 of them in Texas, 86% of the money contributed by the public is used for research, services, and educational

programs. This means that only 12% goes into fund raising and 2% into administration.

Last year researchers at Texas medical institutions received 37 grants for cancer research totalling over 43 million. Since its national research grant program began in 1946, the American Cancer Society has invested more than 1.4 billion in cancer research and provided grant support to 25 nobel prize winners. We are the largest private source of cancer research funds in the United States.

Dates Set For Capital Murder Trials

May 9th is the date for the first of six capital murder trials stemming from two murder cases which happened last year in Clarksville.

According to County Attorney Jack Herrington a change of venue request will send the capital murder case to a Bowie County jury in Bowie County.

Herrington stated that because of the amount of media publicity the Bowie County Jury will decide the guilt or innocence of James Henderson of Idabel, Oklahoma.

Henderson is the first of five suspects (one of whom is a juvenile) to be tried for the death of prominent resident Martha Lennox, age 85, last October 28, 1993.

Henderson and the other suspects were found driving Miss Lennox's car in Dallas where they are also suspected of having robbed a man at gunpoint. Clarksville police found Miss Lennox shot to death in her home after Dallas police called and requested local authorities to check to see if she knew her car was missing.

Four of the five suspects received capital murder indictments, Ricky Dean Bell, 23, of Clarksville; Willie Earl Pondexter, Jr. age 19 of Idabel, Ok.; and James Lee Henderson, age 20, of Idabel, will be tried on Capital Murder Charges.

Deon Lashun Williams, age 16 of Clarksville, was certified by the juvenile court as an adult and will be tried on capital murder charges as well. However, Herrington says, although he will be tried as an adult as a juvenile he can only be given a life sentence if found guilty.

James Earl Bell, age 22, of Clarksville, brother of Ricky Bell was arrested and indicted on a charge of criminal conspiracy, a first degree felony which carries a five to 99 years or life penalty range.

"The attorney representing Henderson feels that it would be difficult to try the case in Red River County," Herrington said. "We've had a lot of local publicity and it might be hard to find an impartial jury."

Herrington said he is confident the change of venue request will not affect the outcome of the trial. "We've got some strong evidence in this case," he said.

In the second murder case, Reginald Lenard Reeves, 19, and Ralph Brown, 18 both of Clarksville, were indicted for capital murder in the strangulation death of Jenny Lynn Weeks. The body of the fourteen-year-old runaway was found in a burned house on Broadway Street in Clarksville on September 9.

Trial date for Reginald Reeves has been set for early August.

Rivercrest High School and Stewart Regional Blood Center will have a blood drive Tuesday, April 19 from noon to 3 p.m.

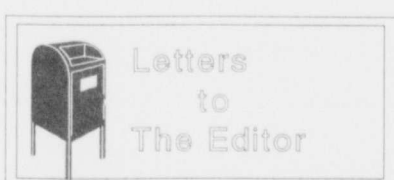
The blood drive will be held at the school on Highway 271 in Bogata.

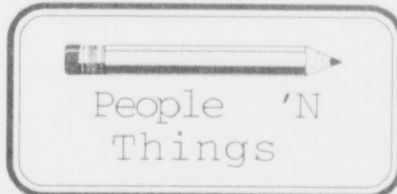


Dear Editor,

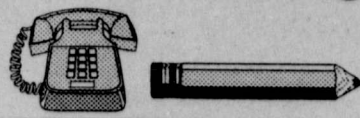

Country Cooking

Do you remember why you liked to go to certain people's houses when you were younger? I can think of reasons I did or did not enjoy relatives homes, and many of my memories involve what we had to eat when we visited. I remember the first time I ever ate an Enchilada. I thought that was the most wonderful dish I had ever tasted. We went to my Aunt Tad's house and she had learned to make them. Tortillas were not available as they are now, so she got them out of a can. They were in oil. It was years before I tasted that dish again because I didn't know what it was called. When people first started making German Chocolate Cakes, the 3 layer ones with 2 icings, made from scratch, I went home from a family gathering with my cousin Brenda. Her mother, also my cousin, Betty, had made one of those "new" cakes and I could not imagine anything better. I was never able to make one as fine as Betty's. Aunt Lucy would take clean cans and fill them with water, and put them in the freezer of the refrigerator in the summer time so that any time anyone wanted cold water they didn't have to fool with a pitcher or ice cubes. I guess that is the reason. I never asked, but that was wonderful tasting cold water. I guess some probably got left in the freezer too long and froze, but I don't remember that part. Also at Aunt Lucy's house you got to eat on a bench. Aunt Johnnie always made a cake with an icing which looked like light chocolate. The cake tasted like a light chocolate cake with spice in it. She would go out with a hooked wire and catch chickens and wring their necks when company came. I loved her fried chicken. It wasn't as good as Mama's

but that stands to reason. Nothing is as ever as good as Mama's. Aunt Nellie made caramel pies which were wonderful. Mam Maw made a stew which I still love to make today. She also kept freshly frozen peaches in the freezer and would take them out and serve them with dessert at meal time. Sometimes they were still partially frozen. It didn't matter. Aunt Lore made a coconut cake which was good, but she made a chocolate cake which she brought to dinners and she would fix a little design out of pecan halves so it would look pretty. I thought that was so neat. Aunt Jessie Lee always had really fresh things out of the garden and you could play in the school bus, because Uncle Kent drove the bus. Uncle Boze's Ruby made cheese sticks out of bulk cheese because it didn't come in slices. She would always put it on the same plate with peeled and sliced tomatoes. She usually had a bowl of peas too, and boxes of comic books to read. Aunt "Bean" had fried pies and you could do anything you wanted to. Aunt Lorette's house was always full of kids and someone would always sit down to the piano and start playing, therefore someone would sing. I also remember going to Aunt Altha's house just because she would talk to me, the same was true with my Aunt Winnie Faye.

Aunts and uncles aren't the only people I enjoyed visiting, but they were the people we seemed to visit most when we were kids. Naturally I remember the food.

Super Burritos

2 lb. hamburger
2 cans pinto mashed or 2 cans refried taco seasoning
salt
grated cheese
sour cream (optional)
shredded lettuce
chopped tomatoes
flour tortillas

Brown Hamburger meat and drain. I run it under hot water to get the grease off. Put back in skillet and stir in taco seasoning (or chili powder) and salt. Either take 2 cans of pinto beans and mash with a fork or 2 cans of refried beans and heat in a pan. You can wrap tortillas in paper towels and warm in microwave or heat in a skillet. Just heat long enough to soften. For each burrito lay tortilla flat. Spread with beans, spread on about a tablespoon of sour cream, spoon on about 2 heaping table-spoons of meat (more if desired), sprinkle on cheese, lettuce and tomatoes and roll tightly. If it doesn't roll tightly enough to hold and eat, you should probably not put as much filler in the next one.

Banana Pudding

1 1/2 cups sugar
1/2 cup flour
3 cups skim milk
4 bananas
vanilla wafers
1/2 tsp salt

1 tsp vanilla
2 eggs separated
1 tbsp. low fat margarine
Mix sugar, flour, and salt. Gradually stir in milk to mix well. Beat one egg yolk, and add to mixture. Throw the other yolk away. Cook on low burner until it thickens. Stir in margarine and vanilla. While the pudding is cooking, beat egg whites until stiff. Stir in 1/4 cup sugar and 1 tsp vanilla. Beat a little while longer. In a casserole dish or some oven safe container, layer pudding, vanilla wafers, bananas, until you run out. End on top with vanilla wafers. Spread beaten egg whites on top and seal edges just as you would a pie. Bake in a 325 oven for 20 minutes.

Breakfast Burritos

Frozen Hash Brown Potatoes
Sausage
Eggs or egg beaters
onion chopped
grated cheese
Flour tortillas

Cook frozen hash browns according to directions. (You can make your own hash browns if you like.) Crumble sausage in skillet add chopped onion and cook until both are done. Scramble eggs. Warm tortillas only until soft. Mix hash browns, sausage, eggs, onion and cheese. Spoon into tortillas and roll tightly. I proportion this so that I use more potatoes and less sausage. It is just as good if you use fat free cheese, egg beaters and no grease in your potatoes. Serve with picante sauce and fresh fruit.

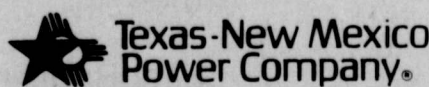

Statement of Intent to Change Rates

In accordance with the regulations of the Public Utility Commission of Texas, Texas-New Mexico Power Company announces the Company's intent to change rates for its entire Texas operations. The effective date of such change is May 5, 1994. All classes of customers will be affected by said proposed changes. The proposed rates will produce an increase in gross revenues to the Company over test year revenues adjusted for test year customer growth and weather and annualization of test year rate increases of \$34,802,920, or 8.92%. Texas-New Mexico Power Company provides electrical service to more than 170,600 customers located within the state of Texas.

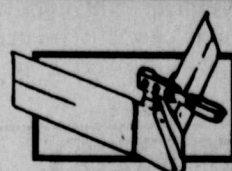

Further information also may be obtained by calling the Public Utility Commission's Public Information Office at (512) 458-0256, or (512) 458-0221 for text telephone. The deadline for intervention in the proceeding is 45 days after the date the application was filed with the commission.

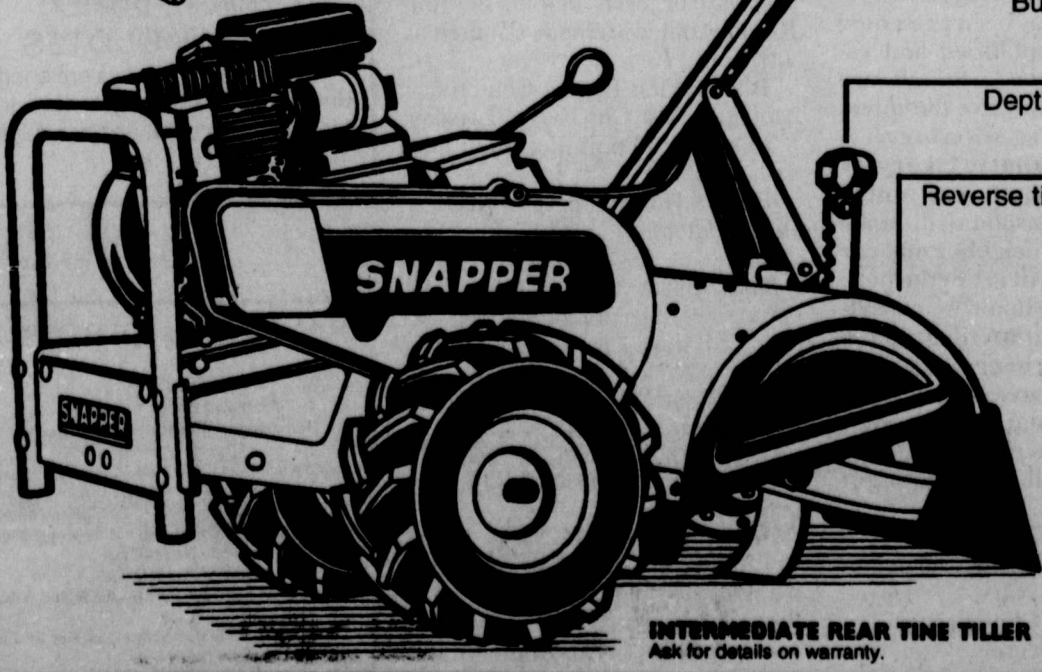

TNP Files For System-Wide Increase

Texas-New Mexico Power Company (TNP) officially filed a request for a system-wide rate increase of 8.9 percent, or \$34.8 million in annual revenue, on March 31. The request was filed with the Public Utility Commission of Texas and with cities maintaining original jurisdiction.

TNP is requesting the rate increase for four primary reasons. First, the company needs to recover the costs of maintaining and operating a reliable transmission and distribution system. The rate increase also is need to maintain TNP's financial integrity so that it can borrow money and issue stock at a reasonable cost for its customers. Third, TNP has experienced increase in its Federal income taxes, as well as state and local taxes. Finally, changes in accounting rules relating to recording the cost of retirees' health and other insurance benefits have resulted in additional costs to TNP which must be recovered.

TNP's request would result in about an 8.6% increase for an average residential customer. The increase for an average commercial customer would be about 11.7%. TNP's proposed rates would increase a monthly residential bill for 500 kWh from an average of \$41.89 to \$46.43, or \$4.54. A monthly residential bill for 1000

kWh would increase from an average of \$91.07 to \$99.38, or \$8.31.

The earliest date upon which TNP could implement bonded rates in association with this rate request is October 2, 1994, after the high summer use period. Assuming a three-week hearing, TNP expects to receive a final order from the Commission during the fourth quarter of 1994.

Once a final order issued by a city with original jurisdiction or by the Commission has taken effect, if TNP implements bonded rates, any excess revenues collected under bonded rates will be refunded to customers with interest. However, if the company under-collects during this period, customers will not be required to pay any additional amount above the bonded rate level.

TNP's last rate case was filed in April 1991. The rate increase in that case became effective in October 1991.

TNP does not expect to request additional base rate increases until January 2000 if 1) the Company receives the amount it currently has requested; and 2) other conditions, such as taxes, inflation, interest rates, etc., do not radically change from what is known or projected.

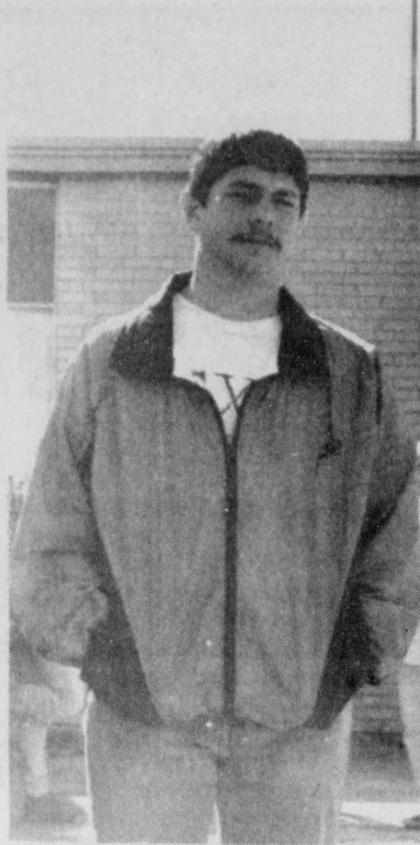

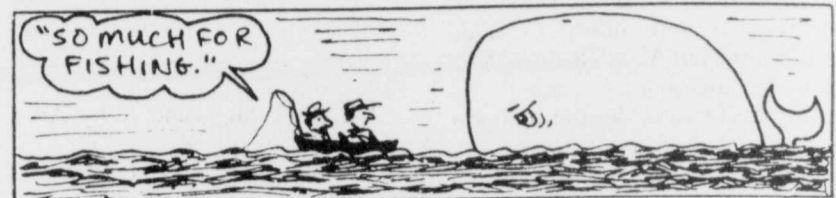

All types of movement, performed 30 to 60 minutes three to four times a week, not only increase the strength of the heart directly but also improve the ratio of "good" HDL cholesterol to "bad" LDL-cholesterol, enhance the effects of a low-fat diet, help keep down body weight, control or prevent the development of diabetes and, in some cases, lower blood pressure.

Exercise has been shown to help prevent heart and blood vessel disease and improve the survival rate of people who have already suffered a heart attack.

This summer the American Heart Association added physical inactivity to the list of risk factors that people can control through lifestyle changes.

Dietary Fiber Is Needed Each Day

Many Americans get only 10 to 12 grams of dietary fiber per day when we really need 25 to 30 grams per day. Here are some tips for getting closer to this dietary goal:

- Add 1/2 cup of cut-up fresh fruit to plain yogurt.

- Instead of drinking fruit juice, eat the whole fruit, such as an apple with the skin, an orange or dried prunes. Remember that when you juice fruit, you lose nearly all the valuable fiber that it has to offer.

- Instead of spreading butter or margarine on toast, use mashed bananas and a sprinkling of raisins for a delicious open-faced breakfast sandwich.

- Substitute whole-grain bagels, pita bread and English muffins for those made with refined grains.

- Try spaghetti or lasagna made with whole-grain pasta. Include vegetables in the lasagna for added fiber.

- Add dry beans - garbanzo, kidney or other favorites - to salads and casseroles.

- Make snacks count by munching higher fiber foods, such as dried fruits. Or have a few almonds, filberts or peanuts. Popcorn is a good choice, too.

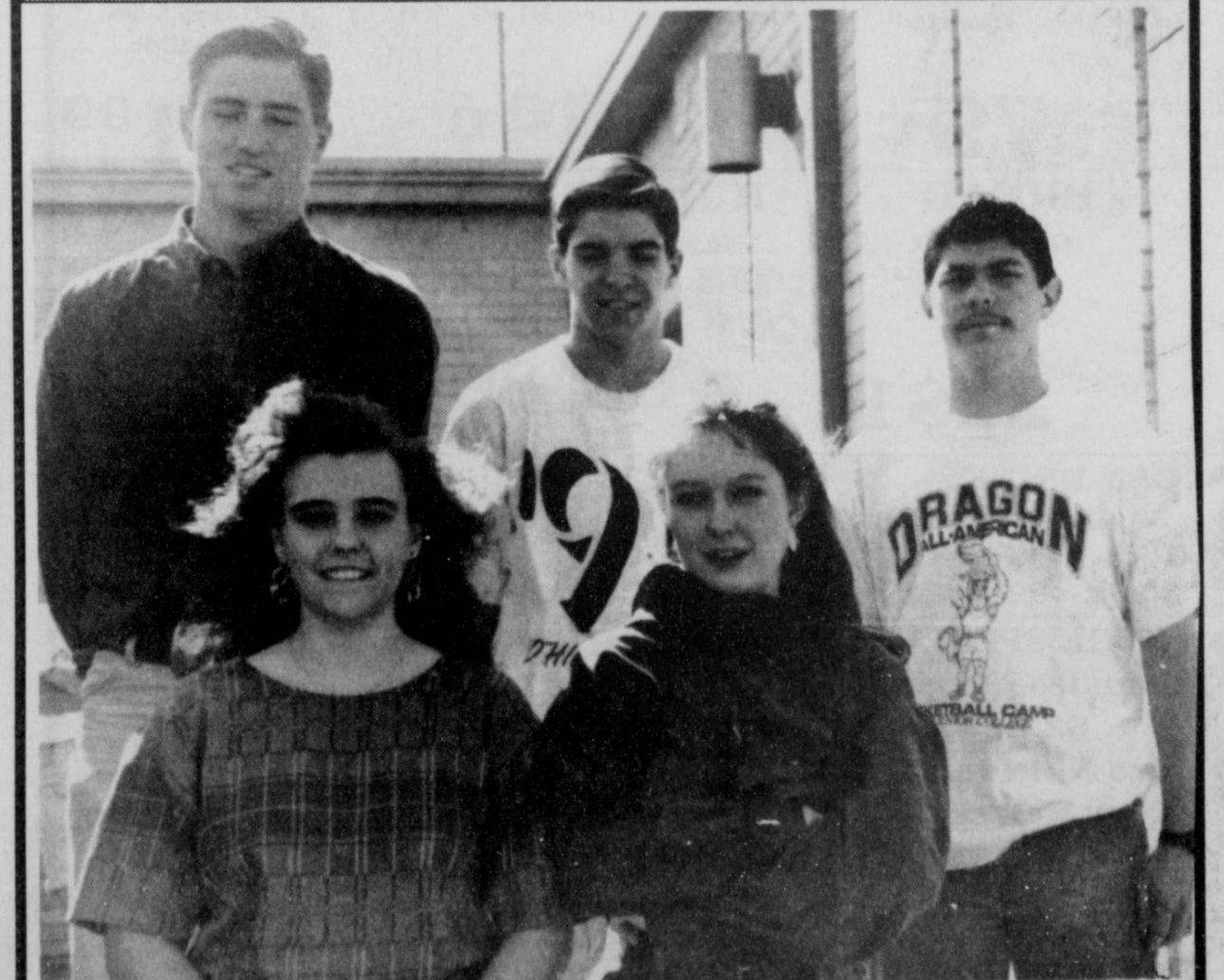

Never Say "Diet"

Health experts have a message for the estimated 65 to 80 million Americans who are currently dieting: "Stop!" For many people, a more effective approach to weight control and even weight loss is to eat healthfully and exercise regularly.

About 90% of people who lose 25 pounds or more gain it back within two years, according to the National Center for Health Statistics. Many dieters repeatedly experience weight fluctuations of more than 10 pounds, which is called yo-yo dieting. Recent studies suggest that yo-yo dieting may contribute to health problems, such as heart disease and diabetes.

Here are some tips that may help in losing weight and keeping it off:

- Set modest goals - don't be lured by promises of quick and easy weight loss.

- Eat three healthful meals a day plus snacks. Stop eating when you are no longer hungry instead of continuing until you feel really full.

- Enjoy meals at a leisurely pace. The slower you eat, the less food it takes to satisfy your appetite.

- Drink 8 to 10 glasses of water or other non-caloric liquids each day.

- Begin an exercise program slowly, increasing to a minimum of three weekly exercise sessions of at least 20 minutes each.

- Try a variety of exercise activities, such as walking, biking, swimming, low-impact aerobics or tennis. It will add to the fun and provide good overall exercise.

Beware of stress and boredom, as they can lead to inactivity and over-eating. Keep a list of things to do in your free time and accomplish one of the tasks on the list instead of eating.

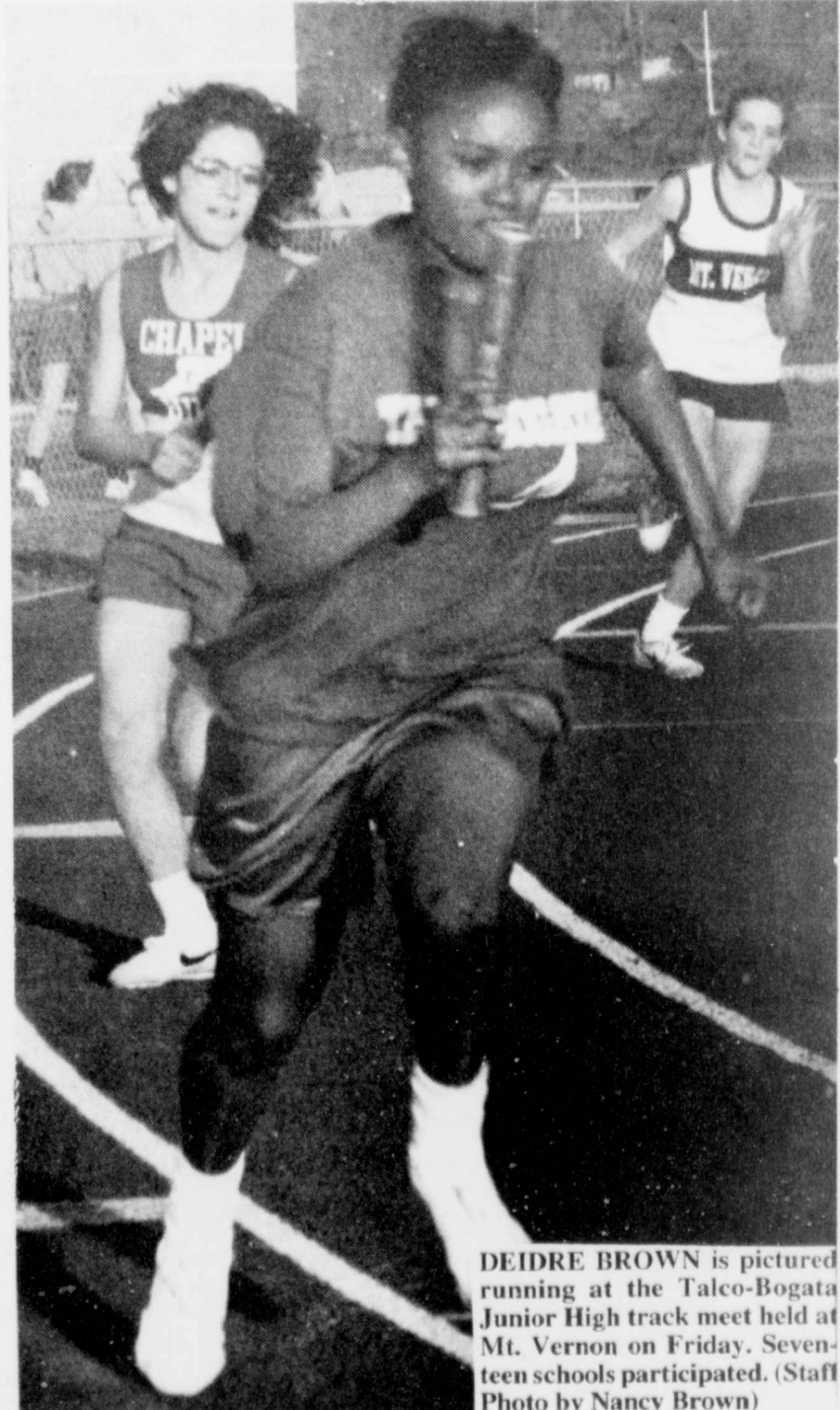

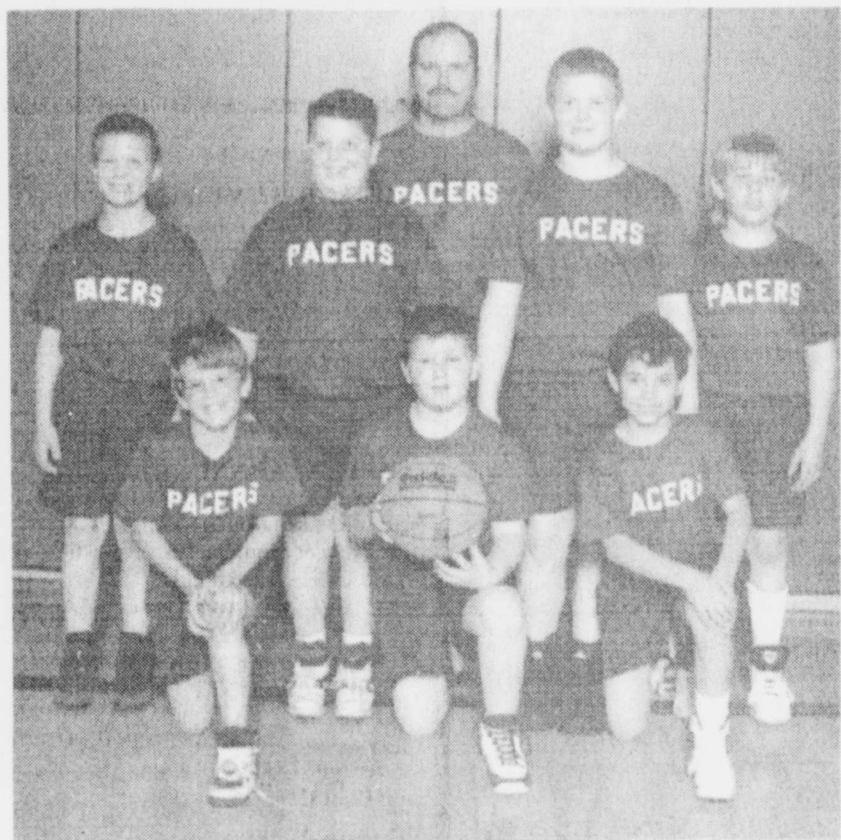

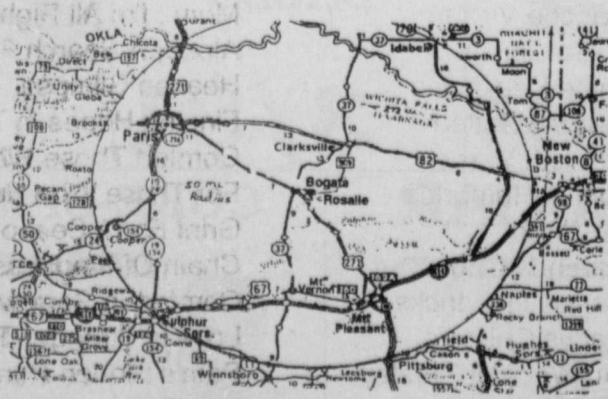

The Health Department emphasizes that this clinic is available to all preschool and school age children

beginning at two months of age. Immunizations offered include Measles/Mumps/Rubella, Oral Polio, Diphtheria/Tetanus/Pertussis and Tetanus/diphtheria. The Haemophilus Influenzae type b vaccine is also available to medically eligible children between the ages of 2 months and 60 months. The pneumonia vaccine is available to all high risk patients meeting income guidelines. All children must be accompanied by a parent or legal guardian. Parents are reminded to bring the child's immunization record and Social Security number if available. The Tetanus/diphtheria vaccine is available to medically eligible adults. Should the parent or legal guardian have questions, please contact the above noted field office staff.
