# Mules hammer Roosevelt in 35-14 Homecoming win

Led by senior Rashad Kirven's 155 yards and two touchdowns rushing, the Muleshoe Mules scored 35 first-half points en route to a 35-14 blowout on Homecoming night over the Lubbock Roosevelt Eagles at Benny Douglas Stadium Friday night.

"We haven't scored 35 points in half since Moby Dick was a minnow," said Muleshoe head coach Randy Adair of his team's explosive start.

The explosion came mainly from the feet of Kirven. Kirven, a converted wide receiver forced into the backfield due to an injury to Robert Toscano, showed a perfect blend of power and speed as he ran over and around the Eagle defense all night.

Kirven put the Mules on the board from a yard out to culminate their opening drive. His second score came on an option pitch down the Eagle's sideline. Kirven made the first defender miss and then showed breakaway speed as he outran several Eagles who seemed to have the angle on him. Fifty-four yards later, he was in the end zone and Muleshoe lead 28-7 in the second quarter.


"That's the kind of back we knew Rashad could be, but up until now, he hasn't wanted to get back there," Adair said. "We knew we could run the ball against (Roosevelt) and Rashad made some things happen."

And run the ball they did -47 times for 348 yards and 15 first downs. In fact, the normally air-oriented Mules only attempted three passes the entire game (all incomplete).

"Coming into the game, we were worried about (receiver) Robert Brown and their tailback, (Kwasi) Taylor," Adair said. "We knew we had to keep the ball out of their hands and the best way to do that is by controlling the clock and you do that by running the

"You go with whatever is working that particular game, but we still know that we can throw the football," Adair continued.

Nevertheless, the Mule ground game was unstop-

# MPD cracking down on illegal, out-of-state tags

Driving is not a crime and neither is driving across the border to visit neighboring states. It is a crime, however, for a Texas resident to drive across the border to other states in order to purchase vehicle registration, even though they are often less expensive than in Texas.

In an effort to crack down on the number of residents driving with illegal, out-ofstate tags, the Muleshoe Police Department (MPD) is iniating a plan to get people to comply with this law.

"We are having a problem with people who are living in Texas and who have out-ofstate license tags," said Mulesoe Police Chief Julian not just with New Mexico though. There are many from Colorado and other states as

A main factor for many Texas residents going to New Mexico is because of cheaper vehicle registration rates.

The large amount of people registering their vehicles out of state is costing the county money is lost taxes.

Vehicle registration fees help support schools and other public facilities. Therefore those people who register their cars out of state are not con-

tributing to property tax revenues these facilities receive. Dominguez. "The problem is although they live in the dis-

> Dominguez said the police department currently has about 150 cases which they arestudying and will follow up

Dominguez has appointed police officer Coy Plott to handle these cases.

Dominguez said that the police department wants to be fair and give people time to comply with the law.

Car owners or operators who are found to be residents of Texas and who are regularly driving vehicles with out-of-

state license plates will be given a warning notice the first time. They will then be given 30 days to comply with the law. Dominguez said the police department will then conduct a follow-up after the 30 days and will issue tickets if violators fail to comply.

"This (out-of-state vehicle registrations) is a violation of the law and we will work to enforce it just like any other law," Dominguez said.^

Dominguez said a common situation in which people don't

realize they have to have instate car tags is when they are


Even receiver Jesus Flores got into the big-play spirit. With the Mule offense determined to grind it out on the ground, the senior receiver took matters into his own hands on a punt return.

With the Eagles backed up at their own 2-yard line, punter Alvin Springfield got off a 43-yarder that bounced over Flores' head, but the Mule return man chased the ball down and made swiss cheese out of the Roosevelt coverage unit as he weaved through the defenders for 45 yards and a touchdown.

Quarterback Jimmy Gauna, although shut down through the air, rushed for 57 yards and converted a two-pointer on an option keeper.

Adair's concern for the potent Roosevelt attack seemed well-founded as the Eagles answered Muleshoe's opening score, going 70 yards on only five plays. Brown made the first big play, a 50-

not the owner of a vehicle, but are a resident of Texas and drive a vehicle on a regular basis with out-of-state tags.

"If a person is living in Muleshoe and driving a car in Muleshoe on a frequent basis, that car must have in-state tags; even if that person is not the owner of the vehicle, since they live in Texas and are mainly using it here."

In addition to fines if caught violating this law, a person may be required to pay the difference in the cost of in-state and out-of-state car registrations.




# Session to aid parents of Hispanic children

# A Tale of Two Pray-ers

esus once told a tale of two pray-ers. Listen to the first one as he begins.

"God, I thank thee ... "

The prayer begins well enough. After all, isn't prayer the overflowing of a thankful heart to its Creator? Thanksgiving is a good thing, right? Yes, but the speaker should have stopped there. Unfortu-

nately, the pious petitioner drones on.

"I thank thee, O God, that I am not like the rest of men-greedy, dishonest, adulterous...

He pauses. Like his kinsmen in every age who spend too little time examining their own lives, he made up for it by spending lots of his time making mental lists of the sins of others. He could easily have continued in the same vein for another paragraph or two. But his eye, momentarily straying from its heavenward focus, catches a glimpse of a tax collector praying nearby. Why continue listing abstract categories of sins and sinners with such a living, breathing, prime

example so handy?

"God, I thank thee that I'm not like this tax collector."

Example in hand, he moves on from the list of other men's sins to the more important list of his own virtues. God probably knows these things already, but it never hurts to be sure. Like everyone who puts his hope in salvation by law instead of salvation by the grace of a Savior, the Pharisee had the uneasy feeling that perhaps he hadn't done enough, or that maybe heavenly record-keeping was a little loose. He'd hate to lose points because of too much modesty. (No worries there!)

"I fast twice a week; I pay tithes on all that I get.'

And so the religious leader

A couple of the translations of this passage give us a hint as to what's really happening here when they say that this man "prayed thus with himself." Lest we disturb his supposedly holy harangue, let's move on.

Some distance away stands the tax collector, the object of the Pharisee's open derision. He, too, is praying. The difference is that he prays to God. One short line captures the essence of his petition: "God, be merciful to me a sinner!"

Oh, yes, there is one other difference: God listens to this man's prayer.

"It is my objective to bring college information closer to our students, without asking them to travel long distances," said Linda Marr, MHS counselor.



The Texas Department of Transportation (TxDOT) and Bailey County will host an Open House beginning at 6:00 P.M. and conduct a Public Hearing beginning at 7:00 P.M. on Tuesday, October 18, 1994, in the auditorium of the Three Way School which is two (2) miles north and three-quarters (3/4) mile west of Maple in Bailey County.

The Open House will begin at 6:00 P.M.

During the Open House, the public will have an opportunity to ask questions about the proposed highway construction and make written comments on the project prior to the beginning of the hearing. All written comments whether received during the Open House, at the Public Hearing, or after the Public Hearing during the ten (10) day comment period will receive the same weight as oral presentations made at the Public Hearing.

The Public Hearing will begin at 7:00 P.M.

The purpose of the Public Hearing is to permit the public an opportunity to review and comment on the proposal to construct a new farm-to market (F.M.) highway in southwestern Bailey County to replace a narrow and deteriorating county owned paved road. The project is the extension of the existing F.M.1731 on a new location, from its current southern terminal at F.M. 298 to F.M. 54, a distance of approximately 9.1. miles. Construction of a modern, two-lane, rural highway at this location will better accommodate local farm and ranch traffic to travel between northern and southern portions of the county, and rural school traffic than does the existing county road.

For the most part, typical right-of-way widths will be expanded from the existing 80 feet in width to 120 feet in width, through the acquisition of approximately 40 feet of additional right-of-way width along the east side of the existing county road. An exception to the right-ofway expansion proposal occurs near the southern end of the project at F.M. 54. Beginning at approximately 1.37 miles north of F.M. 54 and extending approximately 1.17 miles south, the existing county road right-of-way width will remain 80 feet in width and will not be expanded to 120 feet in width. The reason for not expanding the right-of-way width in this area is the requirement that a shelterbelt (treelines) not be destroyed and the need to avoid potentially expensie utility ad-• justment costs. 




