Bogata Council approves wastewater treatment service contract

The Bogata City Council met Monday, July 16 with four council members, Mayor Kennedy, three employees and nine visitors present.

Council heard from Chris Aylor and Lanny Buck, representatives of KSA Engineers, Inc. and approved a proposal for engineering services at wastewater treatment plant to move the effluent flowmeter at an approximate cost of \$10,000-\$15,000. This is a requirement of the Texas Natural Resource Conservation Commission.

They also heard from Beth Vogel of the Red River County Humane Association who recommended an ordinance to spay/neuter all animals, but Council took no action on this.

Minutes of the previous meetings were approved and final water bill accounts were also approved. Council voted to pay Officer Davidson for his overtime hours worked during the ice storm with money received from FEMA, and voted to pay \$800 re-

ceived from FEMA toward the new squad car, and keep the remaining \$407 for City expenses.

Water Superintendent Wendell Davis was absent, but had left a written report for the Council, and Council heard the Fire Marshal's report.

Council voted to take no action on buying an icemaker for the Volunteer Fire Department which is checking out other options. They appointed Randy Kennedy as the new representative to Ark-Tex Council of Governments board of Directors due to resignation of former Mayor Jack Crane. A Resolution regarding a citizen complaint procedure and designating Wendell Davis as the Community Development Citizen Coordinator to respond to complaints for the TCDP Project was approved.

No action was taken to appoint a Fair Housing/Equal Opportunity Standards Officer as required by the Texas Community Development Pro-

gram Contract #720071, but if Mayor Kennedy can serve as the officer he will. No action was taken to approve an order concerning a commitment to order a burn ban in the City whenever the County Judge declares one in the unincorporated areas of the county, on the recommendation of the Texas Forest Service. This will be left to the discretion of the City Fire Marshal. At that time, it will be posted at City Hall, put on the Lions Club sign in town, published in the newspaper, and a flag will be put up at the Volunteer Fire Station.

Action on an ordinance to tax telecommunications was tabled. Council agreed to allow a Court Clerk from Winnsboro to come one Saturday and help train the new Court Clerk, Angie Burgess.

They set a Budget Workshop for Monday, July 23 from 7 to 9 p.m.

The meeting adjourned at 8:45 p.m.

Bogata veterans attend commissioning of the Iwo Jima

To Bogata veterans, along with thousands of others nationwide, were honored with what may be one of the ultimate honors this nation can give recently. Pat Lindsey and Bill White were on hand in Pensacola, Florida June 30, to be honored as the USS Iwo Jima became a proud ship of the line. Both White and Lindsey are veterans of the battle of Iwo Jima, and White is a double Purple Heart recipient.

The Navy commissioning ceremony has been a tradition for centuries, and in the United States Navy since its beginning. It marks the formal entrance of a warship into Naval Forces of the United States. It is the final and perhaps most significant event of the triad bringing the ship to life of the keel laying, christening and commissioning.

The Iwo Jima LHD 7 was named after the World War II battle that is so famous. It is the second ship to bear the name. The first was commissioned in 1960 and decommissioned in 1993.

The captain of the ship, John T. Nawrocki, said that "we will live up to the standards of service that were set by the men who fought so bravely at the battle for Iwo Jima, some of whom are here today. Sailors and Marines aboard Iwo Jima serve our great country in uniform and are model citizens for all Americans to emulate."

Pat and his wife, Billie and Bill and his wife, Barbara, traveled to Florida for the special ceremonies.

Over 11,000 were on hand for the ship's commissioning and special

ceremonies. Many more would have been there if it had not come a near-flood of rain. Soaked to the skin, no one seemed to care, as this patriotic ceremony "brought the ship to life". The rain, no doubt, served to hide tears that coursed down the cheeks of Americans who served their country so bravely, more than fifty years before.

The veterans and their families received the grand tour, and were treated as very special guests...as they should be.

IM4 Division AS2 Clarence Polard gave part of the tour, and Medical Officer Lt. Angela P. Jackson gave the tour of the medical and dental departments.

The huge ship has a 600 bed medical facility, 6 operating rooms and a host of other support facilities.

The ship's primary mission is to embark, deploy and land elements of a marine landing force in amphibious assault operations by helicopter, landing craft, amphibious vehicle or any combination of these methods.

It is second in size only to the present day aircraft carrier and equal in size to the aircraft carriers of WWII.

The USS Iwo Jima is the seventh WASP class multipurpose assault ship. It has living spaces for 3,200 sailors and marines. It carries, in addition to the necessary personnel, but also the necessary vehicles, artillery pieces and supplies to sustain its landing force, a Marine Corps Expeditionary Unit.

It has NSSMS Surface guided missile system; Rolling Air Frame Missile System; and Close in Weapon

systems. It carries everything from Assault and Search and Rescue aircraft to heavy lift assault helicopters, as well as vertical/short take off and landing AV-8B Harriers.

Its flight deck is a staggering 1.5 acres; 830 feet long and 106 feet wide. Memories of the battle of Iwo Jima invariably flooded back to the veterans of that famous battle as they toured the modern ship that honors them.

The fierce battle in the Pacific was begun on February 19, 1945, with a formidable force, totaling 495 ships, including 17 aircraft carriers, 1170 planes and 110,308 troops. Iwo Jima was a "thorn in the side of U.S. Heavy bomber crews". Air attacks on the Marianas bomber bases and bombers enroute to and from Japan were launched from Iwo Jima. The assault on the island was necessary to eliminate these air attacks.

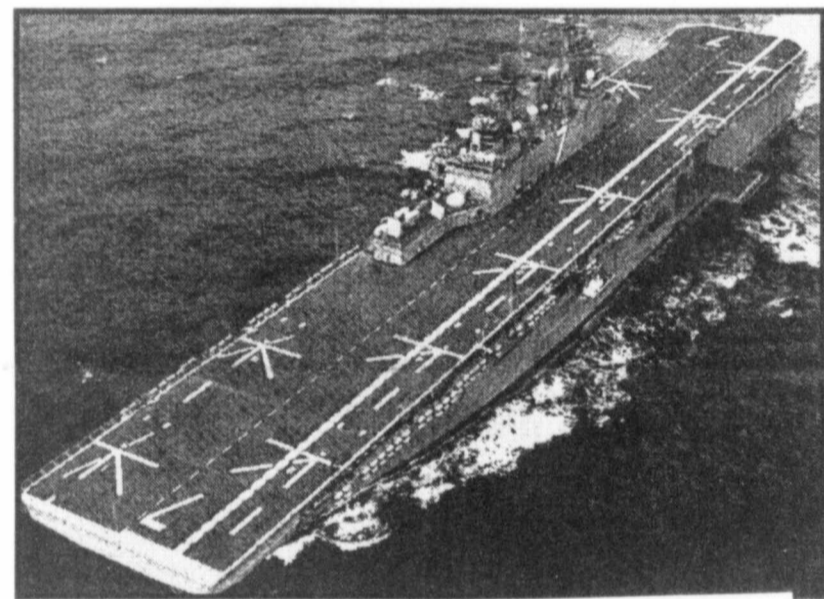
The commander, instead of putting barriers on the beaches, fortified the interior of the island. This took a fearful toll on U.S. Marines.

566 American men died and 1,755 were wounded on that first day of fighting. The struggle for Iwo was fought until March 16th, when the island was secured by U.S. Forces. In the fight 6,281 Americans and more than 20,000 Japanese were killed.

Perhaps, for Bill White and Pat Lindsey, the most important quotation was from Fleet Admiral Chester W. Nimitz observed, "Among the Americans who served on Iwo Jima, uncommon valor was a common virtue." It must mean a great deal to veterans to know their struggle is not forgotten.

Country Cooking

Several of you have asked for some canning and pickling recipes. Well, here they are. With an abundance of garden vegetables this year, everyone seems to be putting up something for the upcoming winter season. But you had better hurry, the sun and grasshoppers seem to be getting a pretty good lead on area gardens. Hope you can use some of these and are the ones you requested! See you in the kitchen!

Bread and Butter Pickles
25-30 large cucumbers
8 large white onions
2 large sweet peppers
1/2 cup salt
1/2 teaspoon cloves
5 cups cider vinegar
5 cups sugar
2 tablespoons mustard seed
1 teaspoon tumeric

Wash cucumbers and slice as thin as possible. Chop onions and peppers. Combine with cucumbers; add salt and let stand for three hours; drain. Combine sugar, vinegar and spices in large pan; bring to boil and add drained cucumbers; heat thoroughly, but do not boil. Pack while hot in clean jars and seal. Yield 16 pints.

Sweet Pickle Sticks
medium firm fresh cucumbers
boiling water
3-3/4 cup vinegar
3 cups sugar
3 tablespoons salt
4-1/2 teaspoons celery seed
4-1/2 teaspoons tumeric
3/4 teaspoon mustard seed

Use firm fresh medium size cucumbers. Wash and cut them up into sticks. Pour boiling water over them and let stand overnight. Next morning pack solidly into jars. Boil solution for 5 minutes. Pour boiling hot over cucumbers in jars. Process in boiling water bath for 5 minutes. Solution fills 6 pint jars.

Sweet Pickles
large dishpan of cucumbers sliced
1/2 cup salt
4 quarts water
28 ice cubes
1-1/2 cup vinegar
3-1/2 cups sugar
1 tablespoon mustard seed
1 teaspoon celery seed
1 teaspoon ground tumeric

Pour salt, water and ice cubes over cucumbers and let set for 2 hours; drain. Combine vinegar, sugar, mustard seed, celery seed and tumeric; dissolve in large dishpan and let come to boil. Add drained cucumbers and stir in until cucumbers are hot. Place in clean jars and seal.

Corn Relish
8 cups cooked fresh corn from cob
1 cup chopped seeded green pepper
1 cup chopped seeded red pepper
2 cups chopped onion
1/2 cup brown sugar
1 cup white vinegar
2 tablespoons dry mustard
1 tablespoon mustard seed
1 tablespoon salt
1 quart cider vinegar
1 cup water

Combine corn, peppers and onion. Add remaining ingredients and mix thoroughly. Bring to boil and simmer uncovered for 15 minutes. Pour at once to overflowing into clean, hot preserve jars. Adjust covers and process for 30 minutes cold pack. Yield 5-6 pints.

Ripe Tomato Relish
10 medium onions-chopped
12 sweet bell peppers-chopped
1 bunch celery-chopped
8 quarts ripe, peeled tomatoes
1 quart vinegar
3 cups sugar
1 tablespoon cinnamon
1 tablespoon allspice
1 tablespoon dry mustard
2 tablespoons salt

Core and chop tomatoes coarsely and bring to boil along with onions, peppers, celery and simmer for 2 hours. Stir frequently. Add remaining ingredients and continue to simmer for 1 hour. Pack in clean warm jars.

Chow Chow
1 gallon green tomatoes
1 dozen bell peppers-some red
6 large carrots
1/2 gallon cabbage
1 quart onion
4 hot peppers or taste
1/2 gallon vinegar
6 cups sugar
2 teaspoons dry mustard
1 teaspoon tumeric
1 teaspoon cinnamon
1 teaspoon cloves
1/2 teaspoon celery seed
1 teaspoon ginger

Combine tomatoes, peppers, carrots, cabbage, and onions. Grind and cover with 1 cup salt. Let stand one hour. Drain. Pack in jars. Bring to boil the vinegar, sugar and spices. Pour boiling mixture over packed mixture and seal.

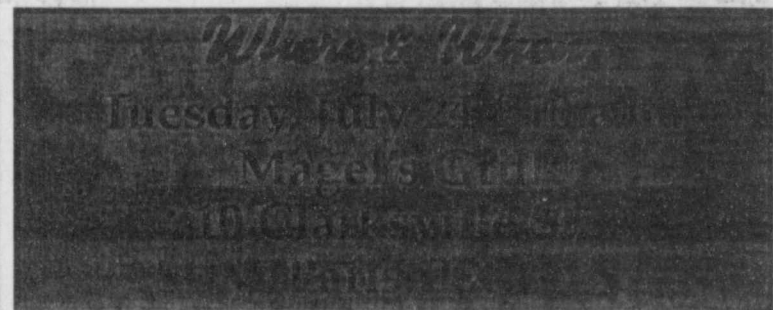

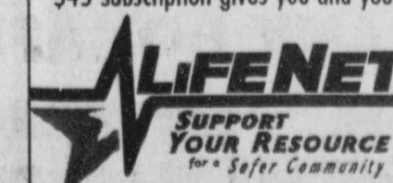

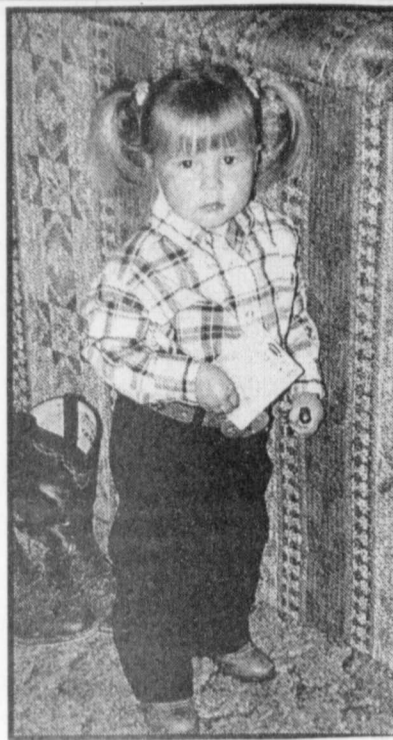
The tour, sponsored by the Paris Visitors and Convention Council, was originally founded by the Red River Cycle Club and has become
