For some reason, we didn't turn the TV on this morning. It wasn't until I got in my vehicle that the radio grabbed my attention. Reports from the World Trade Center were pouring in. I had a few moments hoping this was some giant joke, knowing all the while it wasn't.

As the morning progressed, and things became worse and worse, people began stopping by the office. No one really knew what to say, but they wanted and needed, I think, to be around others and discuss the devastating terrorism that was hitting our country.

So, I am reduced to sitting in front of my computer, simply typing out things I feel about

First of all, it wasn't unexpected. Anyone who has been around airports and big cities can testify that there is no way to secure everything from terrorism.

Secondly, because we are perceived world wide as a super power, we are automatically a target. Being that target just flat out comes with the territory, and we must accept that it is a price we pay for the country we live in.

The third thing that comes to my mind is that I hope we as a nation will stand up, unite

and deal with these attacks. We, as Americans, have the chance to deal with this crisis proudly, strongly and with

heroism. Will we do so? I don't know, but we have the chance.

We can pull together, band together, pray together for the common cause of national strength and pride. Or, we can deteriorate into squabbling childishness.

Now is not a time to begin "second guessing" the actions of people in power, airport security or anything else.

Buildings are just that, structures that can be rebuilt. Our concerns must be for those lost in this tragedy. Our concerns must be for those left behind to deal with their losses. And our concerns must be for this nation as a whole.

We are capable of taking whatever un-understable terrorists dish out. We are capable of turning it into something that makes this nation a stronger, more united whole. That choice is ours, no one else's. Which will it be? I don't know, but I have hopes. Hopes that something good can grow from something so terrible. Beauty and goodness growing from something so evil will make it twice as precious. We must not let terrorism win by being held hostage in fear and trembling. We must react with strength and patriotism. I'm not talking about blind "flag waving" or mindless violence. If something good comes from this, it must begin growing in the hearts of each American, one by one. Let us pray, and let us grow.



Country Cooking

Sue Sheppard of Deport brought in a couple of recipes this week using pears. They sounded very good and I thought, well this is the season for those pear preserves, so here are a few other pear recipes. A lot of folks in this area make pear preserves and know the trouble they go to prepare these are well worth it.....unless you burn or scortch (is that the correct spelling....it sure doesn't look like it!) them and then.....well, the process starts over. It is very easy to do this and preserves have to be watched constantly and cooked at a low temperature for several hours.

Sue always has an abundance of pears and enjoys sharing them with others. She and her husband Eddie own and run Eddie's Service Center in downtown Deport. She enjoys just visiting and meeting folks and enjoys her grandkids. Her youngest, Ty, began school this year in Kindergarten, and she sure has some stories to tell about him! He is a doll!

In our area, the sugar pears are best for baking and the late summer pears are best for pear preserves.

Anyway, pears originally came from Europe and Asia and the first cultivated varieties were cultivated

from the wild varieties in the prehistoric ages. How they know this, I'll never know!!!!!! The Romans knew in the beginning of 6 cultivated varieites and later mention 56. The late medieval Italian list mentions 232 varieties.

Around 1640 in England, only 60 varieties were known. In 1842 more than 700 were known. The American author, T.W. Fields mentions 850 varieties in the 1860's.

#### A Letter from Senator Gramm

Jack Crane of Bogata has shared a letter from Senator Phil Gramm concerning the matter of liability of Japanese companies who used American prisoners of war as forced labor during World War II. Dear Mr. Crane.

Thank you for contacting me about the liability of Japanese companies who used American prisoners of war (POWS) as forced labor during World War II. I appreciate having the benefit of your views on this important matter.

I cannot overstate my respect and appreciation for those brave men and women who were forced to endue untold suffering at a time when our liberties were in grave jeopardy. In these days of unprecedented peace and prosperity, it is all too easy for many Americans to forget that the wealth and security we now enjoy were purchased at a considerable price. An entire generation of Americans interrupted their lives to turn back the hand of tyranny in Europe and the Pacific, and many paid the ultimate price to ensure that their children and grandchildren would enjoy the blessings of freedom and liberty. The endurance of American prisoners of war, many of whom continued their country's fight from behind barbed wire in the face of Japanese atrocities, is a testament to the stubborn, fighting spirit of the American Gl. During World War II, Japan captured and imprisoned roughly 36,000 Americans, of whom over one third died during their imprisonment. Many of those American POWs were forced to work during their incarceration for private Japanese companies under dangerous and op-

pressive conditions. As a result, many such veterans still suffer from long-term health problems.

In the current Congress, H.R. 1198, the "Justice for the United States prisoners of War Act of 2001", has been introduced to address the issue of privately-owned Japanese companies who forced prisoners of war to perform slave labor. This legislation would, in part, direct the federal courts not to interpret article 12(b) of the Treaty of Peace with Japan as a waiver of claims that would prevent U.S. POWs from pursing forced labor suits against Japanese individuals or private corporations. Additionally, the bill would insure that article 26 of the Peace Treaty with Japan should apply to forced labor suits by U.S. POWs. This bill has been referred to the House Judiciary, International Relations, and Government Reform commit-

tees for consideration. We must never forget the sacrifice made by those who stood up to Japanese aggression, and we must always honor them in word and deed. As my colleagues and I debate the issues of our day, I can assure that such deliberations are conducted with the knowledge that our freedom was secured by the blood and sacrifice of those who stood in the way of advancing tyranny. You may be sure that I will keep your views foremost in mind should H.R. 1198 or other relevant legislation be considered by the full





The proposed amendment would authorize a political subdivision that imposes ad valorem taxes, at its option, to tax this type of property after a local public hearing on

#### **PROPOSITION 14** (HJR 44)

Proposition 14 would amend the constitution to allow the legislature to authorize a taxing unit, other than a school district, to exempt travel trailers from property taxation as long as the travel trailers are lawfully registered with the state and are not held or used for the production of

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to authorize the legislature to authorize taxing units other than school districts to exempt from ad valorem taxation travel trailers that are not held or used for the production of income."

#### **PROPOSITION 15**

Proposition 15 would amend the constitution to create the Texas Mobility Fund, which would be administered by the Texas Transportation Commission. The Fund would finance the construction, acquisition, and expansion of state highways and would pay a portion of the costs of public toll roads and other public transportation projects. The legislature may reserve specific sources of state revenue for the Fund and may authorize the Commission to guarantee the payment of any obligations or credit agreements with the full faith and credit of the state. The attorney general shall determine the legality of any such obligations or credit

The proposed amendment will appear on the ballot as follows: "The constitutional amendment creating the Texas Mobility Fund and authorizing grants and loans of money and issuance of obligations for financing the construction, reconstruction, acquisition, operation, and expansion of state highways, tumpikes, toll roads, toll bridges, and other mobility projects."

#### **PROPOSITION 16** (HJR 5)

Proposition 16 would amend the constitution to reduce the waiting period required for a valid home improvement lien on a homestead from 12 days to 5 days. The proposed amendment will appear on the ballot as follows: "The constitutional amendment prescribing requirements for imposing a lien for work and material used in the construction, repair, or renovation of improvements on residential homestead property and including the conversion and refinance of a personal property lien secured by a manufactured home to a lien on real property as a debt on homestead property protected from a forced sale."

#### **PROPOSITION 17**

Proposition 17 would amend the constitution to allow the state to relinquish claim to certain state land and to clear title defects for persons who claim title to those lands. The proposed amendment would apply to land whose owners have disputed title to the land, but for which no patent from the state, giving clear title to the land, was ever issued. Among other requirements, all of the taxes due on the land must have been paid. Under current law, there is no procedure allowing the state to settle title disputes without a constitutional amendment for each piece of land in dispute.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to settle land title disputes between the state and a private party."

#### **PROPOSITION 18** (SJR 49)

Proposition 18 would amend the constitution to authorize the legislature to create a program to consolidate and standardize the collection, deposit, reporting, and payment of criminal and civil court fees. If the legislature creates such a program, any new fees imposed by the legislature may not take effect before January 1 of the following year, unless an earlier effective date is approved by a vote of two-thirds of the members of each house of the legislature.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to promote uniformity in the collection, deposit, reporting, and remitting of civil and criminal fees."

#### **PROPOSITION 19**

Proposition 19 would amend the constitution to allow the Texas Water Development Board to issue up to \$2 billion of additional general obligation bonds. The Board issues bonds to pay for water supply projects, water quality enhancement projects, flood control projects, state participation in water and wastewater facilities, and projects for economically distressed areas. Current law limits the amount of bonds that the Board can issue.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the issuance of additional general obligation bonds by the Texas Water Development Board in an amount not to exceed \$2 billion."

to make fun of someone? I want to say "stay at home" if you


are not there in true support of our children! If it's a two dollar football you want, just ask someone for one! A dedicated fan,
