Mr. Bramlet died at 10:00 a.m. Thursday in a Plainview hospital following a lengthly illness.

Son of the late Mr. and Mrs. Nathaniel Bramlet, he was born in Collin County near Wylie, Texas July 29, 1905. He came with his parents to Swisher County in 19 31 43 61 1916 and settled in the old Whit-10 20 33 45 field Community, some 17 miles east of Kress.

He married the former Eula Savage at Lockney December 10, 1925, and soon after moved to the southwest corner of Briscoe County where they lived until moving into Lockney some three months ago. 


