'I was smelling love and hate'

STEPHENVILLE- Tuesday, the state rested in the capital murder trial of Eddie Routh with compelling evidence of a recorded phone call between Routh and a reporter with The New Yorker.

The call was made to the Erath County Jail four months after Routh was taken into custody. Nicholas Schmidle, a reporter for The New Yorker, interviewed Routh about the day of the murders.

"I was smelling love and hate," Routh told Schmidle:

Routh is accused of killing Chris Kyle and Chad Littlefield at a shooting range at Rough Creek Lodge on February 2, 2013.

"I had to take care of business, so I took care of business," Routh continued. "That's how I felt

that day, ya know?" Routh told Schmidle he got irritated that Littlefield wasn't participating in their shooting activities and kept asking him what he was doing there. Then he told Schmidle

he shot Littlefield first. "I didn't shoot Chris first, I shot him second," Routh replied.

In other testimony, Lancaster police officer Flavio Salazar took the stand for the second time while jurors viewed video of Routh in the backseat of his squad car after his arrest.

"I'm nervous, I don't know what's going to happen to me," Routh was recorded saying. "I've been so paranoid and schizophrenic all day. I don't know if I'm insane. I don't even

know what to think." Amber Moss, a forensic scientist at the DPS crime lab, testified that blood spatter on Routh's boots matched Littlefield's.

Ethan Bredemeyer takes scholarship in Ft Worth

FT WORTH- Ethan Bredemeyer, an FFA member from Winters, took home a \$12,000 scholarship at the 119th annual Fort Worth Stock Show and Rodeo through the eighth annual Heifer Superintendent's Beef Challenge which tested the youth's knowledge on

beef cattle production. "One of the Stock Show's missions is to continue encouraging young people to pursue careers in livestock and agri-business through programs and incentives especially tailored to their interests," said Brad Barnes, president and general manager of the Fort Worth Stock Show & Rodeo.

"Junior exhibitors learn many valuable life lessons during their years of showing livestock, which will serve them well throughout their lives. With the help of Devon Energy's continued commitment to this scholarship contest, it has

created an additional opportunity to help enhance the future of the livestock industry. It's important to the Stock Show that we have this support from Devon Energy and our other sponsors. It makes

The competition was open to junior heifer show exhibitors that are high school seniors and who have exhibited heifers a minimum of two years at the Fort Worth Stock Show, including the current 2015 show. Participants took a written exam and the top scores advanced to the next level, giving a two-minute oral presentation on why ranchers should use the breed of heifer shown by the exhibitor. In total, eleven high school seniors from Texas earned scholarships this year through the Beef Challenge.

Initiated in 2008 by the superintendents of the Stock Show's junior heifer show, the scholarship program allows junior exhibitors to use the knowledge

AUSTIN - Two trainings to help professional irrigators and water conservation staff save water will be conducted by the Texas A&M AgriLife Extension Service Feb. 24-25 at the Lower Colorado River Authority Dalchau Service Center, 3505 Montropolis Drive, Austin.

"Over 1,100 community water systems are currently affected by drought and water restrictions, including many in the Central and South Central regions of the state," said Charles Swanson, AgriLife Extension irrigation specialist, College Station. "Much of the area around Austin currently has some type of outdoor water restrictions in place for irrigation, including limited days per week and times during the day to irrigate.

To help bring professionals and water conservation staff up to date on the latest methods to make best use of their resources, two trainings will be conducted by Swanson and Dr. Guy Fipps, Agrilife Extension

irrigation engineer, College

Eight continuing education units for landscape irrigation licenses will be offered to those attending either training. To register for either or both trainings, go to http:// agriliferegister.tamu.edu/ irrigation.

The Feb. 24 training, "Irrigation Troubleshooting and Performance Testing," will consist of hands-on training in how to program irrigation controllers, electrically troubleshoot controllers and valves, properly install rain sensors, determine sprinkler precipitation rates and create good irrigation schedules, Swanson said. The cost is \$165, including lunch. The training will start at 8:30 a.m. and end at 5:30 p.m.

Vector abatement and mitigation workshops across the state

Special to the Winters Enterprise STEPHENVILLE- The Texas A&M AgriLife Exten-

sion Service will conduct 11 Vector Abatement and Mitigation Workshops across the state in the coming months, according to coordinators.

"The workshops, all with the same curriculum, are designed to train personnel in cities and municipali-ties that are in the field of mosquito abatement," said Dr. Sonja Swiger, AgriLife Extension entomologist at Stephenville.

"The goal of the workshops is to educate personnel
"The goal of the workshops is to educate personnel

on mosquito identification, biology, ecology, control tactics, trap usage, surveillance and mosquito control. We will also offer an overview of vector-borne diseases of concern in Texas and discuss other biting insects.'

Swiger said individual registration is \$40 and will include lunch, except for the Dallas location, which is \$30 and will not include lunch. Copies of the Texas Mosquito Manual will be available at all the sites for an additional \$10 each.

Each location will offer continuing education units for pesticide licensing through the Texas Department of Agriculture and animal control. The pesticide license units that will be available are three for structural and five for agriculture. A total of 4.75 animal control continuing education hours will also be

Weather Whys

Q: When did weather experts start calculating wind chill?

A: It's believed wind chill factors (a combination of air temperature and wind speed and how they affect the human body) were first compiled by two Antarctic explorers, Paul Siple and Charles Passel, in 1945, says Brent McRoberts of Texas A&M University. "The original wind chill index used by them was around for many years, but it really wasn't used much," he notes. "Most agree the event that made the term 'wind chill' famous was the Dallas-Green Bay football game in 1967 when the game-time temperature was minus-13 degrees, putting the wind-chill factor at minus-36 degrees. But even that was bested in 1981 when San Diego and Cincinnati played during wind chill conditions of minus-59 degrees. The term has become very familiar in recent decades.

USDA announces funding for energy projects

WINTERS ENTERPRISE

TEMPLE- Agricultural producers and rural small business owners can now apply for resources to purchase and install renewable energy systems or make energy efficiency improvements according to an announcement recently made by Agriculture Secretary Tom Vilsack.

These efforts help farmers, ranchers and other small business owners save money on their energy bills, reduce America's dependence on foreign oil, support America's clean energy economy, and cut carbon pollution. The resources announced are made possible by the 2014 Farm Bill.

"Developing renewable energy presents an enormous economic opportunity for rural America," Vilsack said. "The funding we are making available will help farmers, ranchers, business owners, tribal organizations and other

entities incorporate renewable energy and energy efficiency technology into their operations. Doing so can help a business reduce energy use and costs while improving its bottom line. While saving producers money and creating jobs, these investments reduce dependence on foreign oil and cut carbon pollution

USDA is making more than \$280 million available to eligible applicants through the Rural Energy for America Program (http://www.rd.usda. gov/programs-services/ rural-energy-america-program-renewable-energysystems-energy-efficiency). Application deadlines vary by project type and the type of assistance requested. Details on how to apply are on page 78029 of the December 29, 2014 Federal Register or are available by contacting the USDA Renewable Energy Coordinator in Texas, Billy Curb, at billy.

curb@tx.usda.gov, or call (254) 742 9775 for more information.

USDA is offering grants for up to 25 percent of total project costs and loan guarantees for up to 75 percent of total project costs for renewable energy systems and energy efficiency improvements. The REAP application window has been expanded. USDA will now accept and review loan and grant applica-

tions year-round. Eligible renewable energy projects must incorporate commercially available technology. This includes renewable energy from wind, solar, ocean, small hydropower, hydrogen, geothermal and renewable biomass (including anaerobic digesters). The maximum grant amount is \$500,000, and the maximum loan amount is \$25 million per applicant.

Energy efficiency improvement projects eligible for REAP funding

include lighting, heating, cooling, ventilation, fans, automated controls and insulation upgrades that reduce energy consumption. The maximum grant amount is \$250,000, and the maximum loan amount is \$25 million per applicant.

USDA is offering a second type of grant to support organizations that help farmers, ranchers and small businesses conduct energy audits and operate renewable energy projects. Eligible applicants include: units of state, tribal or local governments; colleges, universities and other institutions of higher learning; rural electric cooperatives and public power entities, and conservation and development districts. The maximum grant is \$100,000. Applications for these particular grants have been available since December 29 of last year and are due February

created in the 2008 Farm Bill. Because of the success of the program, Congress reauthorized it in the 2014 Farm Bill with guaranteed funding of no less than \$50 million in annual funding for the duration of the 5 year bill. The 2014 Farm Bill builds on historic economic gains in rural America over the past six years while achieving meaningful reform and billions of dollars in sav-

ings for taxpayers. Since 2009, USDA has awarded \$545 million for more than 8,800 REAP projects nationwide. This includes \$361 million in REAP grants and loans for more than 2,900 renewable energy systems. When fully operational, these systems are expected to generate more than 6 billion kilowatt hours annually - enough to power more than 5.5 million homes for a year.

In late 2014, owners of K&J Woodworks, LC in Uhland, Texas, used

REAP funding to install a photovoltaic solar system. The system was completely installed and fully operational on December 5, 2014. Even though the month was cloudy and overcast, the system still produced 1,511 kWh of solar electricity and saved the business approximately \$220 during the billing

Veteran's Corner

New copayments for prescription drugs covered by TRICARE went into effect on February 1. The FY 2015 National Defense Authorization Act (NDAA) requires TRICARE to increase most pharmacy copays by \$3. The old and new copay rates are: Copays for generic formulary drugs increased from \$5 to \$8, copays for brand name formulary drugs increased from \$17 to \$20, and copays for non-formulary drugs increased from \$44 to \$47. For home delivery (you can get up to a 90-day supply of drugs through home delivery), copays for formulary brand name drugs increased from \$13 to \$16, and copays for non-formulary drugs increased from \$43 to \$46. Drugs from military pharmacies and generic drugs from TRICARE Pharmacy Home Delivery still cost beneficiaries nothing. A Titus County game warden responded to a trespassing complaint claiming someone was shooting Canada geese and leaving them to waste near Naples in Morris County. The only suspect was a juvenile seen at the private lake the

The warden located the suspect, who happened to be driving without a license and pulling a trailer with a large hog in it. He claimed he had been hunting all morning with four of his friends. After verifying the story, the warden issued four citations for hunting without licenses, two citations for no Hunter Education certification and a warning for driving without a driver's license.

Later that evening, the juvenile contacted the warden and gave the names of the two juveniles who shot the geese. When the warden contacted the juveniles' parents, he learned they had later returned to Naples and trespassed to retrieve a goose, but they still had not cleaned the goose 15 hours after they shot it. The warden issued citations and civil restitution.

Suspicious friends

A Henderson County game warden received a call from the Chandler Police Department stating a caller witnessed a person run over a white-tailed doe in a neighborhood, and then threw the deer carcass in the bed of his truck and sped off. Another caller informed the warden he had seen a doe in the bed of a truck with only the hindquarters missing. The warden found the truck with the doe in the bed and noted that the doe had been shot in the head. After questioning the homeowners where the truck was found, the warden realized they had no clue how the doe got in the bed of their truck, though they did say a friend of theirs had

stopped by late the previous night and then left in a hurry, which they thought was suspicious. Their description of their friend's truck matched the description of the truck the first caller had given the warden. Later that month, a local constable called the warden to tell him about a truck that matched the one he was looking for. When the warden interviewed the truck owner, the owner admitted to running over the doe for "free meat."

Looking for a dime but found a quarter

A Zavala County game warden walked into a dark camp one night and found an 11-point buck hanging from a skinning rack and a doe strapped over an ATV, both untagged. One of the hunters at the camp admitted to not purchasing a valid Texas hunting license. The warden noticed the hunter acting overly nervous and after a brief search of the hunter's ATV, the warden found a small container of marijua-na and a pipe, as well as a meth pipe and a baggie of crystal meth. Both deer were seized and the hunter was taken to the Zavala County jail and booked for misdemeanor and felony charges.




