Ballinger PD closes investigation with arrests

The Ballinger Police Department underwent some busy days last week as they saw a longtime investigation come to a close with the successful arrest of five individuals on drug charges.

On May 14 and 15, the Ballinger PD arrested those individuals, who were described as three males and two females, for the trafficking of methamphetamine.

'We received field indictments form the Grand Jury and we served the warrants last week," said Police Chief Mark McNulty. "We had no issues with the arrest and they all went smoothly."

The individuals, whose names are not

yet known due to the Runnels County Sheriff being unavailable Monday, were trafficking dealer and street amounts of

McNulty also added that while the arrests were a BPD operation, officers from the Runnels County Sheriff's Office also assisted in the arrests.

"We've been seeing more methamphetamine here in the area in recent years so we enlisted the help of some narcotic officers in assisting us," he said. "There was a lot of time and resources put into this, including undercover employment. We know that these arrests aren't all of the people we're looking for, but it's a

"I Deserve It"

The older son in the parable of the prodigal son had a problem of being self-righteous. (Luke 15) He felt he deserved more from his father than he had received. He was blinded to the fact that he would inherit everything that his father had. The joy that the father and others were expressing in the return of his younger brother led to an anger that blinded him to their joy. All he could see was the favoritism being shown to an undeserving sinner. Why did he feel he deserved more? He had stayed at the farm and worked. He didn't leave and waste money on harlots! He worked. He served. He was faithful! So, he felt he deserved more.

The parable Jesus told of the man hiring workers

throughout the day tells of those who labored all day long and they were paid the same as those who worked only an hour. (Matt. 20) They felt they deserved more. But the landowner was being fair to them and paid them their agreed upon wages.

A lady told me that she deserved something more than she had ever received from her father. I certainly could agree with her. Knowing the abuse she had received from his alcoholism, she certainly deserved better treatment. However, from her perspective it was just like the older son. She deserved it not because he should have done better. but because she was......

At the center of the Gospel message is the absolute truth that none of us

deserve the salvation God has provided through His beloved Son, Jesus Christ. Everyone has fallen short of God's glory. (Rom. 3:23)

We live in a day and age when it is extremely difficult for sinners to be lost (in our own minds and hearts). I think that 'human rights' have moved in and taken over. The older son knew he deserved something more. The workers felt cheated they didn't get something more.

It is the younger son who shows us the way. "He came to his senses". When he did, he begged for mercy. He said, "I have sinned against heaven and against you. I am not longer worthy...."

THE IDLE AMERICAN Irresistible Chocolate Chip Cookies...

Patrick Voith, an accomplished pilot who flies a sleek King Air 200 plane for M&F Western Products Co. in Sulphur Springs, would have COLUMNIST stumped the panel had he appeared on the old TV quiz show, What's My Line.

He could have claimed to be a "food taster" for Texas billionaire Ross Perot. OK, maybe that's a stretch, but he did share a cookie with the 1992 independent presidential candidate--the Texarkana native who founded mega-companies--Electronic Data Systems and later Perot Systems.

Perot, who will be 85 on June 27, ate the "other half of the cookie" on the occasion of his 81st-possibly 82nd—birthday. As The Sound of Music theme song suggests, we'd best start at the beginning—a very good place to start. **Background information** is critical to understanding how such an unlikely chain of events could link up so seamlessly....

Patrick's mom, Nancy Voith--now living in her hometown of Knoxville, TN--joined EDS in 1979. She rose to Director of Communications during her 28-year Dallas career, working closely with Perot in his business.

She returns to Dallas at every opportunity to visit Patrick, his wife Mandy and 15-month-old granddaughter Kennedy. Nancy was in Big D for Perot's aforementioned birthday. (She visits him on or near his birthday annually and typically takes him a birthday gift.)

Anyway, she purchased chocolate chip cookies at the La Madeleine restaurant, remembering how much Perot enjoys this rich dessert. Why not purchase three monster cookies, thought she, "fancying up" the La Madeleine cookie box with a birthday ribbon? A piece of cake, she figured..

The concept was strong, looked great on paper and could easily have worked. When she returned to her son's home, she placed the box on the kitchen table. She planned to add the ribbon later when she left for the party.

Soon, however, Patrick walked through the

kitchen. He is something of a "cookie monster," particularly when the marked box is a dead giveaway as to contents. The master of his house, he did what most TEXAS American males would do. Salivating, he lifted the lid,

ant cookies and was Newbury intoxicated by their grand aroma. Unadvised that the cookies were to be Perot's birthday gift, he showed considerable restraint, breaking off just one-half of one cookie.

Salivating liberally with each jaw movement, he slowly chewed each bite. Then he placed the lid back on the box and went on his way.... Later, his mom whipped

through the kitchen, attached a festive bow to the box and headed for Perot's office, the birthday cookie surprise in tow.

During the visit in his private office, Perot--like Patrick earlier--spotted the unmistakable La Madeleine box. He, too, salivated, and he, too, loved the aroma. As might be expected, he simply couldn't wait, asking, "What do you have for me there?"

Tearing the ribbon away, he spotted the half-cookie. Repeatedly, he alternated stares, first at the cookie, then at Nancy. He lifted the partial cookie from the box for her to see, then took a bite might near as big as the young pilot's chomp a few hours earlier....

For Nancy, as one might guess, time stopped. Immediately, she was 100% certain where the missing half of cookie had wound up. Then, she-in 50 shades of red-tried to explain what probably happened, as Perot continued to slowly eat the cookie, olooenjoying her momentary embarrassment. It all made for a good laugh before the visit was over.

It's a vignette often shared. Patrick's boss, M&F President Mickey Eddins, thrives on the re-telling, often at 25,000 feet, somewhere over the U.S. (Mickey and wife Linda have three sons, and they consider Patrick--a 2001 Richardson HS graduate and a 2005 graduate of Embry-Riddle Aeronautical University-to be a member of the family. He's been the M&F pilot for five

Nancy, who will have a grandson to visit come September when she's in Dallas, will likely wind up at other future Perot birthday observances. Count on her creative juices to flow freely when she shops for birthday gifts. There is little likelihood, though, that future presents will be edible. Perot and his "taster" will be the losers....

A: They can, but sharp turns are not common, he says. "Most tornadoes keep going along the same general path and any change of direction is slight," McRoberts adds. "When a tornado does make a change in direction, it is usually due to changes in the structure of the thunderstorm from which it was spawned. Perhaps the greatest example of a tornado staying on path was the famous Tri-State tornado of March, 1925. It stayed on roughly the same path for an amazing 219 miles, moving from southeast Missouri, crossing Illinois and heading on to southwest Indiana - the usual path of moving from the south to the northeast that most tornadoes make. It moved at 73 miles per hour, killed 695 people, destroyed 15,000 homes and damaged 164 square miles and was at times one mile in width.



VETERAN'S CORNER

The Court of Appeals for Veterans Claims has ruled that Navy veterans who served aboard ships in the harbors of Vietnam more than 40 years ago should not be arbitrarily excluded from Agent Orange claims—a significant step forward for these veterans. Navy veterans have been denied multiple disability claims by the Department of Veterans Affairs (VA) based on the fact that they were aboard a ship—not on land—during the Vietnam War, when the herbicide Agent Orange was liberally sprayed by American forces to remove foliage and eliminate enemy cover. The chemical was later found to cause a myraid of health problems for service members who were exposed, but the federal government has denied disability claims to U.S. Navy sailors under the argument that the seamen were offshore and were not directly exposed. Veteran's advocates have long sought recognition for these conditions. The VA now has a chance to restore the presumption of exposure to veterans who served aboard ships anchored in Da Nang and other harbors of Vietnam. The VA will probably appeal this decision, and Congress has not yet acted on Agent Orange/Blue Water legislation, but hopefully for thousands of Vietnam veterans, they will soon. TxDOT warns drivers to buckle up as law enforcement tickets drivers for seat belt violations

AUSTIN -The Texas Department of Transportation reminds drivers that law enforcement officers across the state will be out in full force May 18-31 issuing tickets to drivers and passengers who are not wearing seat belts. Widely known as TxDOT's annual "Click It or Ticket" campaign, the two-week enforcement period reminds all vehicle occupants that non-compliance with statewide seat belt and child safety seat laws can result in fines up to

"We greatly appreciate the stepped-up efforts of our law enforcement partners during 'Click It or Ticket,' because we know seat belts save lives," said John Barton, TxDOT deputy executive director. "I can't imagine why anyone would risk getting pulled over and ticketed, let alone killed or injured. It only takes a few seconds to make sure everyone in your vehicle is buckled up. Do it for yourself and your loved ones, or else risk being fined or even losing a loved one."

Texas law requires drivers and all passengers, including those in the back seat, to wear a seat belt or risk a ticket, fines and court costs up to \$200 each. Children younger than 8 years old

must be in a child safety seat or booster seat unless they are taller than 4 feet 9 inches. Fines issued to drivers for unrestrained children in their vehicle can be as high as \$250 plus court costs.

Wearing a seat belt helps keep occupants from being ejected in a crash and increases the chances of surviving by 45 percent. In pickup trucks, that number jumps to 60 percent, as those vehicles are twice as likely as cars to roll over in a crash.

Last year, 2,587 vehicle crashes occurred in Texas in which unrestrained vehicle occupants sustained fatal or serious injuries.

Of the more than 3,500 motorists killed in traffic crashes in Texas last year, 44 percent were not wearing a seat belt at the time of the crash.




