Winters ISD board adopts budget

District looking at deficit again this year

The past several school years have shown significant declines in enrollment at all three campuses of the Winters Independent School District and for that reason, the recently approved 2016-17 budget, which was effective July 1, shows a shortfall.

The WISD Board of

Trustees approved a \$5,749,821 budget for the 2016-17 school year on Monday, June 27. Due to enrollment declines, and a decrease in property taxes, the district is showing a deficit of a little over \$100,000.

Superintendent Bruce Davis said the lion's share of the deficit comes from a shortage of state funding due to lower

Hot and dry conditions have been the norm so far in July with temperatures reaching the century mark and over in Runnels County, forecasters at the National Weather Service in San Angelo reported.

No rain was reported last week in Runnels County or Tom Green counties. However there were spotty showers in some areas north of Runnels. There is no chance of rain in the forecast, just more hot and dry weather.

Hot and dry weather continues through the weekend forecasters say with highs reaching over 100 degrees. Lows are expected to be in the upper 70s, the NWS reports. The heat index through out the week could reach as high as 104 the NWS predicts. And triple digit temperatures are in the forecast through Thursday, the National Weather Service says.

So far this year, Ballinger has received 17.56 inches of rainfall, with 16.71 inches reported in Wingate and 22.65 inches received in San Angelo.

Ballots in the mail for sheep and goat predator management board

SAN ANGELO — The Sheep and Goat Predator Management Board will mail ballots this week to elect three producers to represent sheep and goat raisers in its 111-county area. In addition there will be a vote to set the refundable assessment to \$.90 per head. Ballots must be returned to the Board office by the midnight July 29 deadline.

All sheep and goat raisers who reside in one of the three districts are eligible to vote in the upcoming election. The Texas Commodity Referendum Law, which governs the producer board, requires biennial elections. Ballots must bear the signature and address of the voter, and indicate production totals.

Sheep and goat producers nominated for the three open positions on the nine-member board are: District 1: WILL M. BLACK; District 2: JASON BANNOWSKY; District 3: ROBIN GILES. These producers completed a nomination form with ten qualified sheep and/or goat producers supporting their nomination, and returned the completed form by the July 4, 2016 deadline. They will each serve a six-year term.

SAN ANGELO — United Blood Services of San Angelo has issued an emergency critical appeal for blood of all types. The nation's blood supply is facing significantly low inven-tory levels. "Typically we count on other blood centers to help, but this critical need is occurring throughout the country," said Linda Grace, senior donor recruitment representative.

Every two seconds, someone in the US needs blood. It is indispensable and required in the treatment of millions of patients including individuals with cancer and other life threatening diseases, as well as patients undergoing organ transplants and trauma victims.

Grace said summer is always a challenge for us to maintain an adequate supply of blood on hand due to donors taking vacation, schools being out and due to Zika virus deferrals. Despite the season, the need for blood remains constant and patients continue to depend on the generosity of volunteer blood donors to meet that need. All blood types are needed.

Justice will be served, but justice is small solace for the families left behind.


We mourn for the families of the fallen, for the law enforcement community and for our nation.

Today we update the price action and examine how the industry is coping with reduced prices.


Noted market technician John Murphy advocates using exponential moving averages EMA of 13 and 34 periods. The judicious use of those measures has quite accurately tracked the decline and then rises in the crude oil market.

Weekly charts are much more important for long term price action than short term charts. The 13week EMA dropped below the 34 EMA in the summer of 2014. I was warning of a drop then. Importantly the 13-week EMA stayed below the 34 week EMA ever since that date. As the price rose from the February low, the shorter EMA finally crossed to the upside in early May. Now the 13 week EMA is rolling over again. This sets up another test of the longer 34 week EMA. Should the 13-week EMA break below the 34, this would be a very negative sign. That would suggest that the final low in fact has not yet been seen.

House passes POLICE Act, heads to President's desk

WASHINGTON - U.S. Senator John Cornyn (R-TX) and U.S. Representative John Carter (R-TX) released the following statements after the U.S. House of Representatives passed the POLICE Act, legislation that will allow law enforcement and medical personnel to use federal grant funds to train


and better prepare for active shooter situations, including training civilians how to respond if confronted by an active shooter:

"We were tragically reminded last week that an active shooter situation can happen anywhere, any time. Allowing local officials to apply existing grant funding to train our law enforcement and first responders will not

only better prepare our communities for whatever comes their way, it could help stop future tragedies," Sen. Cornyn said. "I commend Congressman Carter for his work in getting this legislation through the House, and I hope to see it become law soon.'

days to attack meat as a carbongenerating threat to the environment. Cows, and people, do pass gas. As with all mammals, this natural activity produces methane, a greenhouse gas.

The staggering majority of greenhouse gases are due to internal combustion engines and manufacturing. Some think that if we stop raising livestock, we can use all that land to grow kale and bean sprouts.

The thing is, on much of this land, grass is about all that will most of their lives. Some are finished with grain in feedlots. With livestock, we harvest grass for human consumption.

Then there is the misleading fact that cattle consume a lot of water. Do you really think that rainfall captured in Throckmorton, Texas to water livestock affects water supplies in Southern California? Really? I don't either. **Regional droughts and rainfall** patterns are part of the story. Eating meat is a choice-free of

climate guilt.







VETERANS CORNER

VA's Airborne Hazards and Open Burn Pit Registry allows eligible Veterans and Service members to document their exposures and report health concerns through an online questionnaire. Eligible veterans and Service members include those who served in Operation Enduring Freedom/Operation Iraqi Freedom/Operation New Dawn, Djibouti, Africa on or after September 11, 2001, Operations Desert Shield or Desert Storm, Southwest Asia theater of operations on or

after August 2, 1990. In total, 61,338 veterans and Service mem-

bers completed and submitted the registry question-

naire between April 25, 2014 and February 28, 2016.

Sandra G. Van Zant Check your eligibility and sign up. It takes about 40 minutes to complete the questionnaire. You can do it in one sitting or save it and come back later. You can print and use your completed questionnaire to discuss concerns with your provider. VA providers can also access an online copy of your questionnaire. There is no cost to participate, it is not a disability compensation questionnaire or required for other VA benefits. You can complete the questionnaire at http://www.publichealth.va.gov/exposures/burnpits/registry. "Our department will provide any law enforcement resources and support needed to assist the City of Dallas in the wake of this reprehensible attack."

Overnight and into the morning, DPS has provided assistance on scene, including perimeter support, aerial support and evidence collection. The department is also sending DPS counselors to provide victim services support for our law enforcement partners.



"Although hot conditions are expected during Texas summers, we want to remind Texans that high temperatures can be deadly and should not be taken lightly," said DPS Director Steven McCraw. "In many cases heatrelated deaths and injuries are preventable, and DPS urges residents to take the necessary steps to protect themselves and others against extreme temperatures – whether they plan to be outside or indoors."

if left unattended in a vehicle. Every year children die from heatrelated injuries after being left in a vehicle or by entering a vehicle unnoticed. A child should never be left unattended in a vehicle. Temperatures inside a

car can rise more than 20 degrees in only 10 minutes; and even with an outside temperature of 60 degrees, the temperature inside a car can reach 110 degrees, according to the National Highway Traffic help. Young children are particularly at risk since their bodies heat up faster than an adult.

According to the Center for Disease Control and Prevention (CDC), extreme heat events or heat waves are one of the leading causes of extreme weather-related deaths in the United States. Periods of severe heat and high humidity tax the body's ability to cool itself and can lead to heat exhaustion and heat stroke, which can sick or very young, especially if they don't have air conditioning.

Drink plenty of water and avoid caffeine and alcohol during prolonged outdoor exposure. Start consuming water before you head outdoors; you may not realize you're dehydrated until it's too late.

■ Pay attention to your body. Heat exhaustion and heat stroke can develop quickly. If you start feeling ill, immediately find a shaded or cooler area and slowly drink fluids. Seek medical attention if necessary.

Monitor weather radios and newscasts for information on current conditions and weather alerts in your area.

• Stay indoors as much as possible, and limit exposure to the sun. Consider indoor activities this summer at places like shopping malls, the library or other community facilities.

■ Light-colored, loosefitting clothing and a hat are recommended during outdoor exposure.


■ If possible, avoid strenuous outdoor activity during the hottest part of the day.

Be extra careful when cooking outdoors, building campfires or driving off road to avoid igniting dry vegetation. Also, stay aware of burn bans in your area and always abide by restrictions on outside burning.


I think of her every time I take "one more chance" on placing on-line orders, not so much because of errors in placement or delivery, but because I know I'm being spied on....

Mobile site offers convenience to child support customers 80 percent of parents access their information from mobile devices

AUSTIN - Attorney General Ken Paxton today announced the availability of a mobile site for parents to obtain information about their child support cases. The mobile-friendly version of Child Support Interactive (CSI) provides added convenience to parents who use smartphones and tablets to browse the web.

Attorney General Paxton said, "The Office of the Attorney General is committed to provid-

ing excellent customer service to mothers and fathers who pay and receive child support. I am pleased that CSI Mobile is available because it will provide more convenience to the families we serve.

Parents with OAG child support cases can obtain payment and case information from CSI located on a secure section of the agency's website at www.texasattorneygeneral.gov . CSI Mobile offers the most requested information in a format that is easy to access and read on portable devices.

Customers can view payments, balances, case status and pending legal actions from CSI Mobile. They also can generate and view payment records and income verification forms, which custodial parents need when applying for day care and housing assistance. Customers visiting CSI from a smartphone or tablet

are automatically directed to the mobile version. The direct link to CSI Mobile is m.childsupport.oag.state. tx.us . Mobile customers who require more detailed information can access the desktop version of CSI from all devices. According to the latest statistics, 80 percent of child support customers view their case information from a mobile device.

Under state and federal law, the Office of the Attorney General can assist families who request child support services and must serve families who currently receive or have received public assistance. Services offered by the Child Support Division include locating absent parents; establishing paternity for children born to unmarried parents; establishing, enforcing and modifying child and medical support orders; and collecting and distributing child support payments.

Statewide, child support collected by the Attorney General's Office exceeded \$3.9 billion for the state fiscal year that ended Aug. 31.

TEXAS HISTORY MINUTE

Governor Campbell was for progress


At the beginning of the twentieth century, Texas was moving ahead. The spirit of reform was in the air as the people demanded accountability from business and government alike. Gov. Thomas M. Campbell, who served from 1907-1911 dedicated himself to progress for the people.

Thomas Mitchell Campbell was born in Rusk is East Texas in 1856. His father was a farmer who had moved from Georgia. His father was a respected member of the community who served as Longview's first mayor in 1871 and later as a justice of the peace and Gregg County sheriff. As a young man, Campbell was also friends with James Stephen Hogg, another future Texas governor.

In 1873, Campbell enrolled at Trinity University with hopes of becoming a lawyer. However, he struggled with being able to afford his tuition and dropped out. He continued to study the law informally and was admitted to the state bar in 1878. That same year, he also married and started his own law office in Longview.

In 1889, he became the attorney for the troubled International-Great Northern Railroad. He guided the line through bankruptcy and later moved to Palestine to serve as its general manager. He resigned from the railroad in 1897 and moved into politics.

In 1906, at his old friend James S. Hogg's urging, Campbell ran for governor, his first run for any office. After a bitter campaign, Campbell won the Democratic



In 1909, he announced to the state that because of the state's new prop-

erty assessment policies, Texas enjoyed a budget surplus of nearly \$900,000. The total appraised value of Texas properties topped \$1 billion for the first time. This also allowed school funding to rise by more than half to \$9.4 million and allowed schools to adopt calendars longer than a six-month school year and also increase per-student spending by a third.

Campbell called two special sessions that year to force the legislature to act on reform measures. Legislators fought and argued, with several having to be escorted out of the House of Representatives. Eventually, they passed measures forcing railroads to be held liable for employee injuries on the job and strengthened state antitrust laws. The legislature also strengthened alcohol regulations and organized a standard ballot for all local option wet-dry elections. After fierce debate, the state mandated that banks had to guarantee the safety of customer deposits, either using a state protection fund or a bond system. For the first time, Texas bank customers would not necessarily lose their savings if the bank were robbed or failed.

And for the first time, the legislature approved funding to bring electricity and modern plumbing into state-owned buildings. Many Texas communities already had electricity, but installation in government buildings lagged far behind. As a result of the bill, even the governor's mansion received electricity for the first time.

Several new regulatory agencies came into being under Campbell's leadership. The Department of Insurance and Banking was created to regulate the practices of those industries in the state. The Bureau of Labor Statistics was created to gather information on employment and wages. A new Texas State Board of Health was created in 1909 as well as the Texas State Library and Historical Commission to preserve state records and artifacts for future generations.

Campbell left office in 1911.

He made one last attempt at elected office, losing a primary race for US Senate against incumbent Sen. Charles A. Culberson. Campbell spent his last years as a lawyer in Palestine and working behind the scenes in Democratic politics until his death in 1923.



enrollment, which is based on average daily attendance, which is expected to be about 509 students down from 600 average daily attendance in 2014.

"It's happened over the last three years," Davis said. "We have to make adjustments."

Even though student numbers and property taxes are down, the trustees did not raise the property taxes during this budgeting cycle. The property tax rate remained at \$1.04 per \$100 valuation.

"It's been 12 years since we raised the tax rate," Davis said.

The district has seen significant declines since the loss of manufacturing and oilfield jobs and a decrease in oil production in the area.

This year, the trustees decided not to fill some positions left vacant through professional and non professional staff either resigning or retiring.

"We had some attrition this year," Davis said.

on the students who want to transfer to Winters ISD.

Students must have passing grades from their previous school and have no discipline issues. Students must also be up to date on their STAAR testing.

"We are looking for people coming to contribute to what we do," Davis said. Davis added that the district will not

fund a bus route to pick up students outside the district, but parents may leave their children at a designated Winters bus stop for pick up.

Davis touted the positive aspects of Winters ISD, such as the 100 percent graduation of seniors this year and the dual credit classes offered through Cisco Junior College that allow students to get as much as 30 hours of college credit before they graduate from high school. In addition, classes are smaller than at larger schools.

"Diversification in our enrollment will not hurt us," Davis said. "It will be healthy for our school."

But, if enrollment numbers continue to decline, Davis said the district will have no choice but to cut professional and non-professional staff. In addition, he said the board will be considering consolidating the schools by having two

The first movie also set in Winters and considered a cult classic, starred Bonnie Bedelia as Latrelle Williamson, Olivia Newton-John as Bitsy, Beau Bridges as G. W. Nethercott, Beth Grant as Sissy and Delta Burke as Noleta Nethercott and Leslie Jordan as Earl "Brother Boy" Ingram. "Sordid Lives" tells the tale of a color-

ful family from a small Texas town must come to grips with the accidental death of the elderly family matriarch during a clandestine meeting in a seedy motel room with her much younger, married neighbor. The woman's family must deal with their own demons while preparing for what could be an embarrassing funeral.

Shores says that he is proud to be from a small rural West Texas town and that has been an inspiration in almost all of his writing and projects. Even, "Daddy's Dyin' Who's Got the Will," was set in the area – first in Winters, but the movie was eventually set in Lowake.

"A Very Sordid Wedding," was actually filmed in Selkirk, Winnepeg, Manitoba Canada and picks up 16 years after the events of the first film and deals with the impact of the advancement of same-sex marriage in the conservative, southern community. Several actors from the original Sordid Lives film are reprising their roles, including Bonnie Bedelia, Leslie Jordan, Newell Alexander, Sarah Hunley, Rosemary Alexander, Ann Walker and Kirk Geiger. Joining them from the Sordid Lives series are David Steen, David Cowgill and Caroline Rhea. Shores also announced that several new actors would be joining the returning performers. In Spring 2015, Whoopi Goldberg was added to the cast as Ty's mother in-law.

Shores wanted to get all the details right – not just the cast of characters, but the location. As it turned out, Selkirk, Winnepeg, was a dead ringer for Win-ters, from the convenience store, to Main Street to the little country Baptist church and even down to a news stand filled with issues of the Winters Enterprise – the set was carefully planned.

"It was a place in Winnepeg where it is so amazingly cheap to shoot there, we got a great deal the town looked like Winters when I saw that downtown, I said where is Heidenheimer's? Shores laughed.

Shores said he decided to do the sequel after the U.S. Supreme Court handed down the decision approving same sex marriage and he hopes that with a little bit of laughter, he can send a more serious message of acceptance, equality and love.

"Here's the deal - the movie is about what happens when equality comes storming in to rural Texas," Shores ex-plained. "I don't think anyone should be discriminated against – that is the kind of hypocrisy I wanted to point out. I did it to make people think – I want them to think and love a little bit more."

Shores raised the funds for the independent via an Indiegogo campaign. Film-ing wrapped in Canada about a month ago, and the final scenes are being filmed in Dallas. The film, owned by Beard Collins Shores Productions, is set to be released by the end of the year.

'We already have several people who are asking to distribute the film," Shores said. "We are blessed with abundance."

Shores said, he never thought he would return to make a sequel to "Sordid Lives," because of legal battles with the television show that followed the movie.

"It was just a nightmare," Shores said. But after going on tour with his standup comedy, he found out how much the characters were loved.

"I wanted to see what happened to the characters and how they had evolved and when the Suprene Court decision was handed down, then we really wanted to tackle that subject matter because it is near and dear to my heart," he said.
