Computers Give New Dimmension to Farming, Ranching

Computers are no longer strangers to the agricultural industry. They offer a new dimension in arillo. farming and ranching that can help producers obtain more accurate information on which to base management decisions.

To give producers, agricultural est in computers in agriculture, leaders and others a better understanding of the role of computers and their actual application, the Texas Agricultural Extension Service, Texas A&M University System, will be conducting a special computer workshop September 23-24 at the Civic Center in Lubbock.

The workshop on "Computers in Farm and Ranch Management" is designed to provide an introduction to several different computer systems available today, points out Dr. Wayne Hayenga, economist in management with the Extension Service.

"Participants will have an opportunity to get some 'actual' experience by operating several different computer programs," says Hayenga. "Everyone attending should have time to run a computer using his own farm or ranch data. This will be a true 'hands-on' workshop."

First day of the workshop will feature discussions on various computer systems, their role in agriculture, how to select one, available programs, and farmer experiences with computers.

Four "work" sessions will round out the workshop the next morning. These will deal with micro farm accounting systems, livestock management decision aids, crop management decision aids, and financial projections and pricing aids.

Speakers and resource personnel during the two-day workshop include Extension economists and several farmers and ranchers who will talk about how they use computers in their operations





Law Changed Some

State Comptroller Bob Bullock said persons and businesses who buy and sell items subject to the state's sales and use tax should be aware of changes in the law that are now in effect.

He said persons who have issued a resale certificate or an exemption certificate to acquire an item can now donate the item to a non-profit charity, religious or educational organization and not be liable for the sales tax on the item.

"This means a merchant can take items from inventory and give them to any organization that's exempt from the sales tax and the merchant doesn't have to report the gifts as taxable purchases when they file their sales tax return," Bullock said.

Bullock pointed out that the Legislature expanded the categories of organizations that qualify for an exemption from sales tax if they are exempted from federal taxes by the Internal Revenue Service.



PROPOSITION NO. 6 above the spending limit provided by Article VIII, **ON THE BALLOT** Section 22, of the Texas

House Joint Resolution 81 authorizes the governing body of a county, city, school district or other political subdivisions to exempt from taxation a portion of the market a residence value of homestead. The portion exempted may be as much as 40% for 1982-1984: 30% for 1985-1987: and 20% for 1988 and af. ter. The amount of an exemption may not be less than \$5.000 unless the legislature by general law prescribes other monetary restrictions on the amount of the exemption. An eligible adult is allowed to receive other applicable exemptions provided by law. An exception is made where ad valorem tax has previously been pledged for the payment of debt. The amendment further directs the legislature to require that notice be given to property owners of a reasonable estimate of tax on their property in certain situations.

The person and his predecessors in interest must have continuously claimed the land and paid the

House Joint Resolution 38 proposes a constitutional amendment that would enable the legislature to grant to a state finance management committee the authority to manage state funds. Funds constitutionally dedicated to specific purposes would not be subject to committee management. The committee would be composed of the Governor, Lieutenant Governor, Speaker of the House of Representatives, Chairman of the Senate Finance Committee, Chairman of the House Appropriations Committee, Chairman of the Senate State Affairs Committee, and the Chairman






