The way I understand it, the operator had planned to try to develop the upper strata, but problems with the casing forced abandonment of the well. It may be that the company will either try a new wildcat or vacate the lease within the near future.

It is understood that the wildcat on the north side of Tule Canyon on the Cogdell ranch has been drilling in an oil formation this week. Let's hope that this will be Briscoe County's second producing well!

Speaking of wildcats: this is a completely different subject. During the Fourth of July

holiday weekend, we were exploring around the top of one of the deep canyons at Lake Mackenzie, and just happened to spot a bobcat walking along a ledge far below us. As we continued to watch its progress, another came into view and followed the other a few feet along the ledge and out of sight in the undergrowth. They didn't seem to be aware of our presence, and it was such a surprise to us that we could hardly believe it.

Later, when we were at Cactus Cove we mentioned this to Steve Cole, who said that these animals had been mentioned to him before by others who had seen them.

There are goats on the two larger islands in Lake Mackenzie, and when we pass by in the boat we almost always see them. We can't keep from wishing that someone had put some aoudads on the islands so people could see them in a natural-type environment. So many never see them. It's been quite a while now since we've seen any of them. For a while we saw them often along the canyon rim in Tule Canyon, but as far as I can tell, they haven't come to that grazing place for the past two summers.

Also, because of the stability of our government, many foreigners are going to be looking at the U.S. for a relatively safe investment. But, Moeller warned, they may not always have the best interest of the local people or this country in mind when they take conrol of the property.

According to the TFU, control of natural resources such as farmland should remain in the hands of residents who have a vested interest in seeing the land protected and carefully used for production. Also, the vast ma-
