# Delinquent Tax Collections Are Subject Of Meeting

The board of directors of the Briscoe County Tax Appraisal District met April 14 to hear information presented regarding delinquent tax collections.

Present for the meeting were directors, L. B. Garvin, jr., Don Burson, Ray Teeple and Stan Fogerson, Mrs. Carlye Hill, chief appraiser, Larry Brandon and Brent Sherrod.

Chairman Garvin called the meeting to order and Secretary Teeple read the minutes of the last regular meeting and of a called meeting, which were approved by the board.

Mr. Brandon, attorney with the firm of Perdue, Brandon, Blair & Fielder, met with the board to give a progress report on delinquent tax collections. The appraisal district contracts with this firm for delinquent tax collections for Briscoe County, Silverton ISD, City of Silverton and Mackenzie Water Authority.

Mr. Brandon reported that on that day they were filing 14 individual tax suits in District Court and six tax suits in Justice Court. There are several others that are being worked up at this time. They also are filing "cleanup" suits in district court which affect 17 tracts of land located within the city limits.

The board had several pertinent questions concerning policies, procedures, etc., and a lengthly discussion followed. Mr. Brandon offered several recommendations.

Mrs. Hill read the financial report and noted that March collections include Briscoe County, 91%; Silverton ISD, 91.2%; City of Silverton, 80.7%, and Mackenzie Water Authority, 81.6%.

Burson stated that he would contact the bank again concerning the NOW accounts, and the board will act accordingly at a later date.

Secretary Teeple reported that he received the approved County Contract for Assessment and Collection Services in 1983. A copy of the contract is on file in the Appraisal District Office.

Murry Wayne Morrison was chosen to serve on the 1983 Board of Review, with Pete Blankenship chosen as an alternate.

# Clocks Move Ahead Sunday Morning

Daylight saving time begins Sunday.

The time change, mandated by law, requires that clocks be set forward an hour at 2:00 a.m. local time on the last Sunday in April, and set back an hour to standard time at 2:00 a.m. local time on the final Sunday in October.

Remember the addage "spring forward, fall back" when you reset your clock.

Not everyone in the United States observes the practice.

Hawaii, Arizona, the eastern time zone part of Indiana, Puerto Rico, the Virgin Islands and American Samoa are excluded from having to make the change.

A move in Congress to expand the amount of time devoted to daylight saving time was unsuccessful last year, but it was revived this year and so far has gotten as far as clearing a House Energy and Commerce subcom-



mittee

The proposal would provide an equal amount of daylight saving time on either side of the summer solstice, the first day of summer, by making it start on the first Sunday in March, two months earlier than it now begins. That would provide eight months of daylight-saving time and just four of standard time.





# **Home Canning Safety Changes**

The United States Department of Agriculture this week released new processing recommendations for tomatoes and tomato juice, applesauce, fruit purees and pumpkin.

To prevent food borne illness and the loss of valuable home canned foods, specialists with the Texas Agricultural Extension Service are urging home canners to follow the new USDA guide-

The USDA now recommends the following:

\*The one-step, cold pack method for canning tomatoes should no longer be used.

\*The hot pack processing time for canning tomatoes should be increased to 35 minutes for pint jars and No. 2 cans, and to 45 minutes for quart jars and No. 21/2 cans.

\*The hot-pack processing time for canning tomato juice should be increased to 35 minutes for pint and quart jars, and for No. 2 and 21/2 cans.

\*Strained (pureed) pumpkin and winter squash should not be

canned at home. Instead, cubed pumpkin and squash may be canned using a processing time of 55 minutes for pint jars and 90 minutes for quart jars.

\*The processing times for applesauce and fruit puree should be increased to 20 minutes for pints, quarts, No 2 and 21/2 cans.

According to Marilyn Haggard, a foods and nutrition specialist with the Extension Service, the changes in canning recommendations are based on research conducted at land-grant universities and the Eastern Regional Research Center of the

"The recommendation to more than triple hot-pack processing times for tomatoes was based on research which indicated that shorter times could be insufficient under certain conditions,' says Ms. Haggard. Insufficient processing could allow botulism organisms to survive the heat treatment, grow and produce harmful toxins, she explains.

"We consider this especially

resistance of a particular mold led the USDA to recommend increased processing times for applesauce and fruit purees. They also recommend that strained (pureed) pumpkin and winter squash no longer be canned at home for the same reason.

"Those wishing to have strained (pureed) pumpkin or winter squash ready for making pies or casseroles should consider freezing the puree instead," says Ms. Haggard.



#### **FEEDING GARBAGE** TO TEXAS SWINE


Food waste to be fed to swine in Texas should be treated properly before feeding to prevent disease problems, says a swine veterinarian with the Texas Agricultural Extension Service, Texas A&M University System.

Regulations prohibit the feeding of garbage to swine unless heat treated at a licensed facility. Treatment consists of boiling food waste for at least 30 minutes. Food waste from ordinary household operations fed to swine on the same premises is exempt.

#### **COIN TELEPHONE USERS FACE CHANGE**

As of April 1, 1983, coin telephone users wanting to charge a long distance call to a third number will be subject to having the charges approved by someone at the third number.

The verification procedure is being initiated to help eliminate fradulent billing of long distance calls and ensure customer protection from having unauthorized charges appear on their monthly

statements.

Under the new procedure, if an individual at the third number does not answer and approve the charges, the caller will be asked to provide alternate billing, such as another third number that will approve the charges, a valid calling card, a collect call or correct change to pay for the call.

Jimmy Bennett, General Telephone Operations Manager in Memphis, said, "Customers who frequently use public coin telephone facilities for third number billing may find that the calling card may represent an attractive alternative. Besides being faster and more convenient than the third number and collect calls, most calling card calls are cheaper." In a growing number of locations, customers can direct dial calling card calls without operator assistance from public telephones. The calling card also provides the customer with a printed monthly statement of long distance calls placed.

Customers can call their local telephone business office to obtain a calling card. There is no charge for the card.

**CONSUMERS MAY BE UNAWARE OF HAZARDS** 

"Consumers are often unaware of the hazards of electrical appliances," says Nancy Granovsky, a family resource management specialist with the Texas Agricultural Extension Service, Texas A&M University System.

To avoid potential danger, the Association of Home Appliance Manufacturers (AHAM) and Underwriters Laboratories (UL) now warn consumers to always unplug any small electrical appliances after using them, says Granovsky.

Don't assume that if the switch is "off" there's no danger of electrocution. This may not be true if the product comes into contact with water.

Electrocutions may occur in kitchens, bathrooms or outdoors -anywhere near water sources.

Never use any electrical product while bathing or put it where it can drop or be pulled into the tub or sink. If the appliance accidentally falls into the water, don't reach into the water for it. Unplug it immediately at the wall outlet.

Never leave a small portable electrical appliance within the reach of small children. Children left unattended could pull the plugged-in, but switched-off appliance into the tub or sink and risk being electrocuted.

According to Granovsky, the Texas Agricultural Extension Service is cooperating with the AHAM and UL in their nationwide effort to promote product safety.

Without this grounding in the love of God, no government or society or way of life will long persevere and the freedoms which we hold so dear will inevitably perish. Therefore, even from a selfish point of view, one should support the Church for the sake of the welfare of himself and his family. Beyond that, however, every person should uphold and participate in the Church because it tells the truth about man's life, death and destiny; the truth which alone will set him free to live as a child of God.
