The Commissioners' Court of Wheeler County, Texas, met in regular sessions on Monday, August 10, 2020, at 9:00 a.m., in the Commissioners' Courtroom of the Wheeler County Courthouse at 401 Main Street, Wheeler, Texas, to consider prior bills and discuss matters of mutual concerns.

At 9:00 a.m. Wendy Hazard and Tommy Meek, Tex-

At 10:00 a.m. Court reconvened to address the 21 items on the agenda.

The minutes of previous meetings were approved as read.

The reports of the County Officers were accepted.

There were no Budget Amendments to be consid-

Two Budget Transfers were approved.

Several Line Item Transfers were approved by the court.

There were no Wheeler County Policy Manual changes to be considered.

No action was taken on the Burn Ban.

Judge Hefley presented the Wheeler County Historical Commission with the 2019

Distinguished Service Award. Only 26 of these awards were presented out of the 254 county in Texas.

County Treasurer Renee Warren presented Judge Hefley with Texas Association of Counties Risk Management Pool Zero Lost Time Award for 2019. Wheeler County lost no time due to accident in the year 2019.

The court voted to allow county employees under the county's insurance policy to


add or subtract dependents from their coverage and/or the deductible.



2020 PGCD Scholarship Winner

In 2002, Panhandle Groundwater Conservation District (PGCD) established a scholarship program for graduating seniors throughout the District. The applicants are required to write a 500-1000 word essay on a topic chosen by PGCD and to enroll as a fulltime student at the college of their choice the fall semester immediately following selection. Also they must maintain at least a 2.5 college GPA. A committee of three board members and a staff member select the winners.

The student awarded first place receives a \$4,000 scholarship second place receives \$3,000 and third place

Marshall's Dedication Runs Deeper Than Wheeler Mustang Football

Marshall's 2019 season—Yards: 2,521; Carries: 234; TDs: 30; YPC: 10.7

Wheeler's main Mustang Hesston Marshall galloped for a Texas Panhandle-best 2,521 yards rushing, while leading his team in every offensive category during an incredible junior year in 2019.

He left every opposing coach scratching his head after ball games on Friday night however, when talking to the soft spoken, humble, explosive running back, his favorite number from last season was 10.

That's the number of wins Wheeler racked up on the way to a Class 2A Division II regional round finish.

"I'm all about wins," said Marshall, who added 346 yards receiving with another two scores last year. "That's my main concern. We're a team, and I can't run without an offensive line. I can't make all the tackles. There's 11 guys on the field and we all have one goal. That is winning, and I love doing that most."

That selfless attitude goes well beyond the field for the senior-to-be. Not only is he the ultimate teammate in any sport he plays, but he's the ultimate teammate for the Wheeler community.

Marshall bleeds black and gold. His dad, Mark, and his uncle Mack, played for great Wheeler teams of the 1990's.

For the past two years Marshall, who will turn 18 years old at the end of this month,

has followed in his family's footsteps serving on the volunteer fire department.

• The court approved a contract with Grant Works for TXDOT's CTIF Program.

• The Resolution to adopt TXDOT's "Standard Specifications for Construction and Maintenance of Highways, Streets and Bridges (November 2014)" and "Roadway Design Manual (July 2020)" for projects under this program.

• The court adopted the Proposed Tax Rate for 2020-21 at 0.52316; the same as last 2019-20.

• The bills in the amount of \$163,641.38 were paid by the court for the period 07/23/2020 to 08/06/2020.

"I've been a volunteer fireman for two years," Marshall said. "I started when I was 16 years old. My dad (Mark) has been on the volunteer fire department for 25 years, and my brother (Urrick) has been on there for six years now. My grandpa (Darrel) was a firefighter and his dad was a fire chief. It's a family tradition."

Marshall has an app on his phone, and is alerted when he needs to go on a fire call. Even as recent as a month ago, he said he's had to deal with some pretty intense situations.

"We've had some crazy fires," Marshall said. "Last month there was a wild fire over in Kelton. It burned a big section of land, probably over 600 acres. It took us about three hours to get it under control because the wind kept going different directions. Those aren't the funnest to be around but it's what we do."

Wheeler head coach Chris Evans uses Marshall as an example when talking about character, discipline and being a perfect teammate. Evans said it's the Wheeler upbringing that has made Marshall the upstanding young man he has become.

"This community means a lot to Hesston and his family," said Evans, who is 24-14 entering his fourth year as Wheeler's head coach. "It's not just Mustang football or basketball, but his dad (Mark) is on the school board, and they are all volunteer firemen."

to a 2015 strategic planning meeting facilitated by the Panhandle Plains Regional Planning Commission (PPRC) to help identify the needs facing our community and to develop the goals and objectives to accomplish these needs.

The necessity, planning and process to set up this meeting was reported in our EDC minutes for several months prior to the meeting itself. These minutes are published by you in the Wheeler Times, as are all EDC and City Council minutes.

The results of the strategic planning meeting and the progress in setting and achieving the goals set from the meeting have been regular discussion points in EDC meetings and minutes. Which again, you publish in the paper.

My question to you is, in reporting on EDC and City Council meetings regarding this 5 plus, yearlong project, if you had questions or concerns why wait until the work has begun to voice those concerns?

You mention in your caption that Xcel could straighten the poles, or a local contractor could replace sidewalks. You apparently see the need for these upgrades and repairs, but what have you done to call attention to the need other than a single critical headline?

You criticize the use of taxpayer monies to repair the sidewalks, but have you done the research as to how many feet of sidewalk need to be repaired? And how many feet of repairs and upgrades sales tax money would actually pay versus the amount of money the grant is paying for? There are strict guidelines for use of

sales tax money, and we do our best to leverage every dollar, in this case, we knew that we could get a significant amount of the work paid for using the CDBG (grant) and EDC is responsible for a 30% match. Without the grant, this project would not be happening.

I believe I can speak for all the people who serve on these boards, such as EDC and City Council, we do not offer our time and efforts for self-promotion. We are working to make Wheeler a better community. We strive to be good stewards with what we have been blessed with. If you do not believe that we, as board members and elected officials, are not doing the best job possible, then I challenge you to step up and become involved. Put your money where your mouth is, so to speak, and not sit back and idly criticize the hard work and efforts these people have made with inflammatory headlines after the fact.

Facts:
o "City Council" approved EDC funds, which is collected from local sales tax dollars.

o "all this money" EDC agreed to a 30% matching of the total grant(s), not the full cost of the project. The CDBG (grants) are only available to those that apply, otherwise the grant money goes elsewhere.
o "a local contractor" the

bids were open to locals; if going at it individually, the individual business would have to pay for it themselves as well as get permission from TX Dot and the city VER-SUS with the grant, none of the businesses are paying directly for the sidewalk improvements, the project gives cohesive look to the entire block, the project follows ADA guidelines, and a lengthy list of other details that we are willing to discuss with anyone that needs further education on the project.

o Xcel can straighten the light poles. Would that not require replacing? Are you certain that what's buried underneath is secure/sturdy enough to just be straightened? If they are to be replaced AND a grant is willing to include lighting, can we not look into upgrades or improvements that can add aesthetics to our downtown?

o "tax payers money" this is vague and for the sake of argument, you are correct, but it could be misleading. The entire project is a form of taxpayer money, but is not limited to the city of wheeler taxpayers.

o Our EDC Director is willing and able to help with any questions or fact checking for the (2) CDBG (grants), the one for Main Street is pending and details have not been finalized. There will be another open public meeting when/if grant is awarded.

Editor's Response

I appreciate the letter. We publish City Council minutes; Commissioners' Court minutes and Wheeler School Board minutes. "We also publish legal notices, and we call meetings to the attention of our readers from time to time".

I was at the presentation of the sidewalk project now under way; there was fair attendance. I was the only one at the meeting on the discussion of the Main Street project.

I was on the council when a proposal was made to upgrade the sidewalks on the 400 block of main. I cannot find the articles in the paper, so I do not know the date. At that time, The highway department would require parallel parking on both sides of Farm-to-market Hwy 2473.

music (not to mention the one who was incompletely enjoying both). It seemed to me that at its essence, the quote was a denunciation of multitasking.

I must confess that I have spent plenty of time experimenting with multitasking, and my experience with multitasking is what has led me to determine that Mr. Chesterton was correct when he made that quote. Multitasking offers the appearance of increasing efficiency and decreasing the total time spent on a series of tasks, by performing or completing more than one of them at a time. I have found that promise to be illusory. If I am not concentrating on what I am doing, I tend to do it poorly, or less effectively than if I were giving it my attention, and some of what I do is only of marginal quality to begin with; I can't afford to allow the quality to sag any further. Have you ever locked or unlocked a door and walked off, leaving the keys in the door lock? Or perhaps you have removed them from the door lock and put them in a jacket pocket, and considered them lost an hour or two later when they were not in your pants pocket where they should be. I have committed both of these follies more times than I would care to know. They are the effect of insufficient attention being paid to what I was doing, and insufficient attention is the effect of multitasking.

Many times I thought I would save time by reading something I was either required to read, or desired to read, while I ate a meal. This is especially tempting if eating alone rather than with company. But the result is that I derive limited enjoyment and benefit from both the meal and the reading material when they are consumed in this manner. Yet the temptation to engage in such multitasking remains, despite the evidence that it is counterproductive.

Perhaps the human brain has a tendency to overestimate its capabilities. After all, people all tend to think their thinking is correct, but the impossibility of everyone's thinking, varied as it is, being correct, is the strongest evidence that our thinking is often flawed. But another cause of the multitasking phenomenon is our hyper-connected, supersonic (I'm exaggerating a bit) lifestyle. Cell phones, computers, the Internet, email – all of these developments have increased the things calling for our attention throughout the day. And each of these tools individually can be very effective at increasing our efficiency. But when they begin to stack on top of each other, ineffectiveness arises as we cascade from inefficiency to inefficiency as more devices are employed.

When was the last time you felt lost in what you were doing, in a good way? Focused and consumed by it, and really experiencing it with your senses? I would wager that that experience was not had while multitasking. I know I do my best work, and perhaps my only good work, when my attention is unencumbered by other things. I believe this is intuitive when it is given adequate thought, but it is one of those lessons that seems to remain out of reach until it is learned the hard way, by trial and error. I have found that when I feel as though my wheels are spinning and I am not getting anywhere, and I'm having very little to no fun doing so, it is because I am scatterbrained or in an atten-

tion-diverted state, and often this correlates to when I am trying to do too many (which means more than one) things at once.

A final argument I would make against multitasking is the insecurity it evokes in us when it is done by others on matters that pertain to us. Would you feel comfortable if your accountant was preparing to meet the IRS on your behalf, if the accountant was playing solitaire while preparing? How about if your plumber were talking on the phone while working on sewer lines? Or if a delivery driver were reading a paperback

separating Hwy.152 from courthouse parking. We did not propose any change to the highway grade.

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for Wheeler County from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval rate is the highest tax rate that Wheeler County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Wheeler County is not proposing to increase property taxes for the 2020 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 24, 2020 10:00 am at Wheeler County Courthouse

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Wheeler County is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting Wheeler County Commissioners of Wheeler County at their offices or by attending the public meeting mentioned above.

New USDA Survey to Measure Areas for Improvement

The U.S. Department of Agriculture (USDA) today announced a new annual survey of farmers, ranchers and private forestland owners. The survey will help USDA understand what it is doing well and where improvements are needed, specifically at the Farm Service Agency (FSA), Natural Resources Conservation Service (NRCS) and Risk Management Agency (RMA).

A selection of 28,000 producers will receive the survey over the next few weeks, but all farmers are encouraged to take the survey at farmers.gov/survey.

"We want to hear from our customers so we can learn what we're doing right and where we're missing the mark," Under Secretary for Farm Production and Conservation Bill Northey said. "Good data is critical to good decision-making. The more responses we receive, the better we can understand what we need to do to improve our services to America's farmers, ranchers and private forestland owners."

This survey is part of the President's Management Agenda. It requires High Impact Service Provider agencies across the federal government, including FSA and NRCS, to conduct annual surveys to measure and respond to areas needing improvement.

"We recognize producers and our staff may be experiencing a lot of change in how they interact with USDA," Farm Service Agency Administrator Richard Fordyce said. "This is a good time to check in with our customers."

"We use this input to help improve the delivery of our conservation programs as our sister agencies will do for their programs." Natural Resources Conservation Service Chief Matthew Lohr said.

"We're about our customers," Risk Management Agency Administrator Martin Barbre said. "RMA works to provide producers with crop insurance policies that meet their needs and we need to know where we can improve."

The survey consists of 20 questions and takes approximately 10 minutes to complete. Responses are confidential, and individual responses will be aggregated. The survey will be open for at least six weeks and will be closed once USDA receives a 30% response rate.
