### **Knox Co. approved for Emergency Conservation** Program, however no program funds allocated

Michael McDonald, County Executive Director for the Knox County Farm Service Agency, announced March 1 that sign-up for the ECP began March 2 and will end the earlier of April 30th or whenever drought-breaking

McDonald said, "Recent rains have helped fill farm ponds, however drought like conditions still exist." It is very important for our producers to know there are no funds available for this program, and if drought ending rain occurs sign-up may be stopped. Washington has indicated to the county office that ECP didn't get funded in 2003 and they don't expect it to get funded in 2004. However, we all know what can happen in an election year.

The ECP drought is designed to provide emergency relief to livestock producers who have severe livestock water shortages due to drought.

If the program is funded, the Farm Service Agency will provide cost-share assistance on the following practices:

- Slit removal from earthen ponds used for livestock water
- · Pipelines, when the primary source of livestock water is inad-
- Water troughs and storage
- Developing seeps and springs • Drilling or deepening wells for livestock use when there is no other water source that can be

enhanced at less expense

In order to be eligible for costshares producers must not start any of these practices until the following occurs:

- An application is filed in the Knox County FSA office. For now, practices are only eligible on land that is physically located in Knox County.
- A FSA representative makes on on-site inspection of the area to determine eligibility.
- · For slit removal, a Natural Resources Conservation Service representative visits the site and makes a 'needs determination'.

#### Quail habitat restoration program offered

A special grassland restoration program is available this year to landowners in Knox County through the Environmental Quality Incentives Program or EQIP. Grassland habitat in the area has been damaged by years of drought, overgrazing and brush en croachment. When grasslands are restored, habitat for bobwhite quail and other birds is greatly improved.

The program is different and separated from the regular County EQIP. This 6 year grassland and quail emphasis program is designed to restore grassland health through a combination of grazing management incentive payments and cost share for needed practices. Up to two years of complete rest from grazing is often needed to start the recovery process and landowners will be paid \$5 per acre cash incentives for the first and second year of rest. After that time, grazing may be resumed, but at about half of the normally recommended stocking rate. In addition to a reduced stocking rate, ranchers will need to rotate livestock from pasture to pasture in a grazing system. This will help insure the continued development and improvement in grassland condition and quail nest cover.

Adequate nesting cover is often the weakest link in providing good quail habitat. About 500 potential nest sites per acre are needed for optimum nesting success. Bobwhites pre fer to make their nests in large clumps of old grass left from the previous year. These clumps are often about the size of a basketball. Rest from grazing followed by light rotational grazing is often the best way to restore good nest cover.

In addition to cash incentive payments, landowners may also receive 50% cost-share to conduct selective brush management, re-seeding, or prescribed burning as needed to accelerate the restoration of grasslands. These practices will be planned in a specific manner to benefit quail and other grassland birds.

In the 5th year of the program, landowners will receive an additional \$5 per acre incentive if they have successfully carried out all of the grazing management provisions. The three incentive payments are limited to 2500 acres.

Participants in this program will also need to work with their local TPWD Biologist to develop a wildlife management plan for their property. These plans will help insure that good wildlife benefits are achieved according to the goals of the landowner.

Application will be taken until April 16, 2004 at the USDA-NRCS office in Knox City.

#### **Environment quality incentives program**

Eligible practices for Knox County to improve irrigation application efficiencies are: Irrigation pipelines, drip irrigation systems (maximum of 30 acres/tract), new irrigation sprinkler systems (LEPA, LESA or LPIC, maximum length eligible for cost-share is 660 feet/system), Convert (renozzle) existing pivot to LEPA, LESA or LPIC. No cost-share for pipelines to new wells (must been in use for 2 years). Land must have an irrigation history of 2 of the past 5 years. Also must have an adequate water supply of at least 3 gallons per minute per acre.

Eligible practice on rangeland is mechanical brush control (treedozing or grubbing, root plowing, and raking. Must have at least 10% crown canopy cover and are in excess of 50 trees / acre to be eligible for cost share. Mechanical brush control may not be converted to cropland for 15 years.

Cost-share rate will be 50% of average cost. If you qualify as a limited resource farmer cost-share rate will be 60% of average cost.

Interested producers should contact the NRCS or FSA office to sign an application.



On February 10, 2004, VALOR Telecommunications of Texas, LP (VALOR) filed its Second Amended Application with the Public Utility Commission of Texas (Commission) to establish surcharges to recover lost revenues and incurred costs associated with Expanded Local Calling Service (ELCS) routes implemented from February 1, 1996 through December 31, 2002 between VALOR's Texas telephone exchanges and, in many instances, the exchanges of other local telephone companies. The Second Amended Application was filed pursuant to the Commission's Substantive Rule § 26.221 titled "Applications to Establish or Increase Expanded Local Calling Service Surcharges."

ELCS expands the local calling scope of a telephone exchange to include one or more additional telephone exchanges if customers in a petitioning exchange approve by ballot the payment of an ELCS fee in lieu of long distance charges. Costs and lost revenues associated with Valor's surcharge application are those not recovered through existing ELCS fees.

In the Second Amended Application, VALOR proposes to implement monthly ELCS surcharges for five years beginning on the date the Commission issues a final order on VALOR's request. The Commission can establish an ELCS surcharge for any duration. ELCS surcharges apply in addition to monthly ELCS fees. VALOR proposes the following monthly ELCS surcharges per residential line: \$.86 in Year 1, \$.85 in Year 2, \$.03 in Year 3, \$.02 in Year 4, \$.01 in Year 5. VALOR proposes the following monthly ELCS surcharges per business line: \$1.72 in Year 1, \$1.70 in Year 2, \$.06 in Year 3, \$.04 in Year 4, \$.02 in Year 5.

VALOR is currently billing interim ELCS surcharges approved by the Commission, including an interim ELCS surcharge of \$.65 per month per residential line and an interim ELCS surcharge of \$1.30 per month per business line. If rates below the level of the interim surcharges are ultimately approved by the Commission, VALOR may be required by the Commission to refund all or part of the interim surcharges.

If VALOR's Second Amended Application is approved, the net annual effect on VALOR's Year 1 revenues will be zero since the requested surcharges are designed to replace lost revenues and to reimburse VALOR for increases in costs associated with the provision of ELCS. The estimated total lost revenues and increased costs VALOR seeks to recover through this proceeding is \$3,867,372 in Year 1, 3,791,870 in Year 2, \$133,831 in Year 3, \$89,220 in Year 4, and \$44,610 in Year 5.


