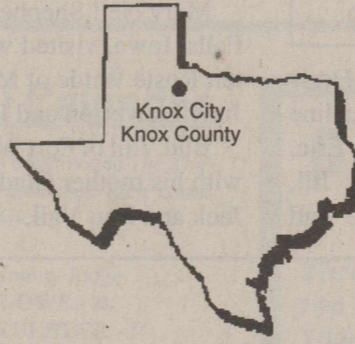

Knox County eligible for FSA emergency loans

Knox County was declared a contiguous county eligible for Farm Service Agency (FSA) disaster emergency loans on February 10, 2004. Generally, that means that farmers who have lost at least 30 percent of their production due to drought and excessive temperatures that occurred from July 1, 2003, and continuing are eligible for FSA loans. Proceeds from crop insurance are taken into consideration when determining eligibility.

FSA Farm Loan Manager, Kelley R. Boone, is urging farmers who are interested in receiving an emergency loan to submit their applications into FSA as soon as possible. Boone said, "We hope farmers will get their applications in early rather than waiting until near the deadline which is October 12, 2004. The longer they wait, the more chance there is for long delays. If the applications come in early, we can avoid backlogs and speed up the process."

Polling places will be open Tuesday as voters decide on Democratic candidate for Knox County Judge

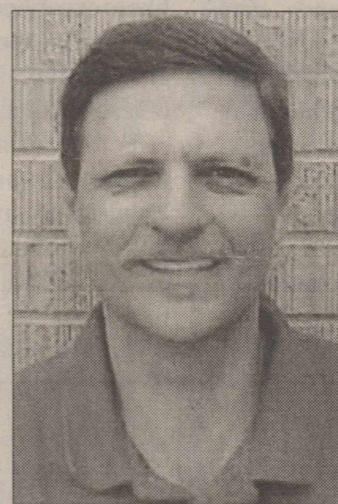

Voters in Knox County will be returning to the polls next Tuesday for a runoff election to decide who will be the Democratic Candidate for the office of Knox County Judge.

Joe Lowe of Munday and David Kuehler of Rhineland both received enough votes in the Democratic primary on March 9 to face each other again for the runoff election on Tuesday, April 13.

The winner of the runoff election next Tuesday will face Republican candidate Travis Floyd in the General election scheduled for November.

An additional 383 votes has candidates campaigning hard

With paid advertisements in both *The Knox County News* and the *Munday Courier*, plus door to door visits and a lot of old fashioned hand shaking, Joe Lowe of Munday and David Kuehler of Rhineland are each campaigning hard to secure the winning share of 383 votes that were cast for other candidates for the office of Knox County Judge in the March 9 Democratic primary election.

While Lowe received the most votes with 313, Kuehler closely followed with 283 votes. Up for grabs in the runoff election next Tuesday are the 201 votes cast for Benjamin resident Mitzi Welch, the 158 votes cast for Munday resident Dwayne Bearden, and the 24 votes cast for Knox City resident Jules Rizan.

Since the election on Tuesday will be held solely to decide between Lowe and Kuehler, both candidates hope that voters will show the same amount of interest they did in the March 9 primary and show up at the polls next Tuesday. The polling places for Tuesday's runoff election will be the same locations in each community as they were back in March.

Knox County Futures Forum Termed a Success

First, thank you to all who participated in the Knox County Texas Community Futures Forum on March 22. Due to your support and concern for the future of Knox County and its citizens, the beginning stage of the Futures Forum has been a success!

The purpose of the Texas Community Futures Forum is to bring together a diverse group of individuals and organizations to identify the issues and concerns facing our county over the next several years. The participants in Knox County were introduced to the goal of the futures forum: to facilitate

the identification of common needs and define a process for addressing these needs. They then gathered in two groups to talk about issues they were concerned with and get input from their group peers. After small group discussion, the large group reassembled to discuss the topics nominated by the small groups. Each topic was discussed individually in the large group, and then the participants voted on the importance of each issue. Participants had ten votes apiece and could vote all ten on one topic, or one vote on ten different topics. After identifying the top issues, the group as a whole helped identify entities that will

be able to help address the concerns recognized at the forum. The Futures Forum is a one-night event that sets into motion a long-range plan for Texas Cooperative Extension and its partners so that the concerns and needs of the county can be met. We have only just begun, but the future looks brighter already!

The Texas Community Futures Forum website (<http://futuresforum.tamu.edu/>) contains information on several topics of interest: Those of you who were not able to attend the live forum can complete an online forum - your voice can still be heard, it's not too late. The results of the last

Futures Forum, held in 1999, are also posted on the website. Once the data for our 2004 Forum is compiled, it will also be available there. Please be sure to take a look!

The top 15 issues identified at our live Forum are as follows: need for skilled labor, job availability, support local business, city beautification, energy, water (quality and conservation), youth recreation, housing (availability and affordability) expanding pre-existing business, new business, developing the hunting industry, improve hispanic involvement, child care, road improvement, improve tourism.

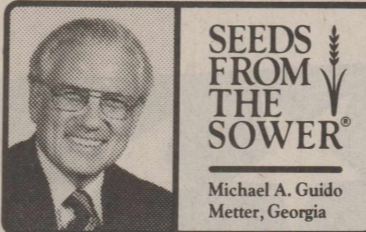

And there are some whose hearts are harder, for no one becomes a great sinner all at once.

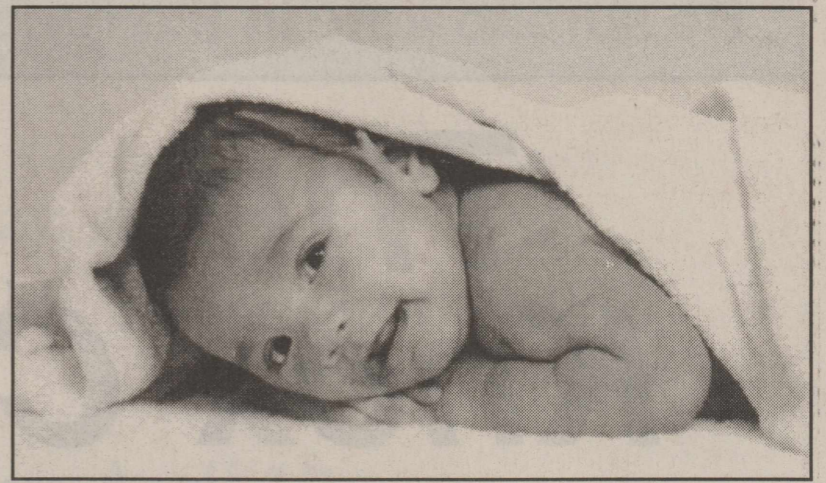
At first you regard sin with fear. When you sin, remorse enters your heart.

IRS Income tax filing extensions available by phone or computer

WASHINGTON - People who need more time to complete their forms will find it easy to extend their filing deadline - they don't need an excuse or even a stamp. Automatic four-month extensions are available by phone or by computer, as well as through the paper Form 4868. The IRS expects to receive almost 9 million extension requests, which must be made by the normal filing deadline.

An extension of time to file does not give more time to pay any taxes owed. A person may choose to pay any projected balance due when requesting an extension, and the payment may be made electronically. Even without a payment, one can still get the extension.

Whether requesting an extension electronically or on paper, the taxpayer must estimate the total tax liability based on the information available. If the IRS later finds this estimate to be unreasonable, the extension will be null and void. The taxpayer will still get credit for any payments made with the extension request.

The IRS has a special toll-free phone line for extensions - 1-888-796-1074 - for those who filed a tax return for 2002. Callers may use Form 4868, Application for Automatic Extension of Time to File U.S. Individual Income Tax Return, as a worksheet to prepare for the call, figuring their 2003 tax and total payments made. They get a confirmation number signifying that the extension request has been accepted. They should put this confirmation number on Form 4868 and keep it for their records. They do not send the form to the IRS.

Taxpayers may also e-file an extension request using tax preparation software on their own computer or by going to a tax preparer. Those filing by computer get an acknowledgment that the IRS has received their request.

Taxpayers asking for extensions by phone or computer can choose to pay any expected balance due by authorizing an automatic withdrawal from a checking or savings account. They will need the appropriate bank routing and account numbers for that account. They must also have the adjusted gross income (AGI) from their 2002 tax return to verify their identity. Another way to get a filing extension is to charge an extension related payment to an American Express, Discover Card, MasterCard or Visa account. Form 4868 has details on making credit card payments.

AUSTIN — A place to call home is a big part of the American dream, and fair-housing laws help make that dream come true.

Title VIII of the Civil Rights Act of 1968, the federal Fair Housing Act, prohibits housing discrimination based on race, color, national origin, religion, sex, family status or disability.

The law covers most types of housing and prohibits:

- Refusing to rent or sell housing.
- Refusing to negotiate for housing.
- Making housing unavailable.
- Denying a dwelling.
- Setting different terms, conditions or privileges for sale or rental of a dwelling.
- Providing different housing services or facilities.
- Falsely denying that housing is available for inspection, sale or rental.
- Denying access to — or membership in — a facility or service (such as a multiple listing service) related to the sale or rental of housing.

It's also illegal for anyone to threaten, coerce, intimidate or interfere with anyone exercising a fair-housing right or assisting others who exercise that right.

April is national Fair Housing

Month, and Texas Realtors are gearing up for it.

"The 60,000 members of the Texas Association of Realtors and our partnering 91 local Realtor organizations encourage all Texans to join us in celebrating the diversity of our great state," said Dave Dalzell, chairman, Texas Association of Realtors. "Together, we can embrace our differences and protect the American dream for everyone."

All real estate brokers and agents must follow the fair-housing law, which covers specific classes of people. Those who choose to be Realtors pledge to abide by a code of ethics, keeping issues of fairness to everyone at the forefront of their business.

What if there's a problem?

Those who think their fair-housing rights have been violated should contact the U.S. Department of Housing and Urban Development (HUD) and complete a Housing Discrimination Complaint Form (HUD-903.1). It's available for download on HUD's Web site (www.hud.gov), or contact the HUD office nearest you. Consumers have one year to file.

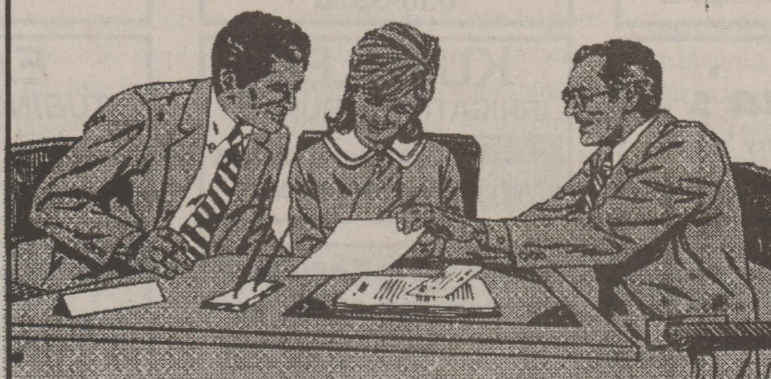

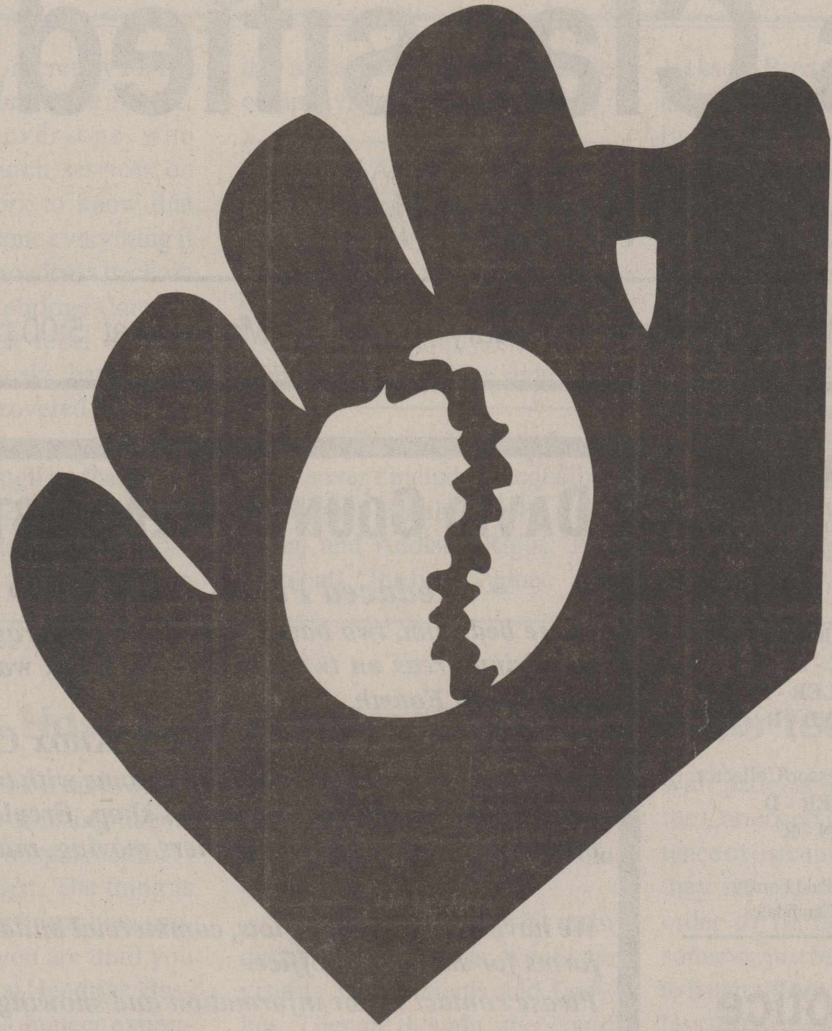

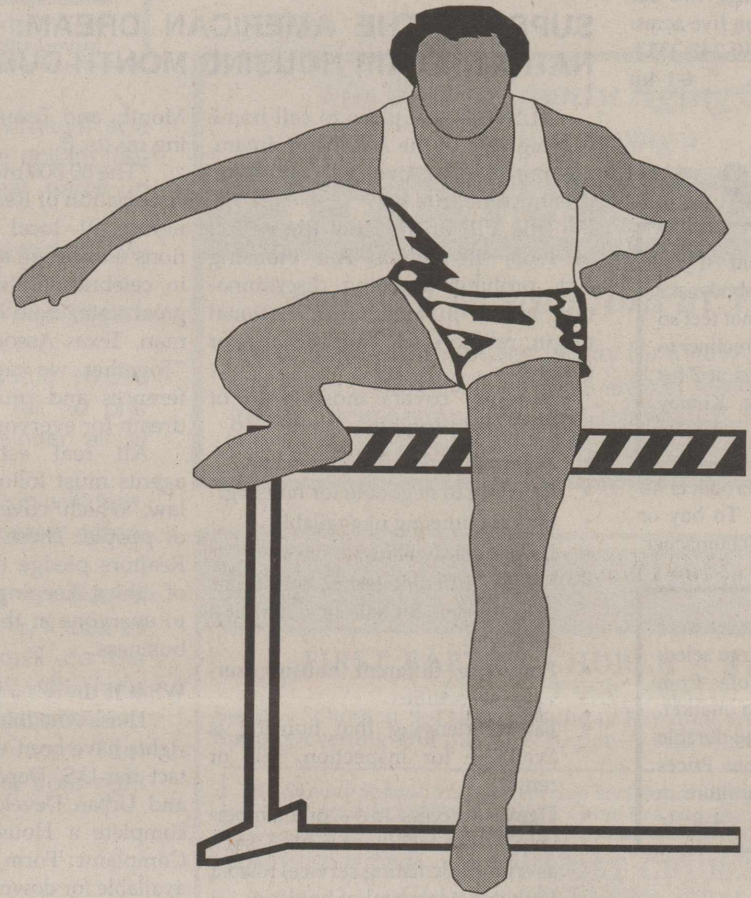
