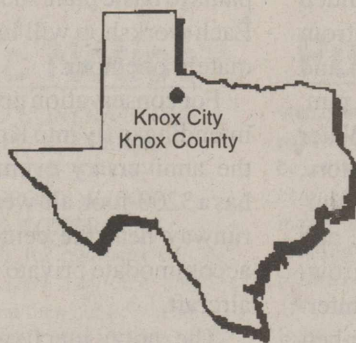

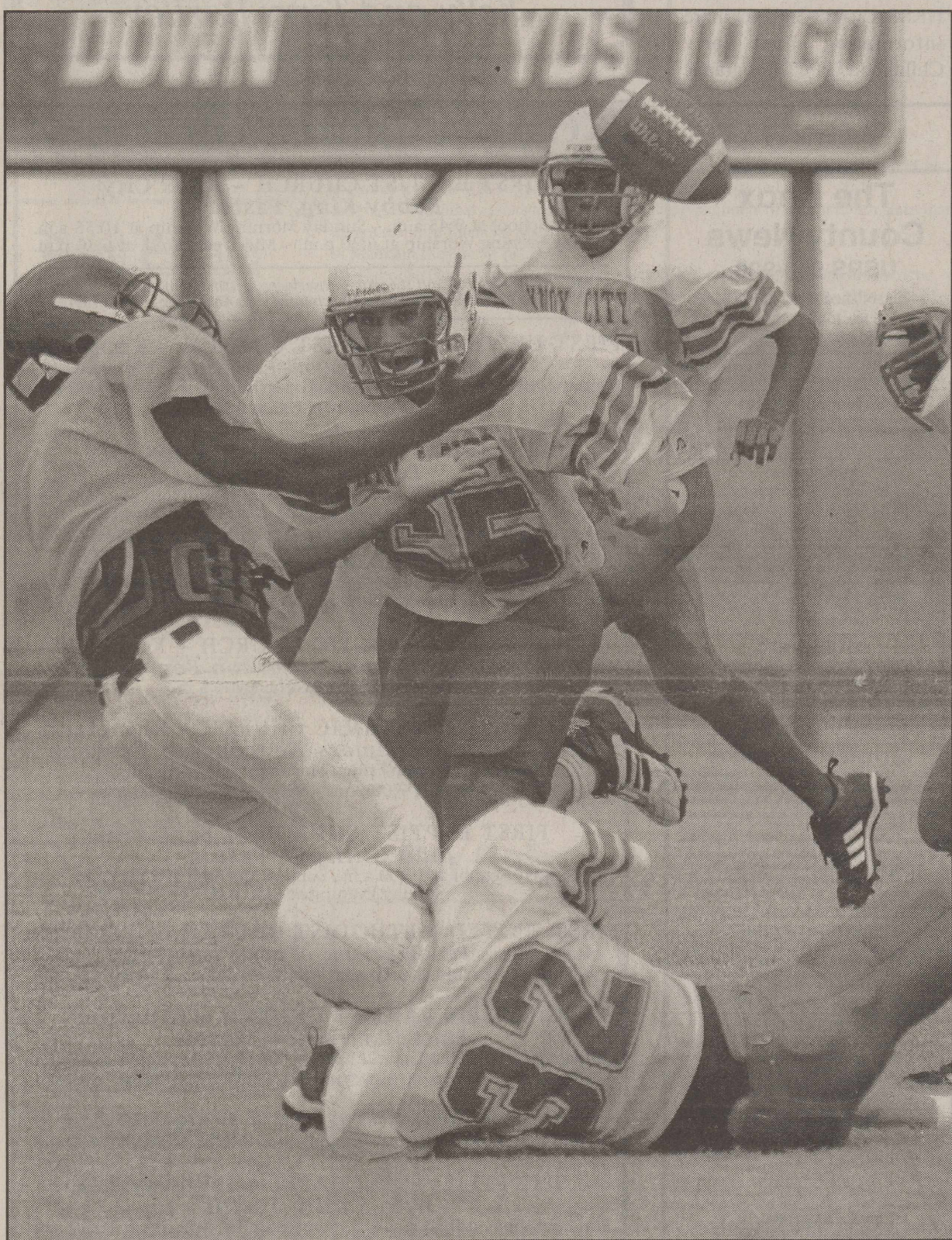

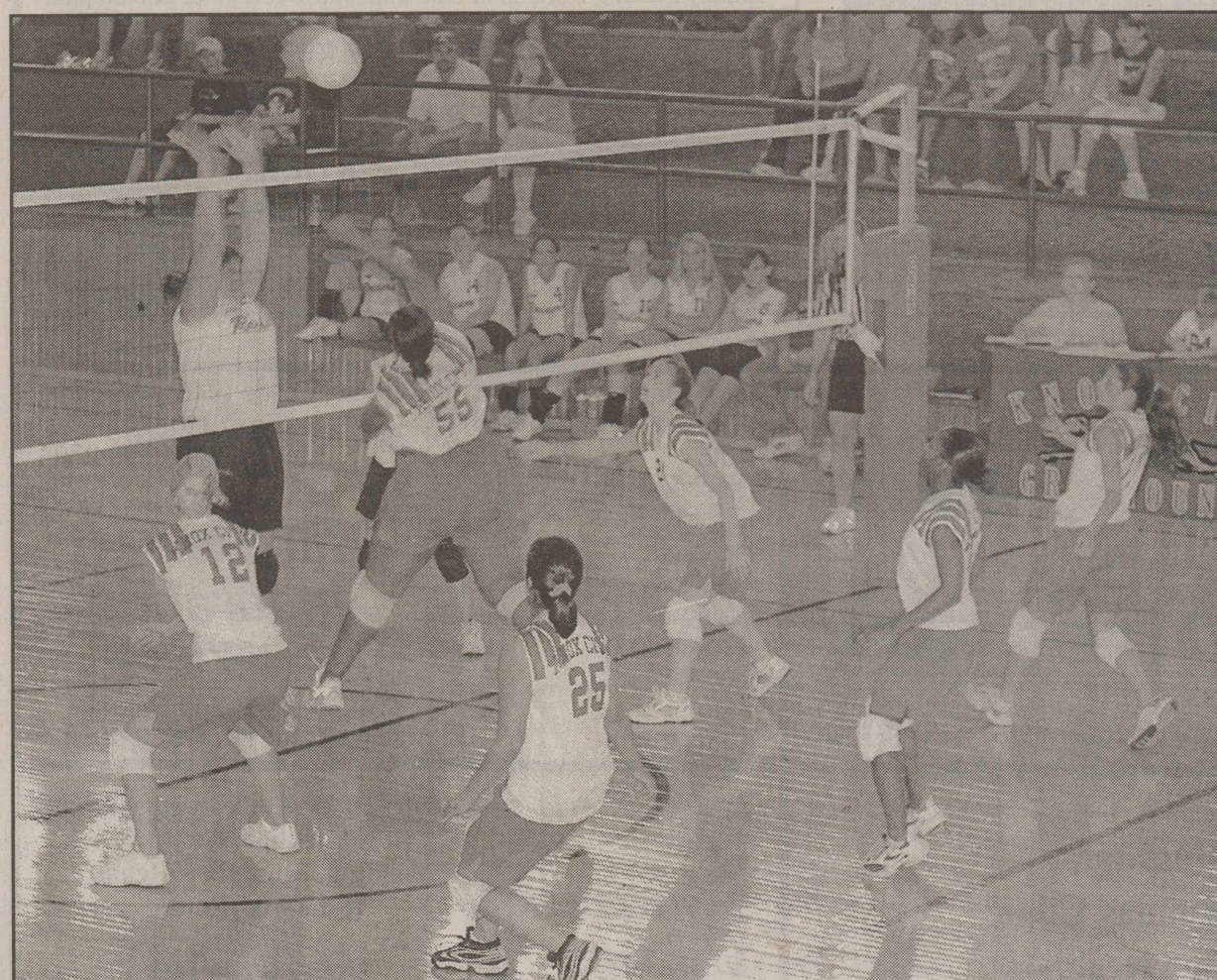

Lance died Wednesday, August 11, 2004, at Fort Lee, Virginia, in Petersburg, Virginia.

Lance graduated from Knox City High School in 1996.

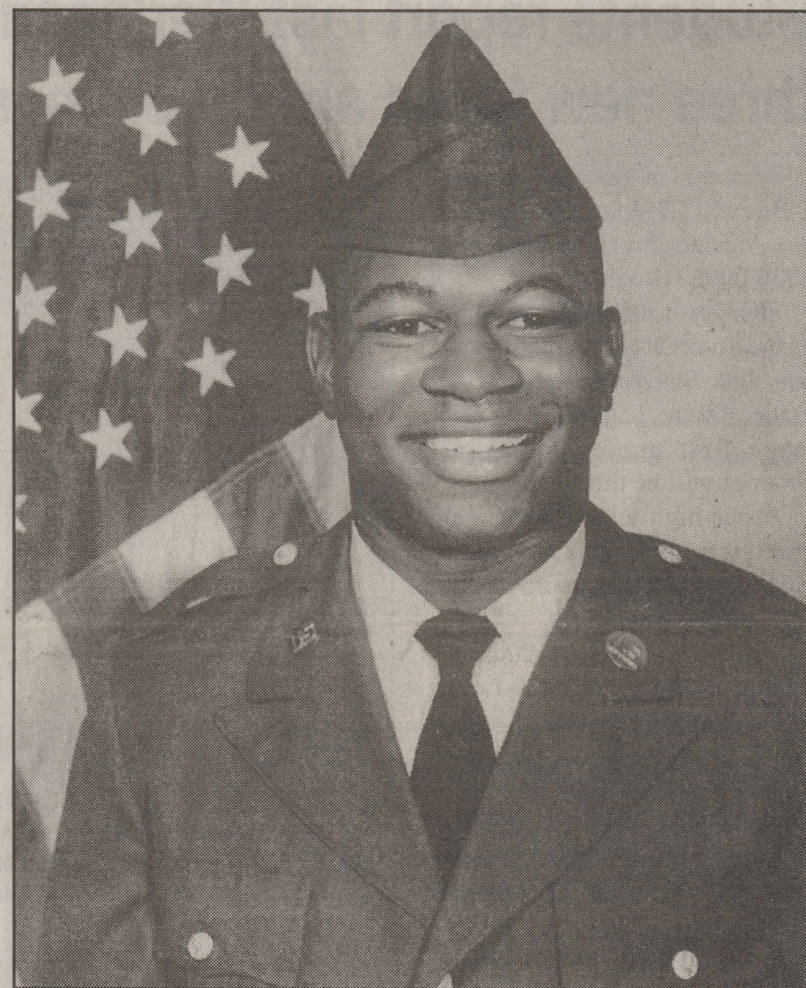
He joined the United States Army on July 31, 1996, and was assigned to Fort Campbell, Kentucky.

Gregg Martinez returning to First Christian

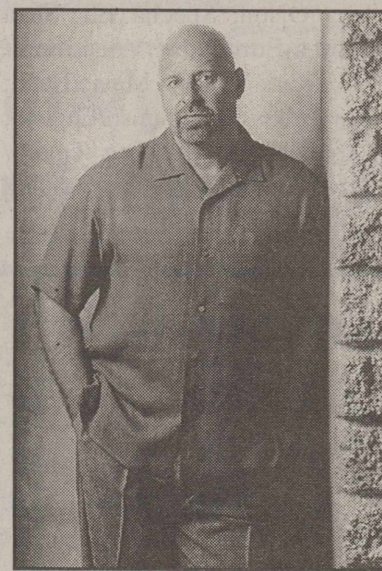
Sunday, August 22, services at 10:45 and 7:00

Texas USDA-NRCS announces field day anniversary of KC Plant Materials Center

Local center to celebrate 40 years August 26

TEMPLE - The USDA-Natural Resources Conservation Service's (NRCS) Knox City Plant Materials Center (PMC) near Knox City, Texas, will be celebrating its 40th Anniversary Field Day on August 26, 2004. Since 1964, the Knox City PMC has released 35 new plant cultivars, along with the technology for their production and use.

For years the PMC has demonstrated cooperative efforts between local, state and federal agencies working together to make the center and plant materials program a success. The PMC is located approximately two miles north of Knox City on State Highway 6, then turn left at FM 1292 for about 2.5 miles and follow the signs to the center.

The Knox City PMC serves north, central and west Texas, as well as southwest Oklahoma. Knox City PMC was the first plant

materials center located in the state of Texas. According to PMC Manager Morris Houck, the anniversary event will have guided tours throughout the center from 9 a.m. until around 3 p.m., and registration will begin at 8 p.m. PMC encourages Soil and Water Conservation District directors, research workers, wildlife enthusiasts, livestock producers, and conservation seed dealers/growers to attend among other interested parties in the search for better plants.

"Among the stops made by wagon-guided tours will be native plant breeding blocks, foundation seed fields, windbreaks and evaluation fields," Houck said. "Part of the tour will highlight a native prairie planting at the center."

A new part of the field day will be an offering of two workshops during the morning of the field

day. One workshop will focus on grass seed drill calibration, while the second will expose the participants to basic plant identification. Each workshop will last approximately one hour.

For conservation professionals intending to fly into Knox City for the anniversary events, the city has a 3200-foot, all-weather paved runway near the center that can accommodate private and charter aircraft.

The noon lunch will have a formal program with guest speakers provided by the Knox City Chamber of Commerce. Those needing to make arrangements for lunch should contact the Knox City Chamber of Commerce at 658-3442.

KC Elementary sets screening for early childhood Monday

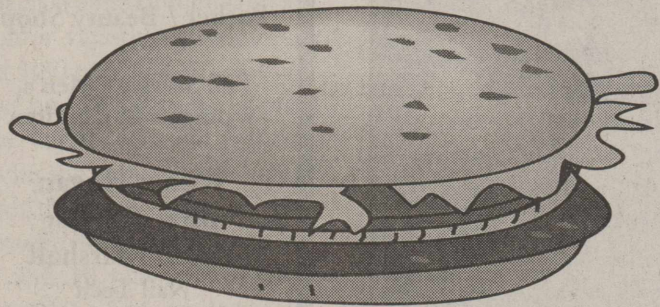

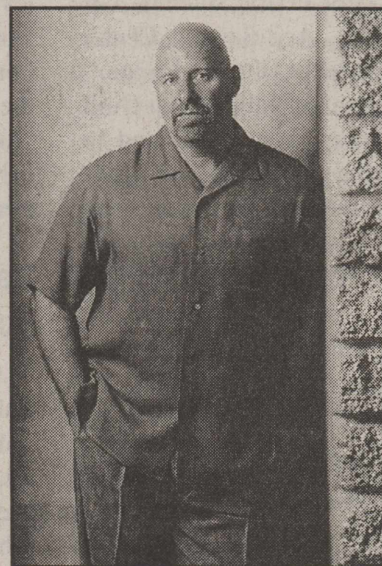

KC-O'Brien enrollment totals 296

Enrollment totals for the beginning of the 2004-2005 school year in the Knox City-O'Brien CISD shows 296 students in this year's system.

In elementary, Pre-K has 27, kindergarten 28, first grade 26, second grade 15, third grade 22, fourth grade 16, for a total of 134 students.

In mid-school, fifth grade has 11 students, sixth 22, seventh 17, and eighth 21, for a total of 71.

In high school, ninth grade has 23, tenth 23, eleventh 25 and twelfth 20, for a total of 91.

Early childhood students are not calculated in these totals which will show an increase, according to Sharon Wainwright at the superintendent's office.

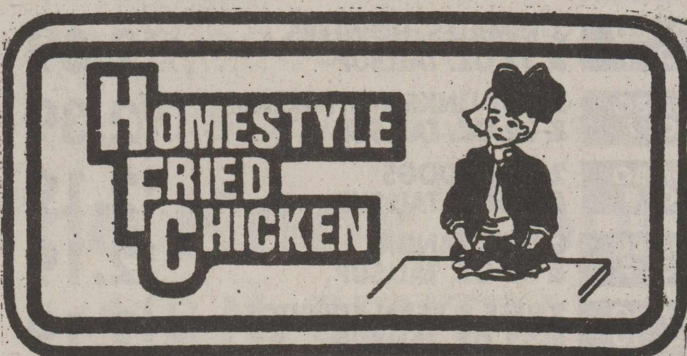

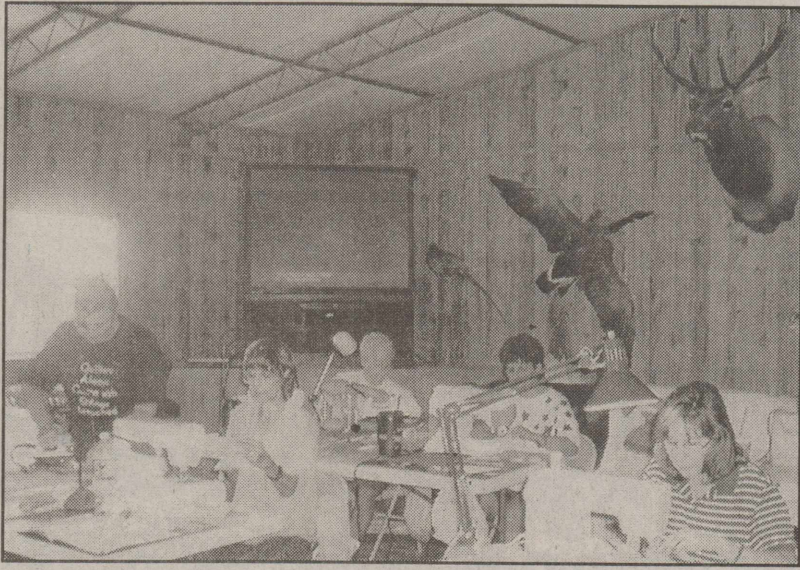
Brazos Valley Quilt Guild converges on Stanfield's Big Honker Hunting Lodge for annual quilting retreat

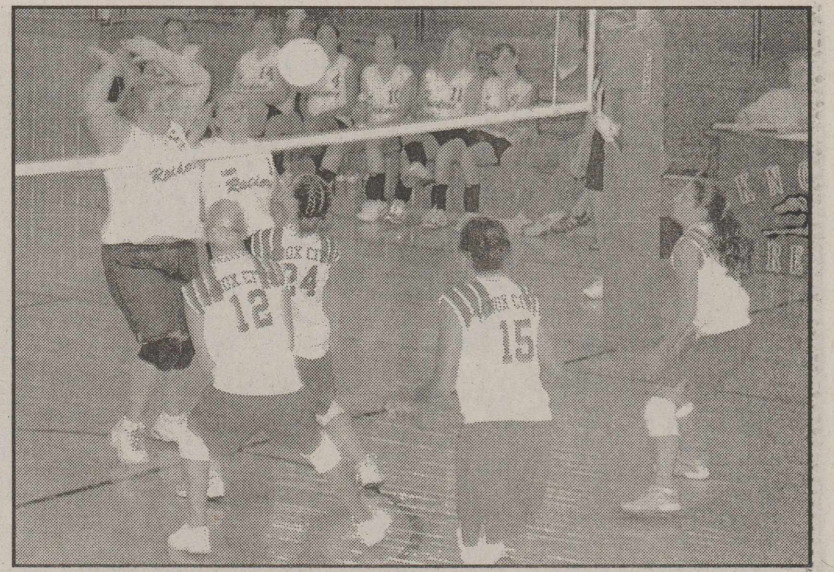

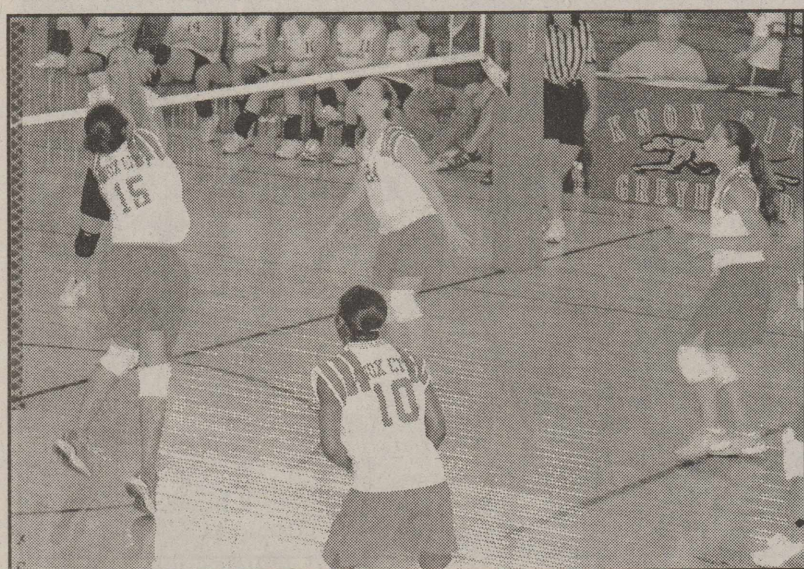

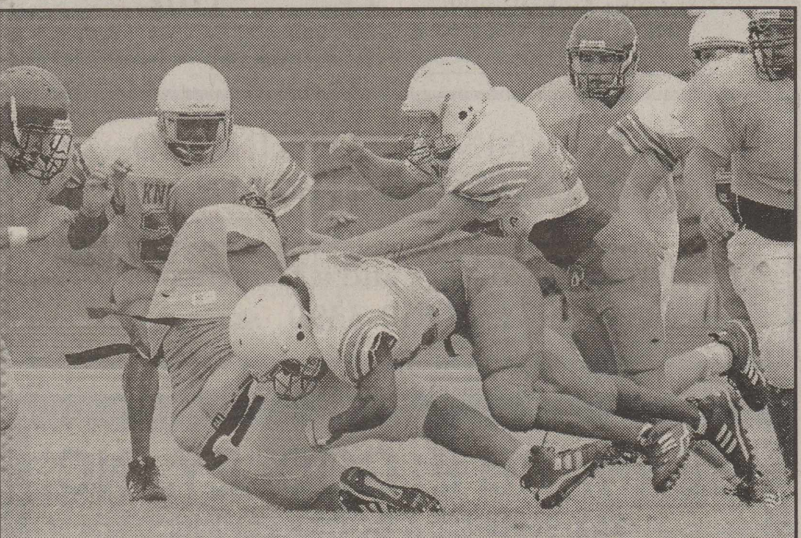

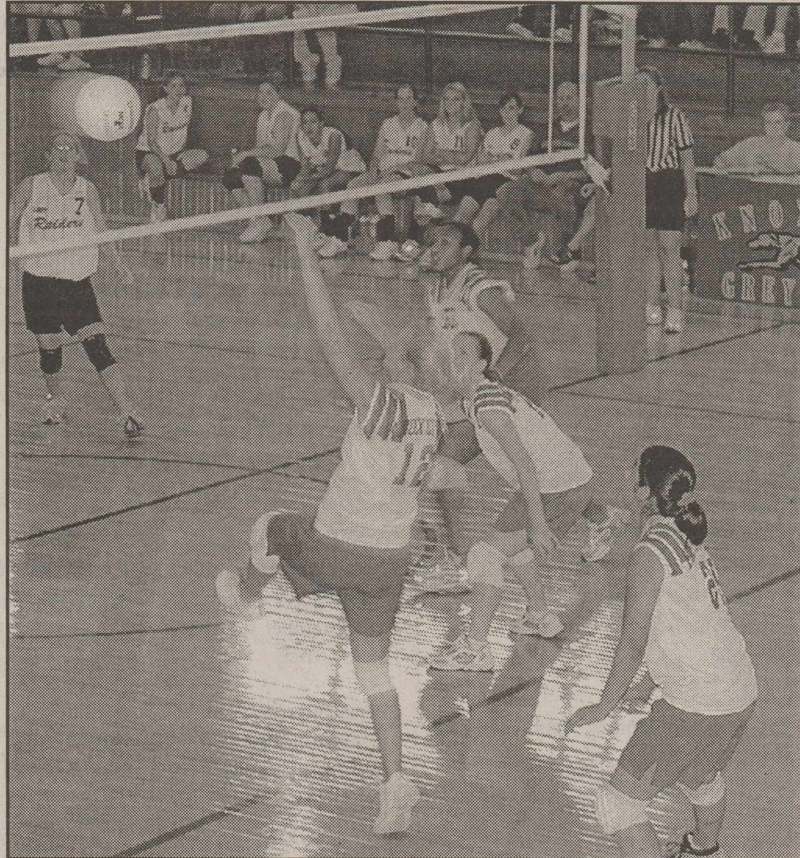

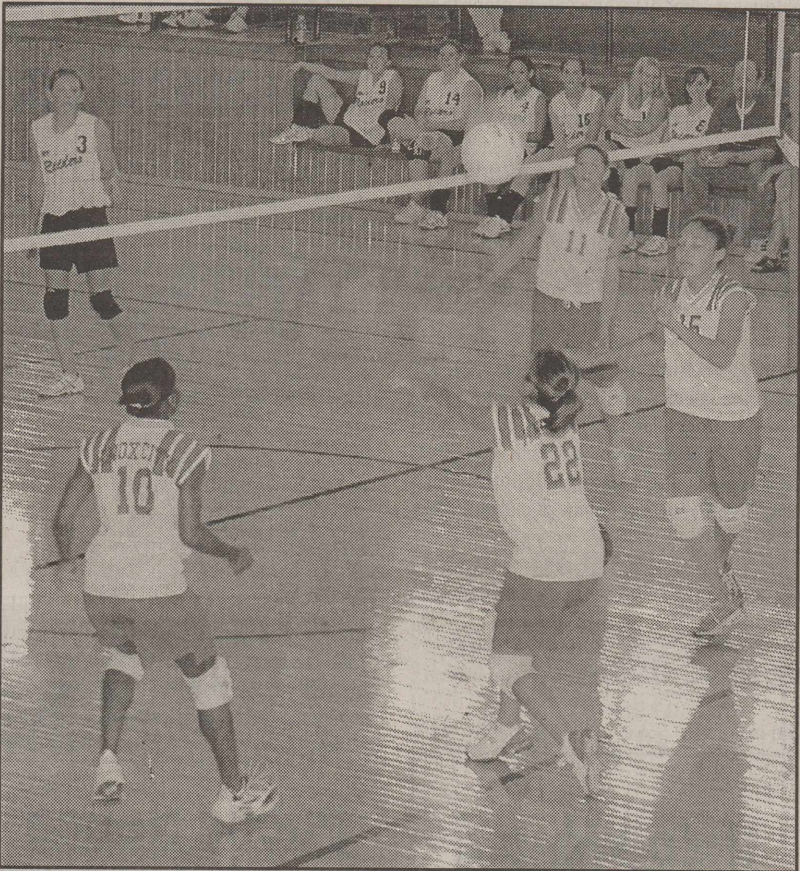

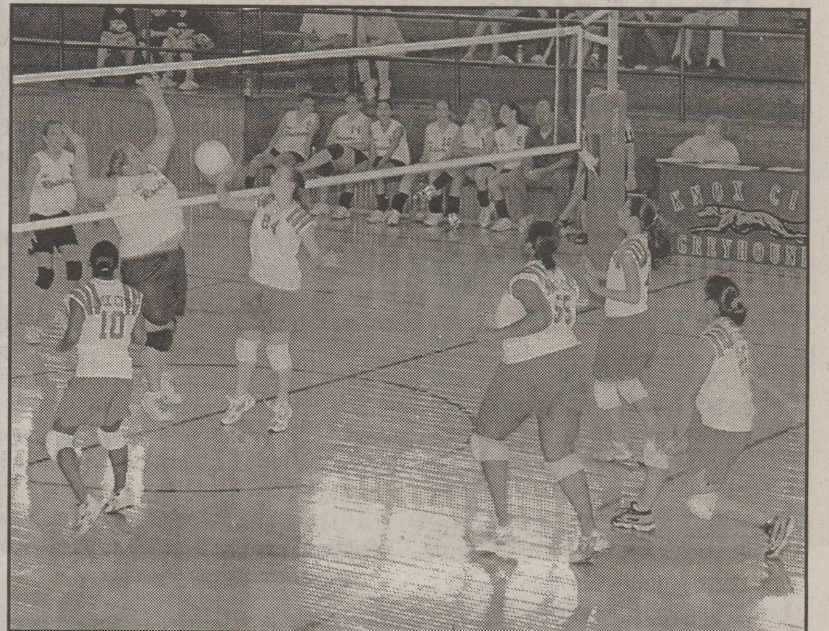
