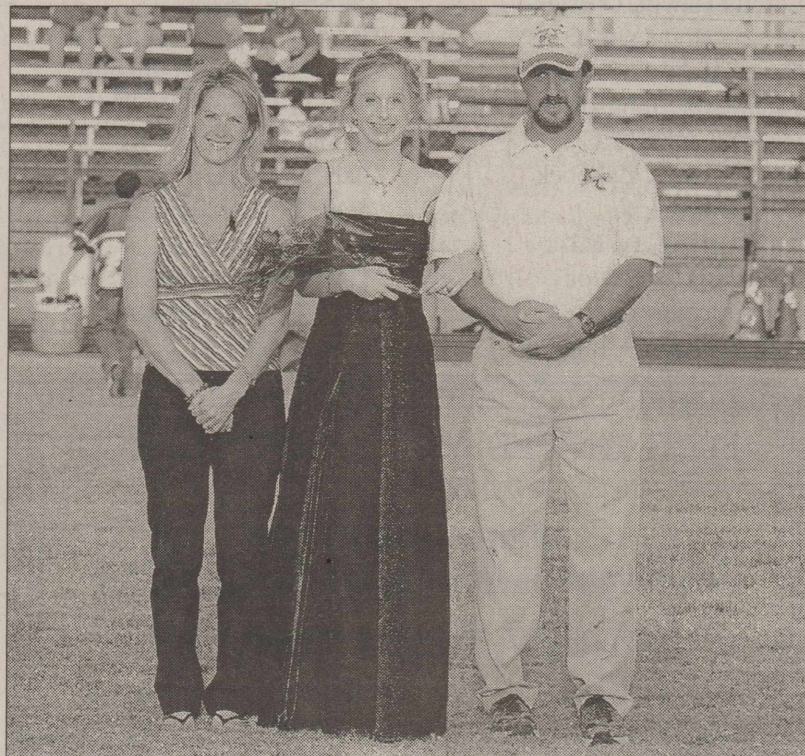

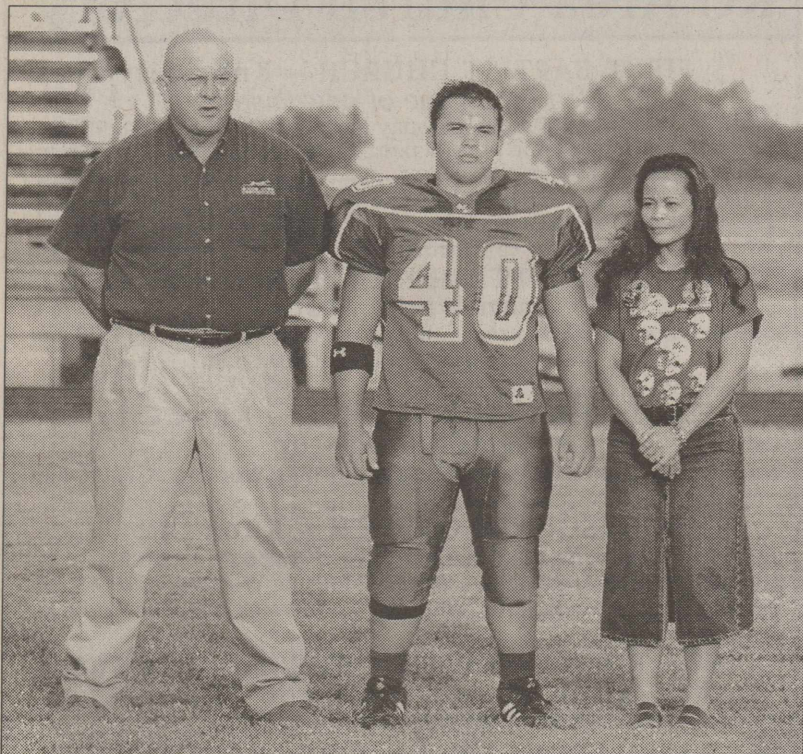

## Class A KCHS Greyhound football team demolishes Class AA Stamford, 52-0

When the Knox City Greyhounds take to the field this Friday night at Anson, they will already have one victory over a larger Class AA team behind them after solidly defeating the Stamford Bulldogs last Friday night by a shutout score of 52-0. Taking on Anson is always a challenge for Knox City, and this year's Greyhounds appear to be up for the task.

With a devastating offense and defense, the 'Hounds have steamrolled over every one of their opponents so far in pre-district games. The impressive win over Stamford's Bulldogs here at home last Friday night came despite a slower than normal start for team. It took all of 4 minutes and 14 seconds for Knox City to light up the scoreboard after quarterback Andy Shaver threw a 31 yard pass to Derrick Magana. The extra point kick by Magana was good, giving the 'Hounds a 7 point lead. With 7:32 left in the second quarter, Shaver and Magana repeated their earlier touchdown play, this time with a 32 yard pass reception and score. Magana once again kicked in the extra point.

Riley Spells added to the score tally when he returned a second quarter punt for 75 yards into the end zone with 5:29 left in the first half. They

scored again in the second quarter after he caught a 57 yard pass from Shaver. Magana kicked in the extra point to lead the team into the locker room at halftime with a 28-0 lead.

Whatever took place in the locker room during halftime inspired the 'Hounds as they came out strong, scoring two more touchdowns in the third quarter and two in the fourth quarter. Third quarter scoring started out with a Riley Spells 3 yard run, followed by a Cody Wainscott 12 yard run. Magana kicked in both extra points. Quentin Spells kicked in a 37 yard field goal in the fourth quarter, that was followed by another Riley Spells touchdown run of 30 yards. Again, Magana kicked in the extra point.

On defense, the 'Hounds are compiling some incredible numbers. This far in the season, Eric Lewis leads the team with 35 tackles, Chris Norton has 27, Kylin DelValle has 26, Ben Simmons has 24, Cody Wainscott has 21, T.J. Richardson has 20, Riley Spells has 18, Thomas Myers has 16 and C.J. Bruce has 15.

Game time this Friday night at Anson is 7:30 p.m.

## Private applicators license training set in Archer City

A private applicators license training course and exam will be held on September 21 at 9:00 a.m. at the Archer County Activity Building in Archer City.

The cost for the training course will be \$15 and this includes a Private Applicators Manual. This course will teach the applicator on the proper way to handle, mix, store, transfer and apply pesticides.

The training will be given by the Texas Cooperative Extension and the test is conducted by Texas Department of Agriculture.

Following this training course, the Private Applicators License exam will be administered. The cost of this test is \$60. Participants are asked to bring a pencil, paper and a calculator for the mathematical problems on the test. The applicators license is good for five years and is required in order to purchase restricted use pesticides like Grazon P+D, 2, 4-D, Tordon 22K and others. Within those 5 years the applicator is required to earn 15 CEU's (Continuing Education Units), with 2 CEU's in Laws and Regulations, 2 CEU's in integrated pest management (IPM). This training course will also serve as 3 CEU's (1 laws and regs, 1 IPM and 1 general) for those who are needing to complete this requirement.

Those interested in attending this training are asked to contact the Extension Office in Archer County at (940) 574-4949 so enough materials will be available.

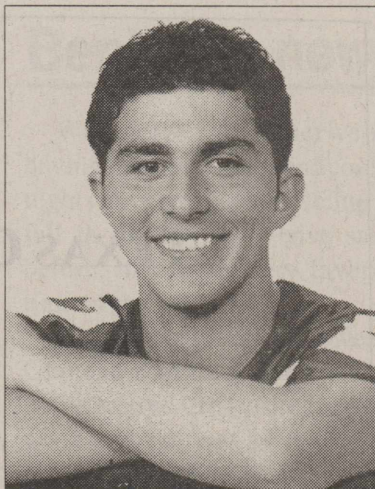

WACO - Baylor University has selected more than 4,000 recent high school graduates as recipients of merit scholarships for the 2004-2005 academic year.

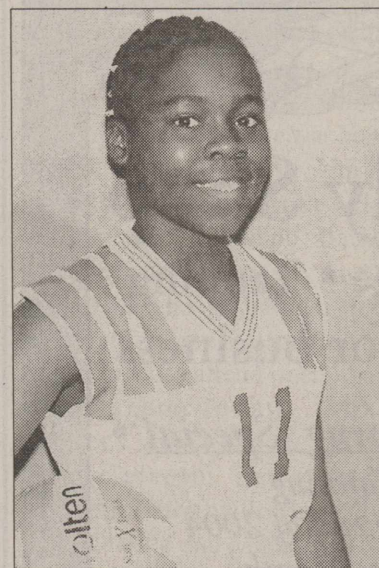

Bridgett Billington is Houndette Player of Week, Nikki Moss all-tourney

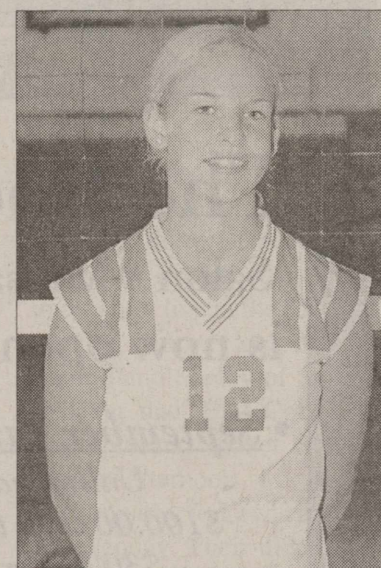


BRIDGETT BILLINGTON

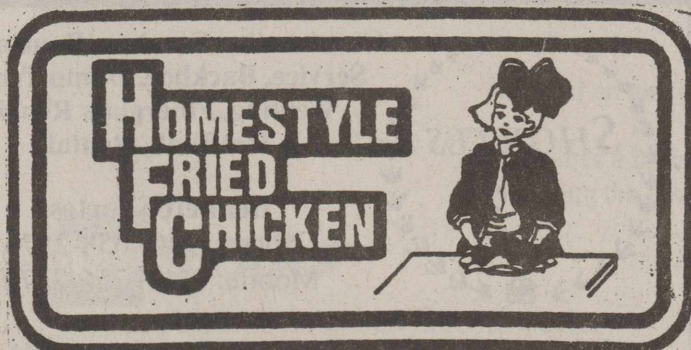

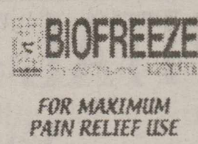


**Mea Linda Abila**

**APPLICATION AND PRELIMINARY DECISION.** City of Knox City, P.O. Box 128, Knox City, Texas 79529-0128, has applied to the Texas Commission on Environmental Quality (TCEQ) for a renewal of TPDES Permit No. 10416-001, which authorizes the discharge of treated domestic wastewater at a daily average flow not to exceed 200,000 gallons per day. This application was submitted to the TCEQ on April 16, 2004.

The facility is located approximately 0.5 mile north of the intersection of Farm-to-Market Road 143 and State Highway 6, on the eastern bank of China Branch in Knox County, Texas. The treated effluent is discharged to China Branch; thence to the Brazos River Above Possum Kingdom Lake in Segment No. 1208 of the Brazos River Basin. The unclassified receiving water uses are no significant aquatic life uses for China Branch. The designated uses for Segment No. 1208 are high aquatic life uses and contact recreation.

The TCEQ executive director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The executive director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements. The permit application, statement of basis/technical summary and executive director's preliminary decision, and draft permit are available for viewing and copying at the Knox City Hall, 200 North Central Avenue, Knox City, Texas.

**PUBLIC COMMENT / PUBLIC MEETING.** You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit written or oral comment or to ask questions about the application. Generally, the TCEQ will hold a public meeting if the executive director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

Written public comments and requests for a public meeting should be submitted to the Office of the Chief Clerk, MC 105, TCEQ, P.O. Box 13087, Austin, TX 78711-3087 within 30 days of the date of newspaper publication of the notice.

**OPPORTUNITY FOR A CONTESTED CASE HEARING.** After the deadline for public comments, the executive director will consider the comments and prepare a response to all relevant and material, or significant public comments. The response to comments, along with the executive director's decision on the application, will be mailed to everyone who submitted public comments or who requested to be on a mailing list for this application. If comments are received, the mailing will also provide instructions for requesting a contested case hearing or reconsideration of the executive director's decision. A contested case hearing is a legal proceeding similar to a civil trial in a state district court.

A contested case hearing will only be granted based on disputed issues of fact that are relevant and material to the Commission's decision on the application. Further, the Commission will only grant a hearing on issues that were raised during the public comment period and not withdrawn. Issues that are not raised in public comments may not be considered during a hearing. The TCEQ may act on this application to renew a permit without providing an opportunity for a contested case hearing if certain criteria are met.

**EXECUTIVE DIRECTOR ACTION.** The executive director may issue final approval of the application unless a timely contested case hearing request or a timely request for reconsideration is filed. If a timely hearing request or request for reconsideration is filed, the executive director will not issue final approval of the permit and will forward the application and requests to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

**MAILING LIST.** In addition to submitting public comments, you may ask to be placed on a mailing list to receive future public notices mailed by the Office of the Chief Clerk. You may request to be added to: (1) the mailing list for this specific application; (2) the permanent mailing list for a specific applicant name and permit number; and/or (3) the permanent mailing list for a specific county. Clearly specify which mailing list(s) to which you wish to be added and send your request to the TCEQ Office of the Chief Clerk at the address above. Unless you otherwise specify, you will be included only on the mailing list for this specific application.

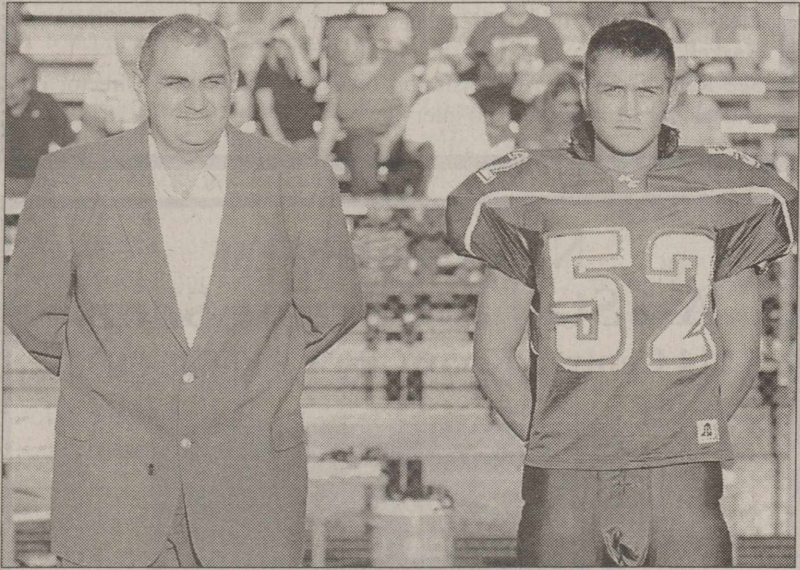

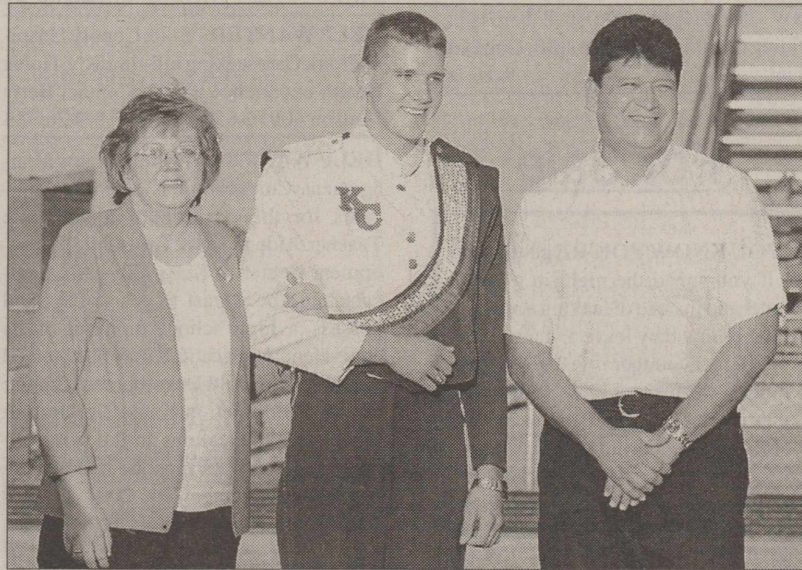

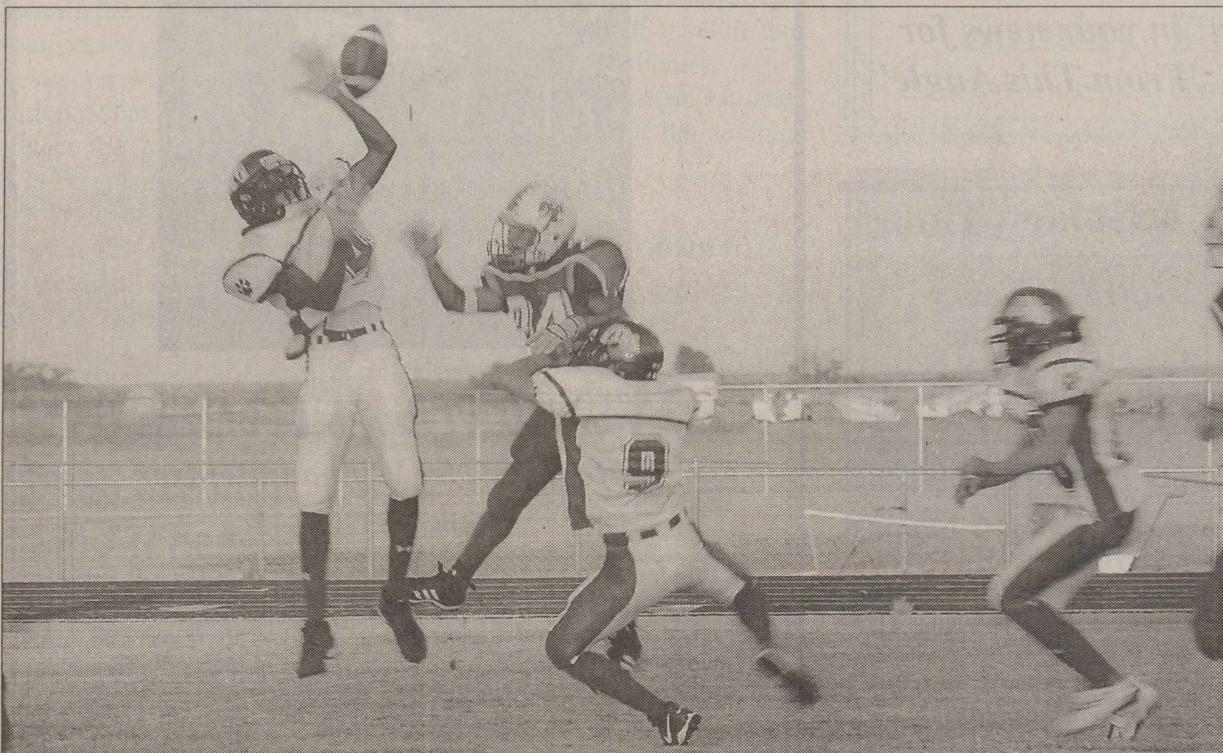
