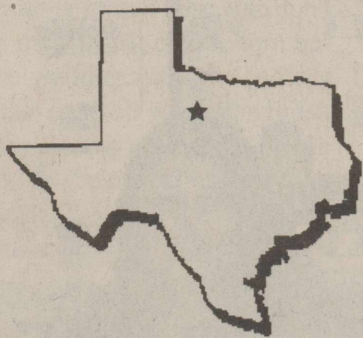

May 25 traffic stop results in arrest of 45 year old white male

Possession of controlled substance, with intent to deliver

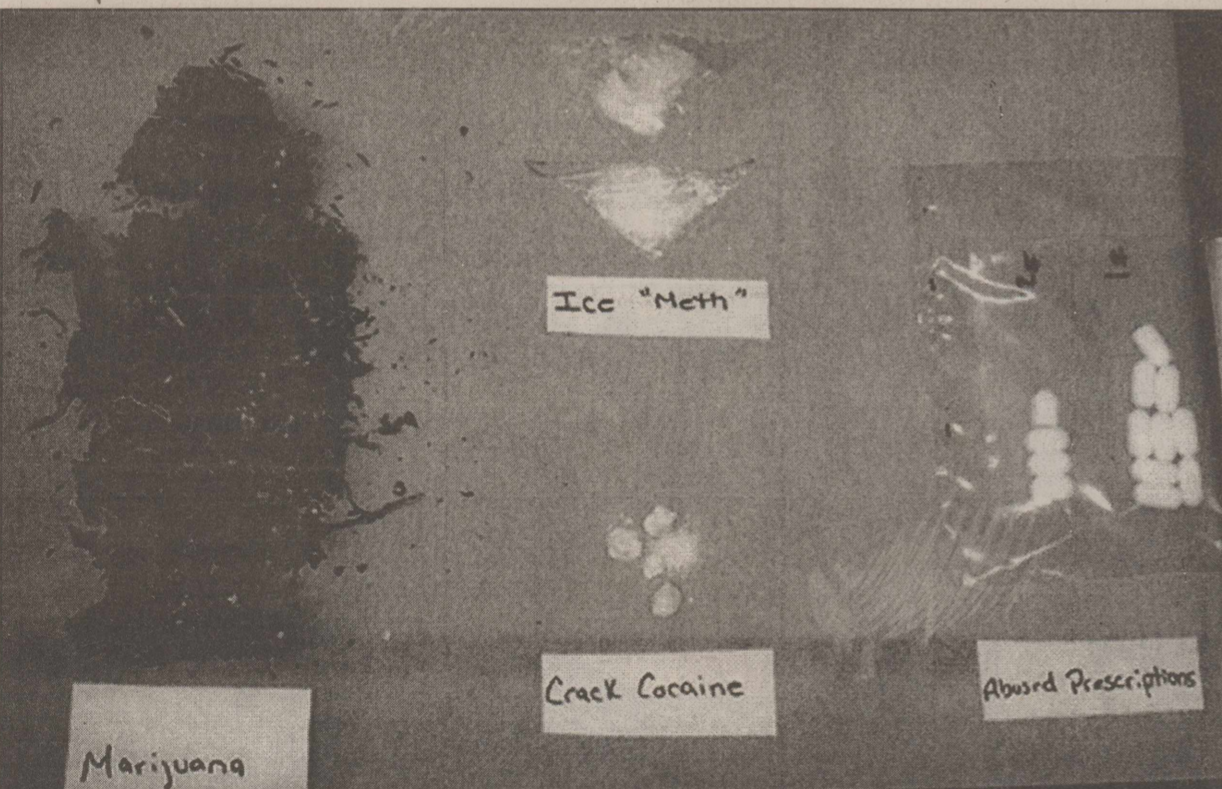
On Wednesday May 25, at 1:30 a.m. as a result of an on going investigation, Knox County Deputy Lee Rowland, assisted by Baylor County Troopers, Jason Zeissel and Todd Lewis, performed a traffic stop which led to the arrest of John Pierce a 45 year old white male, who has an Olney address.

Pierce was arrested for possession of a controlled substance with the intent to deliver. The arrest netted approximately \$800 to \$1000 of methamphetamine in the form of substance with the street name of Ice. Pierce is in jail with a \$50,000 bond.

Knox County Deputy Lee Rowland sated that Pierce has been under suspicion of dealing controlled substances to users in this area for sometime.

Two men arrested, one charged with possession

Sheriff's deputy responds to call

Knox County Sheriff's Deputy Chris Mendoza responded to a welfare call concerning two men with vehicle trouble on Highway 82, Saturday, May 28, at 5:00 a.m.

When Officer Mendoza arrived, he found the two men walking down the middle of the highway.

Both were heavily intoxicated on methamphetamine. Officer Mendoza called for assistance, officer Lee Rowland responded to assist.

Both men were confused and believed they were on Interstate 40 and in New Mexico.

The driver of the vehicle was charged with possession of methamphetamine. Both were out of rehab in Lubbock.

This traffic stop resulted in the arrest of Shawn McIntyre, a white male, 45 years old; and Regan Maze, a white male, 26 years old, both of Lubbock.

Thanks to a concerned citizen who made a call to the sheriff's office, these two subjects were taken off the road before they could be a danger to others traveling on the highway.

The Knox County Hospital District Auxiliary "Pink Ladies" have donated \$15,000.00 for the purchase of a new ambulance.

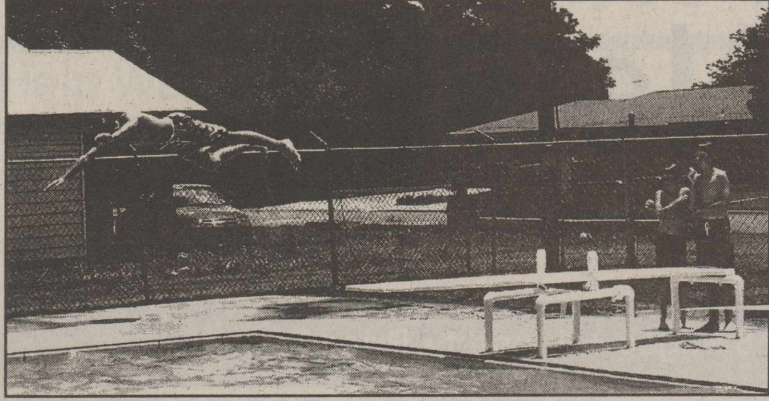
Hospital Board President Clint Jones, commented, "Over the last 14 months, the Pink Ladies have contributed a total of \$30,000.00 for new ambulances. All members of the Auxiliary should be commended in their efforts to assist the District in funding equipment purchases. Without their dedication and commitment to our facility, many of the improvements we have seen over their long

history would not have been possible." Funding provided by the Pink Ladies partnered with grant awards made the replacement ambulance for Knox City a reality. Grants totaling \$79,000.00 were received from the Texas Department of State Health Services Local Projects Grant and The Meadows Foundation.

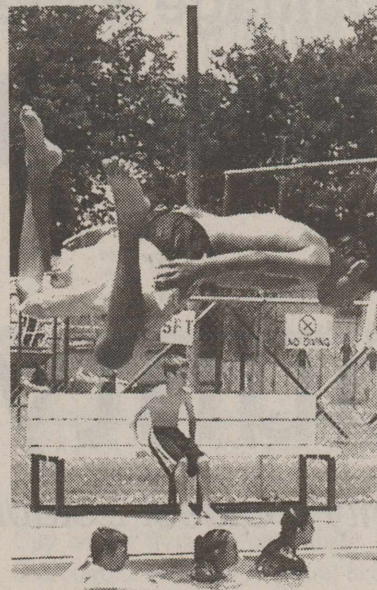
The District assumed responsibility for the EMS in 1993 and continuously recognizes the important role the ambulance service plays in the

Hospital Administrator Stephen Kuehler stated, "The Emergency Medical Service provides a lifeline for our citizens who suffer an acute medical or traumatic event and require pre-hospital intervention. A safe and efficient transport vehicle is an essential element in the care of these patients as well as the patients who rely upon us for safe delivery to a tertiary care facility."

ROLLING PLAINS RAMBLINGS

Frontier Women

Women were an important factor in the settlement of the Western frontier. This was true in Texas, of course, as it was elsewhere.

Men were the usual vanguard of Anglo settlement: the explorers, the hunters, the soldiers. A few women were in each of these categories, but usually the first women on the frontier were the wives of soldiers. Usually, these were the wives of officers.

The frontier was not a hospitable area for these first women. Quarters were often temporary, cold in the winters and hot in the summers. You couldn't go shopping for groceries at nearby stores, or for clothes, or for household goods. Mail from home back east might take weeks, or even months, to arrive. The opportunities for social involvement were very limited.

Perhaps the hardest part of being a frontier wife at military posts was seeing her husband ride or march off, knowing she might never see him again. Her husband might be gone for days or weeks or even months. During this period, the wives would have little knowledge of what was happening.

Rank was an important factor among the wives at military posts, in the west as well as elsewhere. The personality of the commanding officer's wife could make a great difference for the other wives at the post.

Sometimes troops were transferred from one military establishment to another. These moves were made, rarely by rail-

road, but usually by an overland march. The wives, with their children, often would have to travel on these marches.

The wife of Col. Henry B. Carrington described such an 1866 regimental march, Marches could be for hundreds or more than a thousand miles. "Rocking chairs and sewing machines, churns and washing machines, with a bountiful supply of canned fruits were duly stored inside or outside of army wagons, while turkeys and chickens, and one brace of swine, added a specially domestic cast to some of the establishments prepared for the journey."

When a transfer was made, sometimes unexpected tragicomic aspects occurred. In 1873, the Fourth Cavalry under Col. Ranald S. Mackenzie made a toilsome march from Fort Richardson, south of Jacksboro in Jack County. At the time Fort Richardson was the largest army garrison in the United States.

The destination of the march was deep into south Texas, to Fort Clark west of San Antonio in the Rio Grande plains.

After the long trek south, the officers' wives must have been disappointed when they saw the quarters at Fort Clark. The Fort was in a state of dereliction, but was to undergo major reconstruction in the next few years.

However, the condition of the Fort was not their immediate problem. They had two other pressing problems.

Immediately as they arrived, they were informed they were

to entertain at a dance two very important persons, Secretary of War W. W. Belknap and Lt. Gen. Phillip H. Sheridan, commander of the Military Division of Missouri, which included Texas.

Now this would probably have been enough of a challenge to the Fourth Cavalry wives, but they had another problem in preparing to dance with the visitors.

The officers' wives each had a colony of head lice in their hair! They had picked these up when visiting a compound of Comanche women at Fort Concho, at San Angelo, en route from Fort Richardson.

They had to deal with the fleas and quickly, before their dance with Secretary Belknap and General Sheridan.

The Negro maid of Lt. Robert Carter's wife said she had an immediate cure for the head lice. The cure was to wash the hair with a strong solution of plug tobacco and then to massage the head with lard. Well, the wives did this. The treatment got the lice and almost the women, too. The lard caused the hair to tangle. These tangles had to be cut out. With a great deal of effort, the women were able to dress their hair for the dance.

The night of the dance, Mrs. Carter and the other wives were able to dance with Secretary Belknap and Gen. Sheridan, who never knew they almost had to spend the time on their return trip scratching their head.

As I said before, the frontier was often difficult for those early women who came west.

Texas DSHS urges precautions for hot summer temperatures

Forget the thermometer. Hot is hot in Texas in the summer. And whether the weather is dry and parched or humid and damp, intense heat can create serious health problems. Usually the elderly, the very young, people with chronic diseases and those without access to air conditioning are most severely affected by heat, according to the Texas Department of State Health Services (DSHS).

The body normally cools itself by sweating. But under some conditions, sweating is not enough. The body's temperature may rise rapidly to dangerous levels, leading to the possibility of heat illness or death.

The combination of high temperatures and high humidity especially can cause this natural cooling system to work overtime. When humidity is high, sweat does not evaporate efficiently, preventing the body from releasing heat quickly.

Other stresses to the body in hot weather include hard physical activity, fatigue, dehydration, heart disease, obesity, poor circulation, sunburn and prescription drug and alcohol use.

Staying in an air-conditioned area, either at home or in a public place such as a mall, library or recreation center, is the most effective way to combat heat. If air conditioning is not available, pull the shades over the windows and use cross-ventilation and fans to cool rooms.

Symptoms of heat illness include heavy sweating, muscle cramps, weakness, dizziness, nausea, weak but rapid pulse and headaches. People with these symptoms should find shade, drink water slowly and make sure there is good ventilation.

If fluids are not replaced soon enough, heat stroke can follow causing extremely high body temperature, red and dry skin, rapid pulse, confusion, brain damage, loss of consciousness and death.

To help a person showing severe symptoms, get the victim into shade, call for emergency medical services and start cooling the person immediately with cool water or by fanning. Children especially can quickly become dehydrated. They need to drink fluids frequently, especially water, and wear light-colored, loose-fitting clothes.

Avoid drinks that are heavily sweetened or contain caffeine. Check on children often, especially if they are playing outside in high temperatures. Other heat precautions from DSHS:

- * Never leave anyone in a closed, parked vehicle in hot weather, even for a short time.

- * Drink plenty of fluids, but avoid drinks with alcohol, caffeine or a lot of sugar. Don't wait until you are thirsty. Start drinking fluids at least 30 minutes before going out.

- * Plan strenuous outdoor activity for early morning or evening when the temperature is lower.

- * Take frequent breaks when working outside.

- * Wear sunscreen SPF 15 or higher, wide-brimmed hats and light-colored, loose-fitting clothes.

- * Eat more frequently, but be sure meals are well balanced, cool and light.

- * Dress infants and children in cool, loose clothing. Shade their heads and faces with hats or an umbrella.

- * Check frequently on the elderly and those who are ill or may need help.

- * Adjust to the environment. Sudden change in temperature - an early heat wave or travel to a hotter climate - will be stressful to the body. Limit your physical activity until you become accustomed to the heat.

- * Check with a doctor about the effects of sun and heat when taking prescription drugs, especially diuretics or antihistamines. The best defense against heat-related illness is prevention. Staying cool, drinking plenty of fluids, wearing cool clothing and monitoring outdoor activities are keys to staying healthy in hot weather.

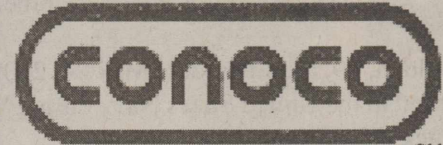

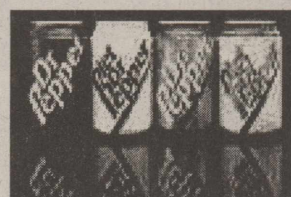

Profit from the sale will go into the drive to raise \$60,000 so the museum can be awarded a \$30,000.00 grant.

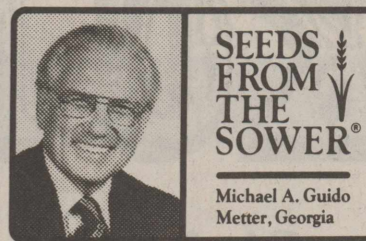
The fund is almost halfway to the goal, with \$25,000.00 brought in so far.
