"Jim is an anchor in the school and the community, an active and faithful layman in the Methodist Church." said Mr. Baker. "When you're in administration, you really appreciate an employee like Jim. He'll be a hard act to follow."

## **Knox County TxDot Crew Conducting Preventive Maintenance**

At the Texas Department of Transportation, (TxDOT), vegetation growing in our right-of-way (ROW) is an important part of preventive maintenance of our roadways. The vegetation will hold the soil against the edge of the pavement. However, if the vegetation is allowed to grow into the pavement, it can cause the roadway to deteriorate because of water leaking in the base and subgrade.

The Knox County Maintenance section has recently been treating the pavement edges with herbicide to prolong the life of the pavement edge and prevent noxious weeds and mesquite from causing a sight problem for motorist.

"We try to keep the ROW as clean as possible, from the edge all the way back to the ROW line", said Gene Ward, Knox County Maintenance supervisor.

TxDOT maintenance crews conduct these types of operations as preventive maintenance of roadways.

= ROLLING PLAINS RAMBLINGS

When the Confederate forces settlers who organized to protect settlers were enjoying a square

at Charleston, S.C. opened fire on the U.S. installation at Fort Sumter on April 12, 1861, the Civil War began and changed the life of almost every American.

This was certainly true in West Texas. The impact on West Texans was unique to the nation.

West Texas was then the frontier of white settlement. A string of forts from the Red River to the Rio Grande was established along the frontier to protect settlers against Indians who inhabited the area. As Texas joined the Confederate States of America, Federal forces withdraw from this line of forts, including Camp Cooper in Throckmorton county and Fort Belknap in Young county.

The threat to frontier settlers was not Union forces, but rather Comanches and other Southern Plains Indians. Soldiers and many of the young men had gone east to fight the War. Many settlers moved back to mid- or eastern Texas. Some hardy souls, however, chose remained to protect their homes.

For a while only occasional skirmishes with the dominant Comanches threatened the stubborn settlers. "But after the Elm Creek Raid by Comanches in October of 1864, in which several people were killed and three were kidnapped, several families decided to gather in a common location for protection against the Indians.

"On October 20, 1864, a stronghold called Fort Davis was established in Stephens County. It was only one of several such 'forts' along the frontier"

These were not government forts, with soldiers; these were their families.

"The post was located on the east side of the Clear Fork about fifteen miles downriver from Camp Cooper. It measured about 300 by 325 feet, and a street ran through it from east to west. About twenty picket-style houses with dirt roofs were set so as to form a loose stockade. A picket stockade fence around the entire fort was begun but never completed. A large stone house built earlier at the location served to anchor one corner of the works and provided protection for women and children in case of attack'.

"Although an attack never materialized, inhabitants did have several confrontations with the hostiles in the area around the outpost."

Life in Fort Davis was much like that of any frontier settlement, except the men were required to spend one-fourth of their time on guard or related duties. Travel to established communities to buy goods was limited. No cloth was available. All had to be spun into thread, then woven to make clothes. Women had to make soap had be made from lye bleached from wood ash. Life was not easy.

"In 1865 Sam Newcomb opened a school in a structure on the northeast corner. Supplies for the inhabitants had to be freighted in by wagon from Weatherford, to the east, a dangerous journey of some days over poor roads. Originally, the flag of the Confederacy flew over Fort Davis but was destroyed by lightning and not replaced.

In 1866, one of these confrontations occurred while

dance. The music was loud and everyone was having a good time. Not until the next morning did the settlers learn some Comanches had enjoyed the dance as well. They discovered numerous moccasin tracks on the muddy banks of the Clear Fork, only about 20 steps from the Fort. They also discovered that some of their horses were missing.

Fort Davis continued to provide protection for those subborn families for some time following the War.

"Fort Davis was abandoned in 1867 when Union troops returned to the area to establish Fort Griffin on the Clear Fork about ten miles upriver, a site much preferred to the unsatisfactory one further upriver where Camp Cooper was earlier located. Today the site of Fort Davis is owned jointly by H. G. Law and the Jones Company of Albany. The stone structure has been restored by Joe Carlton as a hunting lodge. The tombstone of Sam Newcomb is still visible near the site'

Much more information is available about "Forting In." Mrs. Sallie Reynolds Mayhem wrote about "forting in" in her autobiography, Interwoven, published in 1936 by the Anson Jones Press, Houston. Don H. Biggers wrote Shackleford County Sketches, published by The Albany Press in 1908. These items are both difficult to get.

More readily available to most is an excellent source sponsored by The Texas Historical Association: The Handbook of Texas Online You can find this on the internet by entering http://www.tsha. utexas.edu/handbook/online.



## Letter to the Editor

#### Dear Editor,

I urge you to report objectively on legislation which would end the filing of reckless lawsuits against America's law-abiding firearm industry (S. 397/ H.R. 800). Your readers deserve to know the truth, or at minimum, to hear both sides of this very important issue.

The legislation simply prohibits the filing of merit less lawsuits against America's firearm industry for the criminal misuse of an otherwise properly operating and lawful product.

S. 397/H.R 800 would not prohibit lawsuits against the firearm industry for legitimate reasons, such as the manufacture of a truly defective firearms or deliberate criminal actions by a licensed dealer who sells a gun. The only suits that would be precluded under this proposal are those that seek to hold the lawful gun industry liable for the criminal acts of third parties; the same industry that provides arms to our fighting men and women in the U.S. military.

On April 9, 2003, the U.S. House of Representatives passed its version of lawsuit preemption by an overwhelming bipartisan vote of 285-140. Last year, the Senate version had the support of more than 55 Senators. It also had (and has) the full support of the Bush White House. On top of this, 33 states have enacted their own laws to outlaw these offensive abuse of our judicial system.

It's far past time that common sense prevailed and the U. S. Congress passes this legislation and it is enacted into law.
