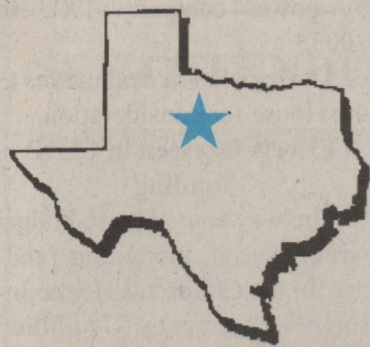

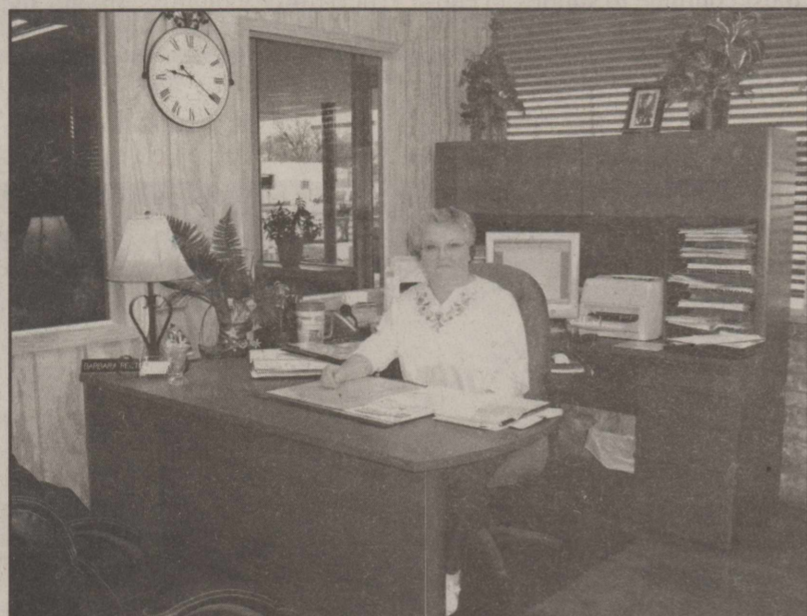

## Out Of The Old And Into The New

The City of Knox City recently completed the transition from the former municipal offices located in the downtown business district to their new home, best remembered as the old Dairy Queen building, on East Main Street.

The entire project, once the building was purchased in November, was completed fairly quickly. The City gained possession of the building in De-

cember after the purchase in November, and they began work soon afterward. The City offices were completely moved in by March 7th. There is still some outside work to be done, though. A brick wall will be formed to the east of the drive through window and drop box lane, both of which have been taken advantage of by the public, according to City Administrator Barbara Rector.

## Construction To Begin For "Awnings Over Knox City" Project



A-Team Construction tears down dilapidated awning in front of Fitness For Life Gym

Last week, preparations began for the first new awning to go up in the downtown Knox City business district.

A-Team Construction of Knox City quickly tore down the dilapidated awning that was in front of the Fitness for Life Gym, located at 120 N. Central,

just north of Duckwalls.

According to Knox City Chamber of Commerce Executive Director Daveine Clark the new awning should start going up in the next three to four weeks. The awning will be tan metal with a light blue underside. "It will be really pretty

when it goes up," Clark said. The "Awnings Over Knox City" Chamber project received grant help last spring in partnership with the City of Knox City.

The grant total was \$3500 and came from the West Central Texas Workforce Development Board in Abilene.

## Annual Sausage Dinner Successful

The annual St. Joseph's Catholic Church Sausage Dinner was held Sunday, March 18 at the Knights of Columbus Hall in Rhineland, Texas to raise funds for the St. Joseph's Catholic Church Building Renovation Fund.

In addition to raising funds with the dinner, bulk sausage was also sold and the Mother Society Country Store sold baked goods and craft items. There were also raffle prizes.

Approximately 915 people attended Sunday's meal. About fifteen hogs were butchered and 1800 pounds of sausage was made for the event.

This was one of the highest attended fundraisers in a few years.

The church, where construction was begun in the 1930's and completed in 1951, is a Knox County landmark, and was in need of several renovations.

## Ribbon Cutting Held For Dollar General Store's Grand Opening In Munday

Munday has seen some big changes over the last year, and all are impressive. First, the west entrance into the city changed dramatically with the replacement of sidewalks and the addition of globe lanterns along the new sidewalks.

Then came the cleanup of the lot across the street from the elementary school and the addition of Centennial Park there.

As time traveled on, the view changed again with the addition of the highway bypass on the eastern side of Munday, and now a new Dollar General store.

Several months ago, Dollar General began receiving letters postmarked from Munday. One from the City of Munday, another from the Development Corporation of Munday, and a petition with 750 signatures all in favor of Dollar General coming to Munday. The signatures were gathered by Edith Hobert.

In September of 2006, representatives from Dollar General visited Munday.

"They came in from Lubbock and were really impressed with the city," said Munday City Manager Dwayne Bearden. "We took

them down and showed them the land, and that was all it took, they were ready," he continued.

In November, construction of the store began.

On February 28th, the store had a soft opening. The store was open for business a little over two weeks before the Grand Opening on March 17th. A ribbon cutting was held at 8:45 that morning.

On hand were representatives from the Chamber of Commerce, the Development Corporation of Munday, the City, including Mayor Robert Bowen, and Edith Hobert.

The 8,581 square foot store boasts wide, clean and well-lit aisles in addition to a wide array of merchandise.

The store has a staff of nine, all very friendly and helpful. The store manager is Traci Blair, a Munday native who recently moved back to the town.

The store has remained busy since its soft opening on February 28th. "Dollar General is real pleased with it," said Blair.

Dollar General is located at 331 E. Main Street in Munday. Store hours are Monday through Saturday, 9 a.m. to 8 p.m. and

AUSTIN — The Texas Youth Commission board of directors resigned March 16 under pressure from the Texas Legislature.

The board's final act was to submit a plan to fix problems at the agency that led to recent reports of sex abuse, beatings and neglect of confined youths.

After submitting the plan at an emergency meeting, the board turned over its duties to

the agency's acting director, Ed Owens.

Even before lawmakers gave the board votes of no-confidence and filed related legislation addressing failures of the agency to meet its obligations, perhaps the loudest voice for swift change was that of Lt. Gov. David Dewhurst.

"I believe the resignation of the Texas Youth Commission board and the submission of a rehabilitation plan will finally allow us to begin making real progress toward reforming the TYC," Dewhurst said.

The lieutenant governor, who is co-chair of the Legislative Audit Committee, said the plan will be reviewed, as will the just-released state auditor's report on the TYC.

Officials will take "whatever action is necessary to protect the children and restore the public

trust in this agency," Dewhurst said.

Owens publicized a list of pledges he intends to fulfill as interim director. A few of those pledges are these:

- To centralize human resource functions to include criminal background checks for new hires and to collaborate with the

Department of Public Safety in conducting monthly notifications of employee arrest;

- To make it so new employees are hired through a central hiring office instead of at TYC facilities.

- To demand that abuse, neglect and exploitation, and complaint policies be redrafted to include review and approval by designated executive staff with notification to the executive director; and

- To restructure programs to

be age appropriate and match the psycho-social stage of confined youths.

## Speaker creates education panel

House Speaker Tom Craddick on March 16 announced the formation of the House Select Committee on Higher and Public Education Finance.

The nine-member, bipartisan committee's task will be to improve public and higher education finance policy so Texas will do a better job of preparing students for college and entering the workforce.

Craddick said improving college and workforce readiness "is immensely important for increasing Texas' competitiveness in the global market."

Committee Chairman Dan Branch, R-Dallas, said, "It's critical that we get this right. We must continue to supply an edu-

cated workforce, so employers will keep relocating to Texas."

## Senate passes utility reforms

The state Senate on March 15 approved a package of electric utility reforms lawmakers hope will bring more affordable rates to many Texas households.

The legislation, authored primarily by Sen. Troy Fraser, R-Marble Falls, also discourages market price manipulation and has safeguards to protect low-income, elderly and critical-care customers from having their power cut off.

"Electric rates are out of control and we need to reel them back in," said Sen. Eddie Lucio, D-Brownsville.

The Senate passed a Lucio amendment that would require power companies to refund any unfair overcharges to customers, pending review by the Public Utility Commission and the

state attorney general.

Customers reportedly paid \$70 million in overcharges because of market manipulation by power company TXU in 2005.

The legislation next moves to the House for consideration.

## Effects foreseen in CHIP funding

The way some House budget writers see it, increasing funding for the Children's Health Insurance Program by \$78 million means cutting other programs that mostly benefit the needy.

According to figures by the House Appropriations Committee, cuts of about \$25 million to Medicaid, plus cuts to breast and cervical cancer programs, community mental health crisis centers, substance abuse programs, foster care programs, and independent living centers would make up the difference.

The wall will be made up of bricks recovered from past demolition projects throughout the city. It will gently stagger to a maximum height of six feet.

"This was all done pretty economically," said Rector. "Most of the work was done by city employees." The only things hired out were the roofing and heating and air conditioning installation.

At the back of the building, a pipe fence will separate the drive through lane from the parking area. This is partly to prevent drivers using the drop box and drive through window from cutting across the parking lot and having an accident with someone who is backing out of the parking lot, an occurrence that happened during the Dairy Queen days.

The building's interior has separate office spaces for City Secretary Amber Lowe and Rector. A large and beautifully decorated council meeting room is in what once was the main dining area, as is Rector's office. The municipal judge has a private office to hold court, and the building also holds public and employee restrooms, a break room, a storage room and a file room.

The police department is still housed in the old municipal building, but plans are to build a separate structure next to the new city offices for the department in the future.

### PUBLIC NOTICE BRIEF EXPLANATORY STATEMENT CONSTITUTIONAL AMENDMENT SPECIAL ELECTION MAY 12, 2007

#### PROPOSITION 1 (SJR 13)

SJR 13 would amend the Constitution to authorize the legislature to adjust the public school ad valorem tax or tax rates for taxpayers who are aged 65 or older, or are disabled, and who are owners of an exempted homestead. The amendment would thereby allow the legislature to provide tax relief to such elderly or disabled taxpayers who did not receive tax relief as a result of the school tax rate reduction passed in the 79th Legislature, 3rd called session.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide for a reduction of the limitation on the total amount of ad valorem taxes that may be imposed for public school purposes on the residence homesteads of the elderly or disabled to reflect any reduction in the rate of those taxes for the 2006 and 2007 tax years."

tionships of the women with one another as well as the relationships they share with their husbands.

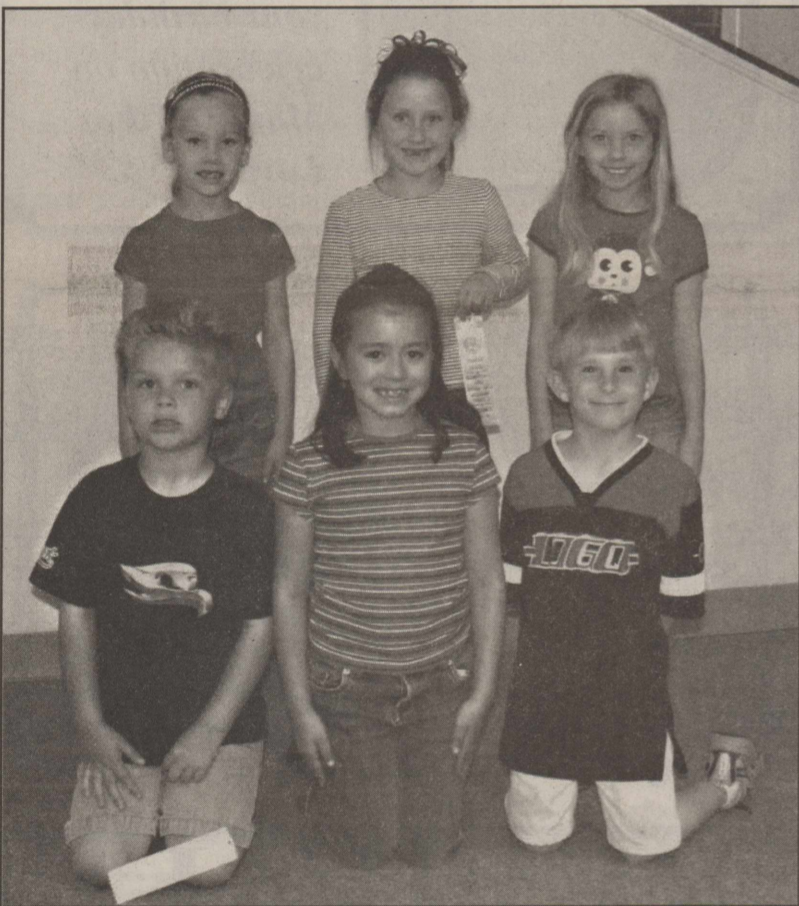

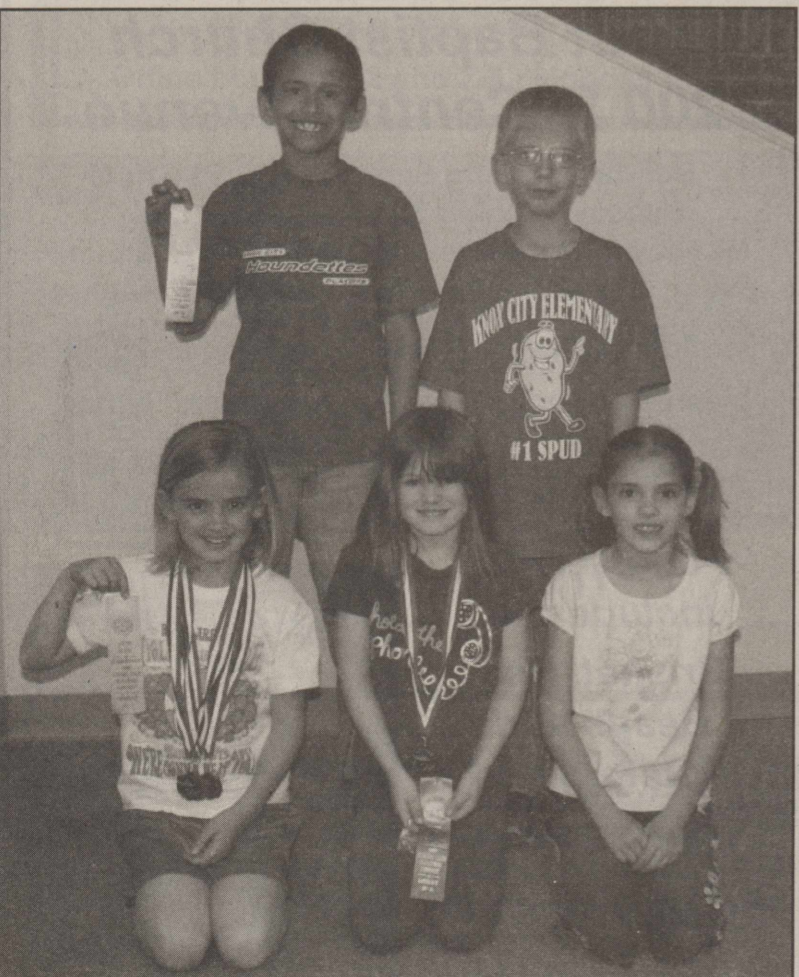

## National Poison Prevention Week Set For March 18-24



AMARILLO – Each year since 1962, the third full week in March has been designated as National Poison Prevention Week.

On March 16, President George W. Bush is expected to continue that trend by signing a proclamation that will designate March 18-24 as National Poison Prevention Week for 2007.

The week gives poison educators an opportunity to remind the public of the dangers of unintentional poisonings and demonstrate ways in which homes and communities can become "Poison Safe."

This year the Texas Panhandle Poison Center, which serves residents within the 71 counties that comprise Texas Public Health Regions I and II, is focusing on "Prevent Poisonings – Clean Out Your Medicine Cabinet" as its theme for National Poison Prevention Week.

According to AAPCC, poison control centers nationwide receive more than one million calls annually regarding poison exposures involving children 5 years and younger and about 30 children younger than 5 years old die each year from unintentional poisonings.

Most of these poisonings are from products commonly found in the home: personal care products, including baby oil and mouthwash containing

ethanol; household cleaners, including drain openers and oven cleaners; over-the-counter pain relievers, including ibuprofen, acetaminophen, aspirin and cough and cold medicines; hydrocarbons, such as lamp oil and furniture polish; and adult-strength vitamins and supplements containing iron.

Ronica Farrar, who has been the educator for TPPC since 2000, says unused and old medicines are a common source for poisonings and should be cleaned out at least once a year.

"Out of all of the calls that we get, the ones that involve exposure to medicines can be the most frightening," Farrar said. "Just one tablet or capsule of some medications can be extremely dangerous if it is taken by a child or by an adult for which it was not prescribed."

To clean out a medicine cabinet, Farrar says the goal should be to remove and safely dispose any old or leftover medicines, whether prescription or over-the-counter.

"If you have questions about whether a medicine is still good or not, contact your pharmacist. Otherwise, when in doubt, clean it out."

She suggests cleaning out medicine supplies once a year at a time when interruptions are less likely to occur.

"You don't want to take medicines out and have them

accessible to children or pets while you're cleaning the medicine cabinet."

Farrar said flushing medications can be hazardous for the environment and that some communities have household waste disposal programs in place to help people safely discard outdated or unused medicines.

If no local programs are available she suggests placing solid medications in a one-gallon zip-lock baggie and crushing them.

Next, add water to the baggie to dissolve the crushed medication and then add Kitty litter or a solid kitchen substance like flour to the mixture.

Finally, the baggie should be sealed and placed directly into an outdoor trash collection container or a secure indoor trash receptacle.

For added safety, Farrar said the entire baggie can be placed in a sealable container such as a small bucket with a lid or an old coffee can.

She said liquid medications can also be placed in a sealable bag with water and kitty litter.

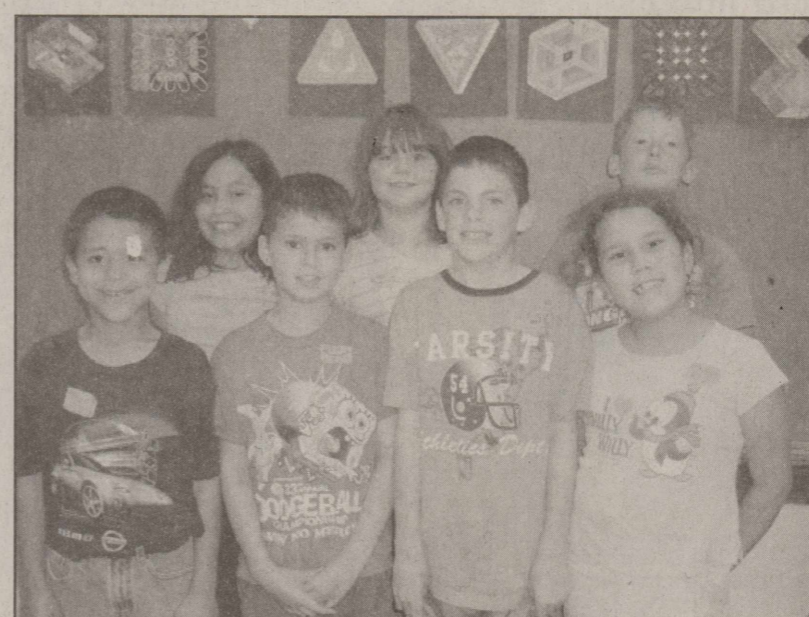

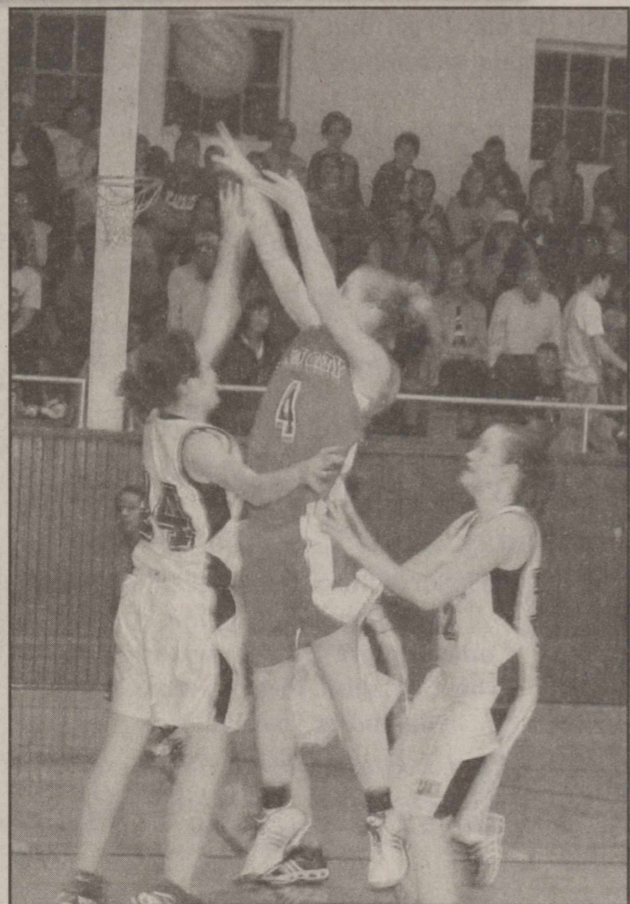

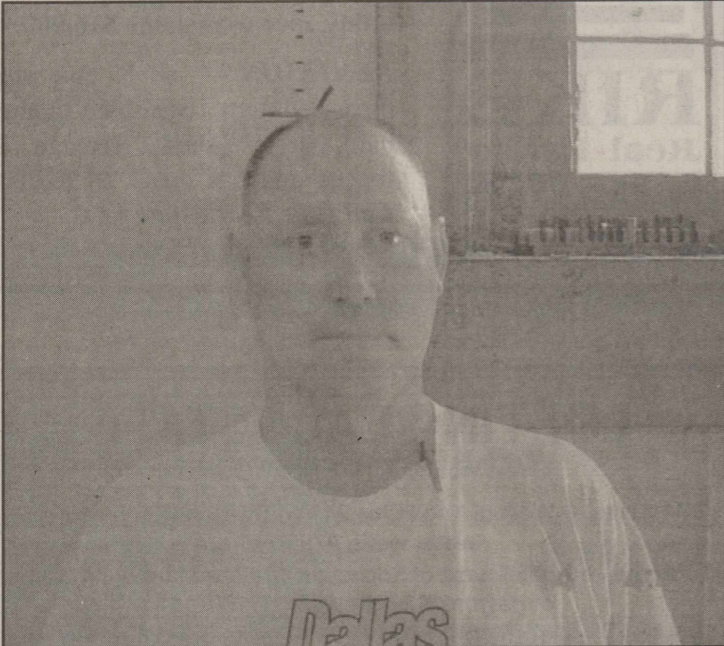

## ORDINANCE NO: 2007-1

### AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BENJAMIN ORDERING A SPECIAL ELECTION TO BE HELD ON MAY 12, 2007 FOR THE PURPOSE OF VOTING FOR OR AGAINST THE

adoption of Section 4B sales and use tax at the rate of one-half of one percent to undertake projects as described in Section 2(11)(A) and Section 4B of Article 5190.6 of Revised Civil Statutes, including but not limited to projects for the promotion of professional and amateur athletics and sports including stadiums, ball parks, auditoriums, projects related to entertainment, convention, tourist, and exhibition facilities, amphitheaters, concert halls, military facilities, including closed and realigned military bases, primary job training facilities for use by institutions of higher education, research and development facilities, regional or national corporate headquarters facilities, museums and related stores, restaurant, concession, and automobile parking facilities, related area transportation facilities, and related roads, streets, and water and sewer facilities, recycling facilities, and projects to promoted new or expanded business enterprises that create or retain primary jobs, and public safety facilities, streets and roads, drainage, and related improvements, demolition of existing structures, development and expansion of affordable housing, and targeted infrastructure and any other improvements, expenditures, or facilities that are related to any of the above projects and any other project that the board determines will promote new or expanded business enterprises that create or retain primary jobs, and the maintenance and operations expenses for any of the above described projects.

WHEREAS. The City Council of the City of Benjamin deems it to be in the best interest of the citizens of the City of Benjamin to order a special election to held on May 12, 2007, for the purpose of voting for or against the adoption of a one-half of one percent sales and use tax pursuant to Chapter 327 of the Texas Tax Code; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BENJAMIN:

SECTION 1. THAT a Special Election be held on May 12, 2006, which date is the next succeeding uniform date available for municipal elections for which sufficient time elapses for the holding of an election after passage of this Ordinance. Said election shall be held to determine whether a one-half of one percent sales and use tax should be imposed for the above stated purposes pursuant to Chapter 327 of the Texas Tax Code.

Page 2, Ordinance 2007-1

SECTION 2. THAT ballots shall be prepared in accordance with the applicable provisions of the Election Code so that voters may cast ballots either for or against the measure, which shall appear on the ballot substantially as follows:

The adoption of a Section 4B sales and use tax at the rate of one-half or one percent to undertake projects as described in Section 2(11)(A) and Section 4B of Article 5190.6 of Revised Civil Statutes, including but not limited to projects for the promotion of professional and amateur athletics and sports including stadiums, ball parks, auditoriums, projects related to entertainment, convention, tourist, and exhibition facilities, amphitheaters, concert halls and public parks, park facilities and events, open space improvements, military facilities, including closed and realigned military bases, primary job training facilities for use by institutions of higher education, research and development facilities, regional or national corporate headquarters facilities, museums and related stores, restaurant, concession, and automobile parking facilities, related area transportation facilities, and related roads, streets, and water and sewer facilities, recycling facilities, and projects to promote new or expanded business enterprises that create or retain primary jobs, and public safety facilities, streets and roads, drainage and related improvements, demolition of existing structures, development and expansion of affordable housing, and targeted infrastructure and any other improvements, expenditures, or facilities that are related to any of the above projects and any other project that the board determines will promote new or expanded business enterprises that create or retain primary jobs, and the maintenance and operations expenses for any of the above described projects.

SECTION 3. THAT the election shall be held at the City Hall, 303 South Hinton, Benjamin, Texas 79505, and all persons qualified to vote in the City of Benjamin under the election laws of the State of Texas shall be allowed to vote therein. Said Special Election shall be held and the polling places shall be open from 7:00 a.m. to 7:00 p.m.

SECTION 4. THAT notice of the election shall be published in a newspaper of general circulation in the City of Benjamin by publication of a Notice of Election as required by Chapter 4 of the Texas Election Code at least once not earlier than the 30th day or later than the 10th day before the election day. In addition, notice of the election shall be posed as required by the Texas Election Code.

Page 3, Ordinance 2007-1

SECTION 5, THAT early voting shall commence on the 1st day of May 2006 and shall conclude on the 9th day of May 2007, and be conducted at City Hall, 303 South Hinton, Benjamin, Texas on weekdays, other than City holidays, during the regular hours of business, which are from 8:00 a.m. to 5:00 p.m. except that on the 1st day of May and the 8th day of May early voting will be held from 7a.m. to 7:00 p.m.

SECTION 6, THAT applications for voting by mail may be accepted beginning March 14, 2007 and concluding on May 4, 2007. Applications are available from City Hall.

SECTION 7, THAT the election judges to serve at the polling place of the election shall be and are hereby appointed as follows:

SECTION 8, THAT there shall be a minimum of one (1) and a maximum of two (2) election clerks at the polling place, which includes the alternate election judge.

SECTION 9, THAT the presiding election judge and at least two (2) election clerks shall also serve as the Early Ballot Voting Board to count the ballots received in early voting by personal appearance and early voting by mail

SECTION 10, THAT the election judges and election clerks shall be paid at the rate of \$ \_\_\_\_\_ per hour and the election judge shall receive and additional \$ \_\_\_\_\_ for the delivery of the returns of the election.
