



## KCPD Investigating Child Left On School Bus

An investigation by the Knox City Police Department is underway concerning an incident in which a pre-school student at Knox City-O'Brien C.I.S.D. was left on a bus on September 13. The child, whose backpack was found on the bus the next day, exited the bus at some point after it was parked in the bus barn and went looking for help.

When contacted about the incident, Superintendent Louis Baty said, "It's a very unfortunate incident, there's nothing that we can do to change what happened. From this point on, in my opinion, we go forward and make sure it doesn't happen again. We have put some [policies] in place to make sure it doesn't happen." According to Baty, this is not the first time an incident like this has occurred.

Elementary Principal Marsha McGaughey said, "We did have a policy in place for safety, every time the bus is parked after running a route, the driver walks the aisles, checking every seat. And that was done that evening, verified by the person waiting on the driver."

No disciplinary action has been taken by the school district against the driver. According to Baty, the child was not physically harmed.

Everyone is encouraged to go and support the Greyhounds.


## Beware! They're Still Here...

AUSTIN — Businesses can get a clearer idea of how much franchise tax they are going to pay because of tax law revisions, and the state is welcoming feedback on the new rules.

The rules implementing changes mandated by the state Legislature were published in the September 14 edition of the Texas Register, and a 30-day public comment period started.

The 79th Legislature in 2006 and the 80th Legislature in 2007 devised changes to the franchise

tax to help pay for a sweeping property tax cut.

"It is important for all franchise taxpayers, especially those who will be required to report franchise tax for the first time, to review these proposed rules," Texas Comptroller Susan Combs

The Legislature revised the franchise tax by changing the tax base and the tax rate and extending coverage to most legal enti-

About 200,000 new entities will have to file franchise tax reports in 2008.

The rules are expected to be adopted in December, according to the Comptroller's office.

Taxable entities with total revenue of \$434,782 or less and entities that calculate they owe less than \$1,000 in franchise tax will not be required to pay the tax, but will still have to file a report, Combs said.

How to pay for it is the question

Texas transportation officials announced plans to form a working group to figure out how to pay for the Ports-to-Plains Corridor road-building project.

Ports-to-Plains is a proposed divided highway running from Laredo through West Texas to Denver, Colo.

Designated as a High Priority Corridor by Congress in 1998, planners intend Ports-to-Plains to expand economic opportunity and serve international trade from Mexico to Canada. Despite the congressional designation, adequate federal funding has not been provided to cover the cost of the project, officials said.

In addition to economic development and job creation, officials said the corridor could provide a way to transfer energy generated by wind turbines in West Texas to other parts of Texas and the Southwest.

**Amnesty program** brings in bucks

Comptroller Combs' tax amnesty program, Project Fresh Start, brought in more than \$100 million in unpaid taxes from June 15 through Aug. 16.

The amount included more than \$90 million in state taxes and more than \$10 million owed to local governments, Combs

A total of 1,258 businesses reported and paid delinquent taxes. Between 3 percent and 5 percent of those were new taxpayers operating businesses without required tax permits and without paying state taxes.

In exchange for their cooperation and payment, the comptroller waived penalty and interest charges normally added to delinquent taxes.

> Land board rejects all proposals

The School Land Board, chaired by Land Commissioner

Jerry Patterson, on Sept. 18 rejected all six bids for the purchase of the 9,200-acre Christmas Mountains ranch tract in Big

Patterson said a mistake in the map of the tract in the original bid specifications was the reason.

The Land Board, which will meet again in November, is expected to consider bids again.

"Moving this land out of government hands is in the best interest of the land and those who want to preserve it," he added.

If a Texas public school teacher wants to be state certified to teach a foreign language, the choices are Spanish, French, German or Latin at the secondary school level.

But beginning in October, they can become certified to teach Arabic, Chinese, Japanese, Russian and Vietnamese in prekindergarten through 12th grade

Karen Loonam, director of educator standards at the Texas Education Agency, said "These five new certificates were created to be responsive to the needs of multicultural communities and to prepare students for increasing globalization of the economy."







Rattlesnakes do not always give a warning before they strike, and rattles that are saturated with water probably won't make a rattle.

Rattlesnake bites usually occur in humans when they startle the snake or they provoke it.

Many people don't realize that a snake has a farther striking distance than they assumed, and greatly underestimate it.

A snake can strike a distance of one-third to one-half its body length, and the strike is typically faster than the human eye can completely process. Rattlesnakes can also strike when not in the "S" coil position.

Rattlesnakes are born live from mid-summer to early autumn and with fully functioning fangs and venom. Rattlesnakes are capable of controlling the amount of venom that they release, though a startled snake or one who has been injured may not use that capability. A dry bite or a bite with less than the full amount of venom may be more of a defensive bite.

Around 8000 venomous snake bites are reported each year. Fewer than fifteen snakebite deaths are reported.

Even so, a rattlesnake bite re-

quires quick medical attention. It is very important to keep a rattlesnake bite victim calm. An increased heart rate will allow the venom to do its work more quickly by allowing it to travel through the body faster.

Anti venom must be given to stop the tissue destruction, nerve effects and blood-clotting disorders common with rattlesnake venom. It is not recommended for untrained individuals to cut around the injection site or to restrict the flow of blood, as this could cause more injury.

Prevention of a snake bite is the key. Always be aware of your surroundings. Do not handle snakes or provoke them in any way. Do not turn rocks, limbs or other items on the ground over with your bare hands.

Use a tool, instead. Step up onto rocks or limbs instead of over them and do not put your hands into animal holes or onto ledges that you only have partial sight of. Also be cautious when walking through high grass, or, at this time of year, fallen leaves that may cover the ground.

Offer snakes respect. Observe them from a safe distance and allow them to perform their function in life when it will not interfere with your safety.


## Junior High And High School Lose Against Lueders-Avoca
