




Mrs. Pat Grimsley is also



Once again the second and third weekends at the Expo Center in Abilene were roaring with excitement as stock showers took to the grounds exhibiting their animals in their respected classes. Again this year Knox County was well represented for the livestock portion of the events.

On Saturday September 10th the lamb shows took pace with Show A beginning in the morning and Show B immediately following in the afternoon. Each show consisted of four classifications of lambs which included Fine Wool, Fine Wool Cross, Medium Wool, and Southdown classes. Kristen Kuehler from Munday had a successful weekend with her three lambs. In Show A Kuehler received a 5th & 6th place with her Fine Wool Crosses and an 11th place with her Medium Wool. In Show B Kuehler received a 1st and 3rd place with her Fine Wool Crosses in which she also received Reserve Breed Champion Honors. In the Medium Wool Class she received a 4th place.

Swine took to the arena the following weekend beginning with the showmanship classes in which all exhibitors competed and did well. 

Postal Service to maintain its nearly 32,000 retail offices, the largest retail network in the country, diminishes. • To that end, the U.S. Postal Service announced July 26 that it will be taking the next step in right-sizing its expansive retail network by conducting studies of approximately 3,700 retail offices to determine customer needs. "Today, more than 35 percent of the Postal Service's retail revenue comes from expanded access locations such as grocery stores, drug stores, office supply stores, retail chains, self-service kiosks, ATMs and usps.com, open 24/7,"

said Postmaster General Patrick Donahoe. "Our customer's habits have made it clear that they no longer require a physical post office to conduct most of their postal business.

For communities currently without a postal retail office and for communities affected by these retail optimization efforts, the Postal Service introduced the Village Post Office as a potential replacement option. Village Post Offices would be operated by local businesses, such as pharmacies, grocery stores and other appropriate retailers, and would offer popular postal products and services such as stamps and flatrate packaging.

"By working with thirdparty retailers, we're creating easier, more convenient access to our products and services when and where our customers want them," Donahoe said. "The Village Post Office will offer another way for us to meet our customers' needs." The Postal Service of the future will be smaller, leaner and more competitive and it will continue to drive commerce, serve communities and deliver value." Donahoe added.

The Postal Service receives no tax dollars for operating expenses, and relies on the sale of postage, products and services to fund its operations.

Flu vaccine protects from all viruses currently circulating in the Southern Hemisphere

HOUSTON – With the 9 who got the vaccine last influenza virus already circulating in the Southern Hemisphere, experts are tracking the trends to know what to expect for this year's flu season in the Northern Hemisphere. According to a flu expert at Baylor College of Medicine (www.bcm.edu), the three viruses currently circulating in the Southern Hemisphere are all covered in this year's flu vaccine.

"Currently, influenza B, H1N1 and H3N2 are circulating in the Southern Hemisphere," said Dr. Paul Glezen, professor of molecular virology and microbiology (http://www.bcm. edu/molvir/) and pediatrics (http://www.bcm.edu/pediatrics/) at BCM.

Although the vaccine is the same as last year, immunity does not persist and everyone over the age of 6 months needs to get the vaccine again this year, Glezen emphasized.

year only need one dose this year, but children who have never gotten the vaccine before need two doses of the vaccine, said Glezen.

The live, attenuated vaccine, available as a nasal spray, has been shown to be more effective in children. Healthy individuals between the age of 2 and 49 can get the nasal spray vaccine.

Because everyone is at risk of getting complications from the virus or spreading the virus to someone who could have serious complications from the virus, universal flu vaccinations are recommended.

"Unless you have a severe anaphylactic reaction to eggs or a previous reaction to the vaccine, you should get immunized," said Glezen.

Because babies younger than 6 months of age can-Children under the age of not be vaccinated, family members and friends who are around them should be sure to get vaccinated to prevent them from getting the virus.

Glezen also points out that studies are increasingly showing the benefits of the flu vaccine for pregnant women, and they should get the vaccine as soon as possible. Having influenza virus infection in the early months of pregnancy can have serious consequences for the fetus, and having the virus in the final months of pregnancy can have serious consequences for the mother.

The High School volleyball team also won on Tuesday.



WATERING RESTRICTIONS NOW IN EFFECT


On September 19, 2011, the City Council of Knox City met to review a letter from the North Central Texas Municipal Water Authority (Knox City water supplier) in which was stated, "In light of the continuing drought and forecasts for more of the same, possibly lingering into 2012, we are asking all of our customers to implement their water conservation plans". According to City Administrator, Chad Roberts, "We are losing a lot of water

through evaporation from extreme drought and heat at approximately one foot per month at Miller Creek Reservoir". Due to this high rate of loss and the unpredictability of future rainfall, the City Council passed the Stage 1 Drought Contingency Pla which is now in effect. Under Stage 1, (a) Water customers are requested to voluntarily limit the irrigation of landscaped areas to Sundays and Thursdays for customers with a street address ending in an even number (0, 2, 4.

6, 8), and Saturdays and Wednesdays for water customers with a street address ending in an odd number (1, 3, 5, 7, or 9), and to irrigate landscapes only between the hours of midnight and 10:00 a.m. and 8:00 p.m. to midnight on designated watering days. (c) Water customers are requested to practice water conservation and to minimize or discontinue water use for non-essential purposes.

Drought takes its toll on Texas pumpkin patch

LUBBOCK – Linus of "Peanuts" comic strip fame might be a little disappointed if he waits for the "Great Pumpkin" in a Texas pumpkin patch this year, said a Texas AgriLife Extension Service expert.

Dr. Russ Wallace, AgriLife Extension vegetable specialist at Lubbock, said pumpkins, like all Texas vegetables in 2011, had a hard time struggling through the record-setting high temperatures, low humidity and drought conditions.

"With only limited rainfall, the quality of the pumpkin fruit itself should be excellent, but I expect the overall production will be much less than normal," Wallace said. "I visited with Mark Carroll, AgriLife Extension agent in Floyd County, which is normally our leading pumpkin producing county in Texas. He told me he estimates the actual size of the pumpkins along with the yields this year will be roughly half what they normally are."

So what does this mean for the annual trek to the pumpkin patch for Halloween? Wallace said the shortage in West Texas, coupled with reduced yields from pumpkin growers in the Northeast due to flooding from Hurricane Irene, will likely result in fewer pumpkins, higher demand and higher prices.

Each year, Wallace grows

up to 40 pumpkin varieties in replicated trials at the Texas AgriLife Research and Extension Center in Lubbock. This year, he had 25 varieties and said each of them struggled to make a decent crop.

"Our small pie and minipumpkins don't appear to have suffered much, but the mid- to large-sized varieties grew vines at a slow pace during the high temperatures and really struggled to set fruit," he said.

"About the only good news for the High Plains pumpkin crop this year was that the low humidity reduced the incidents of disease, especially powdery mildew, which infects pumpkin leaves and reduces yield and quality," he said.

"Severe powdery mildew infections can lead to mushy stems or infected fruit, so when shopping for melons, check out the 'handle.' If it's soft, it may be infected and not last until Halloween. If it's a High Plains Texas pumpkin though, that shouldn't be a problem this year."




Texas Rabies -- Dogs and cats




