



LETTER TO THE EDITOR

Dear Knox City,

A few days ago, I received quite the shock as I sat down to read last week's Knox County News. As I went through the Classifieds section, I noticed a small, non-descript ad - - browsing over it quickly, I almost didn't catch what it was about. Within this small ad, was a petition to bring about a vote for allowing the sale of alcohol in Knox City.

I almost could not believe what I was reading. Knox City? Is this something our little town wants to open the doors to?

As I sat and thought on this, trying to come up with reasons on how this could be "good" for our little community, I heard in my mind's eye the "reasons" most people would use to justify the sale of alcohol.

The first being "money." After all, just think of all the money we as citizens are missing out on by not allowing alcohol sales!

And the second being, "Well, they are going to buy it somewhere, they might as well buy it here!" (Which brings to mind the quote most every parent has used at one time or another ... "If your friend jumped off a bridge would you jump too???")

I guess one could argue that we are "missing out" on loads of money that could be made by the sale of alcohol within the city limits and that we are seeing lots of tax dollars "run away from us that could be used for good things", but even though I have read my bible over the years from cover to cover dozens of times - - - and other Scriptures and books of the bible even more times than that, I have yet to find a Scripture that says, "If thou needeth more money, goeth forth and sell alcohol. The Lord your God will bless you in the city with money from your alcohol sales."

I've looked, but I haven't found that yet. Now, I can imagine, if I climb up on my pulpit Sunday and preach a sermon and say, "Let God be first in everything you do and seek Him first!", I will get lots of "Amens!" from the congregation.

What do you think? If we sought God first and let Him be first in everything ... would His answer be "by all means, open the door for alcohol sales in Knox City! Be Blessed!"

Amen or Oh Me?

"But, Tex! You don't understand! We're just trying to help Knox City grow!

I know this is probably too radical for most people, but when I open up the bible I see COUNTLESS ways to bless the city and even more to bless businesses and individuals. "Give and it shall be given unto you ... bring ALL the tithe into the storehouse ... he who sows generously will also reap generously ... honor the Lord with your capital and sufficiency (from righteous labors) and with the first fruits of all your income ... seek ye first the kingdom of God and all these things shall be given unto you..." and on and on and on and on.

I suppose it makes more sense to put faith in alcohol than it does the Word. Amen? Only "crazy" people would TITHE out of their business and let God do the rest. Most have a hard enough time trying to trust God to tithe out of their salary, much less trust Him with our businesses.

"There is no way we can afford to tithe off our business!! Are you kidding me Tex?"

I think on this and it causes me to reflect on all the PAIN I have watched alcohol cause in the lives of people throughout my lifetime.

I recall countless times I watched my cousins as they grew up in an alcoholic home. My experiences with them would literally turn most stomachs. My aunt died from cirrhosis of the liver at the tender age of 42. Regardless of where they bought it ... ALCOHOL is what killed her.

I remember watching a family grieve and literally be torn apart from the loss of their 15 year old son who had just been killed in a car accident after dropping off his "first ever date" from the Sports Banquet. I held my sister for most of the night as she cried out "Why?? Why???" - - - - this young man had asked her to be his first real girlfriend after she graduated the 8th grade and became





Could You Fend For Yourself After A Disaster?

Some scoff at doomsday prophecies, but this year alone, millions of people have endured catastrophes of seeming apocalyptic Consider: proportions. March 11 -- A 9.0 magnitude earthquake violently shakes Japan, unleashing a tsunami that triggers a nuclear crisis. As of Aug. 15, Japan's National Police Agency reported 20,364 people dead or still missing. May 22 -- A Category 5 tornado rips through Joplin, Mo., wreaking 14 miles of havoc, including 159 lives lost and 7,000 homes destroyed. By July 23, recovery was just beginning, according to a Huffington Post report. Those spectacularly devastating events were just two of dozens this year that left stricken survivors without the essentials of modern life: water, shelter, electricity. Could you manage for a few days? A few

months? Author Dan Martin is confident he could -- and comfortably. He and his wife, Lucia, lived off the grid for 10 years on a self-sustaining Texas ranch they built themselves. They grew, raised or trapped their food: made their own ethanol fuel and solar panels; survived on rainwater they captured and purified. Martin's newest book, Apocalypse: How to Survive a Global Crisis (www.ApocalvpseTheBook.com), details lessons gleaned from the experience with illustrated instructions on everything from finding clean water sources to performing an emergency tracheotomy. "We have a lot of backwards to go before we can even think about going forwards again," Martin says. "We've become too comfortable; too secure; too complacent with our lifestyles. I'm not saying we should abandon everything, our air conditioning, our livelihoods, our technology, and go live in a cave. But when you're 100 percent dependent on these systems and they fail for whatever reason, most people have no idea how to cope and continue." A Desert Shield/Storm veteran and former Boeing aerospace technician, Martin

now works as a consultant predictions that the world on sustainable-living initiatives through his and Lucia's company, Agua-Luna, Inc. He says people must first get back to the basics, and there are simple ways anyone can begin now. No matter what the future holds, they'll gain valuable skills. "Take some hunting and fishing trips with experienced hunters and insist on cleaning the carcass of your kill yourself, so that you know what to expect," he advises. While "Apocalypse" includes step-by-step instructions for gutting and skinning an animal, Martin notes that hunting involves complex variables, from tracking to using your senses, that can't be taught in a book. "If you don't know how to work on cars, it's essential you learn quickly," he says. Take a class on basic repairs at your community college, and while you're there, sign up for welding, first aid and food preservation. Try sleeping without pillows and blankets; going for a day or two without food; taking a cold shower. Once you've experienced such deprivations, they won't come as unnerving shocks following a disaster. While Martin's book hinges on

as we know it will end Dec. 21, 2012, he acknowledges other doomsday dates have come and gone uneventfully. One has only to remember the devastation in New York City following Sept. 11, 2001, he says, or the 2004 tsunami that left millions of people in 11 countries homeless, to acknowledge that some of us may one day face surviving on a dramatically changed planet. "Stop for a moment and take a look around," Martin writes. "The quantity and size of today's natural disasters are rising. It's just a matter of time before we experience a major change, be it 2012 or beyond."

From the Office of The Knox County Sheriff

From the Editor: The following article is a continuation of the sheriff's article which ran in the Nov. 17 issue of the Knox County News.

In 2010, the Knox County Sheriff's office along with the greatly appreciated assistance of Michelle Esquivel, secretary to the county judge and county attorney, obtained a grant to purchase a pickup for the sheriff's office. Again, with no cost to the county and tax payers. Again, in 2011, the same situation presented itself, the Knox county sheriff's office along with Ms. Esquivel, were able to obtain another grant for another vehicle. Keep in mind, neither of us are high paid grant writers paid to obtain grants, and had literally no assistance from anyone in getting this money for the county. The only comment we ever heard was "Why did you appy for another vehicle?" Answer, 'Cause that was what the grant was offered for'. Anyway, sounds pretty good. Well, there is more. The older vehicles were sold back to the county at a very reduced cost to be used by the road hands in their work.

You might say, well big deal? Yeah, it is a big deal. Not only did the sheriff's office along with Ms. Esquivel save the county well over \$150,000.00 in the long run not having to purchase vehicles to replace the aging sheriff's office vehicles but also replaced worn out or aging equipment on the vehicles and purchased additional equipment. The saving did not stop

there. As a good gesture, the sheriff's office then passed on the savings to the county again by allowing the county road and bridge to purchase the passed down vehicles at, as stated earlier, a very reduced cost, as in half or less.

Some may say, "Well, you don't have to pat yourself on the back", but I can say, yeah, why not. It takes dedication, persistence, every day determination along with the help of a very few others involved in the grant process, to make some things come to pass. It's not an automatic approval or guarantee that the every day expenses can be controlled when working with something as complicated as the sheriff's office. The organization deals with employees, inmates, a whole host of family members who are concerned about the inmates, budget, supplies, building maintenance, complaints, criminal offenses, general public who need assistance with a number of problems in situations. Assisting other law enforcement agencies, and on, and on, too many to mention. It's not just sitting around waiting for the phone to ring and for time to

I hope all this has not totally confused anyone, as it has me, and I am the one who has the responsibility to keep things somewhat going in the right direction. Thanks for letting me bend your ear a little.

By all means, let's participate in and make MONEY off of pain, misery, death, sorrow, and regrets! Why let them buy all that somewhere else when they can get it right here in Knox City? Amen or Oh Me?

Whether or not you partake in alcoholic beverages really isn't any of my business. You might even be tempted to bring up the fact that "Jesus turned water into wine and gave it to a party full of people." I chuckle as I mention that because I can just hear all the "fermented wine vs. unfermented wine" arguments that will spring up over that. The Word also says in 1 Corinthians 10:23 "You say, 'I am allowed to do anything - - but not everything is good for you. You say, "I am allowed to do anything" - - but not everything is beneficial."

The individual use of alcohol may not be my business, but whether or not alcohol is sold in Knox City IS. Melesha and I may only make up two votes when that day comes, but it is our business whether or not to participate in that vote. It's your business as well.

To tell you the truth, that sums it up. Yes, we all make mistakes, but this is a mistake we can CHOOSE not to make. The Lord tells us in one of my favorite verses in the bible to choose between life and death, blessings and curses ... and then He advises us on how to choose when He says, "Choose life!!!"

Knox City - - - - when this petition becomes an item to vote on, HOW WILL YOU CHOOSE? As for me and my house, we will serve (choose) the Lord!!




