





I feel that, as a taxpayer, you, the general public, need to be informed about "What goes on at the Courthouse."

I am going to try to describe some of the duties of the County Treasurer and what part I play in county government.

According to the "Vernon's Annotated Texas Statutes" the primary duties of the County Treasurer are to receive all moneys belonging to the county from whatever source and pay and apply as directed by the Commissioners Court.

I am also the payroll disbursing officer. I make numerous monthly and quarterly reports. Some of these reports are for Commissioners Court and some must go to the State Comptrol-

There are numerous steps I must take just to pay the bills. All bills received are checked for error, then numbered and recorded in a claims register book according to the fund from which it is to be paid. Then on the second Monday of each month all claims are examined and approved or disapproved during Commissioners Court. Also at this time the salaries and other "line items" are approved. (Line items are the claims against the county that have been approved sometime earlier during the year or before. These are a set amount that must be paid at regular intervals throughout the year.)

After court approval the checks are written and signed by the County Treasurer and the County Clerk and the Clerk's seal

The County Treasurer has no authority to make payment of any claim without prior court

After the checks are mailed, the duplicate is recorded in a docket book under the proper fund. The County has twelve funds, these being: Jury, Courthouse & Jail, General Precincts numbers 1, 2, 3 and 4 and Lateral Road #1, 2, 3 and 4. Also the county has one other fund of Revenue Sharing.

After attending the required schooling for County Treasurers, we were reminded that all county funds should be in interest-bearing accounts. The county now has all funds in interestbearing Super NOW accounts since May of 1987. The county also has some Certificates of Deposit which they have had for some time.

In his effort to accurately depict the colorful history of Motley County, Taylor re-lived the exploits of the people and places he painted with thorough research. Rare and precious history books, yellowed photo-

research. Rare and precious history books, yellowed photographs, and treasured family histories litter his Crosbyton studio. Looking at a picture of the county's first married couple, the D. C. Kieths, Taylor comments, "There's a man without a job," referring to the Matador Ranch's policy of firing hands

who married.

Bordered by the blue, green and purple Scotish clan tartan of the Campbells, the mural is dominated by three main features: Quanah Parker encamped at Roaring Springs; H. H. Campbell, founder of the Matador Ranch, posing by his dugout; and the sprawling headquarters of the Matador Ranch.

Branding, roundup and broncbusting scenes are intermingled with unique personalities such as the buggy doctor, the fire and brimstone preacher, the Hall of Fame cowgirl, the slain sheriff, the Swedish immigrant who lived in a half-dugout for 35 years, and the pony express rider who rode from Quanah to the Golden Gate.

The buffalo hunters' TeePee City, the landmark Quitaque Peaks, the classic Roaring Springs Depot, and sinful Dewdrop Saloon are some of the places Taylor has captured on canvas to share with future generations.

Being engrossed in history is not a new thing for Taylor, who spends his free time roaming local creek beds and caliche hills for ancient bones of three-toed horses, giant salamanders, bison and camels. This particular hobby led to another enterprise, casting reproductions of the rare specimens for museums and history buffs.

December Weather Was Wetter, Colder Than Normal

The weather across the Texas South Plains during the month of December 1987 was wetter and colder than normal.

Temperatures averaged 2.5 degrees below normal and ranged from 0.3 degrees above normal at Snyder to 5.1 degrees below normal at Friona.

Maximum temperatures averaged 3.5 degrees below normal and ranged from 2.1 degrees above normal at Snyder to 6.6 degrees below normal at Dimmitt. The highest temperature reported during the month was 80 degrees at Big Spring. The Muleshoe Wildlife Refuge and Seminole also reported a high of 80 degrees on December 5.

Minimum temperatures averaged 1.5 degrees below normal and ranged from 0.9 degree above normal at the Muleshoe Wildlife Refuge to 6.1 degrees below normal at Friona. The coldest mornings of the month were December 15 and 16, with many reports below zero. Muleshoe had the lowest reports those mornings with nine below zero both times.

Precipitation averaged 0.65 of an inch above normal and ranged from 1.78 inches above normal at Levelland to 0.45 inch below normal at Big Spring. Much of
