# New Information Presented At Second Grant Application Hearing

Briscoe County Judge Jimmy Ross opened Monday's meeting and turned it over to Perna Strickland of Panhandle Regional Planning Commission, who said, "This is the second required public hearing for the grant application that we discussed with you previously. This will be a grant to the County of Briscoe for a loan to Briscoe County Processing, Inc. This particular project is over a million dollar project. The loan from the county to the business is just a portion of this. We are really looking at quite an injection into your county. The loan will be for construction, equipment and working capital. Construction portion of the project will be approximately \$275,000.

"The project will be located three miles east of Silverton at the intersection of Highways 256 and 86 on forty acres of land. The equipment for this particular project is very specialized. This is a unique process for peanuts and sunflowers. The total cost is \$883,000, \$490,000 of which is to be loaned to the business by Briscoe County and the balance of the equipment cost is to be financed by Archer & Archer, Inc.," Ms. Strickland said.

"Briscoe County Processing, Inc. will have a lease-purchase agreement with Archer & Archer, Inc. for that equipment. There will be an injection of \$40,000 in working capital funds for Briscoe County Processing, Inc. from Archer & Archer. The time frame that we are looking at now for the application is that I will submit this to the Texas Department of Commerce by February 15. This will be reviewed by the staff there. It takes about a month to complete review of applications from across the state of Texas. We should have a decision by the first of April as to whether the application has been approved," she continued. "Then Briscoe County plans to contract for the administration of this grant with PRPC. We have included \$10,000 in the grant to cover the cost of administration, so this will not be an additional expense to the county. Once approved, we will do what is required with all the legal documents so the project can proceed. The business has two years in which to complete the project. By the end of that two-year period, Briscoe County Processing, Inc. will have created 33 full-time new jobs. We are also looking at other positive economic factors which should increase the tax base of the county by diversifying your agricultural industry and we anticipate spin-off businesses from this particular project. Everyone should experience positive things from this coming into

your county. Also I think Archer & Archer and Briscoe County Processing have some plans that they hope in the future will increase their industry. As you heard (from the reading of the minutes of previous commissioners' court meetings), Briscoe County is to loan the funds at an interest rate of 3% and the court will have to set the terms of repayment of these funds."




The March of Time Study Club met in regular monthly session Thursday, February 4, at noon with a Brown Bag Lunch at the City Hall Conference Room.

# **Farmers Should Be Preparing To Seed CRP Grass**

Briscoe County farmers who have bid their land into the Conservation Reserve Program and have their dead litter cover ready should be preparing to get the grass seed planted. A few farmers have already planted their grass prior to the snow and with good spring and early summer moisture have a good chance of getting grass up and off to a good start.

Optimum dates for the remainder of the planting season for establishing warm season grasses is February 15-April 15. Grasses seeded within this time span usually with good moisture

If wheat is your dead litter crop you will need to kill the wheat so grass will be able to get started. The wheat stubble needs to be tall enough to make a good cover. The wheat needs to be a minimum of 3-4 tillers prior to killing. Preferably the wheat needs to be 8-12 inches tall to be adequate. This generally requires longer growing periods in

# **Farmers Need To Plan For Highly Erodible Land Treatment**

Farmers with highly erodible cropland have less than two years to begin meeting the conservation requirements of the 1985 Farm Bill to remain eligible for USDA benefits.

John Crowell, district conservationist for the USDA Soil Conservation Service at Silverton, said these provisions require farmers who have highly erod-

-0-

ible cropland to have a conservation plan approved by their local soil and water conservation district by 1990.

'The plan must be prepared by January 1, 1990, if they want to remain eligible for farm program benefits, loans, or guarantees on all their land," Crowell said.

"We estimate that about 240 new conservation plans need to

20-

be prepared for local farmers by our staff by 1990. Our goal is to get at least 200 written by the end of this year.

"Then we will try to schedule the remaining plans during 1989.

Crowell said the planning workload will be difficult for the local SCS staff, especially if farmers wait until the end of 1989 to begin developing plans.

The sooner farmers ask SCS to help them develop a conservation plan, the greater the chance we will have to get everyone by the deadline, Crowell stressed.

Since highly erodible land is not always obvious, farmers should check with their local SCS

office to see if they have land that meets the criteria if such a determination has not already been made.

Another option is to enroll highly erodible land into the Conservation Reserve Program. Under CRP, farmers receive annual rental payments for putting such cropland in grass or trees.

"If people who grow commodity crops on highly erodible cropland do not want a conservation plan and want to give up USDA benefits, that's their business," Crowell said. "But we intend to do our best to help farmers who want to keep those benefits.'

A new idea that he has implemented is in the seventh grade careers class. There is no textbook. The students research different professions and then send for information direction from the trade associations.

businesses you can have, supporting its own growth, creating its own income and we need to take our technology and get it down into those small areas.

"Texas—our state—is second in the nation in value of agricultural commodities produced; however, only 6% of the nation's food is processed in our state. Here we are the second in the nation in producing commodities and only 6% of those commodities are processed in our state. What happens, in effect, is that we are losing billions and billions of dollars worth of business every year outside our state we're just giving it away," Wilburn said.

When asked how the farmer could reap some of the benefits of the processing, Wilburn replied that the farmers do this by forming co-ops to get their processing done here and do some of the marketing themselves. This helps the farmer get back more of what he should have had in the first place.

"Expansion off this plant directly to Archer & Archer is that we will probably manufacture most of the equipment in our own manufacturing plant," Wilburn continued. He went on to say

that the ground breaking for the processing plant would be in April with plans to process peanuts here this fall.

When asked if as many local people as possible would be employed by the plant, Wilburn said that there wouldn't be but possibly one person brought in from outside and that the plant could be operated totally by people here in Briscoe County. "There's some expertise in management and some expertise in our computer side of it, but other than these two positions-even these two positions—can be filled by people here in your county. We don't have anybody to bring in from outside. Our goal is to help your community out.

There would be no point in bringing someone in," Mr. Mc-Afee said, "unless we cannot meet our employment goals here. If there aren't enough people wanting jobs, then we can bring in other people, but anybody can operate this mill." Wilburn added that it's not that complicated a process. "The technology we put in will require that we train the people to operate it. Office management isn't really any different than any other office management. There's never been another mill like this one, so

there's no experienced person we could bring in. You've got a first. You've got a unique package here. That's something to be proud of. It's not just a peanut processor; it is new, highly-developed technology that you'll be using—the same technology that is in the pizza industry and many other food industries in the United States that we've licensed it to."

When asked about the peanut packaging, McAfee replied that they will be packaging several size packages-from two ounces up to fifty-pound bags. Wilburn said there are several ways to do the labeling. "One way is the private label-in other words, people want peanuts and will furnish the film for the package label and the peanuts will be packaged with their label. Or we will need to develop a package that says Briscoe County Peanuts or something like that. Our marketing people will get with us on that. As it grows, and we find new suppliers, then we'll be shipping all over the world in generic bags.'

They said most of the peanuts to be processed would be grown here, and certainly they expect most all of the sunflowers to be grown here. "What's going to happen when we first kick off the plant, in order to generate immediate cash flow, is that the plant will be on a contract basis to a marketing group in Amarillo that does all these peanuts," Wilburn said. "Now they're the same group that has a mill in Memphis, so basically when the farmers sell their peanuts to the mill over there, then they are, in turn, getting them back to us for processing. Right now, for salting, they're having to go all the way to Virginia. They're saying 'When are you getting your plant going? Please, we're tired of paying the freight and we're tired of shipping our peanuts all over the world.' So there is a strong, strong base there.'

McAfee added that they are checking the prices on peanut butter processing machines, pricing, labeling, and all for peanut butter. "The salting and roasting of the peanuts is just to secure the base for the cash flow. Everything else-the peanut butter, the honey-roasted snack foods-all of that is kind of peripherial to the business itself, which adds employment and adds cash flow back to us in the county. Future projects include flour milling, bakery, possible vegetable processing and of course, manufacturing. Those are some we can see right away, and there are a whole bunch of other things that are there also,"

#### Wilburn added.

Wilburn mentioned that it is generally accepted that a paycheck circulates seven times in the community, and that the economic benefit of having 33 new paychecks is hard to calculate for the communities of Silverton and Quitaque. "It will take two years to get the plant up to 33 employees, and that's just the processing plant. We're not talking about the honey-roasted snacks and all the other stuff," Wilburn said. Virgil Archer added that eventually he estimated there would be 100 employees at the plant.

"Archer & Archer Manufacturing is handling the building of the equipment," Wilburn said. "They will set up right inside the plant with welders and engineers to construct the equipment for the plant. This is new technology, and there isn't any place where we can go out and buy it off the shelf. We will be keeping it secret because the patent is pending since the patient hasn't been issued right now. We kept it under patent pending and will for as long as we can because when the patent is published, it is open to the public and people can design around you and all sorts of things. But a lot of the construction will happen right here and what we can't get done here will be done in Oklahoma and then shipped to you.

"There will be a profit-sharing plan for employees at the company. At the end of the year, employees will share in the profits of the company with an annual bonus check. It gives employees the feeling that if they work hard and help make the company successful, they will be rewarded. This helps employees take pride in their company.

"I was talking to a man locally about honey processing the other day, and we're trying to get him set up so he can process honey and turn this raw value into processed value. I've got him some good leads on some contracts right away if he wants to start, plus we're going to need honey in various aspects of our operation and we can buy from him, so here's something that's jelling in your community already.

"We're all excited about this, and we're just ready to get started. We've already got our engineering work in line and marketing is going full speed," Wilburn concluded.

The commissioners' court has approved lending the proposed grant money to Briscoe County Processing, Inc. at 3% interest for a term of ten years.

Garvin, jr., Joe Mercer, Robert McPherson and Jimmy Ross as members of the board of directors for 1988-89. Due to the fact that Ray Teeple has offered his resignation, another member will be chosen in the near future.

Officers elected were Garvin. chairman; Mercer, vice-chairman; McPherson, secretary

The meeting was called to order by Chairman Garvin, and Secretary McPherson read the minutes of the December 10 meeting. The financial report was given by Carlye Fleming, including 1987 tax collections through the month of December as follow: Briscoe County, 70.0%, Silverton ISD, 71.9%, City of Silverton, 52.1%, and Mackenzie Municipal Water Authority, 58.1%.

Mrs. Fleming noted that the rollback election on January 12 at Quitaque failed, so the City of Quitaque will have a 1987 tax rate of .4300 per \$100 valuation. The office planned to have these tax bills mailed on or about February 1.

Motion carried to renew tax collection contracts with Briscoe County, Silverton ISD, City of Quitaque, City of Silverton and Mackenzie Municipal Water Authority.

It was decided to invite Briscoe County Attorney Tom West to the February meeting in order that he might answer some questions members have concerning the appraisal district. Ross stated that he would like to see Mr. West present at all meetings to make sure motions, etc. are worded correctly and that the appraisal district and board are functioning legally. All members were in agreement.

Motion carried to authorize the chief appraiser to sign appraisal district checks.





