

Board Adopts School Policies

After attending to regular business at the June board meeting last Thursday, the trustees of Silverton ISD adopted the TASB (Texas Association of School Boards) prepared Board Policy Manual. This policy manual will take the place of all the previous board policies. It will be continually updated and kept congruent with all state and federal laws concerning education. A copy will always be available in the board room for anyone to read.

Other business included the first grade TEAMS report (over 90% mastered all the tests), a resolution to sell the San Jacinto School land and approval of commodity agreement, milk bid and bus maintenance. Has Business Meeting Present at the regular June 9 meeting of the board of directors of Briscoe County Tax Appraisal District were members L. B. Garvin, jr., Jimmy Ross, Joe Mercer and John Bowman, and Chief Appraiser Carlye Fleming. Robert McPherson, member,

was absent from the meeting. Minutes were read and approved, and the financial report was given by Mrs. Fleming, who stated that third-quarter payments from the taxing entities will be due in July, and that, overall, the appraisal district is well within its 1988 budget. 1987 tax roll collections through the month of May were: Briscoe County, 95.6%; Silverton ISD, 96.9%; City of Silverton, 93.6%; City of Quitaque, 78.6%; Mackenzie Municipal Water Authority, 93.7%.

Members decided to have a called meeting sometime during the week of June 19 to discuss the 1989 budget. They will have more information about the possibility of obtaining a computer for the appraisal district by that time. Mrs. Fleming stated that an appointment has been set up with the Oldham C.A.D. in Vega to look at their computer system June 17. Any, or all, board members are invited to go. Also, by that time, the members will have more concrete figures

as to the actual costs.

In discussing the justification for purchasing a computer for the office, Mrs. Fleming noted that not only would office work be faster and more accurate, but the annual costs would be approximately the same amount that has been paid out annually to an outside data processing firm to print proof rolls, appraisal rolls, appraisal notices, tax rolls and statements. With an in-house computer, the office staff could not only perform all these functions, but would also have each individual parcel in the county recorded in the computer as to land class, type and class of structures, etc. This would greatly aid in the state annual school and appraisal district reports. It is extremely important that the school report be correct because this particular report determines much of the school's state funding. Bowman stated that another major benefit is that the appraisal district would have control of their records at all times, not at the convenience of another company.

Mrs. Fleming reported that the Appraisal Review Board (ARB) met May 17 to work further on 1988 values. One of the items they worked on extensively was all gins in the county. They made a "fact finding" tour to Quitaque to gather additional information. The ARB set the protest hearing date for July 6 at 10:00 a.m.

through the files of the Briscoe County News

June 15, 1978-A 100-year-old Indian burial has been saved from the rising waters of Lake Mackenzie by a West Texas State University archaeologist. The site was first noticed by Tulia resident Rueben Mireles and his companion who were fishing from a boat in Cope Creek when they saw a human skeleton on the shoreline. Recovered were a slightly perforated skull and most of the bones of the upper torso of a male possibly in his late 20's. An Amarillo pathologist tentatively identified the cause of death as vascular tumors which created the lesions in the skull, a congenital defect which often causes death in the late 20's. The lower right arm was encircled with ten broken copper wire bracelets. There is evidence of copper stains on both the upper right and left arms, but no other bracelets were found at the site. The body also appears to have been wrapped in a red flannel trade blanket, evidences of which are lodged in mud packed into the pelvic region. Accompanying the burial were two bridle bits, several bridle buckles and a metal stirrup. One bit is of Spanish design which was used for stallions and the other possibly a military Whitman curb bit of the Indian war period. In the 1860's, the period in which the artifacts seem to indicate the burial occurred, the Texas Panhandle was dominated by the Comanche Indians, who shared it with a few Kiowas . . . 




The bride was attired in a peach silk dress with lace bodice and a pleated skirt. She was attended by Melissa LeFevre and Wistie Webb, her sister.






