I spoke with School Superintendent David Cavitt Monday about legislation that is pending in Austin at this time, and he told me that he has strong feelings about most of it.
His number one concern is that we don't want the Legislature to mandate things for the local school district without providing funding. Doing this (as HB 72 did) places a burden on local taxpayers and forces local tax increases to foot the bill.
Secondly, he is hoping the Legislature will pass a finance package that will help the package that will help the
smaller school districts. We need more state support for expenses more state support for expenses
created by previous legislation created by previous legislatio
A lot of other bills are pending that concern education.
HB 85 needs support so that retirement benefits for educators can be strengthened. The retire ment fund is in good condition and can stand the changes that educators desire to see made, educators desire to
Mr. Cavitt believes.
HB 484 would
HB 484 would eliminate the TEAMS testing for first graders This is a good bill, Mr. Cavitt said. He doesn't believe TEAMS testing is appropriate for firstgrade boys and girls.
One of the issues you might want to discuss with your representatives is whether you would like to see the school year like to see the school year

SB 20 would ban corporal punishment (spankings) in Texas schools.
"We don't need a bill to base school funding on student performance," Mr. Cavitt said. "This wouldn't particularly hurt our local school, but I just don't agree with this. Also, we need flexibil ity to maintain local control of our schools. This has worked very well for many years in the Silverton Schools."

## Plan Now For Severe Weather

Although tornadoes, severe thunderstorms and floods can strike virtually any part of Texas at any time, spring seems to bring an increase in violent weather.
You can take precautions to assist yourself and your family in the event of a tornado.
Periodically hold a tornado drill so that family members know what to do and where to go know what to do and where to go
if the National Weather Service if the National Weather Service
issues a tornado warning. The issues a tornado warning. The
safest part of a house during a safest part of a house during a
tornado traditionally is the basement, but be aware of the potential for flooding if there is heavy rain in the area. Interior bathrooms, hallways and closets on the ground floor also offer protection from tornadic winds. Avoid windows and outside Avoid windows and outside
walls. Take along blankets or walls. Take along blankets or
sleeping bags to protect yourself sleeping bags to protect yourself
from falling debris and shattering glass, which are frequently the cause of death and injury during a tornado.
Make certain you have a portable radio and several flashlights (and fresh batteries for both) as well as bottled water,

Failure to certify and file before making any other use of the crop will result in the crop being ineligible for program being in
benefits.

## Court Decisions May Cost Local Governments

State Comptroller Bob Bullock has alerted local governments that recent court decisions may cost them $\$ 60$ million or more in refunds of bank franchise tax money they got in 1985-87.
In a letter to cities, school districts, counties and special districts, Bullock said that banks districts, Bullock said that banks
seeking refunds will look to the seeking refunds will look to the
local government entities for local gover
that money.
The problem comes from court decisions invalidating parts of
the franchise tax law which covers all corporations. The Legislature brought banks under the franchise tax for the first time in 1985 and earmarked the tax money for local governments
The 1987 Legislature "repair ed" the tax law so that the taxes paid in 1988 and the $\$ 40$ million expected in 1989 should not be affected, Bullock said.
Bullock told local officials they can expect to see refund requests starting next month.

All listed accounts, other than those from safe deposit boxes, are worth at least $\$ 50$ with the largest account worth more than $\$ 177,000$. All safe deposit boxes are listed regardless of the value of the contents.
Generally, accounts on the list are from checking and savings accounts, utility deposits, oil royalties, and corporate stocks.

Persons who find their name on the list can call the Texa State Treasury on its toll-free telephone line at 1-800-654-3463 or they can write the State Treasury at P. O. Box 17728 Austin, Texas 78745. The tol free line opens at noon on March 5.

During the first few week after the list is published, the toll-free line is often tied up by the volume of calls. The lines however, are kept open for an extended period and there is no time limit for making a claim.
The Unclaimed Money Fund List was first published shortly after Mrs. Richards first took office in 1983 and she has made collecting and returning unclaim ed money one of her top ed money
priorities.

Since she took office in 1983 the Treasury has collected mor than $\$ 209$ million in unclaimed funds, which is almost 83 percent of all such funds ever collected in the State of Texas. About 95 percent of all funds returned in the 27 -year history of the pro gram have been returned during gram have been returned during the six years
Administration.
Money that is not claimed by owners is used by the state fo education and general state services such as highways and law enforcement. Last year, for example, $\$ 30$ million in non-tax revenue was turned over to the Foundation School Fund and the General Revenue Fund.
