> Stockmen also are urged to inspect all livestock regularly and treat all wounds promptly. Ten or more worms should be collected from deep in each wound and taken to the local county agricultural agent's office or mailed to Southwest Screwvorm Eradiction Program, Box 969, Mission, Texas.

Jhonsongrass can be eliminated from Texas cotton fields in one season through the use of proper cultuarl methods supplemented by spot-spraying, says Fred Elliott, extension cotton specialist.

Herbicidal oil such as naphtha should be used early in the season while cool weather prevails, Diesel or kerosene give best results during warmer weather. Water solution of sodium dalapon or other chemicals are also effective. Oils are commonly applied to the crown of Johnsongrass near the ground while solutions are applied as foliar sprays.

A half and half mixture of naphtha and diesel oil or naphtha and Burk, Ray Eastland, and Bill Cole. used in warmer weather. Oil mixtures may be used for economy with C-56 added for increased toxicity, or for a combination of contact when applied to the crown of Johnsongrass sprout's 6 inches or less in height.
