Linesman Is Electrocutted

O. Lopez, 32 of Stamford was pronounced dead on arrival at Callan Hospital about 2 p. m. Wednesday. He was linesman for A&J Construction Co. of Stamford, who have contract with West Texas Utilities Co. for considerable line and pole replacement in Rotan.

Lopez was at top of a new pole at the corner of 5th and Garfield, in 1100 block in front of Mrs. Jewel McSpadden home, and was installing a cross arm on 13,000 volt hot line. Two men on the ground did not see the accident, but heard him utter a sound and looking up saw him drop from the high voltage line, hanging by his safety belt. A helper on the ground called George Field at WTU office by truck radio. Field called his two servicemen, Melton Field and Garvis Hinson, by radio, who were working at the Billie Joe McCombs home west of town. They rushed to the scene, and lowered Lopez to the ground. They had considerable difficulty as his legs tangled in cross arms of the old pole that was being replaced, and this required several minutes. Field also dispatched a Weathersbee Ambulance to the scene and the body was rushed to the hospital. Artificial respiration was given from the time the body touched the ground until reaching the hospital, to no avail.

Justice of Peace Charlie Rivers ruled accidental death by electrocution.

Kinney Funeral Home of Stamford came for the body later in the afternoon, and at press time no funeral arrangements were announced.

Available information at press time gave immediate family survivors as the wife and five small children.

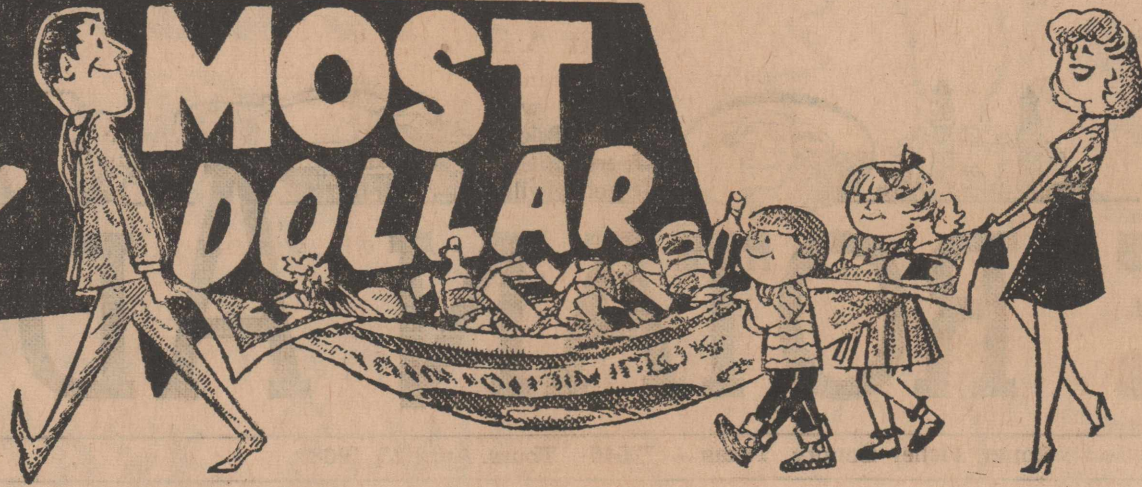
Mr. and Mrs. McQueen lived near Rotan for several years; before moving to Houston.

New Voting Information

Voters in the May primary who moved into the county on or after November 4, 1967, must vote between April 15 and April 30 in the office of the county clerk in the county of their present residence, according to information supplied by John W. Ashley, County Clerk of Fisher County.

A new law enacted last year permits registered voters with less than six months' residence in the county to vote on all statewide offices and issues if they have lived in the state longer than one year, but they must vote in the county clerk's office under procedures similar to absentee voting. The new law puts into effect a constitutional amendment adopted in November, 1966.

Formerly, a person who

moved from one county to another within the state was totally disfranchised for the first six months after he moved, unless one or more of the various types of districts (congressional, legislative, judicial, etc.) included both the county of his former residence and the county of his new residence. If he had lived in a district for six months before the election, he could vote on statewide offices and issues and on the offices for

districts in which he had six months' residence, but he could not vote on local offices and issues within the county.

The new law preserves the voting rights which existed under the old law, but the procedure for voting has been changed. Heretofore, a person entitled to vote on the basis of six months' residence in a district voted on election day at the regular polling place for the voting precinct of his new residence. Under the new law, no one has resided in the county less than six months may vote at a regular polling place, and all voting by such persons must be done through the county clerk's office. The voter must appear in person at the clerk's office between the twentieth day and the fourth day preceding the election unless he is unable to appear because of sickness or physical disability or unless he is absent from the county during that period. Sick or disabled voters and those temporarily absent from the county may obtain a ballot by mail.

Office hours are 8 a.m. to 5 p.m. Monday through Friday.

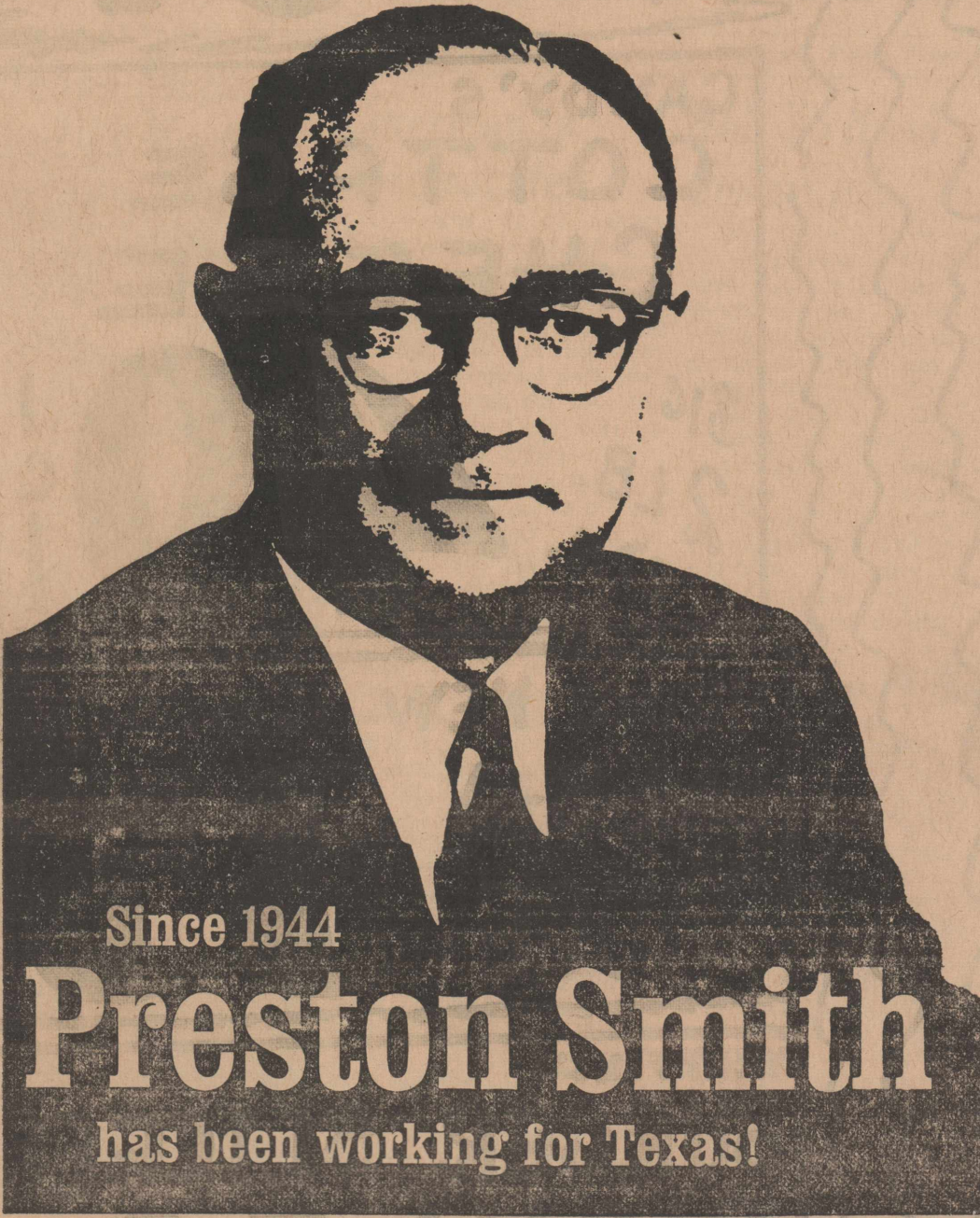

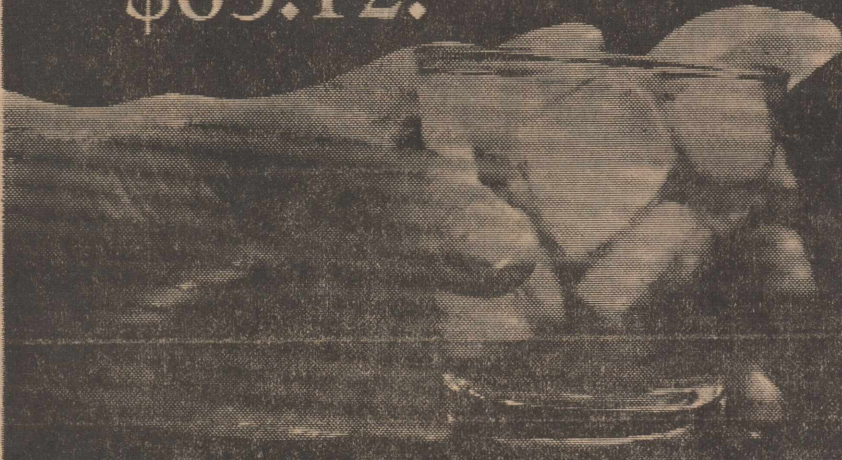

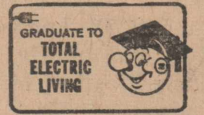

STATEMENT CONCERNING DELINQUENT TAX NOTICES

Perhaps this statement is a week late since there seems to be a great deal of talk, some good and some bad, concerning delinquent tax notices mailed out recently by the City Tax Office. Due to this the City Council felt that a public statement on the situation and the intent this matter might help clarify of the notices.

About three years ago it was called to our attention that the City of Rotan did not have a Delinquent Tax Roll and that notices were not being sent out on delinquent taxes. A program was initiated at that time to begin sending a series of delinquent notices and this practice has been continued.

Due to the absence of a Delinquent Tax Roll, however, it was impossible to get enough correct information from the tax records to send notices on anything prior to this time, and an effort was

initiated to prepare a roll of all delinquent taxes shown on City records. It has taken a long time, but this roll has now been completed, and no further work could be done without sending out notices shown on the records.

These notices have resulted in complaint and complaints in about equal numbers and have produced receipts and tax certificates showing that some of these taxes had been paid.

Please understand that this is not an effort to raise money or to collect taxes, but is done principally to get the tax records as straight and as correct as possible, and much progress toward this end has already been made. These notices were sent to inform you of what was shown on the City Tax Records and we urge you to help us get them in order. We, as a City Council, have no authority to excuse taxes, but if you have receipts or tax certificates showing that taxes on which you have been mailed a notice, were paid, please present them at the City Tax Office, so that the records may be cleared.

We realized that when these notices were mailed that there would be questions that we could not answer and some rather unpleasant statements and accusations made, but that continuing to ignore the situation would only make it worse year by year.

With your cooperation and understanding in a very short time your City Tax Records be in very good order, and it is the intent of the City Council that they be kept that way in the future.

County Agent's Column

With screwworm cases on the upswing, livestock producers are now in a critical period.

This year the first case in Texas was confirmed on March 26, and more cases are being reported. One of the major causes for this early infestation was the movement of cattle from the interior of Mexico into the northern barrier zone for better pastures. Warm weather, humidity, and a large number of wildflowers, weeds and grasses are also added to the possibility of more screwworms moving into Texas. This year the potential for screwworm cases is greater than it has been in a number of years.

We urge all livestock owners to check their animals on a day-to-day basis. They should examine and treat all wounds on their livestock. Injuries can be kept to a minimum by checking fences, pens, and chutes for protruding nails, wires, or splinters. Navel wounds of newborn animals should be treated and rechecked frequently.

It is also important to control external parasites by spraying or dipping the animals with a recommended insecticide. For further information, producers can pick up a copy of "Texas Guide for Controlling External Parasites on Livestock and Poultry," Leaflet 256, at the local county agent's office.

Worms taken from wounds should be sent to the Mission Screwworm Laboratory for identification. Livestock owners who need vials for the larval samples or instructions on collecting the samples should contact the county agent's office.

The quality of the feed and the methods used to make it available to the dairy herd can have a strong bearing on the economics of milk production.

Quality governs the amount of feed a cow eats and affects the rate of its passage through her digestive tract. High quality forage passes through the tract about twice as fast as low quality forage. The rate of passage affects the fill in the cow's digestive system and influences the amount of feed a cow can eat.

Frequency of feeding may affect feed intake and milk production. Cows seldom spend more than eight hours a day eating and for this reason the feeding program should be well managed.

High producing cows are usually the heavier eaters. They consistently eat more forage than lower producers when forage is offered free choice.

Many dairy cattle nutritionists regard appetite as one of the most important factors influencing differences in milk production of dairy cows.

“Ye Shall Know The Truth”

John 8:32

THE TRUTH AND OBSERVANCE OF THE LORD'S SUPPER No. 8

We look at a flower from a mother's grave in memory of man's truest earthly friend; we look at a faded picture of father in remembrance of him who guided us through tender years; we look at a lock of baby's golden hair in memory of her who was with us such a short time, we go to Washington's monument and stand with heads uncovered in memory of the father of our country; also, we gather around the Lord's table and take the Lord's supper in memory of Him who said, "This do in remembrance of me." I Corinthians 11:23-25. It is in memory of Christ, not only in memory of his death, but his birth, life and teaching as well, that we eat the bread and drink the cup symbolic of the body and blood of Jesus in this simple memorial.

Furthermore there are at least three additional things that this memorial does.

- 1. It is a memorial which preaches Christ's death: "For as often as ye eat this bread, and drink the cup, ye proclaim the Lord's death till he come" I Corinthians 11:26. Thus the Lord's supper is a silent witness of the great sacrifice of all ages. Those who fail to take the Lord's supper as God teaches, silence this witness.
2. It is a memorial which preaches the second coming of Christ: "For as often as ye eat this bread, and drink the cup, ye proclaim the Lord's death till he come" I Corinthians 11:26. Here then is a weekly reminder that the Lord is coming again.
3. It is a memorial which preaches the new covenant: "This cup is the new covenant in my blood" I Corinthians 11:25. The cup, the symbol of Christ's blood, is the sign and confirmation of a new covenant between God and man.

The frequency of observing the Lord's Supper according to Acts 20:7 is EVERY first day of the week, "and upon the FIRST DAY OF THE WEEK, when the disciples came together to break bread, Paul preached unto them". Thus early Christians met upon the first day of the week for the purpose of breaking bread. Does this mean that they took the Supper the first day of every week? It does not say "every week", but neither does it say that God commanded the Jews to keep every Sabbath. God said "Remember the sabbath day to keep it holy" Exodus 20:8. The faithful Jew understood this to mean every sabbath. It came once every week; therefore they were obligated to keep it every week. Furthermore, we know that the Jerusalem church "continued steadfastly in the apostles' teaching and fellowship, in breaking of bread and the prayers" Acts 2:42. This passage indicates a regularity and frequency and not an occasional custom. Also, the church at Corinth ate the Lord's supper when they assembled I Corinthians 11:20. The regularity of their meeting together included their regularity of eating the Lord's supper. The regularity of their meeting together is noted in I Corinthians 16:2 "Upon the first day of the week."

"As it looks from here"

Washington, D.C. — Of whatever political persuasion be the candidate or whatever Party he represents, a man offering himself as President of the United States should start with some simple yet fundamental qualifications. People have the right to expect no less.

In these time of crises, of violence, of hatred and of horror, one thing is at least clear amidst the vast and menacing uncertainties of our day. This is that the political future belongs to the man who most truly embodies a sense of dignity, of judgement, of restraint, of action, of strength, of compassion, of calm firm resolve to restore to this Nation the old and traditional values which seem largely to have been lost.

For some years now, it seems that most everything fashionable has been sick — sick comedians, sick students, sick politicians, sick demonstrators and counter-demonstrators, sick books, periodicals and sick movies.

Old fashioned qualities have not seemed fashionable at all in many quarters patriotism, loyalty, love of family, responsibility in private and public conduct, consideration toward other men and other ideas — even in religion.

In this latter, it seems the "IN" pulpits have been ringing out, not so much with man's obligations to God as with the shrill, socio-political dogmas of political preachings. Many men in the "square" pulpits have called attention to the use of sanctuaries of noble cathedrals being used for bitter pseudo-dramas, for wild phychedelic so-called music and the gyrations of youthnics, rather than for the somber measure and timeless liturgies of our ancient faiths.

Seemingly lost also is that sense of manners standing for mankind's true values next to morals themselves. Neither public nor private morality can long endure with that lesser but indispensable companion which used to be called "good taste."

"Student activists" defy Military Draft, coaxed by professors publicly advising them on schemes to evade a common obligation of their generation while less privileged boys carry the guns and do the dying. While these intellectuals proclaim freedom for everything, they close their minds and ears to every opinion except their own. Many have encouraged university students to shout down and even physically menace men invited to their platforms for open discussion if views contrary to theirs are offered. Many such institutions owe their existence for no other reason than for the free and decent exchange of ideas.

Some of us are old enough to remember the hoarse, terrifying, mindless roars of Hitler's youth. It is an uncomplimentary thing to say, but nevertheless it should be said — conditions existing on some of our campuses and elsewhere are not too dissimilar from Hitler's youth of that time.

Some students, young professors and some young and not so young politicians, have laid ugly hands upon the honored concept of free dissent. In too many instances, they have twisted and perverted rights into a license of intellectual terrorism and into a canscious subversion of lawful national purpose constitutionally authorized.

It seems that people should have the right to expect no less of a man who even offers himself for the Presidency, than a dedication and strongest resolve to offer a cure and administer the treatment for this sickness in our land.

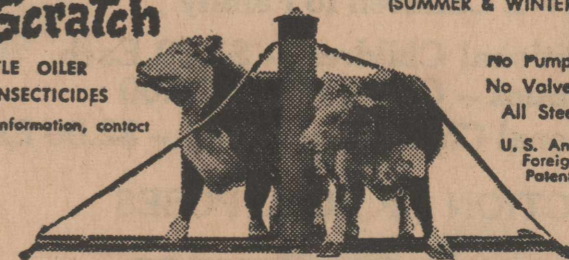

DAR Urge Patriotism

Nancy Harper Chapter of Daughters of the American Revolution met Tuesday in the home of Mrs. James H. Beall, Jr., in Sweetwater, assisting as hostess was Mrs. C. R. Kendrick of Winters.

The meeting was called to order by Chapter Regent, Mrs. Wm. E. Towson. Following the opening prayer and Pledge of Allegiance, Mrs. Carl Anderson presented a short discussion on the proper display of the Flag of the United States. She closed with the poem, "A Prayer for Today."

Mrs. L. T. Nelson read the message from the President General of the National Society, The President General, Mrs. W. H. Sullivan, Jr., stated in her message that during the past three years the Society has had a net gain of nearly four thousand members with a total figure of more than 187,000 on the roll. Mrs. Sullivan closed her message with the remainder that the Society represents a channel through which American women may voluntarily serve their Nation to insure its perpetuation as a free Country under God.

The report on National Defense, a regular feature at each meeting, was given by the Chairman, Mrs. Kirby Kinsey. The report predicts that our gold will be gone, probably in less than two years.

Mrs. Kinsey also pointed out the apparent uselessness of the United Nations in time of crisis and the high percentage of our payments of the total expenditures of the organization.

In the absence of the program chairman, Mrs. Towson presented Mrs. A. C. For-

gay who spoke on the topic, "Your Influence Counts — Use It!" Mrs. Forgay stressed the importance of the ballot and urged that all exercise the privilege of voting in all elections.

In speaking of influence, Mrs. Forgay discussed personal contacts with people who had most influenced her life. She expressed appreciation for a Christian home

and Christian parents. She quoted her Mother as often saying that she was very rich because she had children. She recalled the days when neighbors never went to court against another in the community, but would call an Arbitrator who would help the people to make peace with each other. She remembered her grandfather and great uncle were members of

the ill-fated Mier Expedition. Both were lucky enough to draw white beans. She read a letter which was written by her Uncle from the prison. It described the condition of the men and the circumstances under which they lived. It showed the ability to withstand hardships with courage and fortitude.

Following the program, a social hour was enjoyed by

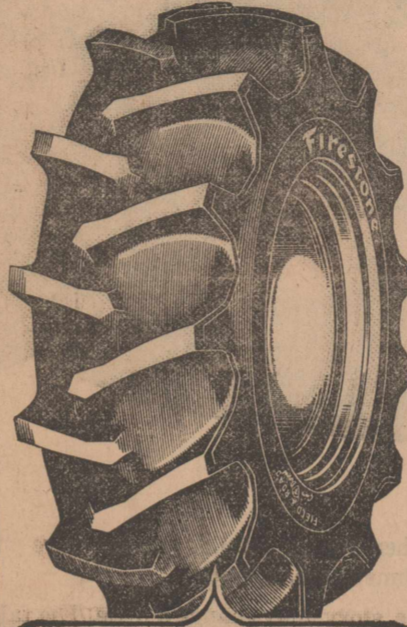
