
Ford coupe which he was driving was almost totally demolished when struck by a bus operated by South-west Coaches, Inc., on Highway 30 near Weinert.

New Mail Compartment in Ford Planes



Use of new equipment in wings allows carriage of heavy postal leads and permits cabin to be utilized solely for passengers.

ITTED with new equipment | enabling them to carry heavy

mail loads in compartments concealed in their wings, six new Ford trimotor high-speed transport planes have just been put in servtes by National Air Transport on the New York-Chicago leg of its massenger and mail routes. The mail compartments as designed by engineers of the Ford Motor Comgamy and approved by Postmaster General Brown will enable the new dype transports to carry very large mail loads in addition to their passonger complement.


This new departure in the design

of the new Air Mail act, which was | by the lower surface of the wing. so framed as to encourage the carriage of the nation's air mail on scheduled air passenger services to as great an extent as possible. The new method of carrying the mail cargoes in the wings in space hitherto not utilised and thus permitting the use of the cabins so for passengers was devised by Ford engineers working in co-operation with National Air Transport officials.

The mail compartments are fabricated of duralumin and are in reality strong boxes which can be carried in recesses in the wing out-side of the center section. The botof Ford transports is an outgrowth | tom of the compartment is formed

the lower edge nearer to the fuselage being hinged so that the entire compartment may be dropped down by use of a rachet and cable to facilitate loading and unloading.

When drawn back into place in the wing, the compartments strengthen its structure, being built up of strong girder-type trueses which lend added rigidity. The compartments are located over the center of gravity line, thus permitting large loads to be carried, while retaining the inherent maneuverability and stability of the plane, something which is not always possible when mail loads are carried in the after cabin.
