

City Council Discusses Grant **Application at Meeting**

At the regular meeting of the Silverton City Council on March 9, the 1992 TCD grant funding was discussed, and it was noted that after two special meetings, the City Councils of Silverton and Quitaque have jointly agreed that it is still in the best interests of the county to pursue the construction of a solid waste transfer station as was originally proposed. The original design for the facility will be scaled back to make it possible to accept the marginal funding amount of \$123,630 to complete construction of the station.

Present at the meeting were Mayor Wayne Nance, Councilmen James Griffin, John Bowman, Dwain Henderson, Flute Hutsell, and Secretary Jerry Patton.

Minutes of the February 10 regular meeting, the February 18 and March 3 special meetings were read and approved with the addition of the name of Pamela Nielson to the list of those present at the March 3 meeting.

Mackenzie Municipal Authority directors Bud Couch and David Reagan met with the City Council and reported on the general operations of the Authority.

Information on the purchase of emergency lights for the City Marshal's vehicle was presented. The Council approved the purchase of the needed equipment.

A mutual-aid agreement between the City and the Memphis Fire Department was presented. Motion was made by Hutsell, seconded by Henderson to execute the agreement. Motion passed. This provides for the Silverton and Memphis fire departments to come to one another's assistance.

The Council discussed potential projects for the 1992 Texas Community Development Program.

David Reagan was re-appointed as a director of the Mackenzie Municipal Water Authority.

Mayor Nance ordered a General Election to be held May 2, 1992, to elect three Councilmen. Mary Ann Sarchet was appointed Election Judge, and Jerry Patton was appointed Absentee Election Judge.

The Secretary reported that Henderson and Hutsell had filed applications for places on the ballot for re-election. The deadline for filing for a place on the ballot is 5:00 p.m. Wednesday, March 18, at the City Hall. Absentee voting begins April 13.

The Secretary presented information on having an ownership map printed of the City. The Council requested more information, and the subject was tabled until the April 13 meeting.

The Council discussed the tax collections report, Mission Cable TV and City streets before adjournment.

Church Renewal Is 12-Hour Event

"Stirring the Flame: Experiencing Church Renewal" is a 12-hour event that will begin Sunday, March 22, at the Silverton United Methodist Church and conclude on Monday evening, March 23. The event will begin Sunday at 9:30 a.m. for fellowship and Sunday School will begin at 10:00 a.m. and will be led by the guest team.

Morning worship will begin at 11:00 a.m. and also will be led by the team.

A noon meal for all present will be

A noon meal for all present will be provided by a supporting neighbor United Methodist Church.

The afternoon session begins at 1:00 p.m. which will include talks, discussion, appropriate breaks and sharing.

Closing worship and The Lord's Supper will be at 4:30 p.m.

The Monday evening meal will be provided by the guest team at 6:30 p.m. with the congregational visioning and planning session to begin at 7:15 p.m.

Closing worship and sending forth is at 8:45 p.m.

Everyone interested in such an event is cordially invited to attend. All church members are urged to be present and supportive of this endeavor

The event is for the entire congregation and will be led by a committed team of laity and clergy who have been trained in this model. The team is composed of The Rev. Mr. Norman Patton, minister of The Crowell United Methodist Church as coordinator, and Mr. Robert Hawkins, song director, a lay member of The Hart United Methodist Church. Mrs. Freda Fuston, lay leader of The Turkey United Methodist Church, and Mrs. Julie Ulrey, wife of The Rev. Mr. Steve Ulrey, minister of The Quitaque and Turkey United Methodist Churches, also will be members of the team.

The purpose of "Stirring the Flame: Experiencing Church Renewal" is two-fold: Spiritual Development and Congregational Development. "Stirring the Flame: Experiencing Church Renewal" seeks to help local church members experience renewal in their own spiritual lives and to be empowered by the Spirit to become involved in the mission and ministry of the church. This model also enables the local church to be affirmed and to be

challenged for ministry.

The program began in 1989 focusing on churches with membership of 200 or less when the Small Membership Church Work Area of the Northwest Texas Conference of The United Methodist Church interviewed pastors and laity to discover the strengths and needs of these churches and how the Conference could help meet these needs. The survey pointed to the need for commitment; that is, a more vital spiritual life, and the need for stronger lay leadership in the churches. In light of these needs, the Work Area developed "Stirring the Flame: Experiencing Church Renewal."

Taxpayer Information Pamphlet Available At Appraisal Office

Carlye Fleming, chief appraiser for the Briscoe County Appraisal District, offers area property owners a pamphlet called "Texas Property Taxes: A Taxpayer's Guide to Rights, Remedies and Responsibilities" to help them save on their property taxes.

Published by the State Comptroller's Office in Austin, the "Remedies" pamphlet explains how the property tax system in Texas operates and offers suggestions for possible tax savings.

Mrs. Fleming noted that the pamphlet applies to property taxes collected by all types of taxing units: counties, cities, school districts, county education districts, and special districts (such as municipal utility, junior college and hospital districts).

"Homeowners may qualify for various property tax exemptions offered by taxing units on residence homesteads," Mrs. Fleming said. In Texas, a homestead is generally the house and yard used as the owner's principle residence. The pamphlet lists and explains each exemption and how

to apply for them.

For example, all homeowners are eligible for a \$5,000 general residence homestead exemption from their home value for school districts and for county education districts. In addition, certain disabled homeowners and those aged 65 or older may qualify for an additional \$10,000 exemption from the value of their homesteads.

"A tax freeze, or ceiling, on a residence homestead for combined school and county education district taxes is a benefit for homeowners who were 65 or older on January 1 of this year," Mrs. Fleming said.

"In other words, the homeowner's taxes that pay for public schools cannot increase above the amount assessed in the year the homeowner owns the homestead and doesn't make an improvement or addition to the house, such as a pool or patio," she continued.

The law provides an additional tax benefit for certain homeowners. If the surviving spouse of an over-65 homeowner is at least 55 at the time of the older spouse's death, then he or she can retain the tax ceiling.

The tax ceiling, however, does not apply for other taxing units, such as the county and cities.

The chief appraiser pointed out, though, that over-65 homeowners do not need to reapply for the exemption this year if they received the exemption and tax ceiling last year. Only those who became 65 during 1991 and those who have never had the exemption and tax ceiling must apply in 1992.

Mrs. Fleming added that any taxing unit may offer a local-option homestead exemption that allows a percentage of each residence homestead's appraised value to be exempt. In 1992, a taxing unit may exempt up to 20 percent of each qualified homestead's appraised

The pamphlet also describes other exemptions available, such as those for

disabled veterans, other disabled persons and senior citizens.

Productivity appraisal is another type of tax relief available to owners of agricultural or timber land. It is available in two forms, referred to by its location in the Texas Constitution: "1-d" or agricultural-use appraisal and "1-d-1" or open-space land appraisal.

Landowners who wish their land to receive 1-d appraisal must apply each year. A signed, sworn application must be filed with the chief appraiser by April 30; however, owners of land receiving 1-d-1 appraisal do not need to reapply, unless the chief appraiser requests it in writing that they do so. All applications in Briscoe County have been 1-d-1 and do not require landowners to reapply each year; however, occasionally the Appraisal District sends new application forms if the records need to be updated because of name changes, etc.

Because the qualifications are less restrictive, many landowners choose to apply for 1-d-1; however, if the land's use is changed to a nonagricultural one, the period for recapturing lost taxes is longer than for 1-d appraisal.

"Appraisal district personnel can offer more information about special land appraisal, tax renditions and exemptions," Mrs. Fleming said. The information also is found in the "Remedies" namphlet.

She said the pamphlet also contains information about preparing and presenting a protest to the Appraisal Review Board (ARB). The ARB is a citizen board that examines appraisal records and hears taxpayer protests to insure that property values are fair and uniform

Another section deals with the procedures voters must follow to petition for an election to limit the amount of a tax increase adopted by any taxing unit.

"I urge all property owners in the Briscoe County Appraisal District to read the pamphlet and learn about all possible property tax relief," Mrs. Fleming said. "Remember, all applications must be filed with the Appraisal Office by April 30, and protests must be filed by June 1 of this

The pamphlet is available at the Appraisal District Office in the basement of the Briscoe County Courthouse.

Children Need to Eat Right, Too!

The principles of the Dietary Guidelines for Americans apply to children as well as adults with some variations for children under two. What children eat or don't eat can make the difference between good health and growth or being sick and not growing properly. Food also can make a difference in how he or she will do in school later on.

Be sure that the food your child eats is the food that counts. Choose your child's food and that for the whole family, from the five food groups in

portion sizes appropriate for their ages.

Make meal time a happy, family time. Getting children to eat right is easier if you set an example. If you eat and enjoy a variety of goods, so will they. Don't skip meals, but be aware that children will eat more on some days than others.

Remember that children like plain food or foods that are not greasy, fried or hot with spices and peppers. Children take to new or different foods slowly; in the beginning give these foods in small amounts. Setting up a positive eating environment for your child can assure that he or she will eat right now and can set positive patterns for the future as well.

Miss LaBaume will be graduating with a bachelor of science in home economics and teacher certification in May 1992.

Import Regulations Protect Cattle Herds

Texas ranchers, regarded for their expertise in raising everything from longhorns to llamas, have been heading south the past year or so for hardy Mexican breeding cattle to add to their herds. Before being brought home, though, these cattle must meet specific federal and state health requirements.

Along the Mexican border, the U. S. Department of Agriculture's Animal and Plant Health Inspection Service (USDA-APHIS) maintains the first line of defense against imported livestock diseases and peats. USDA veterinarians stationed at "ports of entry" inspect cattle, test them for tuberculosis and insure that the animals are dipped in a special insecticide to kill dangerous pests, including fever ticks.

The port veterinarians also test bulls

and cows that are six months or older for brucellosis, a contagious, bacterial disease that can cause cows to abort, deliver weak calves or produce little milk. Additionally, the herds from which these animals originated must have been tested and found to be negative for the diseases. The herd test for tuberculosis must have been conducted between 90 days and 12 months before the animals were moved, and the herd test for brucellosis run 30 to 90 days before movement.

"Besides federal rules, individual states can set more restrictive regulations," said veterinarian Terry Beals, executive director of the Texas Animal Health Commission (TAHC), the state's regulatory agency for livestock health. Texas regulations are set by a governor-appointed commission comprised of 12 livestock industry and public members. Causing concern for some Mexican sellers and Texas buyers is a state regulation

requiring female cattle to be vaccinated against brucellosis.

"After 50 years of fighting brucellosis, we're finally winning the war and were down to only 238 infected herds in February. To boost our herds' disease immunity, we allow in only vaccinated cattle, whether the animals are from out of the country, or just from out of the state," he said, referring to the regulation adopted in 1988 with the backing of the Texas cattle industry.

"Twenty-two other states also allow in only vaccinated cattle and block all others from entering," Beals said. He explained that Texas is the only one of these states that will issue ranchers a special permit allowing them to bring in unvaccinated cattle and have them vaccinated as adult cattle by an approved veterinarian within 10 days.

"There's a very slim chance Mexican breeding cattle—or cattle from other states—would carry or spread brucellosis, because adult animals are tested before and during their move," Beals said. "But if unvaccinated animals enter Texas and are exposed to one of our infected animals, they're likely to develop and spread the disease. Millions of brucellosis bacteria can be shed by an infected cow just before and after calving."



Land Banks Reduce Fixed Rates on Loans

Fixed rate loans for the purchase of agricultural land or rural homes fell to 8.20% this week, local Federal Land Bank Associations (GLBAs) announced.

The new rate is 2% less than the previous fixed rate available for these loan purposes and is the lowest fixed rate FLBAs have offered in several years.

Up to \$50 million is available for loans through this program, which features a 10-year fixed rate after which the borrower can convert to either a variable rate, or select another fixed rate. Loan payments are amortized for up to 40 years.

"On a typical \$65,000 loan, the new rate means a yearly savings of \$1,300 to a home or land buyer," said Michael R. Davis, president of the Farm Credit Bank of Texas.

The Texas bank provides loan funds to 49 locally-owned FLBAs in Alabama, Louisiana, Mississippi and Texas. FLBAs have provided long-term agricultural and rural home financing for the past 75 years. Together, they have about \$2.7 billion in loans outstanding to more than 42,000 farmers, ranchers and rural homeowners in the four-state region.

Don't Mess With Texas and the Adopt-a-Highway programs are credited with an estimated 72 percent reduction in highway litter since 1985.


