Already the Briscoe County Belles have "wowed" their public with their presentations of "Parade of Fashion—1892-1992" in Silverton and Quitaque.

The Caprock Jamboree draws large crowds of people from numerous area cities every first Saturday of the month, and this month's show is being planned to be very special. The Jamboree will have its third birthday and centennial show Saturday night, and the "Salute to 100 Years of Country Music" will include a number of Briscoe County's top female vocalists presenting songs from the 1890's through the 1990's. Each of the singers will be dressed in a costume from that era, and most will be wearing hats. There will be four other talented groups to add to this memorable occasion also, but this is a show you won't want to miss because it spotlights the superb talent among our home-county people.

Another event that is shaping up and looking to be a significant one is the antique tractor show to be held August 8-9, the weekend before the county's centennial birthday celebration and the Silverton School Homecoming.

All these things point up the need to paint up, spruce up, fix up things in Silverton so our visitors from out of town will be impressed with our little town. Times may not be good in the agricultural communities and the economy isn't what we would like it to be, but we don't have to look like we're down and can't get up.

Born in Briscoe County October 30, 1899, he was a son of the late Mr. and Mrs. Aaron Thomas Brooks. He engaged in farming and ranching in this area most of his life.





Harley Redin, who coached the Hutcherson Flying Queens to six Amateur Athletic Union national championships and a record of 431-66

in 18 years as head coach at Wayland Baptist University, is the recipient of the 1992 Jostens Service Award.

Coaches Association in recognition of individuals who have had a significant impact on the sport of women's basketball. Margaret Wade was the first recipient in 1984. Redin was presented the award at a luncheon at the Westin St. Boneventure

annually by the Women's Basketball

Hotel in Los Angeles during the NCAA Women's Final Four recently.

Fran Garman, chair of the WBCA selection committee, and Alice (Cookie) Barron, who never lost a game as a Flying Queen under Redin from 1954-57, introduced him to an audience that included his wife, Wilda, and numerous former players.

"It is appropriate to honor Harley as we celebrate 100 years of basketball because this man has been in this wonderful game for 60 years as a player, coach, professional contributor, and an avid supporter who is still involved in the game today," said

"Most of you may know the pioneers of womens basketball the great AIAW teams, but in my mind, sometimes the forgotten pioneers were the great AAU teams that included the Wayland Baptist College Flying Queens, coached by Harley Redin.

"In talking to former players and from a personal viewpoint, I can say that the most wonderful thing about Harley is the continuous benefit of his support years after you left the program. Players early on were treated by an exceptional orientation into college, and we had a great role model.

"Players sensed his integrity. His fairness and sportsmanship were every day experiences for us. The game was based on skill—that was the honor code. If you got beat it was because the skill was better on the other team-no

"The one thing Harley is most proud of is that he helped a lot of women go to college and become successful. He continues to do this even today. In introducing Harley I represent hundreds of athletes who are fortunate to have been coached by him, and I can assure you that he is remembered and loved for more than just as a winning coach."

"I would like to share this award with my wife, who is very deserving of it, and also to thank Jostens for sponsoring this award," said Redin in accepting the trophy signifying the

"When I arrived at Wayland College in 1946 I went direct to the president and he said, 'Let's go to the gymnasium.' The gym was open-in fact there were no doors, no windows . . .You've heard about the birds flying back to Capistrano; well, they stayed there (in the gym) the rest of the year.

"But we did start a wonderful association there and we did have a wonderful time. I would like to especially thank those who nominated me, including (West Texas State Head Coach) Bob Schneider and (Former Flying Queen) Valerie Goodwin. I would also like to recognize all the Flying Queens. Any fame that I have achieved, they have done it for me."

Redin is a native of Silverton, where he was a multi-sport standout. He went on to play college basketball at Tarleton State, playing on teams there that won 86 of 87 games. He completed his bachelor's and master's degrees at North Texas State and also flew 50 combat missions in the South Pacific as a Marine bomber pilot in World War II. During the 18 years Redin coached the Queens, Wayland won six championships, finished second seven times, third three times, and fifth once. His athletes won 65 All-America honors and 32 were selected to play on U.S. national teams. He joined his predecessor, Caddo Matthews, in coaching teams that won 131 straight games between 1954 and 1958.

The AAU also recognized Redin by selecting him as head coach of two Pan American Games teams, which finished first in 1959 and tied for first in 1971. He also coached the U.S. team in the World Games in Peru in 1963, and coached four U.S. teams selected to play against the Soviet Union, starting the exchange program used so widely today

Redin's influence extended far beyond coaching strategy. He was a major force in major rules changes such the unlimited dribble and establishing the five-player game for women, and also authored two books, The Queens Fly High and Basketball Guide for Girls. He was recently named to the board of directors of the newlyestablished Women's Basketball Hall of Fame in Jackson, Tennessee.

Although the 1992-93 season will mark the 20th since Redin's retirement at WBU, he continues to have a positive impact on the Flying Queens. He helped organize the Queens Court booster organization, formed the Ex-Flying Queen Association, and assisted in establishing the Claude Hutcherson Memorial Award scholarship fund.

His overall coaching record, including stints with Wayland's men's team, the Pioneers, and the Hale Center Owlettes, is 602-163.
