## Little Leaguers finish season with Denver City Tournament

Plains Little League All-Stars spent the holiday at the District 2 Tournament, held in Denver City.

Plains and Ropesville opened the tournament play at 6 p.m. Monday, July 4. Brett Squyres was on the mound for Plains, who defeated the Ropes Eagles 12-3. Brett went the distance for 6 innings, giving up 3 runs on 8 hits. He faced 28 batters and walked one and struck out 9.

Brownfield defeated Seagraves in the second game of the evening.

Denver City, the host, drew a bye and met the winner of the first game. The two losers, Seagraves and Ropes played at 6 p.m. Tuesday, July 5. Ropes pulled off the upset in an extra inning, 7-6. Seagraves got to stay home.

At 8 p.m., Plains met Denver City. Joshua Bell was on the mound for Plains. Joshua went 5 innings and Plains shocked their host 5-3. Josh faced 27 batters. He gave 3 runs on 10 hits. He fanned 7, and didn't walk a man. He gave one homerun to the very first batter he faced on the very first pitch. Gerry Rivas returned the favor in the 3rd inning with a shot over the right field fence.

Denver City had to play Ropesville at 6 p.m. Wednesday and the two winners, Plains and Brownfield faced off at 8 p.m. Denver City defeated Ropes and knocked them out of the tournament. Brownfield defeated Plains 12-3 in the second game. Jeremy Morphis pitched three innings as did Adam Garcia. Jeremy faced 17 batters, giving up 6 runs on 6 hits. He walked 3 and struck out 1. Jeremy also gave up 1 homerun in the first. Adam Garcia faced 19 batters. He gave up 6 runs on 4 hits. Adam walked 5 and struck out 4.

There was only one game scheduled for Thursday night. Plains had to face Denver City again to get into the finals with the Brownfield All-Stars. After such a low scoring game the first time, no one dream the outcome of the second meeting. Plains went to the plate swinging and so did Denver City, who won 31-17. There was a lengthy protest in the second inning when a Denver City player failed to touch

home after hitting one over the fence. Plains pitchers gave up 3 homeruns.

Every player for Plains had at least one hit, including the substitutes. Denver City used 3 pitchers to stop Plains and Plains used 4. Joshua Bell started and stayed 2 and 2/3 innings. Gerry Rivas pitched 1 1/3 inning. Patrick McGinty threw 1 inning and Brett Squyres closed the game by pitching the last inning.

After the bats being so quiet in the last two games, several batters for Plains had an outstanding night at the plate despite the loss. Adam Garcia was 3 for 5 with a homerun in the 4th inning. Jeremy Morphis was 3 for 5 with 2 doubles. Colt Winn was 3 for 4 on the night. Brett Squyres was 3 for 3 with a single, double and a triple; walking his other bat.

There were a number of fans supporting the team other than parents and the team would like to thank them for coming. The Plains All-Stars had 5 twelve-year-olds who finished their Little League careers against Denver City. Seven will be back next year with a little more experience for another crack at them.

## Grass fires keep PVFD busy

The hot dry weather and late evening lightning storms in June and early July combined to cause a rash of fire calls for the Plains Fire Department. Only one of the 16 fire calls during this period was located inside the City limits, while the other 15 were range fires.

Three fires on June 2, two fires on June 11, one fire each on June 27 and 29,

two fires on July 2, and three fires on July 3, were all attributed to lightning storms. A fire west of town on June 21, appeared to be caused by an electric line transformer short. Two out-of-town calls during this time proved to be either false alarms or a controlled fire. One range fire and one fire inside the City limits was caused by fireworks.

While structure damage was held at a minimum by the Fire Department, an undetermined amount of pasture land was destroyed by these fires. There was no property loss caused by the one fire located inside the City limits.

Several of the range fires required assistance from other departments. Support from the Denver City, Tatum, Knowles and Lovington fire departments was required to contain several of these fires. Yoakum County precinct employees also assisted in controlling many of the fires with maintainers and water transport trucks. The Plains Fire Department also assisted the Morton Fire Department in controlling grass fires in the north part of the county.

The Plains Fire Department is comprised of 16 dedicated volunteer men and women who respond as needed to protect the life and property of the citizens of the area. These volunteers spend many hours in training, both locally and at regional training sessions, so that they can be prepared at all times to respond to any and all fire calls.

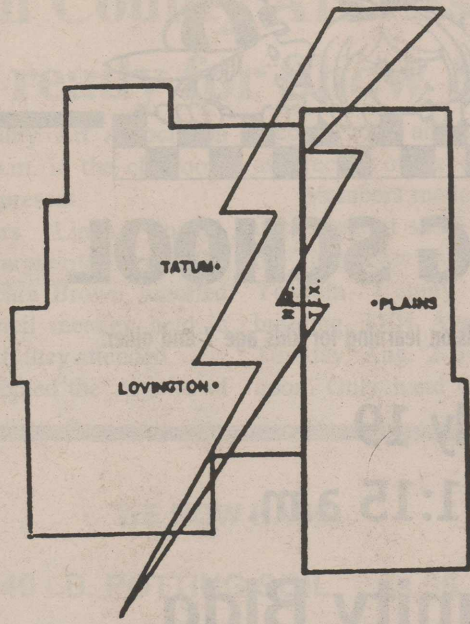

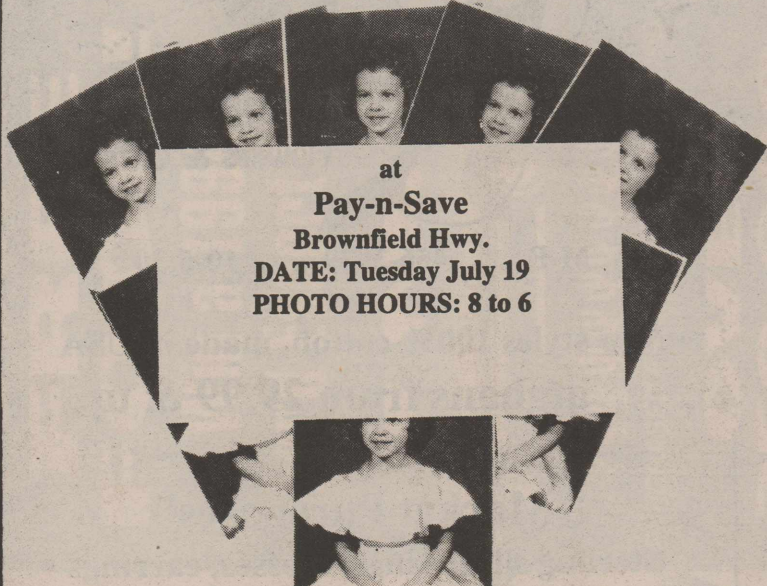
