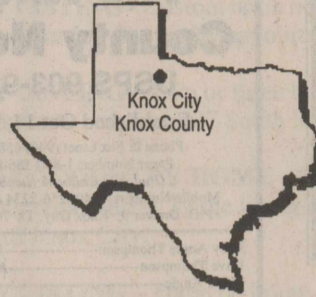

Economic Development Corporation seeking opinions on downtown plans

The Economic Development Corporation (EDC) of Knox City has been busy in recent months trying to come up with plans and ideas for the possible future renovation of our community's downtown business area.

Working along the idea that an improved image for the area could attract new businesses and more shoppers, EDC has actually been working on the project since town hall meetings that were held several years ago indicated that this was a project that Knox City residents wanted to accomplish with the sales tax funded EDC. During those early meetings, many residents voiced opinions that included a new look in the downtown area as part of an overall cleanup of Knox City.

Working with local artist and decorator Denise Cuniff, EDC has two different downtown renovation plans that are being considered. The first plan, referred to here as Project 1, offers ideas such as an overall



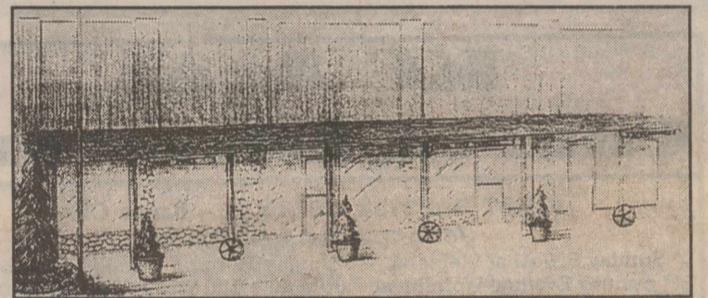
cleanup of downtown that include repainting the buildings all the same colors to highlight the architectural details and including theme murals that center around hunting, and making hunters welcome in the area. With the hunting industry bringing in large amounts of revenue to Knox City each year, it is easy to imagine that future plans for our community could easily focus on being one of the hunting capitols of Texas. Project 1 would also feature awnings in front of every store that would utilize either clay style tiles of cedar shingles and cedar posts. Wood shingles could also be added to the bottom half of store fronts to add to the style. Planters would be placed in the area and planted with evergreen trees and perennial flowers. Project 1 would be a more economic plan that would refresh the area for the least expenditure of EDC and merchant funds.

Plans for the other proposed idea, (referred to as Project 2) are more complex and detailed but would also offer lower maintenance over a longer period of time. This plan would include new, theme based, business fronts for all the downtown businesses. Putting up cedar shingles on the tops of store fronts and refacing the bottom area with flagstone, the whole downtown area would have an image that reflects the area that we live in. All the store signs would be replaced with hanging shingle type boards that are painted in green and burgundy. The buildings themselves would be painted dark sage green. North and South sides of exposed building walls would be painted with murals of landscape, also geared towards hunting. Planters of flagstone and concrete would be planted with evergreen cedars and perennial flowers. This plan would be more detailed and involve a greater expenditure of both EDC and merchant funds.

One point to be emphasized right now is that these two plans are only tentative proposals that are being offered to the community by EDC as a way of generating response to the ideas. EDC does want to hear input from residents and merchants, your ideas are important and are being solicited by EDC.

A smaller, black and white version of the plans are featured inside this edition of *The Knox County News* on page 5, and the full sized color plans are on display for your viewing at Citizens Bank in Knox City.

Another point to stress at this time is that no decisions have been made on how the projects would be paid for. Legally, EDC is checking with state officials to see if partial merchant funding is a requirement, or if EDC funds can cover all the cost involved if either Plan 1 of Plan 2 is selected by the combined input of EDC, citizens and merchants. EDC urges each resident, merchant, and any other concerned individuals to go by the bank, view the proposals, then let your feelings be known.

The family requests that memorials be made to the First Baptist Church in Seymour.

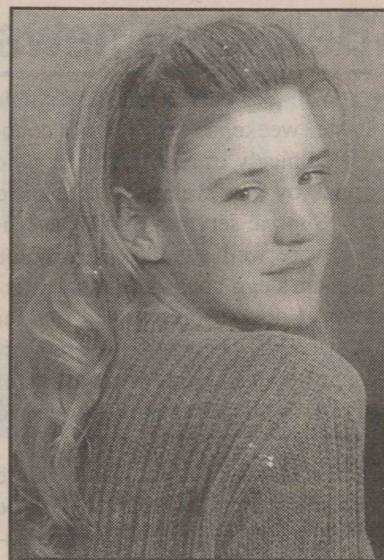
Pointer rites held in Hillsboro

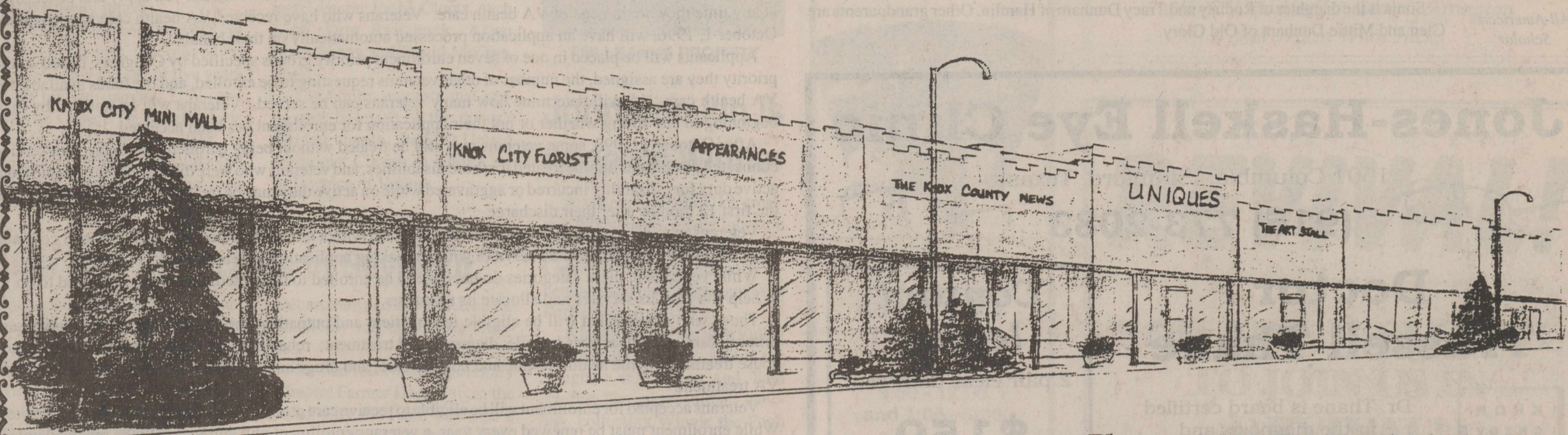

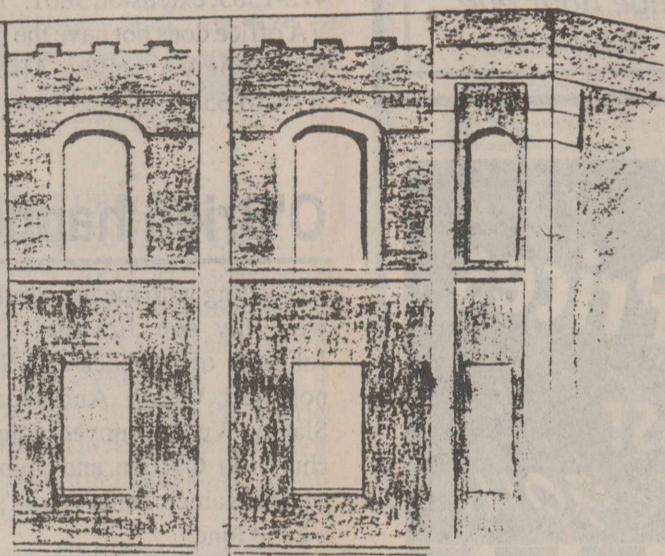
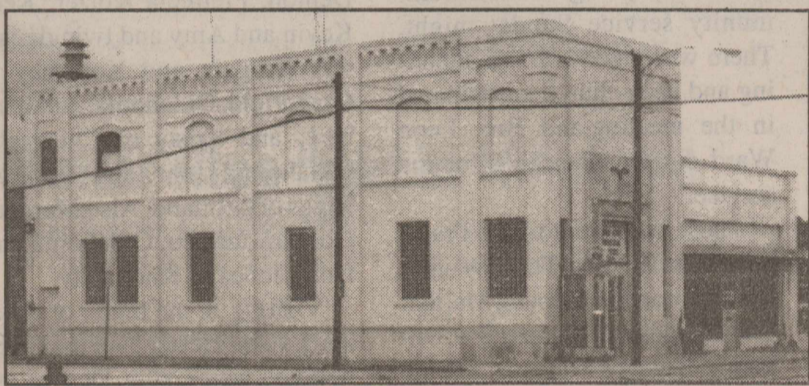

City Hall

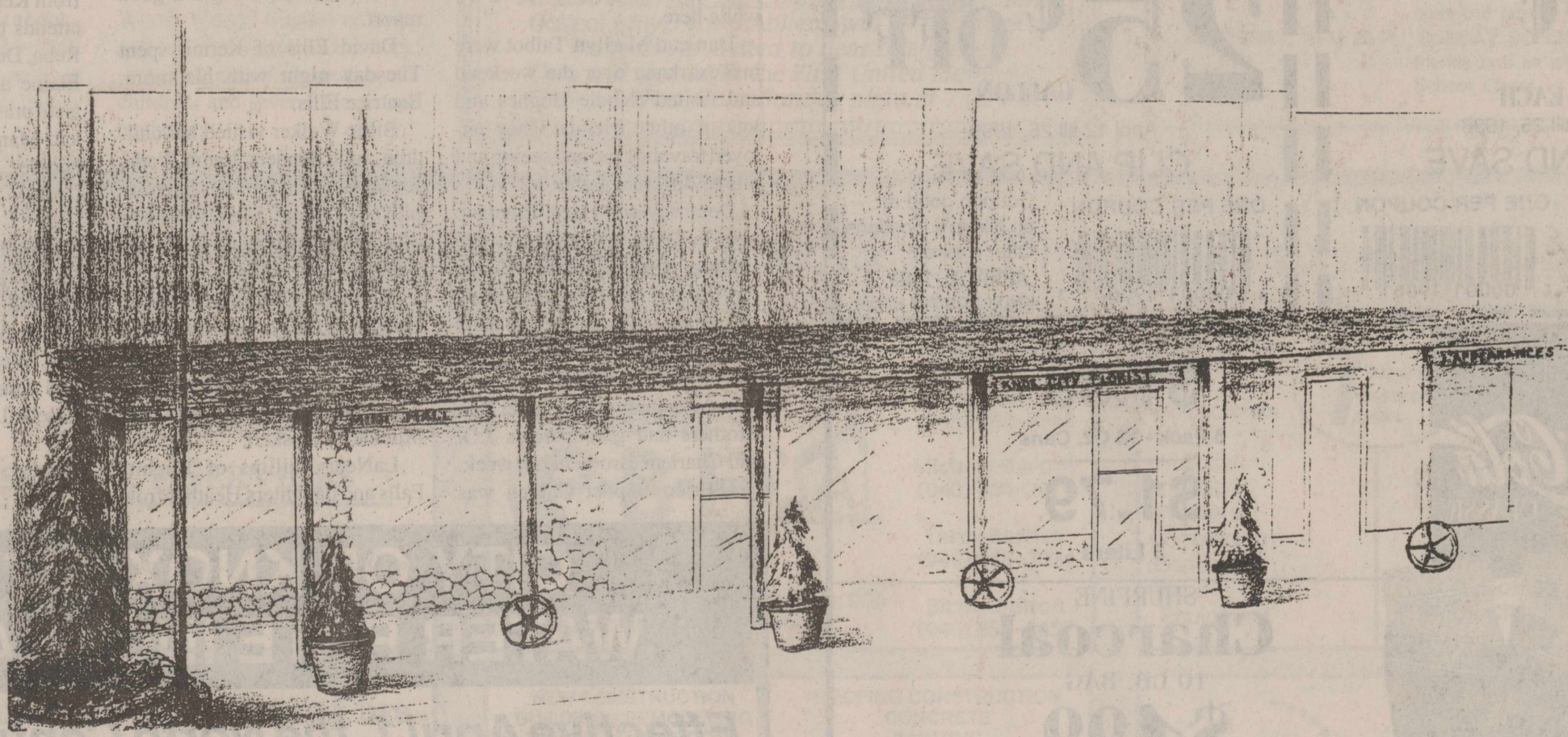
Paint other buildings to highlight architectural details in green, burgundy and cream



- Paint store fronts to impress architectural detail - hunter green & Burgundy.
- Make overall look more appealing with flagstone / concrete planters.
- Build awning with adobe style clay tiles (or cedar shingles) and cedar posts.
- Wood shingles could be added to bottom half of store fronts where possible - adding more style and impact (as is with the Chamber of Commerce office).

At businesses along Main Street and further down Central:

- Add flagstone / concrete planters - plant with ever green trees and perennial flowers
- Paint murals on North and South sides of each block of buildings.
- Most important building - American Legion Hall, Landscape mural geared toward hunting with words "Knox City Welcomes You."



Plan 2 - Highest Impact, Lowest Maintenance Plan For East and West Side Of Main Business Area:

Plans for revising overall look of Knox City should include planting evergreen trees and perennial flowers wherever possible. Native materials should be used, i.e. flagstone, mesquite cedar. Overall style and theme should be geared towards hunting.



Business Fronts:

- Top Section - Re-face with cedar.
- Awning - Cedar shingles and posts (wagon wheel / planter at alternating posts).
- Bottom Section - Re-face brick, tile and stone with flagstone, re-face wood with shingles.
- Signage - Replace with hanging shingle type boards painted in green and burgundy.

North and South Sides Of Buildings

- Paint dark sage green.
- Murals - (Landscape scenes geared towards hunting).
- Planters: - Flagstone and concrete planted with evergreen cedars and perennial flowers.

Veterans' News

Clarifying those recent changes regarding Veterans' eligibility for health care

In response to incorrect information distributed by others on the internet, and to clarify what appeared in this column last week, the Department of Veterans Affairs has provided the following information that I am happy to pass on to all veterans in Knox County.

VA is required by law to establish an enrollment system for health care services to be in place by October 1, 1998. While veterans must be enrolled to receive care, it does not mean that veterans who have not applied for enrollment by that date will lose their eligibility for VA health care. Veterans can apply and be enrolled at any time they are in need of VA health care. Veterans who have received VA health care services since October 1, 1996, will have an application processed automatically on their behalf.

Applicants will be placed in one of seven enrollment priority groups specified by Congress. Based on the priority they are assigned, the number of other veterans requesting to be enrolled, and the funds available for VA health care, VA will determine how many veterans can be served. Veterans will be notified by mail beginning in late spring whether or not their application for enrollment has been accepted.

After October 1, 1998, some veterans may still be treated without being enrolled. Veterans with service connected disabilities may be treated for those disabilities, and veterans who were discharged or released from active duty for a disability incurred or aggravated while on active duty may be treated for that disability within the first 12 months after their discharge.

Veterans who are classified as being service disabled with a rating of 50 percent or greater will continue to be eligible for VA health care services without making application for enrollment.

While veterans in these categories do not have to be enrolled to be treated, they are encouraged to do so to help VA plan its services and allocate its resources.

Those who are enrolled will be eligible for inpatient and outpatient services, including preventive and primary care. Other services include: diagnosis and treatment; rehabilitation; mental health and substance abuse treatment; home health; respite and hospice care; and drugs and pharmaceuticals in conjunction with VA treatment.

Veterans accepted for enrollment will be eligible to receive care at any of VA's more than 1,100 service sites. While enrollment must be renewed every year, a veterans enrollment will automatically be renewed unless he or she chooses not to enroll, or unless VA resources limit the number of veterans the department can cover. Certain veterans will be asked to provide income information annually in order for VA to properly classify them within the enrollment system, as required by law.

To apply for enrollment, area veterans should make a toll free call to the Big Spring VA office at 1-800-472-1365, extension 5801. You can register by phone, then send your DD Form 214 in by mail. The Abilene VA office does not have the manpower available to handle all the calls, so please call the above number at the Big Spring VA facility. Also, I should have the enrollment forms by the end of this week, so you can call me at (940) 658-3487 and I will be able to assist you with the enrollment process.

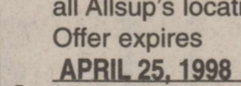
