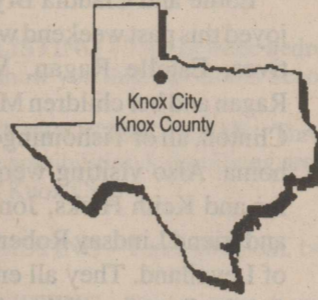

Saturday is the day to vote in elections for city council, school and hospital boards

This Saturday, May 2, is the day for Knox County and Knox City voters to cast their ballots for elected positions on the local city councils, Knox City - O'Brien Consolidated Independent School District Board of Trustees, and the Knox County Hospital Board.

Running for positions on the City Council of Knox City, five newcomers are vying to fill three open vacancies. Council members Walter Rauch, Benny Vasquez and Carol Felts all decided not to seek reelection, so Jeff Stanfield, Barbara Ainsworth, Tommy Mangis, Domingo Garcia and Charles Lankford all filed for the three positions.

In the Benjamin School Board election, Kenneth Carroll, Mitzi Ham, and incumbent Wyman Meinzer are running for two places with a two year term of office. Running for two unexpired terms of two years are Shanna Heard, Louise Leathers and Randy Reed.

There will not be a O'Brien City Council election, with Mayor Charlene Brothers, and incumbent council members Jan Frost and Phil Serabia all being returned uncontested to office.

There will not be a Knox County Hospital Board election, with incumbents Peggy McGaughey from Knox City and Don Bunton from Munday being returned uncontested to office.

There will also not be a Knox City - O'Brien CISD Board of Trustees election, as Dale Turner and Raul Espinosa Jr. are uncontested for positions vacated by Jerry Williams and retiring trustee Dwayne Johnson.

4-H is the youth development and leadership program of the Texas Agricultural Extension Service, a part of the Texas A&M University System.

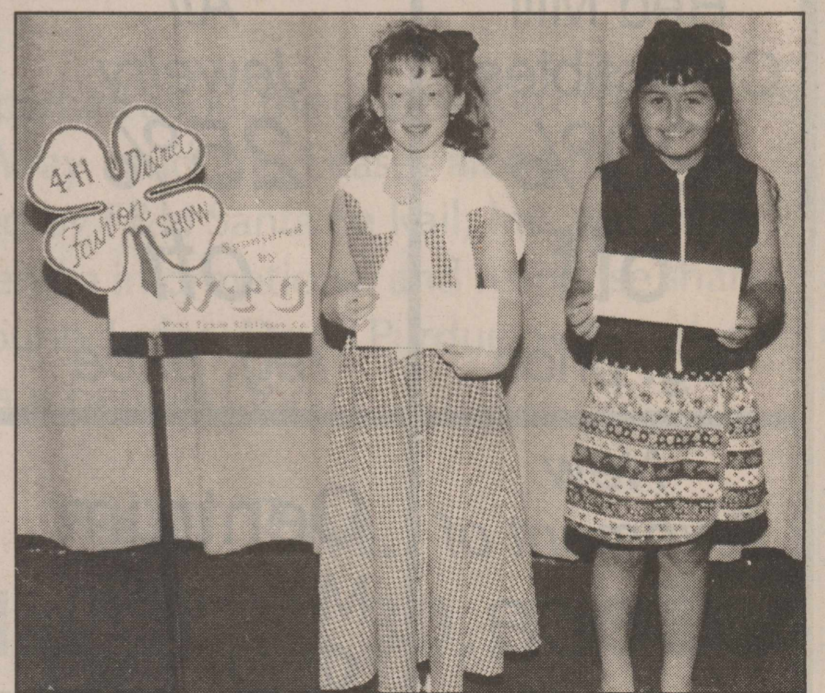

The United States Achievement Academy has announced that Aaron Large of Knox City has been named a United States National Award Winner in both Science and English.

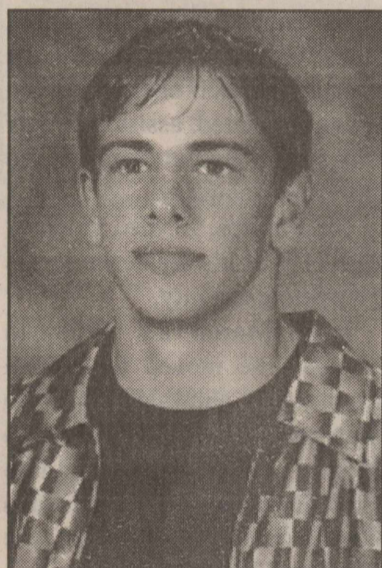
These awards are prestigious honors very few students can ever hope to attain. In fact, the Academy recognizes fewer than 10% of all American high school students.

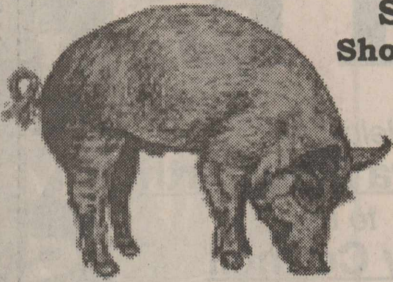

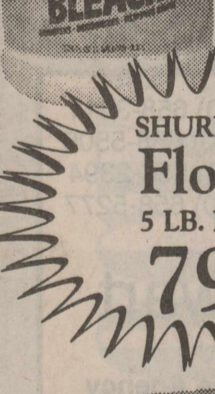

On A Wizer Note.... By Paul Weiser, Knox County Extension Agent - Ag.

Show steer validation tag orders due by Friday

It is time to order validation tags for show steers to be shown in 1998 - 1999. This validation process has been in effect for a long time and is required for market steers shown at most stock shows in Texas.

This year there is a new technology added to the process. A blood sample will be taken from each steer as a means of better identification.

Each county will place only one validation tag order - - no matter how many FFA chapters or 4-H clubs wish to order ear tags. To place an accurate order, the Ag. Science Instructors and County Extension Agents ask that show steer validation tag orders

be turned in by noon, Friday, May 1 to the Knox County Extension office in Benjamin. These tags will cost \$6 each. This fee must be paid when the orders are made. This \$6 covers the ear tag and technology fees for the new Antibody Profile Assay identification process to be used for the first time this year.

On May 1 all ear tags orders will be added together and a total from Knox County will be sent to proper state show steer validation personnel. Extras will not be ordered for anyone unless they are requested.

These ear tags will be received in May and all show steers will be validated in June. A tentative date

of June 16 has been set for steer validation in Knox County. If you have any questions please feel free to call Paul Weiser in the Knox County Extension office in Benjamin 454-2651 or your local Ag Science Instructor.

Educational programs of the Texas Agricultural Extension Service are open to all citizens without regard to race, color, sex, disability, religion, age or national origin.

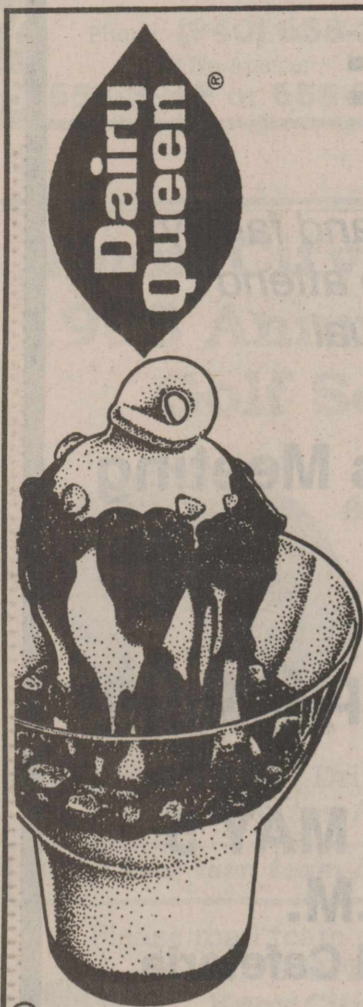

This column is written with a different and somewhat personal perspective about what is happening around the area.

Update on cell phones!

Several weeks ago, I passed on information provided to me by Cellular One that it was not illegal for people to listen in on cellular phone conversations with their scanners. That information was provided because of complaints that certain people in our area were listening in on cell phone conversations by scanner, then passing that information on to whoever else they talked to or gossiped with. Well, here is some

more information on the subject that is very important and should be read very carefully so that everyone fully understands it.

After printing that information, I received another phone call from one of the Cellular One area managers that I had previously talked with. She had been doing some more checking since our earlier conversation and had discovered that indeed it is very illegal to listen in on cellular phone conversations by scanner. In this new information, the Cellular One manager also found out that not only is it illegal to listen, but also to pass the information heard on to others. If you suspect that someone is listening to your conversations, then discussing it around town, you do have the right to file criminal charges if you can prove who it was that listened and did the gossiping.

Because we had already printed the earlier information that it was

not illegal, I asked the Cellular One manager for some sort of written subject matter that I could refer to in backing up what I am printing here. She stated that she would send or fax something, but I was out of town when she called back last week and I have not heard from her again.

So once again, let me just remind everyone to watch what you say in your cellular phone conversations as you never know just who might be listening in. But, now it seems that you do have the legal right to do something about it if you can prove who else is listening and passing on what they hear around town about your cellular phone conversations.

Another bit about phones...

When I opened up the NEWS phone bill from GTE this month, I was surprised to discover a \$37.00 charge from some company that provides 'non-basic services.' This charge was a subscription fee for something called 'premium plan voice mail.' Since we had never subscribed to anything like that and do not have voice mail, I called GTE. I explained the problem and was given a number to call for the other company. At 4:00 on Monday afternoon I called and received a recorded message that stated: "We are too busy to take your call, please call back tomorrow." My first impression was that this could not be much of a company, but I did call back on Tuesday morning. After inquiring about the charge, I was informed that someone from our office had called and asked for the voice mail to be activated. When I stated that no one had called or authorized this service, I was put on hold for awhile. Then, much to my surprise, I heard my voice stating: "Dave Thompson," then after a short electronic pause, my voice saying: "premium plan." A manager came on the line and stated that I had authorized this service. Now even though my memory is not what it used to be in younger years, I knew immediately what was going on. A while back someone had called to ask if we were interested in such a service. When I stated that we were not, the caller said she had to prove to her supervisor that she had called, so could I please state my name and that I was not interested in the premium plan. I did so, and that edited version is what they were now using to say we had ordered the plan. They took just me stating my name, then me stating "premium plan" to back up a \$37.00 charge on the phone bill. After a

rather heated discussion about how dishonest they were with creative electronic editing, they finally agreed to credit back the \$37.00 fee and cancel the service.

I called the business office at GTE to let them know what had happened, and a service representative there was interested in the story and offered this advice to you, our readers: You need to go over your phone bill every month and check out each charge because there's a lot of this sort of thing going on these days. So, that is why I am passing this story on to you in this column, check those bills and do not hesitate to question what does not appear familiar.
