#### State of emergency declared in county

Knox County Judge David N. Perdue declared on Monday morning that a state of emergency exists in Knox County due to recent dry weather and the extreme potential for large and destructive wildfires.

Judge Perdue also issued an emergency order, effective immediately, which prohibits any open burning in the unincorporated areas of Knox County except the burning of combustible material in approved enclosures, such as trash barrels and charcoal grills which are designed to contain all flames and embers.

Due to dry conditions and the lack of significant rainfall, all persons are advised that any open burning is extremely likely to

cause very dangerous wildfire, posing risks to lives and property. Local fire department officials, the National Weather Service, and the personnel from the Texas Forestry Service advise that there is no present forecast for improving weather and/or moisture condi-

The order signed by Judge Perdue provides that repeated or flagrant violations of the order shall constitute a misdemeanor, and that any peace officer of the State of Texas may enforce the order in the venue of Knox County.

This order goes into effect immediately, and will be in effect for the next ten days; and then will stay in effect until significant moisture occurs.

To all of you who have asked, Dave is "making progress" since his knee revision last Thursday in Albuquerque, New Mexico.

In my mind, this surgery would have been more simple than the knee replacement he underwent in July 1991; however, doctors informed us that revisions ('replacing the replacement') are much, more

After being in the operating room and recovery for over eight hours, the doctors told us his leg bone had adhered so much to the upper and lower base plates of the prothesis over the past seven years that they literally had to "hammer and chisel" the bone from this. It was originally thought that so much trauma was put on his leg that they had broken his ankle in the process!!

Thank the Lord, after x-raying, it was determined the ankle was not broken, just severely "traumatized". He is presently undergoing an intensive physical therapy program.

#### **Council minutes from June 11**

(The following minutes are the unapproved copy from the June 11 City Council meeting.)

The Knox City Council met in Regular Session on June 11, 1998 with Mayor Tommie Reynolds presiding. Council members present were Jeff Stanfield, Tommy Mangis and Charles Lankford. Council members absent were Jerry Curd and Cathye Williams. Also present was City Administrator Danny Parker, City Secretary Brenda Correll, Police Chief Harry Steen, Assistant Maintenance Supervisor Adam Campbell, Assistant City Clerk Elaine Eaton and County Constable Buddy

The meeting was called to order at 7:04 p.m.

The invocation was given by Mayor Tommie Reynolds.

There were no public comments. Council discussed and considered minutes of the previous meeting. Charles Lankford made motion to approve minutes and Tommy Mangis seconded. All voted in favor.

Council discussed and considered the April 6, 1998 minutes of the EDC meeting. Jeff Stanfield made motion to approve minutes and Tommy Mangis seconded. All voted in favor.

Gerald Rodgers of James E. Rodgers & Co., CPA presented the

Fiscal Year Audit from Oct. 1, 1996 to Sept. 30, 1997. Gerald Rodgers' overall report was favorable with the City receiving an Unqualified Opinion on General Purpose Financial Statements. Mr. Rodgers expressed his findings of some transfer errors from one account to another and suggested that payroll expenditures be broken down by departments. Mr. Rodgers also expressed that the City financial outlook is in a more positive position than the previous year. Motion was made by Jeff Stanfield to accept the fiscal year audit report. Charles Lankford seconded motion. All voted in favor.

The next item on the agenda was the viewing of the TML video for new councilmembers. Council expressed their appreciation for the opportunity to view the video.

Next on the agenda was the City Park volleyball pit location. After discussion and consideration, Charles Lankford made motion to not do anything at this time. Jeff Stanfield seconded the motion and all voted in

Council discussed and considered personnel matters. Council agreed to continue with one officer on the Police Department. Council also advised Police Chief Harry Steen to take off one day a week and vacation time with Knox County Sheriff's

Department covering the City. Councilmembers also discussed cutting Police Dept. expenses by selling one of the patrol cars. No further action was taken. Charles Lankford made motion to advertise to accept applictions for City Administrator. Tommy Mangis seconded the motion. Charles Lankford advised City Administrator Danny Parker that he would act as Interim City Administrator and his application would be considered along with others for the position.

Council discussed and considered monthly reports for the Police Dept., Municipal Court, Water/Sewer Dept. and Fire Dept. Motion was made by Jeff Stanfield to accept reports. Tommy Mangis seconded. All voted: in favor.

Council discussed and considered financial reports and bills of the







#### HOT WEATHER AND HEART DISEASE A DEADLY COMBINATION

#### **Knox County Hospital Trauma Committee Safety Education**

Long summer days and warm weather make everyone want to go outside to do some of the things we've put off all winter. If you're planning a busy summer of lawn mowing, water skiing, fishing, gardening, golfing or other physical activities, remember to use extra caution if you have any risk factrors for heart disease. People who are overweight, smoke, have high blood pressure, high cholesterol, or a family history of heart disease should be extra careful about taking on new, strenuous activities during the hot weather, according to health care experts at Knox County Hospital.

"Combining sudden exertion and strain with extremely hot weather for a person" who is at risk for heart disease can be a deadly combination," Shirley Barretto, MD, said. "We always caution people who are taking up a new sport or doing an activity that is more strenuous than usual to get a check-up beforehand." Dr. Barretto said that a physician can advise patients about the proper way to begin an exercise program, or help them find exercise limits that are safe for them. "We just know that each of these factors add to the possibility that the person will eventually develop cardiovascular disease."

"We're proud of the fact that we have a formal cardiac rehabilitation program hereat Knox County Hospital," Kevin Ansley, hospital administrator, said. "This program can help the person who has just been diagnosed with cardiovascular disease, as well ast he person who is recovering from a heart attack. For the patient who is experiencing some problems or who has been diagnosed with heart disease, we can work with the physician and the patient to help that person, through exercise, proper nutrition and lifestyle changes."

Dr. Barretto explained that the cardiac rehab program is just one facet of the programs set up to diagnose and treat heart disease. "At Knox County Hospital," we have a complete lab service to help with diagnosis. Our home health service: was developed to assist the person recovering from a heart attack, and our association with regional medical centers in Abilene and Lubbock gives us another level of service to help those with heart disease," Dr. Barretto said.
