# February, 1999 state sales tax rebate for Knox City totals \$18,366.43, up from 1998

State Comptroller Carole Keeton Rylander delivered \$318.2 million in monthly sales tax rebates to 1,097 Texas cities and 118 counties, including a check of \$\$18,366.43 to Knox City. The rebate to Knox City reflects an increase of 1.90% from a rebate check of \$18,022.54 for the same period in 1998. Knox City collects a 2.000% rate of sales tax, with a full 1.000% of the tax directed towards Economic Development (EDC) funding. The Knox City Economic Development Corporation uses this money for projects to spur the local economy of our community. These same state sales tax rebates accumulated over the past three years are the funds being used to renovate the old Perry's building for the new Duckwall's Hometown Variety Store that is scheduled to open during the first week of May. Duckwalls will be hiring local employees, plus paying into this sales tax rebate in the future on items sold when the

store is open.

Texas cities received \$293.6 million, 9.9 percent higher than payments of \$267.1 million at this same time one year ago. Counties received a total of 24.5 million in rebates, up 9.5 for the

same period in 1998. Another 9.7 million went to special purpose districts around the state.

The checks delivered this month are for sales taxes collected in December and reported by businesses filing monthly tax returns in January, plus quarterly returns for sales in October, November and December, and returns from annual filers for the entire year of 1998.

For other Knox County cities, Benjamin received \$895.60, a 0.34% increase from \$892.50 for the same period a year ago. Goree received \$496.18, down 37.94% from a payment of \$799.59 last year at the same time. Munday received \$12,578.63 up 12.15% from a payment of \$11,215.00 in 1998 at the same time. Munday collects a 1.500% rate of sales tax, with Benjamin and Goree collecting a 1.000% sales tax.

In Haskell County, Haskell received \$48,904.80, up 16.20% from a payment of \$42,084.46 in 1998. Haskell collects a 2.000% rate of sales tax. O'Brien received \$205.64 this period, down 52.22% from a payment of \$430.44 a year ago. Rochester received \$1,038.07, down 8.66% form a payment of \$1,136.60 during the same period last year.

In Jones County, Stamford received a payment of \$66,740.31, up 5.72% from a payment of \$63,123.98 in 1998. Anson received \$25,640.58, up 20.52% from a payment of \$21,273.53 last year. Hamlin received a check of \$27,843.43, up 7.79% from \$25,830.18 in 1998. Stamford, Anson and Hamlin all collect a 2% rate of sales tax.

In Baylor County, the city of Seymour received a payment of \$20,639.37, up 2.39% from a payment of \$20,156.31 in 1998. Seymour collects a 1.000 rate of sales tax.

In Foard County, Crowell received a payment of \$7,571.47, up 1.27% from a payment of \$7,476.20 in 1998. Crowell collects a 1.500% rate of sales tax.

In Dickens County, Dickens received \$5,333.50, up 103.54% from a payment of \$2,620.30 in 1998. Spur received a payment of \$5,291.16, up 2.00% from a 1998 payment of \$5,187.37. Dickens collects a 1.5% rate of sales tax, while Spur collects a 1% rate.

In Cottle County, Paducah received a payment of \$9,774.16, down 0.48% from a payment of \$9,821.35 in 1998. Paducah collects a 1.5% rate of sales tax.

After six months in Dallas where he underwent a heart transplant and numerous surgeries, Carol Felts is doing well, and he and Zo are so happy to be home again. They arrived Saturday about 1:00 p.m.

Carol explained that every Monday, Wednesday and Friday he 'hooks himself' up to a Transtelephonic Exercise Monitor at 2:20 p.m. With his set of headphones, he is able to communicate with the nurse in Dallas as she monitors his heart while he is riding the exercise bike.

He also will have to return to the Dallas facility once a month for a heart biopsy, the first being March 4. The biopsy determines if his body is showing any sign of rejection.

Zo said the doctors in Dallas remarked that it was evident it was God's will that Carol recovered.

#### District court hears cases in all four counties

The felony criminal docket kept the District Court occupied last week in all four of the counties composing the 50th Judicial District, according to District Attorney Bill Neal.

Action in the Baylor County District Court last Tuesday saw four defendants enter guilty pleas and one forfeiture case was heard by visiting District Judge Leslie Thomas of Crowell.

Jeffery Glen Bailey, 35, of Harrison, Michigan, plead guilty to possession of cocaine and was sentenced to a four-year probated sentence, was assessed a \$1,000.00 fine, ordered to pay court costs, as well as \$140.00 restitution to the State Crime Lab for testing of the drugs.

Jeffrey Earl Kemp, 21, of Lancaster, plead guilty to hindering apprehension of a felon and was sentenced to a five-year probated sentence, assessed a \$500.00 fine, and was ordered to pay all court costs.

Jennifer Dawn Lee, 25, of Temple, plead guilty to forgery and was given a five year probated sentence, assessed a \$1,000.00 fine, was ordered to pay all court costs and was also ordered to pay restitution to the victim.

Adis Latham, 43, of Seymour, plead guilty to the State's allegations that he violated the terms of probation by failing to abstain from the use of marihuana, failing to pay his fine, failing to report to his probation officer and failing to pay his community supervision fees. Latham has been given a three-year probated sentence on June 28, 1996 for delivery of mari-

huana. After hearing Latham's plea of guilty to violating the terms of probation, Judge Thomas ordered the defendant to be incarcerated in the prison system's felony substance abuse facility for a period of approximately nine months, after which he will be returned to serve the balance of his probation. However, in addition, Judge Thomas ordered an additional two years to be added to his probation, term, making it a total of five years

total of five years. Elizabeth Ann Martinez, 21, of Clinton, Oklahoma, plead guilty on October 19, 1998 for possession of marihuana. At that time she was given a five-year prison sentence, but sentenced to the prison system's "boot camp" program. After successfully completing the prison's boot camp program, she was brought back Tuesday and asked to be put on probation for the balance of her term. Judge Thomas granted the motion. In view of the defendant's youth and the fact that was her first conviction, and the fact that she successfully completed boot camp, District Attorney Neal did not oppose allowing her to be placed on probation for the balance of her five-year term. In addition, however, the State had filed a forfeiture suit to forfeit Martinez's 1986 Pontiac Sunbird automobile which she was using to transport the marihuana in question when arrested. Judge Thomas granted the forfeiture auction by the State and forfeited the vehicle to the State. Since Seymour Police Officer Mike Griffin was the officer making the arrest in

this case, District Attorney Neal

stated that the title of the vehicle would be transferred over to the Seymour Police Department.

The only other action in the **Baylor County District Court was** a scheduled change of venue hearing sought by William Anthony Thornhill, 43, of Seymour, seeking to have this trial for felony driving while intoxicated and his trial for aggravated assault and retaliation moved out of Baylor County. This motion was opposed by District Attorney Neal. The Court granted a temporary continuance of the change of venue hearing and scheduled it for Wednesday, February 19th, 1999, at 1:30 p.m. Thornhill is represented by Bill Heatly, Jr. of Paducah.

On Wednesday, the District Court moved to Knox County and heard two guilty pleas, plus conducted a pretiral hearing in another case.

Roy Q. Lerma, 34, of Knox City, plead guilty to the offense of deadly conduct with a deadly weapon and was given a five-year probated sentence, fined \$500.00 and ordered to pay all court costs. He was represented by Gary Conally of Abilene.

Michael Gerard Albus, 32, of Knox City, plead guilty to possession of less than one gram of cocaine. He was granted deferred adjudicatio probation and his probation term was set for three years. Albus was also fined \$1,000.00 and ordered to pay all court costs, plus \$140.00 restitution to the State Crime Lab for testing the drugs. Albus was represented by

Corporation EDC received word week before last from the Childress office of a few years back. of the Texas Department of Transportation that we will be able to move the handicap zone from the front of the old White Auto store around to the side of the building. As a matter of fact, TxDOT Engineer Randy Butler provided some unique plans for a different type of handicap ramp that is much better than the current one out in front of the building, and will be much easier to use for those with handicaps. We appreciate all the assistance we have received from both the Munday and the Childress offices of the Texas Department of Transportation.

The deadline has passed for receiving bids on the projects for a driveway into Merchants Park for off street parking, and the replacement of the sidewalk on the North side of White's Auto. Two bids were received, and the 4A EDC board will meet this week to open the bids. Upon bid approval, the work could begin right away. Once both projects are completed, we hope the parking downtown will be adequate for current businesses and the new Duckwall Hometown Variety Store. The lot known as Merchants Park will become a parking area for those downtown business people who do not park behind their businesses, and the lot behind the old White Auto building will be a parking area for the employees of Duckwalls. That should leave the on street parking spaces open for customers of all the downtown businesses. Because Central Avenue is also a Texas State Highway, no parking spaces are reserved for any particular business. Every available consumer parking place is equally shared by each business in the downtown area. We hope that downtown business employees will utilize Merchants Park, but that can not be mandated. In short, anyone (including business owners and their employees) can park anywhere they want to. Our goal with EDC is simply to improve the parking situation by providing more parking spaces, but where one chooses to park is left up to the individual.

EDC is working on plans for a really festive grand opening of our new Duckwall's Hometown Variety Store. Whenever that date is, and whatever format we decide on, we sincerely hope everyone will plan to be with us and join in the celebration!

dant's bail bond. District Court action moved to Cottle County Thursday. Pretrial hearings were held in Paducah in the following cases: Norah Lee Williams, Jr., 41, of Floydada, who has been indicted, together with his companion, Guy Edward Ledbetter, 39, of Floydada, for possession of cocaine over four grams but less than 200 grams. Williams is represented by Andrew Ottaway of Hamlin and his companion Ledbetter is represented by Mike Brown of Lubbock. Ledbetter's case is set for jury trial in Paducah on April 27, 1999.

Pretrial was also held in the case of Jeffery Wayne McClenney, 31, of Plainview, who has been indicted for possession of under one gram of methamphetamine. McClenney is represented by earl Griffin of Childress.

Pedro Gonzales Cordoso, 26, of Paducah, who has been on probation for felony DWI, was brought before the Court on a State's Motion to Revoke his probation.
